Air Traffic Noise and Pollution Expert Consensus Act of 2021

This bill would require the FAA to arrange with the National Academies of Sciences, Engineering, and Medicine to examine and report on the health impacts of air traffic noise and pollution.







HR 712, SEC. 2. HEALTH IMPACTS OF AIR TRAFFIC NOISE AND POLLUTION

(a) STUDY.—The....Federal Aviation Administration shall....

(1) not later than 30 days after the date of enactment of this Act, *convene* a committee of experts in health and environmental science to examine the various health impacts of air traffic noise and pollution; and

(2) *issue a corresponding expert consensus report* that sets forth current scientific knowledge relating to the various health impacts of air traffic noise and pollution.

Is This Another Study???


- A National Academies consensus report is <u>NOT</u> new research.
 Don't be confused by the word "study" in the bill language.
- A consensus report reviews the *existing* body of science.
- A consensus report will contain policy recommendations. *It accelerates policy changes.*
- The National Academies is independent of the government but was created to guide Congress on topics like this where legislators have little expertise.
- The National Academies Committee for this consensus report will be coordinated by the Health and Medicine Division, not the National Academy of Engineering

- An NA Consensus Report is a critical *stepping stone* to change FAA policies about aircraft noise and emissions.
- An NA Consensus Report is a *realistic legislative ask* in a highly polarized Congress.
- An NA Consensus Report would **lay the scientific foundations and make the case** for more regulatory reforms in the future.
