17 ports to the Administrator.

11 behalf of the Administrator; and

12 “(v) perform other functions as deter-
13 mined by the Administrator.

14 “(B) ASSISTANT ADMINISTRATOR FOR
15 RULEMAKING AND REGULATORY IMPROVE-
16 MENT.—The Assistant Administrator for Rule-
17 making and Regulatory Improvement shall be
18 appointed by the Administrator and shall—

20 managing the execution of a regulatory

14 completion of the regulatory activities of
15 the Administration outside the Office of
16 the Assistant Administrator for Rule-
17 making and Regulatory Improvement;

18 “(iii) on an ongoing basis—

19 “(I) review the Administration’s
20 regulations in effect to improve safety;

21 “(II) reduce undue regulatory
22 burden;

23 “(III) replace prescriptive regula-
24 tions with performance-based regula-
25 tions, as appropriate;

1 “(IV) prevent duplicative regula-
2 tions; and

3 “(V) increase regulatory clarity
4 and transparency whenever possible;

20 any such interest, including a stock option;

22 “(B) does not include securities held in an
23 index fund.”.

1 **SEC. 124. AUTHORITY OF SECRETARY AND ADMINIS-**

13 the economy of \$250,000,000 or more
14 (adjusted annually for inflation begin-
15 ning with the year following the date
16 of enactment of the Securing Growth
17 and Robust Leadership in American
18 Aviation Act);

19 “(II) raises novel or serious legal
20 or policy issues that will substantially
21 and materially affect other transpor-
22 tation modes; or

23 “(III) adversely affect, in a sub-
24 stantial and material way, the econ-
25 omy, a sector of the economy, produc-

1 tivity, competition, jobs, the environ-
2 ment, public health or safety, or a
3 State, local, or Tribal government or
4 communities.

5 “(iii) EMERGENCY REGULATION.—In
6 an emergency, the Administrator may issue
7 a final regulation described in clause (i)
8 without prior approval of the Secretary. If
9 the Secretary objects to such regulation in
10 writing within 5 days (excluding Saturday,
11 Sundays, and legal public holidays) of the
12 issuance, the Administrator shall imme-
13 diately rescind such regulation.

7 who shall either approve the regulation or
8 return the regulation to the Administrator
9 with comments within 30 days after receiv-
10 ing the regulation. If the Secretary fails to
11 approve or return the regulation with com-
12 ments to the Administrator within 30 days,
13 the regulation shall be deemed to have
14 been approved by the Secretary.

15 “(C) **PERIODIC REVIEW.**—

16 “(i) **IN GENERAL.**—In addition to the
17 review requirements established under sec-
18 tion 5.13(d) of title 49, Code of Federal
19 Regulations, the Administrator shall review
20 any significant regulation issued 3 years
21 after the effective date of the regulation.

22 “(ii) **DISCRETIONAL REVIEW.**—The
23 Administrator may review any regulation
24 that has been in effect for more than 3
25 years.

1 “(iii) SUBSTANCE OF REVIEW.—In
2 performing a review under clause (i) or
3 (ii), the Administrator shall determine if—

4 “(I) the cost assumptions were
5 accurate;

6 “(II) the intended benefit of the
7 regulation is being realized;

8 “(III) the need remains to con-
9 tinue such regulation as in effect; and

10 “(IV) the Administrator rec-
11 ommends updates to such regulation
12 based on the review criteria specified
13 in section 5.13(d) of title 49, Code of
14 Federal Regulations.

15 “(iv) REVIEW MANAGEMENT.—Any
16 periodic review of a regulation under this
17 subparagraph shall be managed by the As-
18 sistant Administrator for Rulemaking and
19 Regulatory Improvement, who may task an
20 advisory committee or the Management
21 Advisory Council established under sub-
22 section (p) to assist in performing the re-
23 view.”;

24 (4) by redesignating paragraphs (3) and (4) as
25 paragraphs (4) and (5), respectively; and

1 (5) by inserting after paragraph (2) the fol-
2 lowing:

3 “(3) DUTIES AND POWERS OF THE ADMINIS-
4 TRATOR.—

5 “(A) IN GENERAL.—The Administrator
6 shall carry out—

7 “(i) the duties and powers of the Sec-
8 retary under this subsection related to
9 aviation safety (except those related to
10 transportation, packaging, marking, or de-
11 scription of hazardous material) and stated
12 in—

13 “(I) subsections (c) and (d) of
14 section 1132;

15 “(II) sections 40101(c),
16 40103(b), 40106(a), 40108,
17 40109(b), 40113(a), 40113(c),
18 40113(d), 40113(e), 40114(a), and
19 40117;

20 “(III) chapter 443;

21 “(IV) chapter 445, except sec-
22 tions 44502(a)(3), 44503, and 44509;

23 “(V) chapter 447, except sections
24 44721(b), and 44723;

25 “(VI) chapter 448;

1 “(VII) chapter 451;
2 “(VIII) chapter 453;
3 “(IX) section 46104;
4 “(X) subsections (d) and (h)(2)
5 of section 46301, section 46303(c),
6 sections 46304 through 46308, sec-
7 tion 46310, section 46311, and sec-
8 tions 46313 through 46320;
9 “(XI) chapter 465;
10 “(XII) chapter 471;
11 “(XIII) chapter 475; and
12 “(XIV) chapter 509 of title 51;
13 and
14 “(ii) such additional duties and pow-
15 ers as may be prescribed by the Secretary.
16 “(B) APPLICABILITY.—Section 40101(d)
17 applies to the duties and powers specified in
18 subparagraph (A).
19 “(C) TRANSFER.—Any of the duties and
20 powers specified in subparagraph (A) may only
21 be transferred to another part of the Depart-
22 ment if specifically provided by law or in a reor-
23 ganization plan submitted under chapter 9 of
24 title 5.

1 “(D) ADMINISTRATIVE FINALITY.—A deci-
2 sion of the Administrator in carrying out the
3 duties or powers specified in subparagraph (A)
4 is administratively final.”.

5 (b) CONFORMING AMENDMENT.—Subsection (h) of
6 section 106 of title 49, United States Code, is repealed.

7 (c) PRESERVATION OF EXISTING AUTHORITY.—
8 Nothing in this section or the amendments made by this
9 section shall be construed to restrict any authority vested
10 in the Administrator of the Federal Aviation Administra-
11 tion by statute or by delegation that was in effect on the
12 day before the date of the enactment of this Act.

13 **SEC. 125. REVIEW OF FAA RULEMAKING PROCESSES.**

14 (a) IN GENERAL.—Not later than 30 months after
15 the date of enactment of this Act, the Administrator of
16 the Federal Aviation Administration shall enter into ap-
17 propriate arrangements with the National Academy of
18 Public Administration to evaluate and make recommenda-
19 tions to improve the Administration’s rulemaking proc-
20 esses.

21 (b) CONTENT OF REVIEW.—In completing the eval-
22 uation under subsection (a), the National Academy of
23 Public Administration shall—

24 (1) review Administration and Department of
25 Transportation policies and procedures for drafting,

1 coordinating, reviewing, editing, and approving rule-
2 making documents;

3 (2) review part 11 of title 14, Code of Federal
4 Regulations, and section 106 of title 49, United
5 States Code—

6 (A) as such section was in effect the day
7 before the date of enactment of this Act; and

8 (B) as amended by this Act; and

9 (3) include in the review—

10 (A) advanced notices of proposed
11 rulemakings;

12 (B) notices of proposed rulemakings;

13 (C) supplemental proposed rulemakings;

14 (D) interim final rules; and

15 (E) final rules, including direct final rules.

16 (c) METHOD OF REVIEW.—As part of the evaluation
17 under this section, the National Academy of Public Ad-
18 ministration shall analyze the scoping, drafting, analysis,
19 and approval processes, including examining incidents in
20 which a rule was referred back to a program office for
21 revision, and the timeline associated with each review and
22 step for—

23 (1) at least 7 rules completed by the Adminis-
24 tration since 2012, including—

1 (A) at least 2 rules that leveraged the
2 work of an aviation rulemaking committee;

3 (B) at least 2 rules considered significant
4 as defined in section 106(f)(3)(B)(ii) (as
5 amended by this Act); and

6 (C) at least 1 rule promulgated through
7 rules considered routine and frequent in the
8 Department's Regulatory Agenda; and

9 (2) at least 2 rulemaking processes where a no-
10 tice of proposed rulemaking has not been followed by
11 a final rule for more than 3 years.

12 (d) REPORT.—The National Academy of Public Ad-
13 ministration shall provide to the Administrator, Secretary
14 of Transportation, the Committee on Transportation and
15 Infrastructure and the Committee on Science, Space, and
16 Technology of the House of Representatives and the Com-
17 mittee on Commerce, Science, and Transportation of the
18 Senate a report containing the results of the evaluation
19 required under subsection (a). The contents of the report
20 shall—

21 (1) identify procedural or resource constraints;

22 (2) identify inefficiencies in the process, includ-
23 ing any causes of delays;

24 (3) provide recommendations for expediting
25 rulemakings, including—

1 (A) ways to improve the efficiency of the
2 scoping process for rulemaking;

3 (B) the use of new routine and frequent
4 rulemakings to allow for the expediting of ac-
5 tivities that may be routinely needed or up-
6 dated;

7 (C) the use of rules of applicability to pro-
8 vide for the expediting of activities that may be
9 routinely needed or updated;

10 (D) the use of frameworks or shell rules to
11 improve the efficiency of drafting;

12 (E) the use of aviation rulemaking commit-
13 tees; and

14 (F) internal process improvements; and

15 (4) not review the policy merits of the reviewed
16 rulemakings, except to the extent that there are con-
17 clusions that can be drawn from the processes used
18 to develop such rules.

19 (e) ACCESS TO DOCUMENTS.—The Administration
20 and Department shall provide the National Academy of
21 Public Administration access, as appropriate, to—

22 (1) the electronic management software the Ad-
23 ministration uses to track internal processing of
24 draft documents;

1 (2) appropriately redacted communications be-
2 tween offices and personnel that were used to coordi-
3 nate work outside of the electronic software; and

4 (3) such other documents and records, includ-
5 ing predecisional documents and records, that will
6 assist the National Academy of Public Administra-
7 tion in completing the evaluation required under
8 subsection (a).

9 **SEC. 126. OFFICE OF INNOVATION.**

10 Section 106 of title 49, United States Code, is further
11 amended by striking subsection (g) and inserting the fol-
12 lowing:

13 “(g) OFFICE OF INNOVATION.—

14 “(1) IN GENERAL.—There is established within
15 the Federal Aviation Administration an Office of In-
16 novation (in this subsection referred to as the ‘Of-
17 fice’) comprised of employees of the Administration
18 who shall—

19 “(A) have a diverse set of expertise;

20 “(B) assist the leadership of the Adminis-
21 tration and the Management Board of the Ad-
22 ministration with—

23 “(i) scoping complex regulatory issues
24 and drafting documents on topics that

1 span multiple offices or lines of business of
2 the Administration;

3 “(ii) evaluating internal processes;
4 and

5 “(iii) positioning the Administration
6 to support aerospace innovation; and

7 “(C) receive taskings from the leadership
8 of the Administration and the Management
9 Board of the Administration, as determined
10 necessary by such individuals, and work collabo-
11 ratively with relevant program offices of the Ad-
12 ministration, as necessary, to respond to such
13 taskings.

14 “(2) APPOINTMENT OF MEMBERS.—

15 “(A) APPOINTMENTS.—The Administrator
16 shall appoint a maximum of 15 employees to
17 serve a 2-year term as a member of the Office
18 of Innovation with at least 1 employee ap-
19 pointed from each of the following:

20 “(i) Office of Aviation Safety.

21 “(ii) The Air Traffic Organization.

22 “(iii) Office of Airports.

23 “(iv) Office of Security and Haz-
24 arduous Materials Safety.

1 “(v) When authority under chapter
2 509 of title 51 is explicitly delegated by the
3 Secretary of Transportation to the Admin-
4 istrator, the Office of Commercial Space
5 Transportation.

6 “(vi) Office of the Chief Counsel.

7 “(vii) Office of Policy, International
8 Affairs, and Environment.

9 “(B) CONSULTATION.—The Office may
10 consult, as necessary, with other personnel of
11 the Administration.

12 “(3) SELECTION OF MEMBERS.—An employee
13 appointed under paragraph (2)—

14 “(A) may be appointed from nominations
15 made by Associate Administrators, Assistant
16 Administrators, and the Chief Counsel of the
17 Administration;

18 “(B) shall not be a senior executive of the
19 Administration;

20 “(C) shall have been an employee of the
21 Administration for at least 2 years; and

22 “(D) shall have expertise in the authorities
23 and duties of the respective office of the em-
24 ployee.

1 “(4) INNOVATION OFFICE LEAD.—The Admin-
2 istrator shall appoint a lead of the Office who shall
3 report to the leadership of the Administration and
4 who—

5 “(A) may have a set term, as determined
6 by the Administrator;

7 “(B) shall manage the personnel and ac-
8 tivities of such Office; and

9 “(C) may be a detailed employee of any of-
10 fice of the Administration, notwithstanding the
11 numerical limits placed on appointments in
12 paragraph (2)(A).

13 “(5) STATUS.—An appointment of an employee
14 to the Office established under this subsection shall
15 not impact the status or position of such employee
16 in the respective office of such employee and such
17 employee shall be considered a detailed employee to
18 the Office of Innovation.

19 “(6) RESOURCES.—The Administrator shall
20 provide resources and staff, as necessary, to the Of-
21 fice to support the activities of the Office described
22 in paragraph (1), not to exceed more than 6 full-
23 time equivalent positions, including any necessary
24 project managers.”.

1 **SEC. 127. FRANK A. LOBIONDO NATIONAL AEROSPACE**
2 **SAFETY AND SECURITY CAMPUS.**

3 (a) IN GENERAL.—The campus and grounds of the
4 Federal Aviation Administration Technical Center located
5 at the Atlantic City International Airport in Egg Harbor
6 Township, New Jersey, shall be known and designated as
7 the “Frank A. LoBiondo National Aerospace Safety and
8 Security Campus”.

9 (b) REFERENCE.—Any reference in a law, map, regu-
10 lation, document, paper, or other record of the United
11 States to the campus and grounds at the Federal Aviation
12 Administration Technical Center referred to in subsection
13 (a) shall be deemed to be a reference to the “Frank A.
14 LoBiondo National Aerospace Safety and Security Cam-
15 pus”.

16 **SEC. 128. TECHNICAL CENTER FOR ADVANCED AERO-**
17 **SPACE.**

18 (a) IN GENERAL.—Section 106 of title 49, United
19 States Code, is further amended by inserting after sub-
20 section (g) (as added by section 126) the following:

21 “(h) TECHNICAL CENTER FOR ADVANCED AERO-
22 SPACE.—

23 “(1) IN GENERAL.—There is established within
24 the Administration a technology center located at
25 the Frank A. LoBiondo National Aerospace Safety
26 and Security Campus to support the advancement of

1 aerospace safety and innovation which shall be
2 known as the ‘William J. Hughes Technical Center
3 for Advanced Aerospace’ (in this subsection referred
4 to as the ‘Technical Center’) that shall be used by
5 the Administrator and, as permitted by the Adminis-
6 trator, other governmental entities, academia, and
7 the aerospace industry.

8 “(2) MANAGEMENT.—The activities of the
9 Technical Center shall be managed by a Director.

10 “(3) ACTIVITIES.—The activities of the Tech-
11 nical Center shall include—

12 “(A) developing and stimulating technology
13 partnerships with and between industry, aca-
14 demia, and other government agencies and sup-
15 porting such partnerships by—

16 “(i) liaising between external persons
17 and offices of the Administration inter-
18 ested in such work;

19 “(ii) providing technical expertise and
20 input, as appropriate; and

21 “(iii) providing access to the prop-
22 erties, facilities, and systems of the Tech-
23 nical Center through appropriate agree-
24 ments;

1 “(B) managing technology demonstration
2 grants awarded by the Administrator;

3 “(C) identifying software, systems, serv-
4 ices, and technologies that could improve avia-
5 tion safety and the operations and management
6 of the air traffic control system and working
7 with relevant offices of the Administration to
8 consider the use and integration of such soft-
9 ware, systems, services, and technologies, as ap-
10 propriate;

11 “(D) supporting the work of any collocated
12 facilities and tenants of such facilities, and to
13 the extent feasible, enter into agreements as
14 necessary to utilize the facilities, systems, and
15 technologies of such collocated facilities and
16 tenants;

17 “(E) managing the facilities of the Tech-
18 nical Center and the Frank A. LoBiondo Na-
19 tional Aerospace Safety and Security Campus;
20 and

21 “(F) carrying out any other duties as de-
22 termined appropriate by the Administrator.”.

23 (b) CONFORMING AMENDMENT.—Section 44507 of
24 title 49, United States Code, is amended—

1 (1) by striking “(a) CIVIL AEROMEDICAL INSTI-
2 TUTE” and all that follows through “The Civil
3 Aeromedical Institute established” and inserting
4 “The Civil Aeromedical Institute established”; and
5 (2) by striking subsection (b).

6 **SEC. 129. OFFICE OF NEXTGEN SUNSET.**

7 (a) IN GENERAL.—Not later than 30 months after
8 the date of enactment of this Act, the Administrator of
9 the Federal Aviation Administration shall terminate the
10 Office of NextGen.

11 (b) CLOSURE PROCESS.—In carrying out subsection
12 (a), the Administrator shall transfer duties, authorities,
13 activities, personnel, and assets managed by the Office of
14 NextGen to other officials of the Administration, as appro-
15 priate, including—

16 (1) transferring such duties, authorities, activi-
17 ties, personnel, and assets to—

18 (A) the Director of the William J. Hughes
19 Technical Center for Advanced Aerospace es-
20 tablished under subsection 106(h) of title 49,
21 United States Code;

22 (B) the Assistant Administrator for Fi-
23 nance and Management;

24 (C) the Chief Operating Officer of the Air
25 Traffic Control System; and

1 (D) other officials of the Administration,
2 as determined by the Administrator; and

3 (2) transferring management of the NextGen
4 Advisory Committee to the Chief Operating Officer
5 of the Air Traffic Control System.

6 **SEC. 130. FAA OMBUDSMAN.**

7 Section 106 of title 49, United States Code, is further
8 amended by striking subsection (i) and inserting the fol-
9 lowing:

10 “(i) FAA OMBUDSMAN.—

11 “(1) ESTABLISHMENT.—There is established
12 within the Federal Aviation Administration an Om-
13 budsman who shall coordinate or facilitate the adju-
14 dication of covered submissions.

15 “(2) OMBUDSMAN.—

16 “(A) IN GENERAL.—The Ombudsman shall
17 be appointed by the Administrator and report
18 to the Assistant Administrator for Government
19 and Industry Affairs.

20 “(B) TERM.—The Ombudsman shall be
21 appointed for a term of 5 years.

22 “(3) DUTIES.—The duties of the Ombudsman
23 shall be as follows:

24 “(A) Work with the relevant offices within
25 the Administration to—

1 “(i) with respect to a covered submis-
2 sion, resolve, provide a status update, or
3 provide clarity on the status of such sub-
4 missions;

5 “(ii) bring to the attention of the rel-
6 evant office of the Administration con-
7 cerns, as necessary, regarding Administra-
8 tion processes or considerations discovered
9 while coordinating an activity related to a
10 covered submission under this subsection;
11 and

12 “(iii) address any gaps and commu-
13 nication lapses in Administration coordina-
14 tion processes.

15 “(B) Determine if, based on a coordinated
16 activity carried out under this subsection, re-
17 consideration with respect to covered submis-
18 sions or administrative actions are necessary
19 and report to the Administrator or the relevant
20 office within the Administration with rec-
21 ommendations relating to such reconsideration.

22 “(C) Determine if trends materialize that
23 could warrant process, procedural, or resource
24 changes and report recommendations regarding

1 such changes to the Administrator and relevant
2 offices within the Administration.

3 “(D) Ensure that reporting, processing, or
4 dispute resolution mechanisms within the Ad-
5 ministration are transparent and accessible to
6 the public, and facilitate the use of such report-
7 ing, processing, or dispute resolution mecha-
8 nisms, when appropriate.

9 “(E) Perform other duties as prescribed by
10 the Assistant Administrator.

11 “(4) DISCRETION ON COORDINATION AND RE-
12 VIEW.—

13 “(A) IN GENERAL.—The Ombudsman shall
14 determine whether to coordinate a review of a
15 covered submission in order to provide a re-
16 sponse, coordinate the reconsideration of an ad-
17 ministrative action, or take no additional action.
18 In making a determination under this subpara-
19 graph, the Ombudsman shall consider—

20 “(i) whether there are reporting, proc-
21 essing, or dispute resolution mechanisms
22 that have not been exhausted or that may
23 be more appropriate for dealing with, in-
24 vestigating, and responding to such cov-
25 ered submission;

1 “(ii) whether the subject or outcome
2 of a covered submission is alleged to be—

3 “(I) contrary to law or regula-
4 tion;

5 “(II) arbitrary and capricious; or

6 “(III) performed in an unreason-
7 ably inefficient or untimely manner;

8 and

9 “(iii) such other factors as the Om-
10 budsman considers appropriate.

11 “(B) EXCEPTION.—With regard to a cov-
12 ered submission concerning an activity relating
13 to an alleged violation of an order, a regulation,
14 or any other provision of Federal law by the
15 Administration or whistleblower retaliation, the
16 Ombudsman shall refer such covered submis-
17 sion to the appropriate Federal entity to adju-
18 dicate or investigate the subject of such submis-
19 sion.

20 “(C) COOPERATION.—The Administrator
21 shall ensure that the officers and employees of
22 the Administration fully cooperate with the ac-
23 tivities of the Ombudsman and provide such in-
24 formation, documents, or materials as may be
25 requested by the Ombudsman.

1 “(5) RESPONSE REQUIREMENT.—The Ombuds-
2 man shall ensure that the Administration provides
3 an initial response to or status update on covered
4 submissions within 10 business days of the Ombuds-
5 man receiving such submission.

6 “(6) DEFINITIONS.—In this subsection:

7 “(A) ADMINISTRATIVE ACTION.—The term
8 ‘administrative action’ means—

9 “(i) an action taken by the Adminis-
10 trator of the Federal Aviation Administra-
11 tion to issue, deny, modify, or revoke a cer-
12 tificate, registration, approval, waiver, li-
13 cense, exemption, determination, interpre-
14 tation, or any other authorizing action; or

15 “(ii) the lack of any action (or activity
16 related to an action) described in clause (i)
17 necessary to be taken by the Adminis-
18 trator.

19 “(B) COVERED SUBMISSION.—The term
20 ‘covered submission’ means an inquiry or objec-
21 tion relating to—

22 “(i) an aircraft, aircraft engine, pro-
23 peller, or appliance certification;

24 “(ii) an airman or pilot certificate, in-
25 cluding scheduling an associated appoint-

1 ment with Administration personnel or
2 designees;

3 “(iii) a medical certificate;

4 “(iv) an operator certificate;

5 “(v) when authority under chapter
6 509 of title 51 is explicitly delegated by the
7 Secretary of Transportation to the Admin-
8 istrator, a license or permit issued under
9 chapter 509 of title 51;

10 “(vi) an aircraft registration;

11 “(vii) an operational approval, waiver,
12 or exemption;

13 “(viii) a legal interpretation;

14 “(ix) an outstanding determination;

15 “(x) an application of agency guid-
16 ance; and

17 “(xi) any certificate not otherwise de-
18 scribed in this subparagraph that is issued
19 pursuant to chapter 447.”.

20 **SEC. 131. PROJECT DASHBOARDS AND FEEDBACK PORTAL.**

21 (a) **IN GENERAL.**—The Ombudsman of the Federal
22 Aviation Administration shall, in reviewing Administration
23 processes, receiving, reviewing, and responding to covered
24 submissions, and through general due diligence, determine
25 whether a publicly facing dashboard that provides appli-

1 cants with the status of an application before the agency
2 would be—

3 (1) beneficial to applicants;

4 (2) an efficient use of resources to build, main-
5 tain, and update; or

6 (3) duplicative with other efforts within the Ad-
7 ministration to streamline and digitize paperwork
8 and certification processes to provide an applicant
9 with a greater awareness of the status of an applica-
10 tion before the Administration.

11 (b) RECOMMENDATION.—Not later than 30 months
12 after the date of enactment of this Act, the Ombudsman
13 shall provide a recommendation to the Administrator of
14 the Federal Aviation Administration regarding the need
15 or benefits of a dashboard or other means by which to
16 track an application status.

17 (c) BRIEFING.—Not later than 45 days after receiv-
18 ing recommendations under subsection (b), the Adminis-
19 trator shall brief the Committee on Transportation and
20 Infrastructure of the House of Representatives and the
21 Committee on Commerce, Science, and Transportation of
22 the Senate on—

23 (1) any recommendation received from the Om-
24 budsman; and

1 (2) any activities the Administrator is taking in
2 response to such recommendation.

3 (d) FAA FEEDBACK PORTAL.—

4 (1) IN GENERAL.—The Ombudsman shall,
5 through interacting with the public and general due
6 diligence, determine whether a publicly facing portal
7 on the website through which the public may provide
8 feedback to the Administrator about experiences
9 they have working with personnel of the Administra-
10 tion would be beneficial.

11 (2) REQUIREMENTS.—The Ombudsman shall
12 ensure any portal established under this subsection
13 asks questions that seek to gauge any shortcomings
14 the Administration has in fulfilling its mission or
15 areas where the Administration is succeeding in
16 meetings its mission.

17 (e) COVERED SUBMISSION.—In this section, the term
18 “covered submission” has the meaning given the term in
19 subsection 106(i) of title 49, United States Code.

20 **SEC. 132. SENSE OF CONGRESS ON FAA ENGAGEMENT DUR-**
21 **ING RULEMAKING ACTIVITIES.**

22 It is the sense of Congress that—

23 (1) the Administrator of the Federal Aviation
24 Administration should engage with aviation stake-
25 holder groups and the public during pre-drafting

1 stages of rulemaking activities and use, to the great-
2 est extent practicable, properly docketed ex-parte
3 discussions during rulemaking activities in order
4 to—

5 (A) inform the work of the Administrator;

6 (B) assist the Administrator in developing
7 the scope of a rule; and

8 (C) reduce the timeline for issuance of pro-
9 posed and final rules; and

10 (2) when it would reduce the time required for
11 the Administrator to adjudicate public comments,
12 the Administrator should publicly provide informa-
13 tion describing the rationale behind a regulatory de-
14 cision included in proposed regulations in order to
15 better allow for the public to provide clear and in-
16 formed comments on such regulations.

17 **SEC. 133. CIVIL AEROMEDICAL INSTITUTE.**

18 Section 106(j) of title 49, United States Code, is
19 amended by striking “There is” and inserting “CIVIL
20 AEROMEDICAL INSTITUTE.—There is”.

21 **SEC. 134. MANAGEMENT ADVISORY COUNCIL.**

7 amended by adding at the end the following:

8 **“SEC. 5. REEXAMINATION OF AN AIRMAN CERTIFICATE.**

9 “(a) IN GENERAL.—The Administrator shall provide
10 timely, written notification to an individual subject to a
11 reexamination of an airman certificate issued under chap-
12 ter 447 of title 49, United States Code.

13 “(b) INFORMATION REQUIRED.—In providing notifi-
14 cation under subsection (a), the Administrator shall in-
15 form the individual—

16 “(1) of the nature of the reexamination and the
17 specific activity on which the reexamination is neces-
18 sitated;

19 “(2) that the reexamination shall occur within
20 1 year from the date of the notice provided by the
21 Administrator, after which, if the reexamination is
22 not conducted, the airman certificate may be sus-
23 pended or revoked; and

1 “(3) when, as determined by the Administrator,
2 an oral or written response to the notification from
3 the Administrator is not required.

4 “(c) EXCEPTION.—Nothing in this section prohibits
5 the Administrator from reexamining a certificate holder
6 if the Administrator has reasonable grounds—

7 “(1) to establish that an airman may not be
8 qualified to exercise the privileges of a certificate or
9 rating based upon an act or omission committed by
10 the airman while exercising such privileges or per-
11 forming ancillary duties associated with the exercise
12 of such privileges; or

13 “(2) to demonstrate that the airman obtained
14 such a certificate or rating through fraudulent
15 means or through an examination that was substan-
16 tially and inadequate to establish the qualifications
17 of an airman.

18 “(d) STANDARD OF REVIEW.—An order issued by the
19 Administrator to amend, modify, suspend, or revoke an
20 airman certificate after reexamination of the airman is
21 subject to the standard of review provided for under sec-
22 tion 2 of this Act.”.

23 **SEC. 202. GAO REVIEW OF PILOT’S BILL OF RIGHTS.**

24 (a) IN GENERAL.—Not later than 2 years after the
25 date of enactment of this Act, the Comptroller General

1 of the United States shall submit to the Committee on
2 Transportation and Infrastructure of the House of Rep-
3 resentatives and the Committee on Commerce, Science,
4 and Transportation of the Senate a study of the imple-
5 mentation of the Pilot’s Bill of Rights (49 U.S.C. 44703
6 note).

7 (b) CONTENTS.—In conducting the study under sub-
8 section (a), the Comptroller General shall review—

9 (1) the implementation and application of the
10 Pilot’s Bill of Rights (49 U.S.C. 44703 note);

11 (2) the application of the Federal Rules of Civil
12 Procedure and the Federal Rules of Evidence to cov-
13 ered proceedings by the National Transportation
14 Safety Board, as required by section 2 of the Pilot’s
15 Bill of Rights (49 U.S.C. 44703 note);

16 (3) the appeal process and the typical length of
17 time associated with a final determination in a cov-
18 ered proceeding; and

19 (4) any impacts of the implementation of the
20 Pilot’s Bill of Rights (49 U.S.C. 44703 note).

21 (c) COVERED PROCEEDINGS.—In this section, the
22 term “covered proceeding” means a proceeding conducted
23 under subpart C, D, or F of part 821 of title 49, Code
24 of Federal Regulations, relating to denial, amendment,

1 modification, suspension, or revocation of an airman cer-
2 tificate.

3 **SEC. 203. EXPANSION OF BASICMED.**

4 (a) IN GENERAL.—Section 2307 of the FAA Exten-
5 sion, Safety, and Security Act of 2016 (49 U.S.C. 44703
6 note) is amended—

7 (1) in subsection (a)—

8 (A) by striking paragraph (2) and insert-
9 ing the following:

10 “(2) the individual holds a medical certificate
11 issued by the Federal Aviation Administration or
12 has held such a certificate at any time after July 14,
13 2006;”;

14 (B) in paragraph (7) by inserting “cal-
15 endar” before “months”; and

16 (C) in paragraph (8)(A) by striking “5”
17 and inserting “6”;

18 (2) in subsection (b)(2)(A)(i) by inserting “(or
19 any successor form)” after “(3–99)”;

20 (3) by striking subsection (h) and inserting the
21 following:

22 “(h) REPORT REQUIRED.—Not later than 4 years
23 after the date of enactment of the Securing Growth and
24 Robust Leadership in American Aviation Act, the Admin-
25 istrator, in coordination with the National Transportation

1 Safety Board, shall submit to the Committee on Transpor-
2 tation and Infrastructure of the House of Representatives
3 and the Committee on Commerce, Science, and Transpor-
4 tation of the Senate a report that describes the effect of
5 the regulations issued or revised under subsection (a) and
6 includes statistics with respect to changes in small aircraft
7 activity and safety incidents.”; and

8 (4) in subsection (j)—

9 (A) in paragraph (1) by striking “6” and
10 inserting “7”; and

11 (B) in paragraph (2) by striking “6,000”
12 and inserting “12,500”.

13 (b) RULEMAKING.—The Administrator of the Fed-
14 eral Aviation Administration shall update regulations in
15 parts 61 and 68 of title 14, Code of Federal Regulations,
16 as necessary, to implement the amendments made by this
17 section.

18 (c) APPLICABILITY.—Beginning on the date that is
19 120 days after the date of enactment of this Act, the Ad-
20 ministrator shall apply part 68, Code of Federal Regula-
21 tions, in a manner reflecting the amendments made by
22 this section.

1 **SEC. 204. DATA PRIVACY.**

2 (a) IN GENERAL.—Chapter 441 of title 49, United
3 States Code, is amended by adding at the end the fol-
4 lowing:

5 **“§ 44114. Privacy**

6 “(a) IN GENERAL.—Notwithstanding any other pro-
7 vision of law, the Administrator of the Federal Aviation
8 Administration shall establish and continuously improve a
9 process by which, upon request of a private aircraft owner
10 or operator, the Administrator blocks the registration
11 number and other similar identifiable data or information,
12 except for physical markings required by law, of the air-
13 craft of the owner or operator from any public dissemina-
14 tion or display (except in furnished data or information
15 made available to or from a Government agency pursuant
16 to a government contract, subcontract, or agreement) for
17 the noncommercial flights of the owner or operator.

18 “(b) WITHHOLDING PERSONALLY IDENTIFIABLE IN-
19 FORMATION ON AIRCRAFT REGISTRY.—Not later than 1
20 year after the date of enactment of this section and not-
21 withstanding any other provision of law, the Administrator
22 shall establish a procedure by which, upon request of a
23 private aircraft owner or operator, the Administrator shall
24 withhold from public disclosure (except in furnished data
25 or information made available to or from a Government
26 agency pursuant to a government contract, subcontract,

1 or agreement) the personally identifiable information of
2 such individual on the Civil Aviation Registry website.

3 “(c) ICAO AIRCRAFT IDENTIFICATION CODE.—

4 “(1) IN GENERAL.—The Administrator shall es-
5 tablish a program for aircraft owners and operators
6 to apply for a new ICAO aircraft identification code.

7 “(2) LIMITATIONS.—In carrying out the pro-
8 gram described in paragraph (1), the Administrator
9 shall require—

10 “(A) each applicant to substantiate the
11 safety or security need in applying for a new
12 ICAO aircraft identification code; and

13 “(B) each approved applicant who obtains
14 a new ICAO aircraft identification code to com-
15 ply with all applicable aspects of, or related to,
16 part 45 of title 14, Code of Federal Regula-
17 tions, including updating an aircraft’s registra-
18 tion number and N-Number to reflect such air-
19 craft’s new ICAO aircraft identification code.

20 “(d) DECOUPLING MODE S CODES.—The Adminis-
21 trator shall develop a plan for which the Administrator
22 could allow for a process to disassociate an assigned Mode
23 S code with the number assigned to an aircraft that is
24 registered pursuant to section 44103.

25 “(e) DEFINITIONS.—In this section:

1 “(1) ADS–B.—The term ‘ADS–B’ means auto-
2 matic dependent surveillance-broadcast.

3 “(2) ICAO.—The term ‘ICAO’ means the
4 International Civil Aviation Organization.

5 “(3) PERSONALLY IDENTIFIABLE INFORMA-
6 TION.—The term ‘personally identifiable informa-
7 tion’ means—

8 “(A) the mailing address or registration
9 address of an individual;

10 “(B) an electronic address (including an e-
11 mail address) of an individual; or

12 “(C) the telephone number of an indi-
13 vidual.”.

14 (b) STUDY ON ENCRYPTING ADS–B.—

15 (1) IN GENERAL.—Not later than 1 year after
16 the date of enactment of this Act, the Administrator
17 of the Federal Aviation Administration shall seek to
18 enter into an agreement with a qualified organiza-
19 tion to conduct a study assessing the technical chal-
20 lenges, impact to international aviation operations,
21 benefits, and costs of encrypting ADS–B signals to
22 provide for a safer and more secure environment for
23 national airspace system users.

1 (2) CONSULTATION.—In carrying out the study
2 under paragraph (1), a qualified organization shall
3 consult with representatives of—

4 (A) air carriers;

5 (B) collective bargaining representatives of
6 the Federal Aviation Administration aero-
7 nautical information specialists;

8 (C) original equipment manufacturers of
9 ADS-B equipment;

10 (D) general aviation;

11 (E) business aviation; and

12 (F) aviation safety experts with specific
13 knowledge of aircraft cybersecurity.

14 (3) CONSIDERATIONS.—In carrying out the
15 study under paragraph (1), a qualified organization
16 shall consider—

17 (A) the technical requirements for
18 encrypting ADS-B signals for both the 978
19 Mhz and 1090 Mhz frequencies;

20 (B) the advantages of encrypting ADS-B
21 signals for both the 978 Mhz and 1090 Mhz
22 frequencies, including those related to cyberse-
23 curity protections, safety, and privacy of na-
24 tional airspace system users;

1 (C) the disadvantages of encrypting ADS-
2 B signals for both the 978 Mhz and 1090 Mhz
3 frequencies, including those related to cyberse-
4 curity protections, safety, and privacy of na-
5 tional airspace system users;

6 (D) the challenges of encrypting ADS-B
7 signals for both the 978 Mhz and 1090 Mhz
8 frequencies, including coordination consider-
9 ations with the International Civil Aviation Or-
10 ganization and foreign civil aviation authorities;

11 (E) potential new aircraft equipage re-
12 quirements and estimated costs;

13 (F) the impact to nongovernmental third-
14 party users of ADS-B data;

15 (G) the estimated costs to—

16 (i) the Federal Aviation Administra-
17 tion;

18 (ii) aircraft owners required to equip
19 with ADS-B equipment for aviation oper-
20 ations; and

21 (iii) other relevant persons the Admin-
22 istrator determines necessary; and

23 (H) the impact to national airspace system
24 operations during implementation and post-im-
25 plementation.

1 (4) REPORT.—In any agreement entered into
2 under paragraph (1), the Administrator shall ensure
3 that, not later than 1 year after the completion of
4 the study required under paragraph (1), the quali-
5 fied organization that has entered into such agree-
6 ment shall submit to the Administrator, the Com-
7 mittee on Transportation and Infrastructure of the
8 House of Representatives, and the Committee on
9 Commerce, Science, and Transportation of the Sen-
10 ate a report on the results of the study described in
11 paragraph (1), including the findings and rec-
12 ommendations related to each item specified under
13 paragraph (3).

14 (5) DEFINITION OF QUALIFIED ORGANIZA-
15 TION.—In this subsection, the term “qualified orga-
16 nization” means an independent nonprofit organiza-
17 tion described in section 501(c)(3) of the Internal
18 Revenue Code of 1986 and exempt from taxation
19 under section 501(a) of such Code.

20 (c) CLERICAL AMENDMENT.—The analysis for chap-
21 ter 441 of title 49, United States Code, is amended by
22 adding at the end the following:

“44114. Privacy.”.

23 (d) CONFORMING AMENDMENT.—Section 566 of the
24 FAA Reauthorization Act of 2018 (49 U.S.C. 44103 note)

1 and the item relating to such section in the table of con-
2 tents under section 1(b) of that Act are repealed.

3 **SEC. 205. PROHIBITION ON USING ADS-B DATA TO INITIATE**
4 **AN INVESTIGATION.**

5 Section 46101 of title 49, United States Code, is
6 amended by adding at the end the following:

7 “(c) PROHIBITION ON USING ADS-B DATA TO INI-
8 TIATE AN INVESTIGATION.—

9 “(1) IN GENERAL.—Notwithstanding any provi-
10 sion of this section, the Administrator of the Federal
11 Aviation Administration may not initiate an inves-
12 tigation (excluding a criminal investigation) of a per-
13 son based exclusively on automatic dependent sur-
14 veillance-broadcast data.

15 “(2) RULE OF CONSTRUCTION.—Nothing in
16 this subsection shall prohibit the use of automatic
17 dependent surveillance-broadcast data in an inves-
18 tigation that was initiated for any reason other than
19 the review of automatic dependent surveillance-
20 broadcast data, including if such investigation was
21 initiated as a result of a report or complaint sub-
22 mitted to the Administrator.”.

23 **SEC. 206. PROHIBITION ON N-NUMBER PROFITEERING.**

24 Section 44103 of title 49, United States Code, is
25 amended by adding at the end the following:

1 “(e) PROHIBITION ON N-NUMBER PROFITEERING.—

2 “(1) IN GENERAL.—No person may reserve an
3 aircraft registration number without certifying that
4 such person intends to use such registration num-
5 ber—

6 “(A) immediately on a specific aircraft; or

7 “(B) for future use on an aircraft owned
8 or controlled, or intended to be owned or con-
9 trolled, by such person.

10 “(2) TRANSFERS.—A person may transfer a re-
11 served aircraft registration number to another per-
12 son if—

13 “(A) the transferor certifies that the air-
14 craft registration number is relinquished will-
15 ingly and at a cost to the transferee that does
16 not otherwise exceed the amount paid by the
17 transferor to reserve such number; and

18 “(B) the transferee—

19 “(i) certifies that the transferor did
20 not impose a dollar cost on the transfer
21 that exceeds the amount provided for in
22 subparagraph (A); and

23 “(ii) complies with the certification re-
24 quirement under paragraph (1).”.

1 **SEC. 207. ACCOUNTABILITY FOR AIRCRAFT REGISTRATION**
2 **NUMBERS.**

3 (a) IN GENERAL.—Not later than 180 days after the
4 date of enactment of this Act, the Administrator of the
5 Federal Aviation Administration shall initiate a review of
6 the process for reserving aircraft registration numbers to
7 ensure that such process offers an equal opportunity for
8 members of the general public to obtain specific aircraft
9 registration numbers.

10 (b) ASSESSMENT.—In conducting the review under
11 subsection (a), the Administrator shall assess the fol-
12 lowing:

13 (1) Whether the use of readily available soft-
14 ware to prevent computer or web-based auto-fill sys-
15 tems from reserving aircraft registration numbers in
16 bulk would improve participation in the reservation
17 process by the general public.

18 (2) Whether a limit should be imposed on the
19 number of consecutive years a person may reserve
20 an aircraft registration number.

21 (3) The impact of the prohibition imposed by
22 section 44103(e) of title 49, United States Code.

23 (c) BRIEFING.—Not later than 18 months after the
24 date of enactment of this Act, the Administrator shall
25 brief the Committee on Transportation and Infrastructure
26 of the House of Representatives and the Committee on

1 Commerce, Science, and Transportation of the Senate on
2 the review conducted under subsection (a), including any
3 recommendations of the Administrator to improve equal
4 participation in the process for reserving aircraft registra-
5 tion numbers by the general public.

6 **SEC. 208. TIMELY RESOLUTION OF INVESTIGATIONS.**

7 (a) IN GENERAL.—Not later than 2 years after the
8 date of issuance of a letter of investigation to any person,
9 the Administrator of the Federal Aviation Administration
10 shall—

11 (1) make a determination regarding such inves-
12 tigation and pursue subsequent action; or

13 (2) close such investigation.

14 (b) EXTENSION.—

15 (1) IN GENERAL.—If, upon review of the facts
16 and status of an investigation described in sub-
17 section (a), the Administrator determines that the
18 time provided to make a final determination or close
19 such investigation is insufficient, the Administrator
20 may approve an extension of such investigation for
21 2 years.

22 (2) ADDITIONAL EXTENSIONS.—The Adminis-
23 trator may approve consecutive extensions under
24 paragraph (1).

1 (c) DELEGATION.—The Administrator may not dele-
2 gate the authority to approve an extension described in
3 subsection (b) to anyone other than the leadership of the
4 Administration as described in section 106(b) of title 49,
5 United States Code.

6 **SEC. 209. EXPANSION OF VOLUNTEER PILOT ORGANIZA-**
7 **TION DEFINITION.**

8 Section 821 of the FAA Modernization and Reform
9 Act of 2012 (49 U.S.C. 40101 note) is amended—

10 (1) in subsection (a)—

11 (A) by striking “for the fuel costs associ-
12 ated with” and inserting “for the fuel costs and
13 airport fees attributed to”; and

14 (B) by striking “for an individual or organ-
15 for medical purposes (and for other associated
16 individuals)” and inserting “for the purposes
17 described in subsection (c)(2)”; and

18 (2) in subsection (c)(2) by striking “charitable
19 medical transportation.” and inserting the following:
20 “charitable transportation for the following pur-
21 poses:

22 “(A) Assisting individuals in accessing
23 medical care or treatment (and for other associ-
24 ated individuals).

1 “(B) Delivering human blood, tissues, or
2 organs.

3 “(C) Aiding disaster relief efforts pursuant
4 to a—

5 “(i) presidential declaration of a
6 major disaster or an emergency under the
7 Robert T. Stafford Disaster Relief and
8 Emergency Assistance Act (42 U.S.C.
9 5121 et seq.); or

10 “(ii) declaration of a major disaster or
11 an emergency by a Governor of a State.”.

12 **SEC. 210. CHARITABLE FLIGHT FUEL REIMBURSEMENT EX-**
13 **EMPTIONS.**

14 (a) IN GENERAL.—

15 (1) VALIDITY OF EXEMPTION.—Except as oth-
16 erwise provided in this subsection, an exemption
17 from section 61.113(e) of title 14, Code of Federal
18 Regulations, that is granted by the Administrator of
19 the Federal Aviation Administration for the purpose
20 of allowing a volunteer pilot to accept reimburse-
21 ment from a volunteer pilot organization for the fuel
22 costs and airport fees attributed to a flight operation
23 to provide charitable transportation pursuant to sec-
24 tion 821 of the FAA Modernization and Reform Act

1 of 2012 (49 U.S.C. 40101 note) shall be valid for
2 5 years.

3 (2) FAILING TO ADHERE.—If the Administrator
4 finds an exemption holder under paragraph (1) or a
5 volunteer pilot fails to adhere to the conditions and
6 limitations of the exemption described under such
7 paragraph, the Administrator may rescind or sus-
8 pend the exemption.

9 (3) NO LONGER QUALIFYING.—If the Adminis-
10 trator finds that such exemption holder no longer
11 qualifies as a volunteer pilot organization, the Ad-
12 ministrator shall rescind such exemption.

13 (4) FORGOING EXEMPTION.—If such exemption
14 holder informs the Administrator that such holder
15 no longer plans to exercise the authority granted by
16 such exemption, the Administrator may rescind such
17 exemption.

18 (b) ADDITIONAL REQUIREMENTS.—

19 (1) IN GENERAL.—A volunteer pilot organiza-
20 tion may impose additional safety requirements on a
21 volunteer pilot without—

22 (A) being considered—

23 (i) an air carrier (as such term is de-
24 fined in section 40102 of title 49, United
25 States Code); or

1 (ii) a commercial operator (as such
2 term is defined in section 1.1 of title 14,
3 Code of Federal Regulations); or

4 (B) constituting common carriage.

5 (2) SAVINGS CLAUSE.—Nothing in this sub-
6 section may be construed to limit or otherwise affect
7 the authority of the Administrator to regulate, as
8 appropriate, a flight operation associated with a vol-
9 unteer pilot organization that constitutes a commer-
10 cial operation or common carriage.

11 (c) REISSUANCE OF EXISTING EXEMPTIONS.—In re-
12 issuing an expiring exemption described in subsection (a)
13 that was originally issued prior to the date of enactment
14 of this Act, the Administrator shall ensure that the re-
15 issued exemption—

16 (1) accounts for the provisions of this section
17 and section 821 of the FAA Modernization and Re-
18 form Act of 2012 (49 U.S.C. 40101 note), as
19 amended by this Act; and

20 (2) is otherwise substantially similar to the pre-
21 viously issued exemption.

22 (d) STATUTORY CONSTRUCTION.—Nothing in this
23 section shall be construed to—

24 (1) affect the authority of the Administrator to
25 exempt a pilot (exercising the private pilot privi-

1 leges) from any restriction on receiving reimburse-
2 ment for the fuel costs and airport fees attributed
3 to a flight operation to provide charitable transpor-
4 tation; or

5 (2) impose or authorize the imposition of any
6 additional requirements by the Administrator on a
7 flight that is arranged by a volunteer pilot organiza-
8 tion in which the volunteer pilot—

9 (A) is not reimbursed the fuel costs and
10 airport fees attributed to a flight operation to
11 provide charitable flights; or

12 (B) pays a pro rata share of expenses as
13 described in section 61.113(c) of title 14, Code
14 of Federal Regulations.

15 (e) DEFINITIONS.—In this section:

16 (1) VOLUNTEER PILOT.—The term “volunteer
17 pilot” means a person who—

18 (A) acts as a pilot in command of a flight
19 operation to provide charitable transportation
20 pursuant to section 821 of the FAA Moderniza-
21 tion and Reform Act of 2012 (49 U.S.C. 40101
22 note); and

23 (B) holds a private pilot certificate, com-
24 mercial pilot certificate, or an airline transpor-

1 tation pilot certificate issued under part 61 of
2 title 14, Code of Federal Regulations.

3 (2) VOLUNTEER PILOT ORGANIZATION.—The
4 term “volunteer pilot organization” has the meaning
5 given such term in section 821(c) of the FAA Mod-
6 ernization and Reform Act of 2012 (49 U.S.C.
7 40101 note).

8 **SEC. 211. GAO REPORT ON CHARITABLE FLIGHTS.**

9 (a) REPORT.—Not later than 4 years after the date
10 of enactment of this Act, the Comptroller General of the
11 United States shall initiate a review of the following:

12 (1) Applicable laws, regulations, policies, legal
13 opinions, and guidance pertaining to charitable
14 flights and the operations of such flights, including
15 reimbursement of fuel costs.

16 (2) Petitions for exemption from the require-
17 ments of section 61.113(c) of title 14, Code of Fed-
18 eral Regulations, for the purpose of allowing a pilot
19 to accept reimbursement for the fuel costs associated
20 with a flight operation to provide charitable trans-
21 portation pursuant to section 821 of the FAA Mod-
22 ernization and Reform Act of 2012 (49 U.S.C.
23 40101 note), as amended by this Act, including as-
24 sessment of—

1 (A) the conditions and limitations a peti-
2 tioner must comply with if the exemption is
3 granted and whether such conditions and limi-
4 tations are—

5 (i) applied to petitioners in a con-
6 sistent manner; and

7 (ii) commensurate with the types of
8 flight operations exemption holders propose
9 to conduct under any such exemptions;

10 (B) denied petitions for such an exemption
11 and the reasons for the denial of such petitions;
12 and

13 (C) the processing time of a petition for
14 such an exemption.

15 (3) Charitable flights conducted without an ex-
16 emption from section 61.113(c) of title 14, Code of
17 Federal Regulations, including an analysis of the
18 certificates, qualifications, and aeronautical experi-
19 ence of the operators of such flights.

20 (b) CONSULTATION.—In carrying out the review initi-
21 ated under subsection (a), the Comptroller General shall
22 consult with charitable organizations, including volunteer
23 pilot organizations, aircraft owners, and pilots who volun-
24 teer to provide transportation for or on behalf of a chari-

1 table organization, flight safety experts, and employees of
2 the Federal Aviation Administration.

3 (c) RECOMMENDATIONS.—As part of the review initi-
4 ated under subsection (a), the Comptroller General shall
5 make recommendations, as determined appropriate, to the
6 Administrator of the Federal Aviation Administration to
7 improve the rules, policies, and guidance pertaining to
8 charitable flight operations.

9 (d) REPORT.—Upon completion of the review initi-
10 ated under subsection (a), the Comptroller General shall
11 submit to the Committee on Transportation and Infra-
12 structure of the House of Representatives and the Com-
13 mittee on Commerce, Science, and Transportation of the
14 Senate a report describing the findings of such review and
15 recommendations developed under subsection (c).

16 **SEC. 212. ALL MAKES AND MODELS AUTHORIZATION.**

17 (a) IN GENERAL.—

18 (1) UNLIMITED LETTER OF AUTHORIZATION.—
19 Not later than 180 days after the date of enactment
20 of this Act, the Administrator of the Federal Avia-
21 tion Administration shall take such action as may be
22 necessary to allow for the issuance of letters of au-
23 thorizations to airmen with the authorization for—

1 (A) all types and makes of experimental
2 high-performance single engine piston powered
3 aircraft; and

4 (B) all types and makes of experimental
5 high-performance multiengine piston powered
6 aircraft.

7 (2) REQUIREMENTS.—An individual who holds
8 a letter of authorization and applies for an author-
9 ization described in paragraph (1)(A) or (1)(B)—

10 (A) shall be given an all-makes and models
11 authorization of—

12 (i) experimental single-engine piston
13 powered authorized aircraft; or

14 (ii) experimental multiengine piston
15 powered authorized aircraft;

16 (B) shall hold the appropriate category
17 and class rating for the authorized aircraft;

18 (C) shall hold 3 experimental aircraft au-
19 thorizations in aircraft of the same category
20 and class rating for the authorization sought;
21 and

22 (D) may become qualified in additional ex-
23 perimental aircraft by completing aircraft spe-
24 cific training.

1 (b) RULE OF CONSTRUCTION.—Nothing in this sec-
2 tion may be construed to disallow an individual from being
3 given both an authorization described in paragraph (1)(A)
4 and an authorization described in paragraph (1)(B).

5 (c) FAILURE TO COMPLY.—

6 (1) IN GENERAL.—If the Administrator fails to
7 implement subsection (a) within the time period pre-
8 scribed in such subsection, the Administrator shall
9 brief the Committee on Transportation and Infra-
10 structure of the House of Representatives and the
11 Committee on Commerce, Science, and Transpor-
12 tation of the Senate on the status of the implemen-
13 tation of such subsection on a monthly basis until
14 the implementation is complete.

15 (2) NO DELEGATION.—The Administrator may
16 not delegate the briefing described in paragraph (1).

17 **SEC. 213. RESPONSE TO LETTER OF INVESTIGATION.**

18 Section 2(b) of the Pilot’s Bill of Rights (49 U.S.C.
19 44703 note) is amended by adding at the end the fol-
20 lowing:

21 “(6) RESPONSE TO LETTER OF INVESTIGA-
22 TION.—If an individual decides to respond to a Let-
23 ter of Investigation described in paragraph (2)(B)
24 such individual may respond not later than 30 days
25 after receipt of such Letter, including providing

1 written comments on the incident to the inves-
2 tigating office.”.

3 **Subtitle B—General Aviation**
4 **Safety**

5 **SEC. 221. ADS-B SAFETY ENHANCEMENT INCENTIVE PRO-**
6 **GRAM.**

7 (a) ESTABLISHMENT.—Not later than 120 days after
8 the date of enactment of this Act, the Administrator of
9 the Federal Aviation Administration shall establish a pro-
10 gram to provide rebates to owners of covered general avia-
11 tion aircraft for the purchase of covered ADS-B equip-
12 ment.

13 (b) APPLICATION.—To be eligible to receive a rebate
14 under this section, an owner of a covered general aviation
15 aircraft shall submit to the Administrator an application
16 in such form, at such time, and containing such informa-
17 tion as the Administrator may require, including proof of
18 successful installation of covered ADS-B equipment.

19 (c) AUTHORIZED REBATE.—

20 (1) AMOUNT.—A rebate approved by the Ad-
21 ministrator to be issued to an owner of a covered
22 general aviation aircraft shall be equal to the lesser
23 of—

24 (A) the cost of purchasing the covered
25 ADS-B equipment; or

1 (B) \$2,000.

2 (2) TIME.—A rebate issued under the program
3 under this section shall be redeemed or presented for
4 payment not later than 180 days after issuance,
5 after which time the rebate shall be deemed void.

6 (d) SUNSET.—The program established under sub-
7 section (a) shall terminate on October 1, 2027.

8 (e) RESTRICTION.—The Administrator may not offer
9 rebates for—

10 (1) a software upgrade for covered ADS–B
11 equipment;

12 (2) covered ADS–B equipment installed prior to
13 the date of enactment of this Act;

14 (3) covered general aviation aircraft manufac-
15 tured after January 1, 2020; or

16 (4) covered general aviation aircraft for which
17 the Administrator has previously issued a rebate re-
18 lated to the purchase and installation of covered
19 ADS–B equipment.

20 (f) DEFINITIONS.—In this section:

21 (1) ADS–B.—The term “ADS–B” means auto-
22 matic dependent surveillance–broadcast.

23 (2) COVERED ADS–B EQUIPMENT.—The term
24 “covered ADS–B equipment” means ADS–B equip-
25 ment that—

1 (A) meets the performance requirements
2 described in section 91.227 of title 14, Code of
3 Federal Regulations (or any successor regula-
4 tion); and

5 (B) is capable of receiving and displaying
6 ADS-B information from other aircraft.

7 (3) COVERED GENERAL AVIATION AIRCRAFT.—
8 The term “covered general aviation aircraft” means
9 a single-engine piston aircraft registered in the
10 United States that is not equipped with covered
11 ADS-B equipment.

12 (g) AUTHORIZATION OF APPROPRIATIONS.—Out of
13 amounts made available under section 106(k) of title 49,
14 United States Code, there is authorized to be expended
15 to carry out this section and pay administrative costs
16 \$25,000,000 for fiscal year 2024 to remain available until
17 expended.

18 **SEC. 222. GAO REPORT ON ADS-B TECHNOLOGY.**

19 (a) IN GENERAL.—The Comptroller General of the
20 United States shall conduct a study on automatic depend-
21 ent surveillance-broadcast equipage and usage rates across
22 the active general aviation fleet in the United States.

23 (b) CONTENTS.—In conducting the study described
24 in subsection (a), the Comptroller General shall, at a min-
25 imum—

1 (1) analyze the reasons why aircraft owners
2 choose not to equip or use an aircraft with auto-
3 matic dependent surveillance-broadcast technology;

4 (2) examine and substantiate any benefits and
5 drawbacks of using automatic dependent surveil-
6 lance-broadcast technology, including safety and
7 operational benefits and drawbacks;

8 (3) survey ways to further incentivize aircraft
9 owners to equip and use aircraft with automatic de-
10 pendent surveillance-broadcast technology; and

11 (4) examine the benefits, costs, and feasibility
12 of requiring equipage of automatic dependent sur-
13 veillance-broadcast technology on all newly manufac-
14 tured aircraft other than aircraft issued a special
15 airworthiness certificate.

16 (c) REPORT.—Not later than 18 months after the
17 date of enactment of this Act, the Comptroller General
18 shall submit to the Committee on Transportation and In-
19 frastructure of the House of Representatives and the Com-
20 mittee on Commerce, Science, and Transportation of the
21 Senate a report on automatic dependent surveillance-
22 broadcast described in subsection (b) and make rec-
23 ommendations to incentivize equipage and usage rates
24 across the active general aviation fleet in the United
25 States.

1 **SEC. 223. PROTECTING GENERAL AVIATION AIRPORTS**
2 **FROM FAA CLOSURE.**

3 (a) NON-SURPLUS PROPERTY.—Section 47125 of
4 title 49, United States Code, is amended by adding at the
5 end the following:

6 “(c) WAIVING RESTRICTIONS.—

7 “(1) IN GENERAL.—Subject to paragraph (2),
8 the Secretary may grant to an airport, city, or coun-
9 ty a waiver of any of the terms, conditions, reserva-
10 tions, or restrictions contained in a deed under
11 which the United States conveyed to the airport,
12 city, or county an interest in real property for air-
13 port purposes pursuant to section 16 of the Federal
14 Airport Act (60 Stat. 179), section 23 of the Airport
15 and Airway Development Act of 1970 (84 Stat.
16 232), or this section.

17 “(2) CONDITIONS.—Any waiver granted by the
18 Secretary pursuant to paragraph (1) shall be subject
19 to the following conditions:

20 “(A) The applicable airport, city, county,
21 or other political subdivision shall agree that in
22 conveying any interest in the real property
23 which the United States conveyed to the air-
24 port, city, or county, the airport, city, or county
25 will receive consideration for such interest that
26 is equal to its current fair market value.

1 “(B) Any consideration received by the air-
2 port, city, or county under subparagraph (A)
3 shall be used exclusively for the development,
4 improvement, operation, or maintenance of a
5 public airport by the airport, city, or county.

6 “(C) Such waiver—

7 “(i) will not significantly impair the
8 aeronautical purpose of an airport;

9 “(ii) will not result in the permanent
10 closure of an airport (unless the Secretary
11 determines that the waiver will directly fa-
12 cilitate the construction of a replacement
13 airport); or

14 “(iii) is necessary to protect or ad-
15 vance the civil aviation interests of the
16 United States.

17 “(D) Any other conditions required by the
18 Secretary.

19 “(3) ANNUAL REPORTING.—The Secretary shall
20 include a list and description of each waiver granted
21 pursuant to paragraph (1) in the report required
22 under section 47131.”.

23 (b) SURPLUS PROPERTY.—

24 (1) IN GENERAL.—Section 47151 of title 49,
25 United States Code, is amended—

1 (A) by striking subsection (d) and insert-
2 ing the following:

3 “(d) WAIVER OF CONDITION.—The Secretary may
4 not waive any condition imposed on an interest in surplus
5 property conveyed under subsection (a) that such interest
6 be used for an aeronautical purpose unless the Secretary
7 provides public notice not less than 30 days before the
8 issuance of such waiver and determines that such waiver—

9 “(1) will not significantly impair the aero-
10 nautical purpose of an airport;

11 “(2) will not result in the permanent closure of
12 an airport (unless the Secretary determines that the
13 waiver will directly facilitate the construction of a
14 replacement airport); or

15 “(3) is necessary to protect or advance the civil
16 aviation interests of the United States.”; and

17 (B) by adding at the end the following:

18 “(f) REVERSIONS OF PROPERTY.—The Secretary
19 shall take all necessary action to revert surplus property
20 conveyed under this subchapter back to the United States
21 if—

22 “(1) the Secretary determines that an instru-
23 ment conveying an interest in surplus property
24 under this subchapter incorporates a provision pro-

1 viding for the reversion of such property in the event
2 the property is not used for aeronautical purposes;

3 “(2) other efforts by the Secretary to ensure
4 that the property is used by the relevant airport
5 sponsor is used for aeronautical purposes are unsuc-
6 cessful; and

7 “(3) the Secretary determines that a rever-
8 sion—

9 “(A) will result in the property being used
10 for aeronautical purposes; or

11 “(B) will not transfer liabilities, including
12 environmental liabilities, greater than the fair
13 market value of the property to the Govern-
14 ment.”; and

15 (2) WAIVING AND ADDING TERMS.—Section
16 47153(c) of title 49, United States Code, is amend-
17 ed to read as follows:

18 “(c) RESTRICTIONS ON WAIVER.—Notwithstanding
19 subsections (a) and (b), the Secretary may not waive any
20 term under this section that an interest in land be used
21 for an aeronautical purpose unless—

22 “(1) the Secretary provides public notice not
23 less than 30 days before the issuance of a waiver;
24 and

1 “(2) the Secretary determines that such waiver—
2 er—

3 “(A) will not significantly impair the aero-
4 nautical purpose of an airport;

5 “(B) will not result in the permanent clo-
6 sure of an airport (unless the Secretary deter-
7 mines that the waiver will directly facilitate the
8 construction of a replacement airport); or

9 “(C) is necessary to protect or advance the
10 civil aviation interests of the United States.”.

11 (c) REPEALS.—

12 (1) AIRPORTS NEAR CLOSED OR REALIGNED
13 BASES.—Section 1203 of the Federal Aviation Reau-
14 thorization Act of 1996 (49 U.S.C. 47101 note), and
15 the item relating to such section in the table of con-
16 tents under section 1(b) of such Act, are repealed.

17 (2) RELEASE FROM RESTRICTIONS.—Section
18 817 of the FAA Modernization and Reform Act of
19 2012 (49 U.S.C. 47125 note), and the item relating
20 to such section in the table of contents under section
21 1(b) of such Act, are repealed.

22 **SEC. 224. ENSURING SAFE LANDINGS DURING OFF-AIR-**
23 **PORT OPERATIONS.**

24 The Administrator of the Federal Aviation Adminis-
25 tration shall not apply section 91.119 of title 14, Code

1 of Federal Regulations, in any manner that requires a
2 pilot to continue a landing that is unsafe.

3 **SEC. 225. AIRPORT DIAGRAM TERMINOLOGY.**

4 (a) IN GENERAL.—The Administrator of the Federal
5 Aviation Administration shall update Airport Diagram
6 Order JO 7910.4 and any related advisory circulars, pol-
7 icy, and guidance to ensure the clear and consistent use
8 of terms to delineate the types of parking available to gen-
9 eral aviation pilots.

10 (b) COLLABORATION.—In carrying out subsection
11 (a), the Administrator shall collaborate with industry
12 stakeholders, commercial service airports, and general
13 aviation airports in—

14 (1) facilitating basic standardization of general
15 aviation parking terms;

16 (2) accounting for the majority of uses of gen-
17 eral aviation parking terms; and

18 (3) providing clarity for chart users.

19 (c) IAC SPECIFICATIONS.—The Administrator shall
20 encourage the Interagency Air Committee to incorporate
21 the terms developed under subsection (a) in publications
22 produced by the Committee.

1 **SEC. 226. ALTERNATIVE ADS-B TECHNOLOGIES FOR USE IN**
2 **CERTAIN SMALL AIRCRAFT.**

3 (a) IN GENERAL.—Not later than 3 years after the
4 date of enactment of this Act, the Administrator of the
5 Federal Aviation Administration shall publish an approved
6 list of effective alternatives to automatic dependent sur-
7 veillance–broadcast equipment (in this section referred to
8 as “alternative ADS–B equipment”) for covered aircraft
9 operating outside of Mode C veil airspace so that such air-
10 craft may voluntarily broadcast positioning to other air-
11 craft.

12 (b) REVIEW; APPROVAL.—

13 (1) REVIEW.—In carrying out subsection (a),
14 the Administrator shall, to the maximum extent
15 practicable, review available commercial–off–the–
16 shelf alternative ADS–B equipment that are used
17 outside of the United States for purposes of allowing
18 a pilot to voluntarily utilize such equipment while
19 operating outside of Mode C veil airspace and within
20 the national airspace system.

21 (2) APPROVAL.—The Administrator shall work
22 with manufacturers of such equipment to expedite
23 technical standard order authorization, or other ap-
24 provals, required by the Administrator for such
25 equipment for use in covered aircraft.

26 (c) DEFINITIONS.—In this section:

1 (1) ALTERNATIVE ADS-B EQUIPMENT.—The
2 term “alternative ADS-B equipment” means a posi-
3 tioning technology that—

4 (A) does not otherwise meet the perform-
5 ance requirements prescribed in section 91.227
6 of title 14, Code of Federal Regulations;

7 (B) may be affixed to, or portable within,
8 a covered aircraft; and

9 (C) can broadcast positioning of a covered
10 aircraft to other aircraft operating outside of
11 Mode C veil airspace.

12 (2) COVERED AIRCRAFT.—The term “covered
13 aircraft” means—

14 (A) a single-engine piston aircraft;

15 (B) an ultralight aircraft; or

16 (C) an aircraft not equipped with an elec-
17 trical system.

18 (d) RULE OF CONSTRUCTION.—Nothing in this sec-
19 tion may be construed by the Administrator to require cov-
20 ered aircraft to install—

21 (1) alternative ADS-B equipment; or

22 (2) automatic dependent surveillance-broadcast
23 equipment.

1 **SEC. 227. AIRSHOW SAFETY TEAM.**

2 (a) IN GENERAL.—Not later than 180 days after the
3 date of enactment of this Act, the Administrator of the
4 Federal Aviation Administration shall coordinate with the
5 General Aviation Joint Safety Committee to establish an
6 Airshow Safety Team focused on airshow and aerial event
7 safety.

8 (b) OBJECTIVE.—The objective of the Airshow Safety
9 Team described in subsection (a) shall be to—

10 (1) serve as a mechanism for Federal Govern-
11 ment and industry cooperation, communication, and
12 coordination on airshow and aerial event safety; and

13 (2) reduce airshow and aerial event accidents
14 and incidents through non-regulatory, proactive safe-
15 ty strategies.

16 (c) ACTIVITIES.—In carrying out the objectives pur-
17 suant to subsection (b), the Airshow Safety Team shall,
18 at a minimum—

19 (1) perform an analysis of airshow and aerial
20 event accidents and incidents in conjunction with the
21 Safety Analysis Team;

22 (2) publish and update every 2 years after ini-
23 tial publication an Airshow Safety Plan that incor-
24 porates consensus based and data driven mitigation
25 measures and non-regulatory safety strategies to im-

1 prove and promote safety of the public, performers,
2 and airport personnel; and

3 (3) engage the airshow and aerial event commu-
4 nity to—

5 (A) communicate non-regulatory, proactive
6 safety strategies identified by the Airshow Safe-
7 ty Plan to mitigate incidents; and

8 (B) discuss best practices to uphold and
9 maintain safety at events.

10 (d) MEMBERSHIP.—The Administrator may request
11 the Airshow Safety Team be comprised of at least 10 indi-
12 viduals, each of whom shall have knowledge or a back-
13 ground in the planning, execution, operation, or manage-
14 ment of an airshow or aerial event.

15 (e) MEETINGS.—The Airshow Safety Team shall
16 meet at least twice a year at the direction of the co-chairs
17 of the General Aviation Joint Safety Committee.

18 (f) CONSTRUCTION.—The Administrator shall not
19 initiate a regulatory action based on any—

20 (1) discussion or sharing of information and
21 data that occurs as part of an official meeting of the
22 Airshow Safety Team; or

23 (2) safety strategies or best practices identified
24 by the Airshow Safety Plan that are not intended to

1 be used by the Administrator for regulatory pur-
2 poses.

3 **SEC. 228. TOWER MARKING NOTICE OF PROPOSED RULE-**
4 **MAKING.**

5 (a) IN GENERAL.—Not later than 1 year after the
6 date of enactment of this Act, the Administrator of the
7 Federal Aviation Administration shall issue a notice of
8 proposed rulemaking to implement section 2110 of the
9 FAA Extension, Safety, and Security Act of 2016 (49
10 U.S.C. 44718 note).

11 (b) REPORT.—If the Administrator fails to issue the
12 notice of proposed rulemaking pursuant to subsection (a),
13 the Administrator shall submit to the Committee on
14 Transportation and Infrastructure of the House of Rep-
15 resentatives and the Committee on Commerce, Science,
16 and Transportation of the Senate an annual report on the
17 status of such rulemaking, including—

18 (1) the reasons that the Administrator has
19 failed to issue the rulemaking; and

20 (2) a list of fatal aircraft accidents associated
21 with unmarked towers that have occurred over the
22 5 years previous to the date of submission of the re-
23 port.

1 **Subtitle C—Improving FAA**
2 **Services**

3 **SEC. 241. AIRCRAFT REGISTRATION VALIDITY DURING RE-**
4 **NEWAL.**

5 (a) IN GENERAL.—Section 44103 of title 49, United
6 States Code, is further amended by adding at the end the
7 following:

8 “(f) VALIDITY OF AIRCRAFT REGISTRATION DURING
9 RENEWAL.—

10 “(1) IN GENERAL.—An aircraft may be oper-
11 ated on or after the expiration date found on the
12 certificate of registration issued for such aircraft
13 under this section as if it were not expired if the op-
14 erator of such aircraft has aboard the aircraft—

15 “(A) documentation validating that—

16 “(i) an aircraft registration renewal
17 application form (AC Form 8050–1B, or a
18 succeeding form) has been submitted to
19 the Administrator for such aircraft but not
20 yet approved or denied; and

21 “(ii) such aircraft is compliant with
22 maintenance, inspections, and any other
23 requirements for the aircraft’s airworthi-
24 ness certificate issued under section
25 44704(d); and

1 “(B) the most recent aircraft registration.

2 “(2) PROOF OF PENDING RENEWAL APPLICA-
3 TION.—The Administrator shall provide an applicant
4 for renewal of registration under this section with
5 documentation described in paragraph (1)(A). Such
6 documentation shall—

7 “(A) be made electronically available to the
8 applicant immediately upon submitting an air-
9 craft registration renewal application to the
10 Civil Aviation Registry for an aircraft;

11 “(B) notify the applicant of the operational
12 allowance described in paragraph (1);

13 “(C) deem an aircraft’s airworthiness cer-
14 tificate issued under section 44704(d) as valid
15 provided that the applicant confirms acknowl-
16 edgment of the requirements of paragraph
17 (1)(A)(ii);

18 “(D) confirm the applicant acknowledged
19 the limitations described in paragraph (3)(A)
20 and (3)(B); and

21 “(E) include identifying information per-
22 taining to such aircraft and to the registered
23 owner.

1 “(3) RULE OF CONSTRUCTION.—Nothing in
2 this subsection shall be construed to permit any per-
3 son to operate an aircraft—

4 “(A) with an expired registration, except
5 as specifically provided for under this sub-
6 section; or

7 “(B) if the Administrator has denied an
8 application to renew the registration of such
9 aircraft.”.

10 (b) RULEMAKING; GUIDANCE.—Not later than 18
11 months after the date of enactment of this Act, the Ad-
12 ministrators of the Federal Aviation Administration shall
13 issue a final rule, if necessary, and update all applicable
14 guidance and policies to implement the amendment made
15 by this section.

16 **SEC. 242. TEMPORARY AIRMAN CERTIFICATES.**

17 Section 44703 of title 49, United States Code, is
18 amended by adding at the end the following:

19 “(1) TEMPORARY AIRMAN CERTIFICATE.—An indi-
20 vidual may obtain a temporary airman certificate from the
21 Administrator after requesting a permanent replacement
22 airman certificate issued under this section. A temporary
23 airman certificate shall be—

24 “(1) made available—

1 “(A) electronically to the individual imme-
2 diately upon submitting an online application
3 for a replacement certificate to the Adminis-
4 trator; or

5 “(B) physically to the individual at a flight
6 standards district office—

7 “(i) if the individual submits an online
8 application for a replacement certificate; or

9 “(ii) if the individual applies for a
10 permanent replacement certificate other
11 than by online application and such appli-
12 cation has been received by the Federal
13 Aviation Administration; and

14 “(2) destroyed upon receipt of the permanent
15 replacement airman certificate from the Adminis-
16 trator.”.

17 **SEC. 243. FLIGHT INSTRUCTION OR TESTING.**

18 (a) IN GENERAL.—An authorized flight instructor
19 providing student instruction, flight instruction, or flight
20 training shall not be deemed to be operating an aircraft
21 carrying persons or property for compensation or hire.

22 (b) AUTHORIZED ADDITIONAL PILOTS.—An indi-
23 vidual acting as an authorized additional pilot during
24 Phase I flight testing of aircraft holding an experimental
25 airworthiness certificate, in accordance with section

1 21.191 of title 14, Code of Federal Regulations, and meet-
2 ing the requirements set forth in Federal Aviation Admin-
3 istration regulations and policy in effect as of the date
4 of enactment of this section, shall not be deemed to be
5 operating an aircraft carrying persons or property for
6 compensation or hire.

7 (c) USE OF AIRCRAFT.—An individual who uses,
8 causes to use, or authorizes to use aircraft for flights con-
9 ducted under subsection (a) or (b) shall not be deemed
10 to be operating an aircraft carrying persons or property
11 for compensation or hire.

12 (d) REVISION OF RULES.—

13 (1) IN GENERAL.—The requirements of this
14 section shall become effective upon the date of enact-
15 ment of this Act.

16 (2) REVISION.—The Administrator of the Fed-
17 eral Aviation Administration shall issue, revise, or
18 repeal the rules, regulations, guidance, or procedures
19 of the Federal Aviation Administration to conform
20 to the requirements of this section.

21 **SEC. 244. LETTER OF DEVIATION AUTHORITY.**

22 (a) IN GENERAL.—A flight instructor, registered
23 owner, lessor, or lessee of a covered aircraft shall not be
24 required to obtain a letter of deviation authority from the
25 Administrator of the Federal Aviation Administration to

1 allow, conduct, or receive flight training, checking, and
2 testing in such aircraft if—

3 (1) the flight instructor is not providing both
4 the training and the aircraft;

5 (2) no person advertises or broadly offers the
6 aircraft as available for flight training, checking, or
7 testing; and

8 (3) no person receives compensation for use of
9 the aircraft for a specific flight during which flight
10 training, checking, or testing was received, other
11 than expenses for owning, operating, and maintain-
12 ing the aircraft.

13 (b) COVERED AIRCRAFT DEFINED.—In this section,
14 the term “covered aircraft” means—

15 (1) an experimental category aircraft;

16 (2) a limited category aircraft; and

17 (3) a primary category aircraft.

18 **SEC. 245. NATIONAL COORDINATION AND OVERSIGHT OF**

19 **DESIGNATED PILOT EXAMINERS.**

20 (a) IN GENERAL.—Not later than 16 months after
21 the date of enactment of this Act, the Administrator of
22 the Federal Aviation Administration shall establish a pro-
23 gram or office to provide national coordination and over-
24 sight of designated pilot examiners appointed under sec-
25 tion 183.23 of title 14, Code of Federal Regulations.

1 (b) RESPONSIBILITIES.—The program or office es-
2 tablished under subsection (a) shall be responsible for the
3 following:

4 (1) Oversight of designated pilot examiners ap-
5 pointed under section 183.23 of title 14, Code of
6 Federal Regulations, including the selection, train-
7 ing, duties, and deployment of such examiners.

8 (2) Supporting the standardization of policy,
9 guidance, and regulations across the Administration
10 pertaining to the selection, training, duties, and de-
11 ployment of designated pilot examiners appointed
12 under section 183.23 of title 14, Code of Federal
13 Regulations, including evaluating the consistency by
14 which such examiners apply Administration policies,
15 orders, and guidance.

16 (3) Coordinating placement and deployment of
17 such examiners across regions based on demand for
18 examinations from the pilot community.

19 (4) Developing a code of conduct for such ex-
20 aminers.

21 (5) Deploying a survey system to track the per-
22 formance and merit of such examiners.

23 (6) Facilitating an industry partnership to cre-
24 ate a formal mentorship program for such exam-
25 iners.

1 (c) COORDINATION.—In carrying out the responsibil-
2 ities listed in subsection (b), the Administrator shall en-
3 sure the program—

4 (1) coordinates on an ongoing basis with flight
5 standards district offices, designated pilot examiner
6 managing specialists, and aviation industry stake-
7 holders, including representatives of the general
8 aviation community; and

9 (2) considers (or reconsiders) implementing the
10 final recommendations report issued by the Des-
11 ignated Pilot Examiner Reforms Working Group
12 and accepted by the Aviation Rulemaking Advisory
13 Committee on June 17, 2021.

14 (d) BRIEFING.—The Administrator shall brief the
15 Committee on Transportation and Infrastructure of the
16 House of Representatives and the Committee on Com-
17 merce, Science, and Transportation of the Senate in each
18 fiscal year beginning after the date of enactment of this
19 Act through fiscal year 2028 detailing—

20 (1) the methodology by which designated pilot
21 examiners appointed under section 183.23 of title
22 14, Code of Federal Regulations, are deployed and
23 any subsequent changes to the methodology to fulfill
24 the demand for examinations;

- 1 (2) a review of the previous fiscal year detailing
2 the average time an individual in each region must
3 wait to schedule an appointment with such an exam-
4 iner; and
- 5 (3) the turnover rates and resource costs associ-
6 ated with such examiners.

7 **SEC. 246. BASICMED FOR EXAMINERS ADMINISTERING**
8 **TESTS OR PROFICIENCY CHECKS.**

9 (a) **EQUIVALENT PILOT-IN-COMMAND MEDICAL RE-**
10 **QUIREMENTS.**—Notwithstanding section 61.23(a)(3)(iv)
11 of title 14, Code of Federal Regulations, an examiner may
12 administer a practical test or proficiency check if such ex-
13 aminer meets the medical qualification requirements
14 under part 68 of title 14, Code of Federal Regulations,
15 if the operation being conducted is in a covered aircraft,
16 as such term is defined in section 2307(j) of the FAA Ex-
17 tension, Safety, and Security Act of 2016 (49 U.S.C.
18 44703 note).

19 (b) **RULEMAKING.**—Not later than 18 months after
20 the date of enactment of this Act, the Administrator of
21 the Federal Aviation Administration shall issue a final
22 rule to update part 61 of title 14, Code of Federal Regula-
23 tions, to implement the requirements under subsection (a),
24 in addition to any related requirements the Administrator
25 finds are in the interest of aviation safety.

1 **SEC. 247. DESIGNEE LOCATOR TOOL IMPROVEMENTS.**

2 Not later than 2 years after the date of enactment
3 of this Act, the Administrator of the Federal Aviation Ad-
4 ministration shall ensure that the designee locator search
5 function of the public website of the Designee Manage-
6 ment System of the Administration has the functionality
7 to—

8 (1) filter a search for an Aviation Medical Ex-
9 aminer (as described in section 183.21 of title 14,
10 Code of Federal Regulations) by sex, if such infor-
11 mation is available;

12 (2) display credentials and aircraft qualifica-
13 tions of a designated pilot examiner (as described in
14 section 183.23 of such title); and

15 (3) display the scheduling availability of a des-
16 ignated pilot examiner (as described in section
17 183.23 of such title) to administer a test or pro-
18 ficiency check to an airman.

19 **SEC. 248. DEADLINE TO ELIMINATE AIRCRAFT REGISTRA-**
20 **TION BACKLOG.**

21 Not later than 120 days after the date of enactment
22 of this Act, the Administrator of the Federal Aviation Ad-
23 ministration shall take such actions as may be necessary
24 to reduce and maintain the aircraft registration and rec-
25 ordation backlog at the Civil Aviation Registry so that,

1 on average, applications are processed not later than 10
2 business days after receipt.

3 **SEC. 249. PART 135 AIR CARRIER CERTIFICATE BACKLOG.**

4 (a) IN GENERAL.—The Administrator of the Federal
5 Aviation Administration shall take such actions as may
6 be necessary to achieve the goal of reducing the backlog
7 of air carrier certificate applications under part 135 of
8 title 14, Code of Federal Regulations, to—

9 (1) not later than 1 year after the date of en-
10 actment of this Act, maintain an average certificate
11 decision time of less than 60 days; and

12 (2) not later than 2 years after the date of en-
13 actment of this Act, maintain an average certificate
14 decision time of less than 30 days.

15 (b) MEASURES.—In meeting the goal under sub-
16 section (a), the Administrator may—

17 (1) assign, as appropriate, additional personnel
18 or support staff, including on a temporary basis, to
19 review, adjudicate, and approve applications;

20 (2) improve and expand promotion of existing
21 applicant resources which could improve the quality
22 of applications submitted to decrease the need for
23 Administration applicant coordination and commu-
24 nications; and

1 (3) take into consideration any third-party enti-
2 ty that assisted in the preparation of an application
3 for an air carrier certificate under part 135 of title
4 14, Code of Federal Regulations.

5 (c) WORKING GROUP.—The Administrator shall con-
6 vene a working group comprised of industry stakeholders
7 and aviation experts to—

8 (1) not later than 1 year after the date of en-
9 actment of this Act, study methods and make rec-
10 ommendations to clarify requirements and stand-
11 ardize the process for conducting and completing
12 aircraft conformity processes for existing air carriers
13 and operators under part 135 of title 14, Code of
14 Federal Regulations, in a timely manner, which shall
15 include—

16 (A) developing a plan to honor or expedite
17 the consideration of previously accepted aircraft
18 configuration evaluations when an aircraft
19 moves from one certificate under part 135 of
20 title 14, Code of Federal Regulations, to an-
21 other such certificate;

22 (B) streamlining protocols for operators
23 under such part 135 to add an aircraft that
24 was listed on another certificate under such

1 part 135 immediately prior to moving to the
2 new carrier; and

3 (C) evaluating non-safety related Federal
4 Aviation Administration policies, guidance, and
5 documentation and identify needed changes to
6 such policies, guidance, and documentation to
7 accomplish subparagraph (B); and

8 (2) not later than 2 years after of the date of
9 enactment of this Act—

10 (A) study and review methods to mod-
11 ernize and improve the air carrier certification
12 process under part 135 of title 14, Code of
13 Federal Regulations; and

14 (B) recommend long-term solutions for ef-
15 fective management of Administration resources
16 dedicated to approving air carrier certificate ap-
17 plications under such part 135.

18 (d) CONGRESSIONAL BRIEFING.—Beginning 6
19 months after the date of enactment of this Act, and not
20 less than every 6 months thereafter until the Adminis-
21 trator complies with the requirements under subsection
22 (a)(2), the Administrator shall provide a briefing to the
23 Committee on Transportation and Infrastructure of the
24 House of Representatives and the Committee on Com-
25 merce, Science, and Transportation of the Senate on the

1 status of the backlog of air carrier certificate applications
2 under part 135 of title 14, Code of Federal Regulations,
3 any measures the Administrator has put in place under
4 subsection (b), and any recommendations received from
5 the review under subsection (c).

6 **SEC. 250. LOGGING FLIGHT TIME ACCRUED IN CERTAIN**
7 **PUBLIC AIRCRAFT.**

8 (a) COMPLETION OF RULEMAKING.—Not later than
9 18 months after the date of enactment of this Act, the
10 Administrator of the Federal Aviation Administration
11 shall issue a final rule modifying section 61.51(j)(4) of
12 title 14, Code of Federal Regulations, to include aircraft
13 under the direct operational control of forestry and fire
14 protection agencies, as required by section 517 of the FAA
15 Reauthorization Act of 2018 (49 U.S.C. 44703 note).

16 (b) FAILURE TO COMPLETE RULEMAKING.—If the
17 Administrator fails to issue a final rule pursuant to sub-
18 section (a) by the deadline described in such subsection,
19 beginning on the date that is 18 months after the date
20 of enactment of this Act—

21 (1) notwithstanding section 61.51(j)(4) of title
22 14, Code of Federal Regulations, a pilot, while en-
23 gaged on an official flight for a Federal, State,
24 county, or municipal forestry or fire protection agen-

1 cy, may log flight time so long as the time acquired
2 is in an aircraft that—

3 (A) is identified as an aircraft under sec-
4 tion 61.5(b) of such title; and

5 (B) is a public aircraft under the direct
6 operational control of a forestry or fire protec-
7 tion agency; and

8 (2) the Administrator may not take an enforce-
9 ment action against the pilot for logging such flight
10 time as described in paragraph (1).

11 (c) SUNSET.—Subsection (b) shall cease to be effec-
12 tive on the date on which the final rule required under
13 subsection (a) is effective.

14 **SEC. 251. FLIGHT INSTRUCTOR CERTIFICATES.**

15 (a) COMPLETION OF RULEMAKING.—Not later than
16 36 months after the date of enactment of this Act, the
17 Administrator of the Federal Aviation Administration
18 shall issue a final rule for the rulemaking activity titled
19 “Removal of the Expiration Date on a Flight Instructor
20 Certificate”, published in Fall 2022 in the Unified Agenda
21 of Federal Regulatory and Deregulatory Actions (RIN
22 2120–AL25) to, at a minimum, update part 61 of title
23 14, Code of Federal Regulations, to—

24 (1) remove the expiration date on a flight in-
25 structor certificate; and

1 (2) replace the requirement that a flight in-
2 structor renews their flight instructor certificate
3 with appropriate recent experience requirements for
4 the holder of a flight instructor certificate to exer-
5 cise the privileges of such certificate.

6 (b) **FAILURE TO COMPLETE RULEMAKING.**—If the
7 Administrator fails to issue a final rule pursuant to sub-
8 section (a) before the deadline prescribed in that sub-
9 section, beginning on the date that is 36 months after the
10 date of enactment of this Act—

11 (1) notwithstanding sections 61.19(d) and
12 61.197 of title 14, Code of Federal Regulations, an
13 individual holding a flight instructor certificate that
14 is not expired as of the date that is 36 months after
15 the date of enactment of this Act may exercise the
16 privileges of the certificate regardless of whether the
17 certificate subsequently expires, provided that the in-
18 dividual meets eligibility requirements in accordance
19 with section 61.183 of title 14, Code of Federal Reg-
20 ulations; and

21 (2) the Administrator—

22 (A) shall consider a flight instructor cer-
23 tificate described in paragraph (1) as having no
24 expiration date; and

1 (B) may not enforce any regulation attrib-
2 uted to the renewal of a flight instructor certifi-
3 cate of an individual.

4 (c) SUNSET.—Subsection (b) shall cease to be effec-
5 tive on the effective date of a final rule issued pursuant
6 to subsection (a).

7 **SEC. 252. CONSISTENCY OF POLICY APPLICATION IN**
8 **FLIGHT STANDARDS AND AIRCRAFT CERTIFI-**
9 **CATION.**

10 (a) IN GENERAL.—The inspector general of the De-
11 partment of Transportation shall initiate audits, as de-
12 scribed in subsection (d), of the Flight Standards and Air-
13 craft Certification Services of the Federal Aviation Admin-
14 istration, and the personnel of such offices, on the consist-
15 ency of—

16 (1) the interpretation of policies, orders, guid-
17 ance, and regulations; and

18 (2) the application of policies, orders, guidance,
19 and regulations.

20 (b) COMPONENTS.—In completing the audits re-
21 quired under this section, the inspector general shall inter-
22 view stakeholders, including at a minimum, individuals or
23 entities that—

24 (1) hold a certificate or authorization related to
25 the issue being audited under subsection (d);

1 (2) are from different regions of the country
2 with matters before different flight standards dis-
3 trict offices or aircraft certification offices of the Ad-
4 ministration;

5 (3) work with multiple flight standards district
6 offices or aircraft certification offices of the Admin-
7 istration; or

8 (4) hold a single or multiple relevant certifi-
9 cates or authorizations.

10 (c) REPORTS.—The inspector general of the Depart-
11 ment of Transportation shall submit to the Committee on
12 Transportation and Infrastructure of the House of Rep-
13 resentatives, the Committee on Commerce, Science, and
14 Transportation of the Senate, the Secretary of Transpor-
15 tation, and the Administrator of the Federal Aviation Ad-
16 ministration a report for each audit required in this sec-
17 tion, containing the results of the audit, including findings
18 and recommendations to the Administrator to improve the
19 consistency of decision-making by Flight Standards and
20 Aircraft Certification Services offices of the Administra-
21 tion.

22 (d) AUDITS.—The inspector general shall complete
23 an audit and issue the associated report required under
24 subsection (c) not later than—

1 (1) 18 months after the date of enactment of
2 this Act, with regard to supplemental type certifi-
3 cates;

4 (2) 34 months after the date of enactment of
5 this Act, with regard to repair stations certificated
6 under part 145 of title 14, Code of Federal Regula-
7 tions; and

8 (3) 50 months after the date of enactment of
9 this Act, with regard to technical standards orders.

10 (e) IMPLEMENTATION.—In addressing any rec-
11 ommendations from the inspector general contained in the
12 reports required under subsection (c), the Administrator
13 shall—

14 (1) maintain an implementation plan; and

15 (2) broadly adopt any best practices to improve
16 the consistency of interpretation and application of
17 policies, orders, guidance, and regulations by other
18 offices of the Administration and with regard to
19 other activities of the Administration.

20 (f) BRIEFING.—Not later than 6 months after receiv-
21 ing a report required under subsection (c), the Adminis-
22 trator shall brief the Committee on Transportation and
23 Infrastructure of the House of Representatives and the
24 Committee on Commerce, Science, and Transportation of
25 the Senate on the implementation plan required under

1 subsection (d), the status of any recommendation received
2 pursuant to this section, and any best practices that are
3 being implemented more broadly.

4 **SEC. 253. APPLICATION OF POLICIES, ORDERS, AND GUID-**
5 **ANCE.**

6 Section 44701 of title 49, United States Code, is
7 amended by adding at the end the following:

8 “(g) POLICIES, ORDERS, AND GUIDANCE.—

9 “(1) CONSISTENCY OF APPLICATION.—The Ad-
10 ministrator shall ensure consistency in the applica-
11 tion of policies, orders, and guidance of the Adminis-
12 tration by—

13 “(A) regular audits of the application and
14 interpretation of such material by Administra-
15 tion personnel from person to person and office
16 to office;

17 “(B) updating policies, orders, and guid-
18 ance to resolve inconsistencies and clarify dem-
19 onstrated ambiguities, such as through repeated
20 inconsistent interpretation; and

21 “(C) ensuring officials are properly docu-
22 menting findings and decisions throughout a
23 project to decrease the occurrence of duplicative
24 work and inconsistent findings by subsequent
25 officials assigned to the same project.

1 “(2) ALTERATIONS.—The Administrator shall
2 consult as appropriate with regulated entities who
3 will be impacted by proposed changes to the content
4 or application of policies, orders, and guidance be-
5 fore making such changes.

6 “(3) AUTHORITIES AND REGULATIONS.—The
7 Administrator shall issue policies, orders, and guid-
8 ance documents that are related to a law or regula-
9 tion or clarify the intent of or compliance with spe-
10 cific laws and regulations.”.

11 **SEC. 254. EXPANSION OF THE REGULATORY CONSISTENCY**
12 **COMMUNICATIONS BOARD.**

13 Section 224 of the FAA Reauthorization Act of 2018
14 (49 U.S.C. 44701 note) is amended—

15 (1) in subsection (c)—

16 (A) in paragraph (2) by striking “; and”
17 and inserting a semicolon;

18 (B) in paragraph (3) by striking the period
19 and inserting a semicolon; and

20 (C) by adding at the end the following:

21 “(4) the Office of Airports;

22 “(5) the Office of Security and Hazardous Ma-
23 terials Safety;

24 “(6) the Office of Rulemaking and Regulatory
25 Improvement; and

1 “(7) such other offices as the Administrator de-
2 termines appropriate.”; and

3 (2) in subsection (d)(1)—

4 (A) in subparagraph (A) by striking
5 “anonymous regulatory interpretation ques-
6 tions” and inserting “regulatory interpretation
7 questions, including anonymously,”;

8 (B) in subparagraph (C) by striking
9 “anonymous regulatory interpretation ques-
10 tions” and inserting “regulatory interpretation
11 questions, including anonymously”; and

12 (C) by adding at the end the following:

13 “(6) Submit recommendations, as needed, to
14 the Assistant Administrator for Rulemaking and
15 Regulatory Improvement for consideration.”.

16 **SEC. 255. EXEMPTION OF FEES FOR AIR TRAFFIC SERV-**
17 **ICES.**

18 (a) IN GENERAL.—Chapter 453 of title 49, United
19 States Code, is amended by adding at the end the fol-
20 lowing:

21 **“§ 45307. Exemption of fees for air traffic services**

22 **“(a) REQUIREMENT TO PROVIDE SERVICES AND RE-**
23 **LATED SUPPORT.—**The Administrator shall provide or en-
24 sure the provisioning of air traffic services and aviation
25 safety support for large, multiday aviation events, includ-

1 ing airshows and fly-ins, where the average daily number
2 of manned operations were 1,000 or greater in at least
3 1 of the preceding 3 years, without the imposition or col-
4 lection of any fee, tax, or other charge for that purpose.
5 Amounts for the provision of such services and support
6 shall be derived from amounts appropriated or otherwise
7 available for the Administration.

8 “(b) DETERMINATION OF SERVICES AND SUPPORT
9 TO BE PROVIDED.—In determining the services and sup-
10 port to be provided for an aviation event for purposes of
11 subsection (a), the Administrator shall take into account
12 the following:

13 “(1) The services and support required to meet
14 levels of activity at prior events, if any, similar to
15 the event.

16 “(2) The anticipated need for services and sup-
17 port at the event.”.

18 (b) CLERICAL AMENDMENT.—The analysis of chap-
19 ter 453 of title 49, United States Code, is amended by
20 adding at the end the following:

“Sec. 45307. Exemption of fees for air traffic services.”.

21 (c) CONFORMING REPEAL.—Section 530 of the FAA
22 Reauthorization of 2018 (49 U.S.C. 40103 note), and the
23 item relating to that section in the table of contents in
24 section 1(b) of such Act, are repealed.

1 **SEC. 256. MODERNIZATION OF SPECIAL AIRWORTHINESS**
2 **CERTIFICATION RULEMAKING DEADLINE.**

3 Not later than 24 months after the date of enactment
4 of this Act, the Administrator of the Federal Aviation Ad-
5 ministration shall issue a final rule for the rulemaking ac-
6 tivity titled “Modernization of Special Airworthiness Cer-
7 tification”, published in Fall 2022 in the long-term actions
8 of the Unified Agenda of Federal Regulatory and Deregula-
9 tory Actions (RIN 2120–AL50).

10 **SEC. 257. TERMINATION OF DESIGNEES.**

11 (a) IN GENERAL.—Not later than 1 year after the
12 date of enactment of this Act, the Administrator of the
13 Federal Aviation Administration shall update the Admin-
14 istration’s Designee Management Policy (FAA Order
15 8000.95B), or any successor order, to ensure due process
16 and increase transparency in Federal Aviation Adminis-
17 tration-initiated terminations of designees.

18 (b) UPDATES TO THE DESIGNEE MANAGEMENT POL-
19 ICY.—In updating the Administration’s Designee Manage-
20 ment Policy under subsection (a), the Administrator shall,
21 at a minimum, provide for the following:

- 22 (1) A process by which a designee—
23 (A) is notified of the root causes and rea-
24 sons for a termination initiated by the Adminis-
25 trator;

1 (B) is notified of the change in a delegated
2 authority to “suspended” or “terminated” dur-
3 ing a Federal Aviation Administration-initiated
4 termination;

5 (C) is provided a point of contact, who is
6 independent of any investigation or termination
7 action involving the designee, within the Admin-
8 istration, to correspond with for purposes of
9 discussing the termination process and the des-
10 ignee’s status, including the handling of cor-
11 respondence during the investigation process
12 described in paragraph (2), if applicable, and
13 the review panel described in paragraph (3);

14 (D) is notified of the results of the inves-
15 tigation described in paragraph (2) in a reason-
16 able and timely manner, which shall include no-
17 tice of additional action by the Administrator,
18 if required; and

19 (E) may respond within 30 calendar days
20 to the Administrator if the Administrator deter-
21 mines that a termination for cause is the appro-
22 priate course of action and initiates such action.

23 (2) An investigation process to determine the
24 appropriate outcome in situations in which termi-

1 nation is being considered by the Administrator,
2 which shall include the following elements:

3 (A) The root causes and reasons for the
4 investigation, including any complaints or alle-
5 gations.

6 (B) Collection of evidence related to the in-
7 vestigation.

8 (C) A review of the facts and cir-
9 cumstances surrounding the case.

10 (D) A review of the designee's record in
11 the designee management system and any rel-
12 evant background information in the appro-
13 priate Federal Aviation Administration data-
14 bases to determine if there is a pattern of inap-
15 propriate behavior or misconduct.

16 (E) A review of the designee's response to
17 the investigation, if provided, to include any
18 documentation provided by the designee.

19 (F) A decision on the appropriate course of
20 action based on the results of the investigation.

21 (G) Recording the results of the investiga-
22 tion in the Federal Aviation Administration's
23 designee management system.

24 (H) A notification to the designee that an
25 investigation has been initiated, but only after

1 it is determined through an established process
2 that such notification would not adversely im-
3 pact the investigation or safety.

4 (3) A review panel to determine whether a ter-
5 mination is appropriate when termination for cause
6 is a possible outcome upon the completion of the in-
7 vestigation described in paragraph (2), of which
8 such review panel shall—

9 (A) consider the elements of the investiga-
10 tion process provided for under paragraph (2),
11 including the designee's response to the inves-
12 tigation and any associated documents, if pro-
13 vided; and

14 (B) complete the review process within 45
15 calendar days of the Administrator initiating a
16 for cause termination decision of a designee.

17 (c) SUBSEQUENT REVIEW FOR DESIGNATED PILOT
18 EXAMINERS.—

19 (1) IN GENERAL.—The Administrator shall set
20 up a process through which a Designated Pilot Ex-
21 aminer terminated for cause may request a subse-
22 quent review by the Executive Director of the Flight
23 Standards Service.

24 (2) REQUEST.—A Designated Pilot Examiner
25 terminated for cause may request a subsequent re-

1 view described in paragraph (1) not later than 15
2 calendar days after termination,

3 (3) REVIEW.—The Executive Director shall re-
4 view all relevant information and facts by which the
5 decision was made to terminate the designee, includ-
6 ing the information considered by the review panel,
7 and issue a final determination.

8 (4) TIMING.—Such final determination shall be
9 issued by the Director not later than 45 calendar
10 days upon receiving the request.

11 (d) LIMITATION ON INVESTIGATION AND REVIEW
12 PANEL PARTICIPANTS.—An Administration employee in-
13 volved in the selection, appointment, or management of
14 a designee the Administrator is investigating or termi-
15 nating for cause may not be party—

16 (1) to an investigation described in subsection
17 (b)(2) of such designee; or

18 (2) participating on a review panel described in
19 subsection (b)(3) pertaining to such designee.

20 **SEC. 258. PART 135 CHECK AIRMEN REFORMS.**

21 (a) IN GENERAL.—The Administrator of the Federal
22 Aviation Administration shall assign to the Aviation Rule-
23 making Advisory Committee (in this section referred to
24 as the “Committee”) the task of reviewing all regulations
25 and policies related to check airmen for air carrier oper-

1 ations conducted under part 135 of title 14, Code of Fed-
2 eral Regulations.

3 (b) DUTIES.—The Committee shall—

4 (1) review the processes and requirements by
5 which authorized check airmen are selected, trained,
6 and approved by the Administrator, and provide rec-
7 ommendations with respect to the regulatory and
8 policy changes necessary to ensure efficient training
9 and utilization of such check airmen;

10 (2) review differences in qualification standards
11 between an inspector of the Federal Aviation Admin-
12 istration and an authorized check airmen in evalu-
13 ating and certifying the knowledge and skills of pi-
14 lots; and

15 (3) make recommendations with respect to the
16 regulatory and policy changes necessary to allow au-
17 thorized check airmen to perform duties beyond the
18 duties permitted on the date of enactment of this
19 Act.

20 (c) ACTION BASED ON RECOMMENDATIONS.—Not
21 later than 1 year after receiving recommendations under
22 subsection (a), the Administrator shall take such action
23 as the Administrator considers appropriate with respect
24 to such recommendations.

1 (d) DEFINITION OF AUTHORIZED CHECK AIRMAN.—
2 In this section, the term “authorized check airman”
3 means an individual employed by an air carrier that meets
4 the qualifications and training requirements of sections
5 135.337 and 135.339 of title 14, Code of Federal Regula-
6 tions, and is approved to evaluate and certify the knowl-
7 edge and skills of pilots employed by such air carrier.

8 **Subtitle D—Other Provisions**

9 **SEC. 261. REQUIRED CONSULTATION WITH NATIONAL** 10 **PARKS OVERFLIGHTS ADVISORY GROUP.**

11 Section 40128(b)(4) of title 49, United States Code,
12 is amended—

13 (1) in subparagraph (C) by striking “and” at
14 the end;

15 (2) in subparagraph (D) by striking the period
16 at the end and inserting “; and”; and

17 (3) by adding at the end the following:

18 “(E) consult with the advisory group es-
19 tablished under section 805 of the National
20 Parks Air Tour Management Act of 2000 (49
21 U.S.C. 40128 note) and consider all advice, in-
22 formation, and recommendations provided by
23 the advisory group to the Administrator and the
24 Director.”.

1 **SEC. 262. SUPPLEMENTAL OXYGEN REGULATORY REFORM.**

2 (a) IN GENERAL.—Beginning on the date that is 30
3 days after the date of enactment of this Act, the following
4 regulations shall cease to apply to any aircraft operating
5 below 41,000 feet above mean sea level:

6 (1) Paragraphs (3) and (4) of section 135.89(b)
7 of title 14, Code of Federal Regulations (or any suc-
8 cessor regulations).

9 (2) Paragraphs (1)(ii) and (2) of section
10 91.211(b) of title 14, Code of Federal Regulations
11 (or any successor regulations).

12 (b) CONFORMING AMENDMENT.—Not later than 1
13 year after the date of enactment of this Act, the Adminis-
14 trator of the Federal Aviation Administration shall issue
15 a final regulation revising the provisions of title 14, Code
16 of Federal Regulations, described in paragraphs (1) and
17 (2) of subsection (a) to conform to the limitation in appli-
18 cability pursuant to subsection (a).

19 **SEC. 263. EXCLUSION OF GYROPLANES FROM FUEL SYSTEM**
20 **REQUIREMENTS.**

21 Section 44737 of title 49, United States Code, is
22 amended—

23 (1) by striking “rotorcraft” and inserting “heli-
24 copter” each place it appears; and

25 (2) by adding at the end the following:

1 “(d) EXEMPTION.—A helicopter issued an experi-
2 mental certificate under section 21.191 of title 14, Code
3 of Federal Regulations (or any successor regulations), or
4 operating under a Special Flight Permit issued under sec-
5 tion 21.197 of title 14, Code of Federal Regulations (or
6 any successor regulations), is exempt from the require-
7 ments of this section.”.

8 **SEC. 264. AIRSHOW VENUE INFORMATION, AWARENESS,**
9 **TRAINING, AND EDUCATION PROGRAM.**

10 (a) IN GENERAL.—Not later than 4 years after the
11 date of enactment of this Act, the Administrator of the
12 Federal Aviation Administration shall establish a pro-
13 gram, in cooperation with the National Center for the Ad-
14 vancement of Aerospace, to be known as the “Airshow
15 Venue Information, Awareness, Training, and Education
16 Program” (in this section referred to as the “AVIATE
17 Program”).

18 (b) OBJECTIVE.—The objectives of the AVIATE Pro-
19 gram shall be—

20 (1) to make information available to general
21 aviation airport managers, local government officials,
22 and other relevant stakeholders about how to host
23 an airshow;

1 (2) to provide guidance and resources to help
2 organizers plan and execute airshows and aerial
3 events, including—

4 (A) compliance with all applicable regula-
5 tions;

6 (B) providing technical assistance in estab-
7 lishing—

8 (i) emergency response plans; and

9 (ii) communication plans between rel-
10 evant event stakeholders, including local
11 enforcement and emergency first respond-
12 ers; and

13 (C) ensuring protection of the public, per-
14 formers, and airport personnel;

15 (3) to promote public awareness and engage-
16 ment with airshows and aerial events, including op-
17 portunities for community education, outreach, and
18 involvement; and

19 (4) to provide access to tools and resources that
20 enable general aviation airport managers, local gov-
21 ernment officials, and other relevant stakeholders to
22 understand the impact of airshows and aerial events
23 on local economies and communities.

1 (c) ADMINISTRATION.—In carrying out the AVIATE
2 Program, the Administrator shall consult and coordinate,
3 as appropriate, with relevant stakeholders, including—

4 (1) airshow safety experts;

5 (2) general aviation aircraft owners and opera-
6 tors, including experimental aircraft owners and op-
7 erators;

8 (3) general aviation airports, including airport
9 officials;

10 (4) air traffic control specialists with knowledge
11 of coordinating airshows and aerial events, including
12 experts from the exclusive bargaining representative
13 of air traffic controllers certified under section 7111
14 of title 5, United States Code; and

15 (5) experts from the exclusive bargaining rep-
16 resentative of air traffic controllers certified under
17 section 7111 of title 5, United States Code.

18 **SEC. 265. LOW ALTITUDE ROTORCRAFT AND POWERED-**
19 **LIFT OPERATIONS.**

20 (a) IN GENERAL.—Not later than 3 years after the
21 date of enactment of this Act, the Administrator of the
22 Federal Aviation Administration shall, as appropriate, es-
23 tablish or update low altitude routes and flight procedures
24 to ensure safe rotorcraft and powered-lift aircraft oper-

1 ations within Class B airspace of the national airspace sys-
2 tem.

3 (b) FLIGHT PROCEDURES.—In carrying out sub-
4 section (a), the Administrator shall, as appropriate, estab-
5 lish or update approach and departure procedures at pub-
6 lic-use airports and heliports within Class B airspace for
7 rotorcraft and powered-lift aircraft operations.

8 (c) FLIGHT ROUTES.—

9 (1) IN GENERAL.—In carrying out this section,
10 the Administrator shall revise part 71 of title 14,
11 Code of Federal Regulations, as necessary, to estab-
12 lish or update low altitude routes related to Class B
13 airspace operations for rotorcraft and powered-lift
14 aircraft.

15 (2) CONSIDERATIONS.—In carrying out this
16 section, the Administrator shall consider the impact
17 of such low altitude flight routes described in para-
18 graph (1) on other airspace users and impacted
19 communities to ensure that such routes are designed
20 to minimize—

21 (A) the potential for conflict with existing
22 national airspace system operations;

23 (B) the workload of air traffic controllers;
24 and

1 (C) negative effects to impacted commu-
2 nities.

3 (d) CONSULTATION.—In carrying out this section,
4 the Administrator shall develop the procedures and routes
5 required under subsection (b) and (c) in consultation
6 with—

7 (1) rotorcraft operators, including air ambu-
8 lance operators;

9 (2) powered-lift operators;

10 (3) exclusive bargaining representatives of air
11 traffic controllers certified under section 7111 of
12 title 5, United States Code; and

13 (4) any other relevant stakeholders as deter-
14 mined by the Administrator.

15 **SEC. 266. BASICMED IN NORTH AMERICA.**

16 The Administrator of the Federal Aviation Adminis-
17 tration shall seek to facilitate the recognition of medical
18 qualifications under part 68 of title 14, Code of Federal
19 Regulations, with civil aviation authorities in Canada and
20 such other foreign countries that the Administrator deter-
21 mines are appropriate.

22 **SEC. 267. ELIMINATE AVIATION GASOLINE LEAD EMIS-**
23 **SIONS.**

24 (a) EAGLE INITIATIVE.—

1 (1) IN GENERAL.—The Administrator of the
2 Federal Aviation Administration shall continue to
3 partner with industry and other Federal Government
4 stakeholders in carrying out the Eliminate Aviation
5 Gasoline Lead Emissions Initiative (in this section
6 referred to as the “EAGLE Initiative”).

7 (2) FAA RESPONSIBILITIES.—In collaborating
8 with industry and other Government stakeholders to
9 carry out the EAGLE Initiative, the Administrator
10 shall take such actions as may be necessary under
11 the Administrator’s authority to facilitate—

12 (A) the safe elimination of the use of lead-
13 ed aviation gasoline by piston-engine aircraft by
14 the end of 2030 without adversely affecting the
15 piston-engine aircraft fleet;

16 (B) the approval of unleaded alternatives
17 to leaded aviation gasoline for use in all piston-
18 engine aircraft types and piston-engine types;

19 (C) the implementation of the require-
20 ments of section 431 as they relate to the con-
21 tinued availability of aviation gasoline;

22 (D) efforts to make approved unleaded
23 aviation gasoline widely available at airports;
24 and

1 (E) the development and implementation
2 of a transition plan to safely expedite the tran-
3 sition of the piston-engine general aviation air-
4 craft fleet to unleaded fuels by 2030.

5 (3) ACTIVITIES.—In carrying out the Adminis-
6 tration’s responsibilities pursuant to paragraph (2),
7 the Administrator, at a minimum, shall—

8 (A) develop and publish, as soon as prac-
9 ticable, a fleet authorization process for the ef-
10 ficient approval or authorization of unleaded
11 aviation gasolines;

12 (B) review, update, and prioritize, as soon
13 as practicable, certification processes and
14 projects for aircraft engines and modifications
15 to such engines to operate with unleaded avia-
16 tion gasoline;

17 (C) evaluate and support programs that
18 accelerate the creation, evaluation, qualification,
19 deployment, and use of unleaded aviation gaso-
20 lines;

21 (D) carry out, in partnership with the gen-
22 eral aviation community, an ongoing campaign
23 for training and educating aircraft owners and
24 operators on how to safely transition to un-
25 leaded aviation gasoline;

1 (E) evaluate aircraft and aircraft engines
2 to ensure that such aircraft and aircraft en-
3 gines can operate with unleaded aviation gaso-
4 line candidates during cold weather conditions;
5 and

6 (F) facilitate Government policy, regu-
7 latory proposals, and voluntary consensus
8 standards with the objective of achieving the
9 following:

10 (i) Establishing a commercially viable
11 supply chain for unleaded aviation gaso-
12 lines.

13 (ii) Facilitating market-based produc-
14 tion and distribution of unleaded aviation
15 gasolines.

16 (iii) Encouraging procurement of
17 equipment required for the deployment,
18 storage, and dispensing of unleaded avia-
19 tion gasolines.

20 (4) CONSULTATION AND COORDINATION WITH
21 RELEVANT STAKEHOLDERS.—In carrying out the
22 EAGLE Initiative, the Administrator shall continue
23 to consult and coordinate, as appropriate, with rel-
24 evant stakeholders, including—

1 (A) general aviation aircraft engine, air-
2 craft propulsion, and aircraft airframe manu-
3 facturers;

4 (B) general aviation aircraft users, aircraft
5 owners, aircraft pilots, and aircraft operators;

6 (C) airports, heliports, and fixed-base oper-
7 ators;

8 (D) State, local, and Tribal airport offi-
9 cials or public agencies, with representation
10 from both urban and rural areas;

11 (E) representatives of the petroleum indus-
12 try, including developers, refiners, producers,
13 and distributors of unleaded aviation gasolines;
14 and

15 (F) air carriers and commercial operators
16 operating under part 135 of title 14, Code of
17 Federal Regulations.

18 (5) REPORTS TO CONGRESS.—

19 (A) INITIAL REPORT.—Not later than 1
20 year after the date of enactment of this Act, the
21 Administrator shall submit to the Committee on
22 Transportation and Infrastructure of the House
23 of Representatives and the Committee on Com-
24 merce, Science, and Transportation of the Sen-
25 ate a report that—

1 (i) contains an updated strategic plan
2 for developing a fleet authorization process
3 for efficient approval and use of unleaded
4 aviation gasolines;

5 (ii) describes the structure and in-
6 volvement of all Federal Aviation Adminis-
7 tration offices that have responsibilities de-
8 scribed in paragraph (2); and

9 (iii) identifies cost-effective policy ini-
10 tiatives, regulatory initiatives, or legislative
11 initiatives needed to improve and enhance
12 the timely transition to unleaded aviation
13 gasoline for the piston-engine aircraft fleet.

14 (B) ANNUAL REPORTING.—Not later than
15 1 year after the date on which the Adminis-
16 trator submits the initial report under subpara-
17 graph (A), and annually thereafter, the Admin-
18 istrator shall submit to the Committee on
19 Transportation and Infrastructure of the House
20 of Representatives and the Committee on Com-
21 merce, Science, and Transportation of the Sen-
22 ate an annual report on activities and progress
23 of the EAGLE Initiative.

24 (C) SUNSET.—Subparagraph (B) shall
25 cease to be effective after December 31, 2030.

1 (b) TRANSITION PLAN TO UNLEADED FUELS.—

2 (1) IN GENERAL.—In developing the transition
3 plan under subsection (a)(2)(E), the Administrator
4 shall, at a minimum, assess the following:

5 (A) Efforts undertaken by the EAGLE
6 Initiative, including progress towards—

7 (i) safely eliminating the use of leaded
8 aviation gasoline by piston-engine aircraft
9 by the end of 2030 without adversely af-
10 fecting the piston-engine aircraft fleet;

11 (ii) approving unleaded alternatives to
12 leaded aviation gasoline for use in all pis-
13 ton-engine aircraft types and piston-engine
14 types; and

15 (iii) facilitating efforts to make ap-
16 proved unleaded aviation gasoline widely
17 available at airports.

18 (B) The evaluation and development of
19 necessary airport infrastructure, including fuel
20 storage and dispensing facilities, to support the
21 distribution and storage of unleaded aviation
22 gasoline.

23 (C) The establishment of best practices for
24 piston-engine aircraft owners and operators,
25 airport managers and personnel, aircraft main-

1 tenance technicians, and other appropriate per-
2 sonnel for protecting against exposure to lead
3 containment when—

4 (i) conducting fueling operations;

5 (ii) disposing of inspected gasoline
6 samples;

7 (iii) performing aircraft maintenance;

8 and

9 (iii) conducting engine run-ups.

10 (D) Efforts to address supply chain and
11 other logistical barriers inhibiting the timely
12 distribution of unleaded aviation gasoline to air-
13 ports.

14 (E) Outreach efforts to educate and up-
15 date piston-engine aircraft owners and opera-
16 tors, airport operators, and other members of
17 the general aviation community on the potential
18 benefits, availability, and safety of unleaded
19 aviation gasoline.

20 (2) CONSULTATION.—In developing such transi-
21 tion plan, the Administrator shall consult, at a min-
22 imum, with representatives of entities described in
23 subsection (a)(4).

1 (3) PUBLICATION; GUIDANCE.—Upon comple-
2 tion of developing such transition plan, the Adminis-
3 trator shall—

4 (A) make the plan available to the public
5 on an appropriate webpage of the Administra-
6 tion; and

7 (B) provide guidance supporting the imple-
8 mentation of the transition plan.

9 (4) COORDINATION WITH EAGLE INITIATIVE.—
10 In developing such transition plan and associated
11 guidance pertaining to the implementation of such
12 transition plan, the Administrator shall consult and
13 coordinate with individuals carrying out the EAGLE
14 Initiative.

15 (5) MAPPING UNLEADED AVIATION GASO-
16 LINE.—The Administrator shall develop and con-
17 tinuously update websites, brochures, and other com-
18 munication materials associated with such transition
19 plan to clearly convey the availability of unleaded
20 aviation gasoline at airports.

21 (6) BRIEFING TO CONGRESS.—Not later than
22 60 days after the publication of such transition plan,
23 the Administrator shall brief the Committee on
24 Transportation and Infrastructure of the House of
25 Representatives and the Committee on Commerce,

1 Science, and Technology of the Senate on such tran-
2 sition plan and any efforts or actions pertaining to
3 the implementation of such transition plan.

8 **SEC. 301. EXTENSION OF AVIATION WORKFORCE DEVELOP-**
9 **MENT PROGRAMS.**

10 Section 625(b)(1) of the FAA Reauthorization Act of
11 2018 (49 U.S.C. 40101 note) is amended by striking “sec-
12 tion 48105” and all that follows through the period at the
13 end and inserting the following: “section 48105 of title
14 49, United States Code, not more than—

15 “(A) \$15,000,000 for each of fiscal years
16 2024 through 2026 is authorized to be ex-
17 pended to provide grants under the program es-
18 tablished under subsection (a)(1); and

19 “(B) \$15,000,000 for each of fiscal years
20 2024 through 2026 is authorized to provide
21 grants under the program established under
22 subsection (a)(2).

23 “(C) \$15,000,000 for each of fiscal years
24 2024 through 2026 is authorized to be ex-

1 pended to provide grants under the program es-
2 tablished under subsection (a)(3).”.

3 **SEC. 302. IMPROVING AVIATION WORKFORCE DEVELOP-**
4 **MENT PROGRAMS.**

5 (a) MANUFACTURING PROGRAM.—Section 625(a) of
6 the FAA Reauthorization Act of 2018 (49 U.S.C. 40101
7 note) is amended—

8 (1) in paragraph (1) by striking “and” at the
9 end;

10 (2) in paragraph (2) by striking the period and
11 inserting “; and”; and

12 (3) by adding at the end the following:

13 “(3) a program to provide grants for eligible
14 projects to support the education and recruitment of
15 aviation manufacturing workers and the development
16 of the aviation manufacturing workforce.”.

17 (b) PROJECT GRANTS.—Section 625(b) of the FAA
18 Reauthorization Act of 2018 (49 U.S.C. 40101 note) is
19 amended—

20 (1) in paragraph (2) by striking “\$500,000”
21 and inserting “\$750,000”; and

22 (2) by adding at the end the following:

23 “(3) EDUCATION PROJECTS.—The Secretary
24 shall ensure that not less than 20 percent of the
25 amounts authorized to be expended under this sub-

1 section shall be used to carry out a grant program
2 which shall be referred to as the ‘Willa Brown Avia-
3 tion Education Program’ (in this paragraph referred
4 to as the ‘Program’) under which the Secretary shall
5 provide grants for eligible projects described in sub-
6 section (d) that are carried out in communities in
7 counties containing at least 1 qualified opportunity
8 zone (as such term is defined in section 1400Z-1(a)
9 of the Internal Revenue Code of 1986).”.

10 (c) ELIGIBLE APPLICATIONS.—Section 625(c) of the

14 “(1) APPLICATION FOR AIRCRAFT PILOT PRO-
15 GRAM.—An application for a grant under the pro-
16 gram established under subsection (a)(1) may be
17 submitted, in such form as the Secretary may speci-
18 fy, by—

19 “(A) an air carrier, as defined in section
20 40102 of title 49, United States Code;

21 “(B) an entity that holds management
22 specifications under subpart K of title 91 of
23 title 14, Code of Federal Regulations;

24 “(C) an institution of higher education (as
25 defined in section 101 of the Higher Education

1 Act of 1965 (20 U.S.C. 1001)), a postsecondary
2 vocational institution (as defined in section
3 102(c) of the Higher Education Act of 1965
4 (20 U.S.C. 1002)), or a high school or sec-
5 ondary school (as such terms are defined in sec-
6 tion 8101 of the Elementary and Secondary
7 Education Act of 1965 (20 U.S.C. 7801));

8 “(D) a flight school that provides flight
9 training, as defined in part 61 of title 14, Code
10 of Federal Regulations, or that holds a pilot
11 school certificate under part 141 of title 14,
12 Code of Federal Regulations;

13 “(E) a labor organization representing pro-
14 fessional pilots;

15 “(F) an aviation-related nonprofit organi-
16 zation described in section 501(c)(3) of the In-
17 ternal Revenue Code of 1986 that is exempt
18 from taxation under section 501(a) of such
19 Code; or

20 “(G) a State, local, territorial, or Tribal
21 governmental entity.

22 “(2) APPLICATION FOR AVIATION MAINTEN-
23 NANCE PROGRAM.—An application for a grant under
24 the program established under subsection (a)(2) may

1 be submitted, in such form as the Secretary may
2 specify, by—

3 “(A) a holder of a certificate issued under
4 part 21, 121, 135, 145, or 147 of title 14, Code
5 of Federal Regulations;

6 “(B) a labor organization representing
7 aviation maintenance workers;

8 “(C) an institution of higher education (as
9 defined in section 101 of the Higher Education
10 Act of 1965 (20 U.S.C. 1001)), a postsecondary
11 vocational institution (as defined in section
12 102(c) of the Higher Education Act of 1965
13 (20 U.S.C. 1002)), or a high school or sec-
14 ondary school (as such terms are defined in sec-
15 tion 8101 of the Elementary and Secondary
16 Education Act of 1965 (20 U.S.C. 7801));

17 “(D) an aviation-related nonprofit organi-
18 zation described in section 501(c)(3) of the In-

10 “(ii) has significant operations in the
11 United States and a majority of the em-
12 ployees of such entity that are engaged in
13 aviation manufacturing or development ac-
14 tivities and services are based in the
15 United States;

16 “(B) an institution of higher education (as
17 defined in section 101 of the Higher Education
18 Act of 1965 (20 U.S.C. 1001)), a postsecondary
19 vocational institution (as defined in section
20 102(c) of the Higher Education Act of 1965
21 (20 U.S.C. 1002)), or a high school or sec-
22 ondary school (as such terms are defined in sec-
23 tion 8101 of the Elementary and Secondary
24 Education Act of 1965 (20 U.S.C. 7801));

1 “(C) an aviation-related nonprofit organi-
2 zation described in section 501(c)(3) of the In-
3 ternal Revenue Code of 1986 that is exempt
4 from taxation under section 501(a) of such
5 Code; or

6 “(D) a State, local, territorial, or Tribal
7 governmental entity.”.

8 (d) ELIGIBLE PROJECTS.—Section 625(d) of the

12 “(1) AIRCRAFT PILOT PROGRAM.—For purposes

16 provides high school or secondary school stu-
17 dents with meaningful aviation education to be-
18 come aircraft pilots, aerospace engineers, or un-
19 manned aircraft systems operators, including
20 purchasing and operating a computer-based
21 simulator associated with such curriculum;

22 “(B) to support the professional develop-
23 ment of teachers using the curriculum described
24 in subparagraph (A);

1 “(C) to create and deliver curriculum that
2 provides certified flight instructors with the
3 necessary instructional, leadership, and commu-
4 nication skills to better educate student pilots;

5 “(D) to support transition to professional
6 pilot careers, including for members of the
7 Armed Forces; or

8 “(E) to support robust outreach about ca-
9 reers in the commercial aviation as a profes-
10 sional pilot, including outreach to primary, sec-
11 ondary, and post-secondary school students.

12 “(2) AVIATION MAINTENANCE PROGRAM.—For
13 purposes of the program established under sub-
14 section (a)(2), an eligible project is a project—

15 “(A) to create and deliver curriculum that
16 provides high school and secondary school stu-
17 dents with meaningful aviation maintenance
18 education to become an aviation mechanic or
19 aviation maintenance technician, including pur-
20 chasing and operating equipment associated
21 with such curriculum;

22 “(B) to support the professional develop-
23 ment of teachers using the curriculum described
24 in subparagraph (A);

1 “(C) to establish or improve apprentice-
2 ship, internship, or scholarship programs for in-
3 dividuals pursuing employment in the aviation
4 maintenance industry;

5 “(D) to support transition to aviation
6 maintenance careers, including for members of
7 the Armed Forces; or

8 “(E) to support robust outreach about ca-
9 reers in the aviation maintenance industry, in-
10 cluding outreach to primary, secondary, and
11 post-secondary school students.

12 “(3) AVIATION MANUFACTURING PROGRAM.—
13 For purposes of the program established under sub-
14 section (a)(3), and eligible project is a project—

15 “(A) to create and deliver curriculum that
16 provides high school and secondary school stu-
17 dents with meaningful aviation manufacturing
18 education, including teaching the technical
19 skills used in the production of components,
20 parts, or systems thereof for inclusion in an air-
21 craft, aircraft engine, propeller, or appliance;

22 “(B) to support the professional develop-
23 ment of teachers using the curriculum described
24 in subparagraph (A);

1 “(C) to establish apprenticeship, intern-
2 ship, or scholarship programs for individuals
3 pursuing employment in the aviation manufac-
4 turing industry;

5 “(D) to support transition to aviation
6 manufacturing careers, including for members
7 of the Armed Forces; or

8 “(E) to support robust outreach about ca-
9 reers in the aviation manufacturing industry,
10 including outreach to primary, secondary, and
11 post-secondary school students.”.

12 (e) REPORTING AND MONITORING REQUIRE-
13 MENTS.—Section 625 of the FAA Reauthorization Act of
14 2018 (49 U.S.C. 40101 note) is amended by adding at
15 the end the following:

16 “(f) REPORTING AND MONITORING REQUIRE-
17 MENTS.—The Secretary shall establish reasonable report-
18 ing and monitoring requirements for grant recipients
19 under this section to measure relevant outcomes for the
20 grant programs established under paragraphs (1), (2),
21 and (3) of subsection (a).

22 “(g) NOTICE OF GRANTS.—

23 “(1) TIMELY PUBLIC NOTICE.—The Secretary
24 shall provide public notice of any grant awarded

1 under this section in a timely fashion after the Sec-
2 retary awards such grant.

3 “(2) NOTICE TO CONGRESS.—The Secretary
4 shall provide to the Committee on Transportation
5 and Infrastructure of the House of Representatives
6 and the Committee on Commerce, Science, and
7 Transportation of the Senate advance notice of a
8 grant to be made under this section.

9 “(h) TERMINATION.—The authority of the Secretary
10 to issue grants under this section shall terminate on Sep-
11 tember 30, 2026.”

12 **SEC. 303. NATIONAL CENTER FOR THE ADVANCEMENT OF**
13 **AEROSPACE.**

14 (a) IN GENERAL.—Chapter 1 of title 49, United
15 States Code, is amended by adding at the end the fol-
16 lowing:

17 **“§ 120. National Center for the Advancement of Aero-**
18 **space**

19 “(a) FEDERAL CHARTER AND STATUS.—

20 “(1) IN GENERAL.—The National Center for
21 the Advancement of Aerospace (in this section re-
22 ferred to as the ‘Center’) is a federally chartered en-
23 tity which shall be incorporated in the District of
24 Columbia. The Center is a private independent enti-
25 ty, not a department, agency, or instrumentality of

1 the United States Government or a component
2 thereof. Except as provided in subsection (f)(1), an
3 officer or employee of the Center is not an officer or
4 employee of the Federal Government.

5 “(2) PERPETUAL EXISTENCE.—Except as oth-
6 erwise provided, the Center shall have perpetual ex-
7 istence.

8 “(b) GOVERNING BODY.—

9 “(1) IN GENERAL.—The Board of Directors (in
10 this section referred to as the ‘Board’) is the gov-
11 erning body of the Center.

12 “(2) AUTHORITY.—

13 “(A) IN GENERAL.—The Board shall adopt
14 bylaws, policies, and procedures to carry out the
15 purpose of the Center and may take any other
16 action that it considers necessary (in accord-
17 ance with the duties and powers of the Center)
18 for the management and operation of the Cen-
19 ter. The Board is responsible for the general
20 policies and management of the Center and for
21 the control of all funds of the Center.

22 “(B) POWERS OF BOARD.—The Board
23 shall have the power to do the following:

24 “(i) Adopt and alter a corporate seal.

1 “(ii) Establish and maintain offices to
2 conduct its activities.

3 “(iii) Enter into contracts or agree-
4 ments as a private entity not subject to the
5 requirements of title 41.

6 “(iv) Acquire, own, lease, encumber,
7 transfer, and dispose of property as nec-
8 essary and appropriate to carry out the
9 purposes of the Center.

10 “(v) Publish documents and other
11 publications in a publicly accessible man-
12 ner.

13 “(vi) Incur and pay obligations as a
14 private entity not subject to the require-
15 ments of title 31.

16 “(vii) Perform any other act necessary
17 and proper to carry out the purposes of
18 the Center as described in its bylaws or
19 duties outlined in this section.

20 “(3) MEMBERSHIP OF THE BOARD.—

21 “(A) IN GENERAL.—The Board shall have
22 10 Directors as follows:

23 “(i) EX-OFFICIO MEMBERSHIP.—The
24 following individuals, or their designees,

1 shall be considered ex-officio members of
2 the Board:

3 “(I) The Administrator of the
4 Federal Aviation Administration.

5 “(II) The Executive Director,
6 pursuant to paragraph (5)(D).

7 “(ii) APPOINTMENTS.—

8 “(I) IN GENERAL.—From among
9 those members of the public who are
10 highly respected and have expert
11 knowledge and experience in the fields
12 of aviation, finance, or academia—

13 “(aa) the Secretary of
14 Transportation shall appoint 5
15 members to the Board;

16 “(bb) the Secretary of De-
17 fense shall appoint 1 member to
18 the Board;

19 “(cc) the Secretary of Vet-
20 erans Affairs shall appoint 1
21 member to the Board; and

22 “(dd) the Secretary of Edu-
23 cation shall appoint 1 member to
24 the Board.

25 “(II) TERMS.—

1 “(aa) IN GENERAL.—The
2 members appointed under sub-
3 clause (I) shall serve for a term
4 of 3 years and may be re-
5 appointed.

6 “(bb) STAGGERING
7 TERMS.—The Board shall stag-
8 ger the duration of the terms of
9 the initial members appointed to
10 promote the stability of the
11 Board.

12 “(B) VACANCIES.—A vacancy on the
13 Board shall be filled in the same manner as the
14 initial appointment.

15 “(C) STATUS.—All Members of the Board
16 shall have equal voting powers, regardless if
17 they are ex-officio members or appointed.

18 “(4) CHAIR OF THE BOARD.—The Board shall
19 choose a Chair of the Board from among the mem-
20 bers of the Board that are not ex-officio members
21 under paragraph (3)(A)(i).

22 “(5) ADMINISTRATIVE MATTERS.—

23 “(A) MEETINGS.—

24 “(i) IN GENERAL.—The Board shall
25 meet at the call of the Chair but not less

1 than 2 times each year and may, as appro-
2 priate, conduct business by telephone or
3 other electronic means.

4 “(ii) OPEN.—

5 “(I) IN GENERAL.—Except as
6 provided in subclause (II), a meeting
7 of the Board shall be open to the pub-
8 lic.

9 “(II) EXCEPTION.—A meeting,
10 or any portion of a meeting, may be
11 closed if the Board, in public session,
12 votes to close the meeting because the
13 matters to be discussed—

14 “(aa) relate solely to the in-
15 ternal personnel rules, practices,
16 and matters of the Center;

17 “(bb) may result in disclo-
18 sure of commercial or financial
19 information obtained from a per-
20 son that is privileged or confiden-
21 tial;

22 “(cc) may disclose informa-
23 tion of a personal nature where
24 disclosure would constitute an

1 unwarranted invasion of personal
2 privacy; or

3 “(dd) are matters that are
4 specifically exempted from disclo-
5 sure by Federal or District of Co-
6 lumbia law.

7 “(iii) PUBLIC ANNOUNCEMENT.—At
8 least 1 week before a meeting of the
9 Board, and as soon as practicable there-
10 after if there are any changes to the infor-
11 mation described in subclauses (I) through
12 (III), the Board shall make a public an-
13 nouncement of the meeting that de-
14 scribes—

15 “(I) the time, place, and subject
16 matter of the meeting;

17 “(II) whether the meeting is to
18 be open or closed to the public; and

19 “(III) the name and appropriate
20 contact information of a person who
21 can respond to requests for informa-
22 tion about the meeting.

23 “(iv) RECORD.—The Board shall keep
24 minutes from each Board meeting. Such
25 minutes shall be made available to the pub-

1 lic in an accessible format, except for por-
2 tions of the meeting that are closed pursu-
3 ant to subparagraph (A)(ii)(II).

4 “(B) QUORUM.—A majority of members of
5 the Board shall constitute a quorum.

6 “(C) CODE OF ETHICS.—The Board shall
7 adopt a code of ethics for Directors, officers,
8 agents, and employees of the Center to—

9 “(i) prevent inappropriate conflicts of
10 interest and promote good employee con-
11 duct; and

12 “(ii) at a minimum, prohibit any
13 member of the Board from participating in
14 any proceeding, application, ruling, or
15 other determination, contract claim, award,
16 controversy, or other matter in which the
17 member, the member’s employer or pro-
18 spective employer, or the member’s imme-
19 diate family member has a direct financial
20 interest.

21 “(D) EXECUTIVE DIRECTOR.—The Board
22 shall appoint and fix the pay of an Executive
23 Director of the Center (in this section referred
24 to as the ‘Executive Director’) who shall—

1 “(i) serve as an ex officio Member of
2 the Board;

3 “(ii) serve at the pleasure of the
4 Board, under such terms and conditions as
5 the Board shall establish;

6 “(iii) is subject to removal by the
7 Board at the discretion of the Board; and

8 “(iv) be responsible for the daily man-
9 agement and operation of the Center and
10 for carrying out the purposes and duties of
11 the Center.

12 “(E) APPOINTMENT OF PERSONNEL.—The
13 Board shall delegate to the Executive Director
14 the authority to appoint additional personnel as
15 the Board considers appropriate and necessary
16 to carry out the purposes and duties of the
17 Center.

18 “(6) RECORDS.—The Board shall keep correct
19 and complete records of accounts.

20 “(7) PUBLIC INFORMATION.—With the excep-
21 tion of the matters described in subsection
22 (b)(5)(A)(ii)(II), nothing in this section may be con-
23 strued to withhold disclosure of information or
24 records that are subject to disclosure under section
25 552 of title 5.

1 “(c) PURPOSE.—The purpose of the Center is to—

2 “(1) develop a skilled and robust aerospace
3 workforce in the United States;

4 “(2) provide a forum to support collaboration
5 and cooperation between governmental, nongovern-
6 mental, and private aerospace sector stakeholders re-
7 garding the advancement of the aerospace workforce,
8 including general, business, and commercial aviation,
9 education, labor, manufacturing, international orga-
10 nizations, and commercial space transportation orga-
11 nizations;

12 “(3) serve as a repository for research con-
13 ducted by institutions of higher education, research
14 institutions, or other stakeholders regarding the
15 aerospace workforce and related technical and skill
16 development.

17 “(4) serve as a centralized resource that pro-
18 vides comprehensive and relevant information
19 sources on the following:

20 “(A) Aviation pathway programs and pro-
21 fessional development opportunities.

22 “(B) Aviation apprenticeship, scholarship,
23 and internship programs.

24 “(C) Aviation-related curricula and re-
25 sources about aviation occupations and career

1 pathways developed for students, teachers, and
2 guidance counselors at all levels of education.

3 “(D) Aviation industry organizations.

4 “(d) DUTIES.—In order to accomplish the purpose
5 described in subsection (c), the Center shall perform the
6 following duties:

7 “(1) Improve access to aerospace education and
8 related skills training to help grow the U.S. aero-
9 space workforce, including by—

10 “(A) assessing the state of the aerospace
11 workforce, including challenges and identifying
12 actions to address such challenges;

13 “(B) developing a comprehensive workforce
14 strategy to help coordinate workforce develop-
15 ment initiatives;

16 “(C) establishing or supporting apprentice-
17 ship, scholarship, internship, and mentorship
18 programs that assist individuals who wish to
19 pursue a career in an aerospace-related field;

20 “(D) supporting the development of aero-
21 space education curricula, including syllabi,
22 training materials, and lesson plans, for use by
23 an institution of higher education (as defined in
24 section 101 of the Higher Education Act of
25 1965 (20 U.S.C. 1001)), a postsecondary voca-

1 tional institution (as defined in section 102(c)
2 of the Higher Education Act of 1965 (20
3 U.S.C. 1002)), or a high school or secondary
4 school (as such terms are defined in section
5 8101 of the Elementary and Secondary Edu-
6 cation Act of 1965 (20 U.S.C. 7801)); and

7 “(E) building awareness of youth-oriented
8 aerospace programs and other robust outreach
9 programs, including for primary, secondary,
10 and post-secondary school students.

11 “(F) supporting the professional develop-
12 ment of teachers using the curricula, syllabi,
13 training materials, and lesson plans described
14 in subparagraph (D); and

15 “(G) developing an array of educational
16 and informative aviation-related educational ac-
17 tivities and materials for students of varying
18 ages and levels of education to use in the class-
19 room and at home.

20 “(2) Support personnel or veterans of the
21 Armed Forces seeking to transition to a career in
22 aerospace through outreach, training, scholarships,
23 apprenticeships, or other means.

24 “(3) Amplify and support the work carried out
25 at the Centers of Excellence and Technical Centers

1 of the Federal Aviation Administration regarding
2 the aerospace workforce, or related technical and
3 skills advancement, including organizing and hosting
4 symposiums, conferences, and other forums as ap-
5 propriate.

6 “(4) Administer on behalf of the Secretary of
7 the Department of Transportation the Cooperative
8 Aviation Recruitment, Enrichment, and Employment
9 Readiness Program established by subsection (a) of
10 40131.

11 “(e) DUTY TO MAINTAIN TAX-EXEMPT STATUS.—
12 The Center shall be operated in a manner and for pur-
13 poses that qualify the Center for exemption from taxation
14 under the Internal Revenue Code as an organization de-
15 scribed in section 501(c)(3) of such Code.

16 “(f) ADMINISTRATIVE MATTERS OF CENTER.—

17 “(1) DETAILEES.—

18 “(A) IN GENERAL.—At the request of the
19 Center, the head of any Federal agency or de-
20 partment may, at the discretion of such agency
21 or department, detail to the Center, on a reim-
22 bursable basis, an employee of the agency or
23 department.

24 “(B) CIVIL SERVANT STATUS.—The detail
25 of an employee under subparagraph (A) shall be

1 without interruption or loss of civil service sta-
2 tus or privilege.

3 “(2) NAMES AND SYMBOLS.—The Center may
4 accept, retain, and use proceeds derived from the
5 Center’s use of the exclusive right to use its name
6 and seal, emblems, and badges incorporating such
7 name as lawfully adopted by the Board in further-
8 ance of the purpose and duties of the Center.

9 “(3) GIFTS, GRANTS, BEQUESTS, AND DE-
10 VISES.—The Center may accept, retain, use, and
11 dispose of gifts, grants, bequests, or devises of
12 money, services, or property from any public or pri-
13 vate source for the purpose of covering the costs in-
14 curred by the Center in furtherance of the purpose
15 and duties of the Center.

16 “(4) VOLUNTARY SERVICES.—The Center may
17 accept voluntary services from any person that are
18 provided in furtherance of the purpose and duties of
19 the Center.

20 “(g) RESTRICTIONS.—

21 “(1) PROFIT.—The Center may not engage in
22 business activity for profit.

23 “(2) STOCKS AND DIVIDENDS.—The Center
24 may not issue any shares of stock or declare or pay
25 any dividends.

1 “(3) POLITICAL ACTIVITIES.—The Center shall
2 be nonpolitical and may not provide financial aid or
3 assistance to, or otherwise contribute to or promote
4 the candidacy of, any individual seeking elective pub-
5 lic office or political party. The Center may not en-
6 gage in activities that are, directly, or indirectly, in-
7 tended to be or likely to be perceived as advocating
8 or influencing the legislative process.

9 “(4) DISTRIBUTION OF INCOME OR ASSETS.—
10 The assets of the Center may not inure to the ben-
11 efit of any member of the Board, or any officer or
12 employee of the Center or be distributed to any per-
13 son. This paragraph does not prevent the payment
14 of reasonable compensation to any officer, employee,
15 or other person or reimbursement for actual and
16 necessary expenses in amounts approved by the
17 Board.

18 “(5) LOANS.—The Center may not make a loan
19 to any member of the Board or any officer or em-
20 ployee of the Center.

21 “(6) NO CLAIM OF GOVERNMENTAL APPROVAL
22 OR AUTHORITY.—Except as otherwise provided by
23 section 40131, the Center may not claim approval of
24 Congress or of the authority of the United States for
25 any of its activities.

1 “(h) ADVISORY COMMITTEE.—

2 “(1) IN GENERAL.—The Executive Director
3 shall appoint members to an advisory committee
4 subject to approval by the Board. Members of the
5 Board may not sit on the advisory committee.

6 “(2) MEMBERSHIP.—The advisory committee
7 shall consist of not more than 15 members who rep-
8 resent various aviation industry and labor stake-
9 holders, stakeholder associations, and others as de-
10 termined appropriate by the Board. The advisory
11 committee shall select a Chair and Vice Chair from
12 among its members by majority vote.

13 “(3) DUTIES.—The advisory committee shall—

14 “(A) provide recommendations to the
15 Board on an annual basis regarding the prior-
16 ities for the activities of the Center;

17 “(B) consult with the Board on an ongoing
18 basis regarding the appropriate powers of the
19 Board to accomplish the purposes and duties of
20 the Center; and

21 “(C) provide relevant data and information
22 to the Center in order to carry out the duties
23 set forth in subsection (d).

24 “(4) MEETINGS.—The provisions for meetings
25 of the Board under subsection (b)(5) shall apply as

1 similarly as is practicable to meetings of the advi-
2 sory committee.

3 “(i) WORKING GROUPS.—

4 “(1) IN GENERAL.—The Board may establish
5 working groups as determined necessary and appro-
6 priate to achieve the purpose of the Center under
7 subsection (c).

8 “(2) MEMBERSHIP.—Any working group estab-
9 lished by the Board shall be composed of private sec-
10 tor representatives, stakeholder associations, mem-
11 bers of the public, labor representatives, and other
12 relevant parties, as determined appropriate by the
13 Board. Once established, the membership of such
14 working group shall choose a Chair from among the
15 members of the working group by majority vote.

16 “(j) CAREER COUNCIL.—

17 “(1) ESTABLISHMENT.—Not later than Sep-
18 tember 30, 2026, the Executive Director, in coordi-
19 nation with the Secretary, shall establish a council
20 (in this section referred to as the ‘CAREER Coun-
21 cil’) for the CAREER Program established under
22 section 40131.

23 “(2) DUTIES.—The CAREER Council shall aid
24 the Secretary and the Center in carrying out the

1 CAREER Program by reviewing grant applications
2 and recommending grant recipients.

3 “(3) APPOINTMENT.—The CAREER Council
4 shall be appointed from candidates nominated by na-
5 tional associations representing various sectors of
6 the aviation industry, including—

7 “(A) general aviation;

8 “(B) commercial aviation;

9 “(C) aviation labor, including collective
10 bargaining representatives of Federal Aviation
11 Administration aviation safety inspectors, avia-
12 tion safety engineers, and air traffic controllers;

13 “(D) aviation maintenance, repair, and
14 overhaul; and

15 “(E) unmanned aviation.

16 “(4) TERM.—Each council member appointed
17 under paragraph (3) shall serve a term of 4 years.

18 “(k) ANNUAL REPORT.—The Board shall submit an
19 annual report to the Committee on Transportation and In-
20 frastructure of the House of Representatives and the Com-
21 mittee on Commerce, Science, and Transportation of the
22 Senate that, at minimum, includes a review and examina-
23 tion of—

24 “(1) the activities performed as set forth in
25 subsection (d) during the prior fiscal year;

1 “(2) the advisory committee described in sub-
2 section (h);

3 “(3) the working groups described in subsection
4 (i); and

5 “(4) the Cooperative Aviation Recruitment, En-
6 richment, and Employment Readiness Program and
7 related activities established under section 40131,
8 including activities of the CAREER Council estab-
9 lished under subsection (j).

10 “(1) AUDIT BY DEPARTMENT OF TRANSPORTATION
11 INSPECTOR GENERAL.—

12 “(1) IN GENERAL.—Not later than 2 years
13 after the date on which the Center is established
14 under subsection (a), the inspector general of the
15 Department of Transportation shall conduct a re-
16 view of the Center.

17 “(2) CONTENTS.—The review shall—

18 “(A) include, at a minimum, an evaluation
19 of the efforts taken at the Center to achieve the
20 purpose set forth in subsection (c); and

21 “(B) provide any other information that
22 the inspector general determines is appropriate.

23 “(3) REPORT ON AUDIT.—

24 “(A) REPORT TO SECRETARY.—Not later
25 than 30 days after the date of completion of the

1 audit, the inspector general shall submit to the
2 Secretary a report on the results of the audit.

3 “(B) REPORT TO CONGRESS.—Not later
4 than 60 days after the date of receipt of the re-
5 port under subparagraph (A), the Secretary
6 shall submit to the appropriate committees of
7 Congress a copy of the report, together with, if
8 appropriate, a description of any actions taken
9 or to be taken to address the results of the
10 audit.

11 “(m) AUTHORIZATION OF APPROPRIATIONS.—There
12 is authorized to be appropriated to the National Center
13 for the Advancement of Aerospace out of the Airport and
14 Airway Trust Fund to carry out this section—

15 “(1) \$10,000,000 for fiscal year 2024;

16 “(2) \$10,000,000 for fiscal year 2025;

17 “(3) \$10,000,000 for fiscal year 2026;

18 “(4) \$11,000,000 for fiscal year 2027; and

19 “(5) \$11,000,000 for fiscal year 2028.”.

20 (b) CLERICAL AMENDMENT.—The analysis for chap-
21 ter 1 of title 49, United States Code, is amended by insert-
22 ing after the item relating to section 119 the following:

“120. National Center for the Advancement of Aerospace.”.

1 **SEC. 304. COOPERATIVE AVIATION RECRUITMENT, ENRICH-**
2 **MENT, AND EMPLOYMENT READINESS PRO-**
3 **GRAM.**

4 (a) IN GENERAL.—Chapter 401 of title 49, United
5 States Code, is amended by adding at the end the fol-
6 lowing:

7 **“§ 40131. Cooperative Aviation Recruitment, Enrich-**
8 **ment, and Employment Readiness Pro-**
9 **gram**

10 “(a) ESTABLISHMENT.—Not later than September
11 30, 2026, the Secretary of Transportation, through the
12 National Center for the Advancement of Aerospace (in
13 this section referred to as the ‘Center’), shall establish an
14 aviation workforce cooperative development program to be
15 known as the Cooperative Aviation Recruitment, Enrich-
16 ment, and Employment Readiness Program (in this sec-
17 tion referred to as the ‘CAREER Program’) to support
18 the education, recruitment, training, and retention of fu-
19 ture aviation professionals and the development of a ro-
20 bust United States aviation workforce by—

21 “(1) using relevant workforce forecasts to pre-
22 dict and identify aviation-related workforce chal-
23 lenges; and

24 “(2) funding projects that address such chal-
25 lenges and help to sustain the long-term growth of
26 civil aviation.

1 “(b) IMPLEMENTATION.—

2 “(1) PARTNERSHIP WITH NCAA.—In imple-
3 menting the CAREER Program established under
4 subsection (a), the Secretary shall partner with the
5 CAREER Council established in subsection (j) of
6 section 120.

7 “(2) NONDELEGATION.—Except as provided in
8 paragraph (3), the Secretary may not delegate any
9 of the authorities or responsibilities under this sec-
10 tion to the Administrator of the Federal Aviation
11 Administration.

12 “(3) SUPPORT.—To support the administration
13 of the CAREER Program, the Secretary may assign
14 employees of the Department of Transportation, in-
15 cluding employees of the Federal Aviation Adminis-
16 tration, on detail to the Center.

17 “(c) SOLICITATION, REVIEW, AND EVALUATION
18 PROCESS.—In carrying out the CAREER Program, the
19 Secretary shall establish a solicitation, review, and evalua-
20 tion process that ensures funds made available to carry
21 out this section are awarded to eligible entities with pro-
22 posals that have adequate merit and relevancy to the mis-
23 sion of the program.

24 “(d) ELIGIBLE ENTITIES.—An eligible entity under
25 this section is—

1 “(1) an air carrier;

2 “(2) an entity that holds management specifica-
3 tions under subpart K of title 91 of title 14, Code
4 of Federal Regulations;

5 “(3) a holder of a certificate issued under parts
6 139, 145, or 147 of title 14, Code of Federal Regu-
7 lations;

8 “(4) an institution of higher education (as de-
9 fined in section 101 of the Higher Education Act of
10 1965 (20 U.S.C. 1001)), a postsecondary vocational
11 institution (as defined in section 102(e) of the High-
12 er Education Act of 1965 (20 U.S.C. 1002)), or a
13 high school or secondary school (as such terms are
14 defined in section 8101 of the Elementary and Sec-
15 ondary Education Act of 1965 (20 U.S.C. 7801));

16 “(5) a flight school that provides flight training,
17 as defined in part 61 of title 14, Code of Federal
18 Regulations, or that holds a pilot school certificate
19 under part 141 of title 14, Code of Federal Regula-
20 tions;

21 “(6) an aviation labor organization;

22 “(7) a State, local, territorial, or Tribal govern-
23 ment, including a political subdivision thereof;

24 “(8) an aviation-related nonprofit organization
25 described in section 501(c)(3) of the Internal Rev-

1 venue Code of 1986 that is exempt from taxation
2 under section 501(a) of such Code; or

3 “(9) an entity that—

4 “(A) actively designs or manufactures any
5 aircraft, aircraft engine, propeller, or appliance,
6 or a component, part, or system thereof, cov-
7 ered under a type or production certificate
8 issued under section 44704; and

9 “(B) has significant operations in the
10 United States and a majority of the employees
11 of such entity that are engaged in aviation
12 manufacturing or development activities and
13 services are based in the United States.

14 “(e) REPORTING AND MONITORING REQUIRE-
15 MENTS.—The Secretary shall establish reasonable report-
16 ing and monitoring requirements for grant recipients
17 under this section to measure relevant outcomes of the
18 program maintained pursuant to subsection (a).

19 “(f) REPORT.—Not later than September 30, 2027,
20 and annually through fiscal year 2028, the Secretary shall
21 submit to the Committee on Transportation and Infra-
22 structure of the House of Representatives and the Com-
23 mittee on Commerce, Science, and Transportation of the
24 Senate a report on the program that includes—

1 “(1) a summary of projects awarded grants
2 under this section and the progress of each recipient
3 towards fulfilling program expectations;

4 “(2) an evaluation of how such projects cumula-
5 tively impact the future supply of individuals in the
6 U.S. aviation workforce, including best practices or
7 programs to incentivize, recruit, and retain individ-
8 uals in aviation professions; and

9 “(3) recommendations for better coordinating
10 actions by governmental entities, educational institu-
11 tions, and businesses, aviation labor organizations,
12 or other stakeholders to support aviation workforce
13 growth.

14 “(g) NOTICE OF GRANTS.—

15 “(1) TIMELY PUBLIC NOTICE.—The Secretary
16 shall provide public notice of any grant awarded
17 under the CAREER Program in a timely fashion
18 after the Secretary awards such grant.

19 “(2) NOTICE TO CONGRESS.—The Secretary
20 shall provide advance notice of a grant to be made
21 under the CAREER Program to the Committee on
22 Transportation and Infrastructure of the House of
23 Representatives and the Committee on Commerce,
24 Science, and Transportation of the Senate.

1 “(h) AUTHORIZATION OF APPROPRIATIONS.—Of the
2 amounts made available under section 48105,
3 \$50,000,000 for each of fiscal years 2027 and 2028 is
4 authorized to be expended to provide grants under the pro-
5 gram established under subsection (a).”.

6 (b) CLERICAL AMENDMENT.—The analysis for chap-
7 ter 401 of title 49, United States Code, is amended by
8 adding at the end the following:

“40131. Cooperative Aviation Recruitment, Enrichment, and Employment Read-
iness Program.”.

9 **SEC. 305. REPEAL OF DUPLICATIVE OR OBSOLETE WORK-**
10 **FORCE PROGRAMS.**

11 (a) REPEAL.—Sections 44510 and 44515 of title 49,
12 United States Code, are repealed.

13 (b) CLERICAL AMENDMENTS.—The analysis for
14 chapter 445 of title 49, United States Code, is amended
15 by striking the items relating to sections 44510 and
16 44515.

17 **SEC. 306. CIVIL AIRMEN STATISTICS.**

18 (a) PUBLICATION FREQUENCY.—The Administrator
19 of the Federal Aviation Administration shall publish the
20 study commonly referred to as the “U.S. Civil Airmen Sta-
21 tistics” on a monthly basis.

22 (b) PRESENTATION OF DATA.—

23 (1) IN GENERAL.—Not later than 1 year after
24 the date of enactment of this Act, the Administrator

1 of the Federal Aviation Administration shall estab-
2 lish a web-based dashboard for purposes of pre-
3 senting the findings of the study described in sub-
4 section (a).

5 (2) **DOWNLOADABLE FORMAT.**—The Adminis-
6 trator shall make the data publicly available on the
7 website of the Administration in a downloadable for-
8 mat.

9 (c) **EXPANDED DATA CRITERIA.**—Not later than 1
10 year after the date of enactment of this Act, the Adminis-
11 trator shall ensure that data sets and tables published as
12 part of the study described in subsection (a) display infor-
13 mation relating to the sex of certificate holders in more
14 instances.

15 (d) **HISTORICAL DATA.**—Not later than 1 year after
16 the date of enactment of this Act, the Administrator shall
17 make all previously published annual data from the study
18 described in subsection (a) available on the website of the
19 Administration.

20 **SEC. 307. BESSIE COLEMAN WOMEN IN AVIATION ADVISORY**
21 **COMMITTEE.**

22 (a) **ESTABLISHMENT.**—Not later than 120 days after
23 the date of enactment of this Act, the Secretary of Trans-
24 portation shall establish a Bessie Coleman Women in

1 Aviation Advisory Committee (hereinafter referred to as
2 the “Committee”).

3 (b) PURPOSE.—The Committee shall advise the Sec-
4 retary and the Administrator of the Federal Aviation Ad-
5 ministration on matters and policies related to the recruit-
6 ment, retention, employment, education, training, well-
7 being, and treatment of women in the aviation industry
8 and aviation-focused Federal civil service positions.

9 (c) FORM OF DIRECTIVES.—All activities carried out
10 by the Committee, including special committees, shall be
11 in response to written terms of reference or taskings from
12 the Secretary and may not duplicate the objectives of the
13 Air Carrier Training Aviation Rulemaking Committee.

14 (d) FUNCTIONS.—In carrying out the directives de-
15 scribed in subsection (c), the functions of the Committee
16 are as follows:

17 (1) Foster industry collaboration in an open
18 and transparent manner by engaging, as prescribed
19 by this section, representatives of the private sector
20 associated with an entity described in subsection
21 (e)(1)(B).

22 (2) Make recommendations for strategic objec-
23 tives, priorities, and policies that would improve the
24 recruitment, retention, and training of women in
25 aviation professions.

1 (3) Evaluate opportunities for the Administra-
2 tion to improve the recruitment and retention of
3 women in the Administration.

4 (e) MEMBERSHIP.—

5 (1) VOTING MEMBERS.—The Advisory Com-
6 mittee shall be composed of the following members:

7 (A) The Administrator, or the designee of
8 the Administrator.

9 (B) At least 25 individuals, appointed by
10 the Secretary, representing the following:

11 (i) Transport aircraft and engine
12 manufacturers.

13 (ii) General aviation aircraft and en-
14 gine manufacturers.

15 (iii) Avionics and equipment manufac-
16 turers.

17 (iv) Public and private aviation labor
18 organizations, including collective bar-
19 gaining representatives of—

20 (I) aviation safety inspectors and
21 safety engineers of the Federal Avia-
22 tion Administration;

23 (II) air traffic controllers;

24 (III) certified aircraft mainte-
25 nance technicians; and

- 1 (IV) commercial airline pilots.
- 2 (v) General aviation operators.
- 3 (vi) Air carriers.
- 4 (vii) Business aviation operators.
- 5 (viii) Unmanned aircraft systems
6 manufacturers and operators.
- 7 (ix) Aviation safety management ex-
8 perts.
- 9 (x) Aviation maintenance, repair, and
10 overhaul entities.
- 11 (xi) Airport owners and operators.
- 12 (xii) Advanced air mobility manufac-
13 turers and operators.
- 14 (xiii) Institutions of higher education
15 (as defined in section 101 of the Higher
16 Education Act of 1965 (20 U.S.C. 1001)),
17 a postsecondary vocational institution (as
18 defined in section 102(c) of the Higher
19 Education Act of 1965 (20 U.S.C. 1002)),
20 or a high school or secondary school (as
21 such terms are defined in section 8101 of
22 the Elementary and Secondary Education
23 Act of 1965 (20 U.S.C. 7801)).
- 24 (xiv) A flight school that provides
25 flight training, as defined in part 61 of

1 title 14, Code of Federal Regulations, or
2 that holds a pilot school certificate under
3 part 141 of title 14, Code of Federal Regu-
4 lations.

5 (xv) Aviation maintenance technician
6 schools governed under part 147 of title
7 14, Code of Federal Regulations.

8 (2) NONVOTING MEMBERS.—

9 (A) IN GENERAL.—In addition to the
10 members appointed under paragraph (1), the
11 Committee shall be composed of not more than
12 5 nonvoting members appointed by the Sec-
13 retary from among officers or employees of the
14 FAA.

15 (B) DUTIES.—The nonvoting members
16 may—

17 (i) take part in deliberations of the
18 Committee; and

19 (ii) provide subject matter expertise
20 with respect to reports and recommenda-
21 tions of the Committee.

22 (C) LIMITATION.—The nonvoting members
23 may not represent any stakeholder interest
24 other than that of the FAA.

1 (3) TERMS.—Each voting member and non-
2 voting member of the Committee appointed by the
3 Secretary shall be appointed for a term of 4 years.

4 (4) COMMITTEE CHARACTERISTICS.—The Com-
5 mittee shall have the following characteristics:

6 (A) The ability to obtain necessary infor-
7 mation from additional experts in the aviation
8 and aerospace communities.

9 (B) A membership size that enables the
10 Committee to have substantive discussions and
11 reach consensus on issues in a timely manner.

12 (C) Appropriate expertise, including exper-
13 tise in human resources, human capital man-
14 agement, policy, labor relations, employment
15 training, workforce development, and youth out-
16 reach.

17 (f) CHAIRPERSON.—

18 (1) IN GENERAL.—The Chairperson of the
19 Committee shall be appointed by the Secretary from
20 among the voting members of the Committee under
21 subsection (e)(1)(B).

22 (2) TERM.—The Chairperson shall serve a 2-
23 year term.

24 (g) MEETINGS.—

1 (1) FREQUENCY.—The Committee shall meet at
2 least twice each year at the call of the Chairperson
3 or the Secretary.

4 (2) PUBLIC ATTENDANCE.—The meetings of
5 the Committee shall be open and accessible to the
6 public.

7 (h) SPECIAL COMMITTEES.—

8 (1) ESTABLISHMENT.—The Committee may es-
9 tablish special committees composed of private sec-
10 tor representatives, members of the public, labor
11 representatives, and other relevant parties in com-
12 plying with the consultation and participation re-
13 quirements under subsection (d).

14 (2) AUTHORITIES.—A special committee estab-
15 lished by the Committee may provide rulemaking ad-
16 vice, recommendations, and additional opportunities
17 to obtain firsthand information to the Committee
18 with respect to issues regarding the advancement of
19 women in aviation.

20 (3) APPLICABLE LAW.—Public Law 92–463
21 shall not apply to a special committee established by
22 the Committee.

23 (i) PERSONNEL MATTERS.—

24 (1) NO COMPENSATION OF MEMBERS.—

1 (A) NON-FEDERAL EMPLOYEES.—A mem-
2 ber of the Committee who is not an officer or
3 employee of the Federal Government shall serve
4 without compensation.

5 (B) FEDERAL EMPLOYEES.—A member of
6 the Committee who is an officer or employee of
7 the Federal Government shall serve without
8 compensation in addition to the compensation
9 received for the services of the member as an
10 officer or employee of the Federal Government.

11 (2) TRAVEL EXPENSES.—The members of the
12 Committee shall be allowed travel expenses, includ-
13 ing per diem in lieu of subsistence, at rates author-
14 ized for employees of agencies under subchapter I of
15 chapter 57 of title 5, United States Code, while
16 away from their homes or regular places of business
17 in the performance of services for the Committee.

18 (j) REPORTS.—The Committee shall submit to the
19 Secretary, the Committee on Transportation and Infra-
20 structure of the House of Representatives, and the Com-
21 mittee on Commerce, Science, and Transportation of the
22 Senate a report upon completion of each tasking summa-
23 rizing the Committee's—

24 (1) findings and associated recommendations to
25 improve the advancement of women in aviation; and

1 (2) planned activities of the Committee, as
2 tasked by the Secretary, and proposed terms of work
3 to fulfill each activity.

4 (k) SUNSET.—The Committee shall terminate on the
5 last day of the 8-year period beginning on the date of the
6 initial appointment of the members of the Committee.

7 (l) FAA DEFINED.—In this section, the term “FAA”
8 means the Federal Aviation Administration.

9 **SEC. 308. ESTABLISHING A COMPREHENSIVE WEB-BASED**
10 **AVIATION RESOURCE CENTER.**

11 (a) IN GENERAL.—Not later than 1 year after the
12 date of enactment of this Act, the Administrator of the
13 Federal Aviation Administration shall partner with the
14 National Center for the Advancement of Aerospace (in
15 this section referred to as the “Center”) to establish a
16 high-quality, web-based resource center that provides
17 stream-lined public access to information sources on the
18 following:

19 (1) Aviation pathway programs and professional
20 development opportunities.

21 (2) Aviation apprenticeship, scholarship, and in-
22 ternship programs.

23 (3) Aviation-related curricula and resources
24 about aviation occupations and career pathways de-

1 veloped for students, teachers, and guidance coun-
2 selors at all levels of education.

3 (4) Aviation industry organizations.

4 (b) LEVERAGING FAA EDUCATION, RESEARCH, AND
5 PARTNERSHIP PROGRAMS.—In carrying out subsection
6 (a)(3), the Administrator and the Executive Director of
7 the Center, in partnership with museums, nonprofit orga-
8 nizations, and commercial entities, shall, to the maximum
9 extent practicable, leverage field and regional offices of the
10 Federal Aviation Administration, the Mike Monroney
11 Aeronautical Center, the William J. Hughes Technical
12 Center for Advanced Aerospace, Air Transportation Cen-
13 ters of Excellence, and the Aviation and Space Education
14 program of the Federal Aviation Administration to develop
15 an array of educational and informative aviation-related
16 educational activities and materials for students of varying
17 ages and levels of education to use in the classroom, for
18 after-school programs and at home.

19 (c) BRIEFING.—Not later than 2 year after the date
20 of the enactment of this Act, the Administrator shall brief
21 the Committee on Transportation and Infrastructure of
22 the House of Representatives and the Committee on Com-
23 merce, Science, and Technology of the Senate on—

24 (1) the web-based aviation resource center es-
25 tablished under subsection (a); and

1 (2) the manner in which the education develop-
2 ment and engagement activities of the Federal Avia-
3 tion Administration are organized and funded.

4 **SEC. 309. DIRECT HIRE AUTHORITY FROM UAS COLLE-**
5 **GIATE TRAINING INITIATIVE.**

6 (a) **IN GENERAL.**—The Administrator of the Federal
7 Aviation Administration may hire individuals from eligible
8 institutions of higher education under the Unmanned Air-
9 craft System Collegiate Training Initiative (in this section
10 referred to as “UAS CTI”), as established in section 632
11 of the FAA Reauthorization Act of 2018 (49 U.S.C.
12 40101 note), without regard to—

13 (1) sections 3309 through 3318 of title 5,
14 United States Code;

15 (2) part 211 of title 5, Code of Federal Regula-
16 tions; or

17 (3) subpart A of part 337 of title 5, Code of
18 Federal Regulations.

19 (b) **ELIGIBILITY.**—Individuals eligible for employ-
20 ment by the Administrator under subsection (a) shall—

21 (1) be in good standing or have graduated in
22 good standing from an institution of higher edu-
23 cation with a signed memorandum of understanding
24 under the UAS CTI;

1 (2) hold or have completed the majority of a re-
2 lated Bachelors or Associates degree, as described by
3 the eligibility requirements of the UAS CTI;

4 (3) have completed all requirements for a re-
5 lated minor, concentration, or certificate, as de-
6 scribed by the eligibility requirements of the UAS
7 CTI; or

8 (4) meet any other criteria as considered appro-
9 priate by the Administrator.

10 (c) DEFINITIONS.—In this section:

11 (1) INSTITUTION OF HIGHER EDUCATION.—The
12 term “institution of higher education” has the
13 meaning given such term in section 101 of the High-
14 er Education Act of 1965 (20 U.S.C. 1001).

15 (2) GOOD STANDING.—The term “good stand-
16 ing” means in good standing, as determined by the
17 applicable institution of higher education.

18 (d) SUNSET.—The authority of the Administrator
19 under this section shall terminate on September 30, 2028.

20 **Subtitle B—Improving Training**
21 **and Rebuilding Talent Pipelines**

22 **SEC. 311. JOINT AVIATION EMPLOYMENT TRAINING WORK-**
23 **ING GROUP.**

24 (a) ESTABLISHMENT.—Not later than 120 days after
25 the date of enactment of this Act, the Secretary of Trans-

1 portation shall establish an interagency working group (in
2 this section referred to as the “working group”) to advise
3 the Secretary of Transportation and the Secretary of De-
4 fense on matters and policies related to the training and
5 certification of a covered aviation professional to improve
6 career transition between the military and civilian
7 workforces.

8 (b) MEMBERSHIP.—

9 (1) IN GENERAL.—The working group shall
10 consist of—

11 (A) 2 co-chairs described in paragraph (2);

12 (B) not less than 6 representatives of the
13 Federal Aviation Administration, to be ap-
14 pointed by the co-chair described in paragraph
15 (2)(A); and

16 (C) not less than 1 representative of each
17 component of the armed forces (as such term is
18 defined in section 101 of title 10, United States
19 Code), to be appointed by the co-chair described
20 in paragraph (2)(B).

21 (2) CO-CHAIRS.—The working group shall be
22 co-chaired by—

23 (A) a representative of the Department of
24 Transportation, to be appointed by the Sec-
25 retary of Transportation; and

1 (B) a representative of the Department of
2 Defense, to be appointed by the Secretary of
3 Defense.

4 (c) ACTIVITIES.—The working group shall—

5 (1) evaluate and compare all regulatory require-
6 ments, guidance, and orders affecting covered avia-
7 tion professionals and identify challenges that inhibit
8 recruitment, training, and retention within the re-
9 spective workforces of such professionals; and

10 (2) assess appropriate areas for increased inter-
11 agency information sharing and harmonization
12 across workforces on matters related to certification
13 pathways and certification requirements, including
14 knowledge testing, affecting covered aviation profes-
15 sionals.

16 (d) INITIAL REPORT TO CONGRESS.—

17 (1) IN GENERAL.—Not later than 1 year after
18 the date on which the Secretary of Transportation
19 establishes the working group, the working group
20 shall submit to the appropriate committees of Con-
21 gress an initial report on the activities of the work-
22 ing group.

23 (2) CONTENTS.—The report required under
24 paragraph (1) shall include—

1 (A) a detailed description of the findings of
2 the working group pursuant to the activities re-
3 quired under subsection (c); and

4 (B) recommendations for regulatory, pol-
5 icy, or legislative action to improve the training
6 and certification of covered aviation profes-
7 sionals across the civilian and military
8 workforces.

9 (e) ANNUAL REPORTING.—Not later than 1 year
10 after the date on which the working group submits the
11 initial report under subsection (d), and annually there-
12 after, the working group shall submit to the appropriate
13 committees of Congress a report—

14 (1) describing the continued activities of the
15 working group;

16 (2) describing any progress made by the Sec-
17 retary of Transportation or Secretary of Defense in
18 implementing the recommendations described in sub-
19 section (d)(2)(B); and

20 (3) containing any other recommendations the
21 working group may have with respect to efforts to
22 improve the employment and training of covered
23 aviation professionals in the civilian and military
24 workforces.

1 (f) SUNSET.—The working group shall terminate on
2 the date that is 4 years after the date on which the work-
3 ing group submits the initial report to Congress pursuant
4 to subsection (d).

5 (g) DEFINITIONS.—In this section:

6 (1) APPROPRIATE COMMITTEES OF CON-
7 GRESS.—The term “appropriate committees of Con-
8 gress” means—

9 (A) the Committee on Armed Services of
10 the House of Representatives;

11 (B) the Committee on Armed Services of
12 the Senate;

13 (C) the Committee on Transportation and
14 Infrastructure of the House of Representatives;
15 and

16 (D) the Committee on Commerce, Science,
17 and Transportation of the Senate.

18 (2) COVERED AVIATION PROFESSION.—The
19 term “covered aviation professional” means—

20 (A) an airman;

21 (B) an aircraft maintenance and repair
22 technician;

23 (C) an air traffic controller; and

24 (D) any other aviation-related professional
25 that has comparable tasks and duties across the

1 civilian and military workforces, as determined
2 jointly by the co-chairs of the working group.

3 **SEC. 312. AIRMAN KNOWLEDGE TESTING WORKING GROUP.**

4 (a) WORKING GROUP.—Not later than 180 days after
5 the date of enactment of this Act, the Administrator of
6 the Federal Aviation Administration shall task the Avia-
7 tion Rulemaking Advisory Committee to establish a work-
8 ing group to review knowledge testing processes and proce-
9 dures to improve the facilitation, administration, and ac-
10 cessibility of knowledge tests.

11 (b) ACTIVITIES.—The working group established pur-
12 suant to subsection (a) shall—

13 (1) assess methods to increase knowledge test-
14 ing capacity, including through—

15 (A) the adoption of alternative proctoring
16 methods; and

17 (B) increased utilization of pilot schools
18 that hold a pilot school certificate under part
19 141 of title 14, Code of Federal Regulations,
20 and aviation maintenance technician schools
21 governed under part 147 of title 14, Code of
22 Federal Regulations; and

23 (2) evaluate the following:

24 (A) The management and provision of
25 knowledge tests by testing centers.

1 (B) The testing registration process for
2 students.

3 (C) Student access to knowledge tests.

4 (D) Fees associated with knowledge tests.

5 (E) The accuracy of public sample knowl-
6 edge tests available to students.

7 (F) Development and maintenance of
8 knowledge tests and forms.

9 (c) MECHANIC GENERAL KNOWLEDGE TEST.—In
10 addition to the activities under subsection (b), the Aviation
11 Rulemaking Advisory Committee shall task the working
12 group established pursuant to subsection (a) with assess-
13 ing opportunities to allow a high school student upon suc-
14 cessful completion of an aviation maintenance curriculum
15 to take the general written knowledge portion of the me-
16 chanic exam described in section 65.75 of title 14, Code
17 of Federal Regulations, at an Administration-approved
18 testing center.

19 (d) REPORT.—Not later than 18 months after the
20 Aviation Rulemaking Advisory Committee tasks the work-
21 ing group under subsection (a), the working group shall
22 submit to the Administrator a final report making rec-
23 ommendations to improve the facilitation, administration,
24 and accessibility of knowledge tests.

25 (e) DEFINITIONS.—In this section:

1 (1) HIGH SCHOOL.—The term “high school”
2 has the meaning given such term in section 8101 of
3 the Elementary and Secondary Education Act of
4 1965 (20 U.S.C. 7801).

5 (2) KNOWLEDGE TEST.—The term “knowledge
6 test” means a test prescribed under parts 61 and 65
7 of title 14, Code of Federal Regulations.

8 (3) SECONDARY SCHOOL.—The term “sec-
9 ondary school” has the meaning given such term in
10 section 8101 of the Elementary and Secondary Edu-
11 cation Act of 1965 (20 U.S.C. 7801).

12 **SEC. 313. AIRMAN CERTIFICATION SYSTEM WORKING**
13 **GROUP AND TIMELY PUBLICATION OF**
14 **STANDARDS.**

15 (a) WORKING GROUP.—The Administrator of the
16 Federal Aviation Administration shall task the Airman
17 Certification System Working Group established under the
18 Aviation Rulemaking Advisory Committee of the Adminis-
19 tration to review Airman Certification Standards to ensure
20 that airman proficiency and knowledge correlates and cor-
21 responds to regulations, procedures, equipment, aviation
22 infrastructure, and safety trends at the time of such re-
23 view.

24 (b) ACS PUBLICATION.—Not later than 180 days
25 after the date of enactment of this Act, the Administrator

1 of the Federal Aviation Administration shall publish on
2 the website of the Administration—

3 (1) the process by which the Airman Certifi-
4 cation Standards are to be established, updated, and
5 maintained;

6 (2) the process by which relevant guidance doc-
7 uments, handbooks, and test materials associated
8 with such standards are to be established, updated,
9 and maintained; and

10 (3) any anticipated or required updates to such
11 standards, including providing a date by which such
12 modifications can be expected to be completed and
13 made available to the public.

14 **SEC. 314. AIR TRAFFIC CONTROL WORKFORCE STAFFING.**

15 (a) RESPONSIBILITY FOR CONTROLLER WORKFORCE
16 PLAN.—

17 (1) AIR TRAFFIC CONTROLLER STAFFING INI-
18 TIATIVES AND ANALYSIS.—Section 221 of the Vision
19 100–Century of Aviation Reauthorization Act (49
20 U.S.C. 44506 note) is amended by striking “Admin-
21 istrator of the Federal Aviation Administration” and
22 inserting “Chief Operating Officer of the Air Traffic
23 Organization of the Federal Aviation Administra-
24 tion”.

1 (2) STAFFING REPORT.—Section 44506(e) of
2 title 49, United States Code, is amended in the mat-
3 ter before paragraph (1) by striking “Administrator
4 of the Federal Aviation Administration” and insert-
5 ing “Chief Operating Officer of the Air Traffic Or-
6 ganization of the Federal Aviation Administration”.

7 (b) MAXIMUM HIRING.—Subject to the availability of
8 appropriations, for each of fiscal years 2024 through
9 2027, the Administrator of the Federal Aviation Adminis-
10 tration shall set as the hiring target for new air traffic
11 controllers (excluding individuals described in section
12 44506(f)(1)(A) of title 49, United States Code) the max-
13 imum number of individuals able to be trained at the Fed-
14 eral Aviation Administration Academy.

15 (c) HIRING AND STAFFING.—The Chief Operating
16 Officer of the Federal Aviation Administration shall revise
17 the air traffic control hiring plans and staffing standards
18 of the Administration to—

19 (1) provide that the controller and management
20 workforce is adequately staffed to safely and effi-
21 ciently manage and oversee the air traffic control
22 system to the satisfaction of the Chief Operating Of-
23 ficer;

1 (2) account for the target number of certified
2 professional controllers able to control traffic at each
3 independent facility; and

4 (3) avoid any required or requested reduction of
5 national airspace system capacity or aircraft oper-
6 ations as a result of inadequate air traffic control
7 system staffing.

8 (d) INTERIM ADOPTION OF COLLABORATIVE RE-
9 SOURCE WORKGROUP MODELS.—

10 (1) IN GENERAL.—In carrying out subsection
11 (e) and in submitting a Controller Workforce Plan
12 of the Administration published after the date of en-
13 actment of this Act, the Chief Operating Officer
14 shall adopt and utilize the staffing models and meth-
15 odologies developed by the Collaborative Resource
16 Workgroup that were recommended in a report sub-
17 mitted to the Administrator and referenced in the
18 Controller Workforce Plan submitted to Congress on
19 May 5, 2023.

20 (2) SUNSET.—The requirement under para-
21 graph (1) shall cease to be effective upon the adop-
22 tion of a staffing model required under subsection
23 (f).

24 (e) ASSESSMENT.—

1 (1) REVIEW.—Not later than 180 days after
2 the date of enactment of this Act, the Administrator
3 shall enter into an agreement with the Transpor-
4 tation Research Board to—

5 (A) compare the Administration’s staffing
6 models and methodologies in determining staff-
7 ing standards targets with those developed by
8 the Collaborative Resource Workgroup, includ-
9 ing—

10 (ii) the availability factor multiplier
11 and other formula components; and

12 (iii) the independent facility staffing
13 targets of certified professional controllers
14 able to control traffic; and

15 (B) assess future needs of the air traffic
16 control system and potential impacts on staffing
17 standards.

18 (2) REPORT.—

19 (A) FINDINGS.—In carrying out this sub-
20 section, the Transportation Research Board
21 shall—

22 (i) report to the Administrator and
23 Congress on the findings of the review
24 under this subsection; and

1 (ii) determine which staffing models
2 and methodologies best accounts for the
3 operational staffing needs of the air traffic
4 control system and provide a justification
5 for such determination.

6 (B) MODIFICATIONS TO IDENTIFIED
7 MODEL.—The Transportation Research Board
8 may make recommendations to improve the
9 staffing model described in (2)(A)(ii).

10 (3) CONSULTATION.—In conducting the assess-
11 ment under this subsection, the Transportation Re-
12 search Board shall consult with—

13 (A) exclusive bargaining representatives of
14 air traffic controllers certified under section
15 7111 of title 5, United States Code;

16 (B) Administration officials and executives;

17 (C) front line managers of the air traffic
18 control system;

19 (D) managers and employees responsible
20 for training air traffic controllers;

21 (E) the MITRE Corporation;

22 (F) the Chief Operating Officer of the Air
23 Traffic Organization of the Federal Aviation
24 Administration; and

25 (G) users of the air traffic control system.

1 (f) REQUIRED IMPLEMENTATION OF IDENTIFIED
2 STAFFING MODEL.—The Administrator shall take such
3 action that may be necessary to adopt and utilize the staff-
4 ing model identified by the Transportation Research
5 Board pursuant to subsection (e)(2)(A)(ii), including any
6 recommendations for improving such model.

7 (g) CONTROLLER TRAINING.—In any Controller
8 Workforce Plan of the Administration published after the
9 date of enactment of this Act, the Chief Operating Officer
10 shall—

11 (1) identify all limiting factors on the Adminis-
12 tration’s ability to hire and train controllers in line
13 with the staffing standards target set out in such
14 Plan; and

15 (2) describe what actions the Administration
16 will take to rectify any impediments to meeting
17 staffing standards targets and identify contributing
18 factors that are outside the control of the Adminis-
19 tration.

20 **SEC. 315. AVIATION SAFETY WORKFORCE ASSESSMENT.**

21 (a) IN GENERAL.—The Administrator of the Federal
22 Aviation Administration shall assess, on a recurring basis,
23 staffing levels, critical competencies, and skills gaps of
24 safety critical positions in the Flight Standards Service

1 and Aircraft Certification Service and within other offices
2 of the Administration that support such services.

3 (b) CONSIDERATIONS.—In completing the assessment
4 described in subsection (a), the Administrator shall—

5 (1) evaluate the workload at the time of the as-
6 sessment, historic workload, and estimated future
7 workload of such personnel;

8 (2) conduct a critical competency and skills gap
9 analysis to determine the knowledge and skill sets
10 needed for work at the time of the assessment and
11 anticipated work, with an emphasis on work per-
12 taining to—

13 (A) new and novel aircraft propulsion and
14 power methods;

15 (B) simplified vehicle operations and
16 human factors; and

17 (C) autonomy, machine learning, and arti-
18 ficial intelligence;

19 (3) compare the outcome of such analysis de-
20 scribed in paragraph (2) to the competency and
21 skills of the workforce at the time of the assessment;
22 and

23 (4) review opportunities for employees of the
24 Administration to gain or enhance expertise, knowl-
25 edge, skills, and abilities through cooperative train-

1 ing with appropriate companies and organizations;
2 and

3 (5) develop hiring and recruitment plans to—

4 (A) address hard to fill positions; and

5 (B) address competency and skill gaps at
6 various levels of experience and management
7 within Flight Standards Service and Aircraft
8 Certification Service.

9 (c) REPORT.—Upon completion of an assessment de-
10 scribed in subsection (a), the Administrator shall submit
11 to the Committee on Transportation and Infrastructure
12 of the House of Representatives and the Committee on
13 Commerce, Science, and Transportation of the Senate a
14 report detailing the following:

15 (1) The methodology and findings of the assess-
16 ment described in subsection (a), including an anal-
17 ysis of hiring authorities of the Administration at
18 the time of the assessment, including direct hiring
19 authorities, by occupation series for inspector, engi-
20 neer, and other safety critical positions within Flight
21 Standards Service and Aircraft Certification Service.

22 (2) Action based recommendations the Adminis-
23 tration can take to improve—

24 (A) the Aviation Safety Workforce Plan;

1 (B) the skill sets and competencies of in-
2 spectors, engineers, and other safety critical po-
3 sitions at the time of the assessment;

4 (C) competition with industry and other
5 non-aviation sectors for candidates with identi-
6 fied competencies and technical skill sets; and

7 (D) overall hiring and retention of inspec-
8 tors, engineers, and other critical positions.

9 (3) Actions Congress can take to improve the
10 recruitment, hiring, upskilling, and retention of in-
11 spectors, engineers, and other safety critical posi-
12 tions in Flight Standards Service and Aircraft Cer-
13 tification Service and within other offices of the Ad-
14 ministration that support such services.

15 (d) SAFETY CRITICAL POSITION DEFINED.—In this
16 section, the term “safety critical position” means—

17 (1) an aviation safety inspector, an aviation
18 safety specialist (denoted by the Administration as
19 1801 series), an aviation safety technician, and an
20 operations support position in the Flight Standards
21 Service; and

22 (2) a manufacturing safety inspector, a pilots,
23 an engineer, a Chief Scientist Technical Advisor, an
24 aviation safety specialist (denoted by the Adminis-
25 tration as 1801 series), a safety technical specialist,

1 and an operational support position in the Aircraft
2 Certification Service.

3 **SEC. 316. MILITARY AVIATION MAINTENANCE.**

4 (a) STREAMLINED CERTIFICATION FOR ELIGIBLE
5 MILITARY MAINTENANCE TECHNICIANS.—Not later than
6 1 year after the interagency working group in section 311
7 of this Act is convened, the Administrator of the Federal
8 Aviation Administration shall task such working group
9 with evaluating the appropriateness of revising part 65 of
10 title 14, Code of Federal Regulations, to—

11 (1) create a mechanic written competency test
12 for eligible military maintenance technicians;

13 (2) develop, as necessary, a relevant Airman
14 Certification Standard to qualify eligible military
15 maintenance technicians for a mechanic certificate
16 issued by the Federal Aviation Administration with
17 an airframe rating or a powerplant rating, or both;
18 and

19 (3) allow a certificate of eligibility from the
20 Joint Services Aviation Maintenance Technician Cer-
21 tification Council (in this section referred to as the
22 “JSAMTCC”) evidencing completion of a training
23 curriculum for any rating sought to serve as a sub-
24 stitute to fulfill the requirement under such part 65
25 for oral and practical tests administered by a des-

1 igned mechanic examiner for eligible military
2 maintenance technicians.

3 (b) FINAL RULE.—If the working group finds that
4 revising part 65 of title 14, Code of Federal Regulations,
5 as described in section (a) is appropriate, not later than
6 1 year after the finding, the Administrator shall issue a
7 final rule that revises part 65 of title 14, Code of Federal
8 Regulations, as described in subsection (a).

9 (c) AERONAUTICAL KNOWLEDGE SUBJECT AREAS.—

10 (1) IN GENERAL.—The military mechanic writ-
11 ten competency test and Airman Certification Stand-
12 ard described in subsection (a)(1) and subsection
13 (a)(2), respectively, shall focus on the aeronautical
14 knowledge subject areas contained in the Aviation
15 Mechanic General, Airframe, and Powerplant Air-
16 man Certificate Standards, as appropriate to the
17 rating sought.

18 (2) IDENTIFICATION OF SUBJECT AREAS.—The
19 aeronautical knowledge subject areas described in
20 paragraph (1) shall be identified in consultation with
21 industry stakeholders and the Airman Certification
22 System Working Group.

23 (d) EXPANSION OF TESTING LOCATIONS.—The
24 interagency working group described in subsection (a)
25 shall determine whether an expansion of the number of

1 active testing locations operated within military installa-
2 tion testing centers would increase access to testing, as
3 well as how to implement such expansion.

4 (e) **OUTREACH AND AWARENESS.**—The interagency
5 working group described in subsection (a) shall develop a
6 plan to increase outreach and awareness regarding—

7 (1) the services made available by the
8 JSAMTCC; and

9 (2) the military mechanic written competency
10 test described in subsection (a), if appropriate.

11 (f) **ELIGIBLE MILITARY MAINTENANCE TECHNICIAN**
12 **DEFINED.**—In this section, the term “eligible military
13 maintenance technician” means an individual who is a
14 current or former military aviation maintenance techni-
15 cian who was honorably discharged or has retired from
16 the armed forces (as such term is defined in section 101
17 of title 10, United States Code).

18 **Subtitle C—Engaging and** 19 **Retaining the Workforce**

20 **SEC. 321. AIRMAN’S MEDICAL BILL OF RIGHTS.**

21 (a) **IN GENERAL.**—

22 (1) **DEVELOPMENT.**—Not later than 1 year
23 after the date of enactment of this Act, the Adminis-
24 trator of the Federal Aviation Administration shall
25 develop a document (in this section referred to as

1 the “Airman’s Medical Bill of Rights”) detailing the
2 right of an individual before, during, and after a
3 medical exam conducted by an Aviation Medical Ex-
4 aminer.

5 (2) CONTENTS.—The Airman’s Medical Bill of
6 Rights required under paragraph (1) shall, at a min-
7 imum, contain information about the right of an in-
8 dividual to—

9 (A) bring a trusted companion or request
10 to have a chaperone present for a medical
11 exam;

12 (B) terminate an exam at any time and for
13 any reason;

14 (C) receive care with respect and recogni-
15 tion of the dignity of the individual;

16 (D) be assured of privacy and confiden-
17 tiality;

18 (E) select an Aviation Medical Examiner
19 without interference;

20 (F) privacy when changing, undressing,
21 and using the restroom;

22 (G) ask questions about the health status
23 of the individual or any suggested treatments or
24 evaluations, and to have such questions fully
25 answered;

1 (H) report an incident of misconduct by an
2 Aviation Medical Examiner to the appropriate
3 authorities, including to the State licensing
4 board of the Aviation Medical Examiner or the
5 Federal Aviation Administration;

6 (I) report to the Administrator an allega-
7 tion regarding alleged Aviation Medical Exam-
8 iner misconduct without fear of retaliation or
9 negative action relating to an airman certificate
10 of the individual; and

11 (J) be advised of any known conflicts of in-
12 terest an Aviation Medical Examiner may have
13 with respect to the care of the individual.

14 (3) PUBLIC AVAILABILITY.—The Airman’s
15 Medical Bill of Rights required under paragraph (1)
16 shall be—

17 (A) made available to, and acknowledged
18 by, an individual in the MedXpress system;

19 (B) made available in a hard-copy format
20 by an Aviation Medical Examiner at the time of
21 exam upon request by an individual; and

22 (C) displayed in a common space in the of-
23 fice of the Aviation Medical Examiner.

24 (b) EXPECTATIONS FOR MEDICAL EXAMINATIONS.—

1 (1) IN GENERAL.—Not later than 1 year after
2 the date of enactment of this Act, the Administrator
3 shall develop a simplified document explaining the
4 standard procedures performed during a medical ex-
5 amination conducted by an Aviation Medical Exam-
6 iner.

7 (2) PUBLIC AVAILABILITY.—The document re-
8 quired under paragraph (1) shall be—

9 (A) made available to, and acknowledged
10 by, an individual in the MedXpress system;

11 (B) made available in a hard-copy format
12 by an Aviation Medical Examiner at the time of
13 exam upon request by an individual; and

14 (C) displayed in a common space in the of-
15 fice of the Aviation Medical Examiner.

16 **SEC. 322. IMPROVED DESIGNEE MISCONDUCT REPORTING**
17 **PROCESS.**

18 (a) IMPROVED DESIGNEE MISCONDUCT REPORTING
19 PROCESS.—

20 (1) IN GENERAL.—Not later than 1 year after
21 the date of enactment of this Act, the Administrator
22 of the Federal Aviation Administration shall estab-
23 lish a streamlined process for individuals involved in
24 incidents of alleged misconduct by a designee to re-

1 port such incidents in a manner that protects the
2 privacy and confidentiality of such individuals.

3 (2) PUBLIC ACCESS TO REPORTING PROCESS.—

4 The process for reporting alleged misconduct by a
5 designee shall be made available to the public on the
6 website of the Administration, including—

7 (A) the designee locator search webpage;

8 and

9 (B) the webpage of the Office of Audit and
10 Evaluation of the Federal Aviation Administra-
11 tion.

12 (3) OBLIGATION TO REPORT CRIMINAL

13 CHARGES.—Not later than 90 days after the date of

14 enactment of this Act, the Administrator shall revise

15 the orders and policies governing the Designee Man-

16 agement System to clarify that designees are obli-

17 gated to report any arrest, indictment, or conviction

18 for violation of a local, State, or Federal law within

19 a period of time specified by the Administrator.

20 (4) AUDIT OF REPORTING PROCESS BY INSPEC-

21 TOR GENERAL.—

22 (A) IN GENERAL.—Not later than 3 years

23 after the date on which the Administrator final-

24 izes the update of the reporting process under

25 paragraph (1), the inspector general of the De-

1 partment of Transportation shall conduct an
2 audit of such reporting process.

3 (B) CONTENTS.—In conducting the audit
4 of the reporting process described in subpara-
5 graph (A), the inspector general shall, at a min-
6 imum—

7 (i) review the efforts of the Adminis-
8 tration to improve the reporting process
9 and solutions developed to respond to and
10 investigate allegations of misconduct;

11 (ii) analyze reports of misconduct
12 brought to the Administrator prior to any
13 changes made to the reporting process as
14 a result of the enactment of this Act, in-
15 cluding the ultimate outcomes of those re-
16 ports and whether any reports resulted in
17 the Administrator taking action against
18 the accused designee;

19 (iii) determine whether the reporting
20 process results in appropriate action, in-
21 cluding reviewing, investigating, and clos-
22 ing out reports; and

23 (iv) if applicable, make recommenda-
24 tions to improve the reporting process.

1 (C) REPORT.—Not later than 1 year after
2 the date of initiation of the audit described in
3 subparagraph (A), the inspector general shall
4 submit to the Committee on Transportation and
5 Infrastructure of the House of Representatives
6 and the Committee on Commerce, Science, and
7 Transportation of the Senate a report on the
8 results of such audit, including findings and
9 recommendations.

10 (b) DESIGNEE DEFINED.—In this section, the term
11 “designee” means an individual who has been designated
12 to act as a representative of the Administrator as—

13 (1) an Aviation Medical Examiner (as described
14 in section 183.21 of title 14, Code of Federal Regu-
15 lations);

16 (2) a pilot examiner (as described in section
17 183.23 of such title); or

18 (3) a technical personnel examiner (as described
19 in section 183.25 of such title).

20 **SEC. 323. REPORT ON SAFE UNIFORM OPTIONS FOR CER-**
21 **TAIN AVIATION EMPLOYEES.**

22 (a) IN GENERAL.—The Administrator of the Federal
23 Aviation Administration shall conduct a review to deter-
24 mine whether air carriers operating under part 121 of title
25 14, Code of Federal Regulations, and repair stations cer-

1 tificated under part 145 of such title have in place uniform
2 policies and uniform offerings that ensure pregnant em-
3 ployees can perform required duties safely.

4 (b) CONSULTATION.—In conducting the review re-
5 quired under subsection (a), the Administrator shall con-
6 sult with air carriers and repair stations described in sub-
7 section (a) and employees of such air carriers and such
8 stations who are required to adhere to a uniform policy.

9 (c) BRIEFING.—Not later than 2 years after the date
10 of enactment of this Act, the Administrator shall brief the
11 Committee on Transportation and Infrastructure of the
12 House of Representatives and the Committee on Com-
13 merce, Science, and Transportation of the Senate on the
14 results of the review required under subsection (a).

15 **SEC. 324. EXTENSION OF SAMYA ROSE STUMO NATIONAL**
16 **AIR GRANT FELLOWSHIP PROGRAM.**

17 Section 131(d) of the Aircraft Certification, Safety,
18 and Accountability Act (49 U.S.C. 40101 note) is amend-
19 ed by striking “fiscal years 2021 through 2025” and in-
20 serting “fiscal years 2023 through 2028”.

21 **SEC. 325. PROMOTION OF CIVIL AERONAUTICS AND SAFETY**
22 **OF AIR COMMERCE.**

23 Section 40104 of title 49, United States Code, is
24 amended—

1 (1) in subsection (a) by striking “In carrying
2 out” and all that follows through “other interested
3 organizations.”;

4 (2) by redesignating subsection (d) as sub-
5 section (e);

6 (3) by redesignating subsection (b) as sub-
7 section (d); and

8 (4) by redesignating subsection (c) as sub-
9 section (b) and reordering the subsections accord-
10 ingly.

11 **SEC. 326. EDUCATIONAL AND PROFESSIONAL DEVELOP-**
12 **MENT.**

13 Section 40104 of title 49, United States Code, is fur-
14 ther amended by inserting after subsection (b) (as redesign-
15 ated by section 325) the following:

16 “(c) **EDUCATIONAL AND PROFESSIONAL DEVELOP-**
17 **MENT.—**

18 “(1) **IN GENERAL.—**In carrying out subsection
19 (a), the Administrator shall support and undertake
20 efforts, including through the National Center for
21 the Advancement of Aerospace, to promote and sup-
22 port the education of current and future aerospace
23 professionals.

24 “(2) **EDUCATION MATERIALS.—**Based on the
25 availability of resources, the Administrator shall dis-

1 tribute civil aviation information, and educational
2 materials, and provide expertise to State and local
3 school administrators, college and university offi-
4 cials, and officers of other interested organizations
5 and entities.

6 “(3) SUPPORT FOR PROFESSIONAL DEVELOP-
7 MENT AND CONTINUING EDUCATION.—To the extent
8 a nonprofit organization, association, industry
9 group, educational institution, collective bargaining
10 unit, governmental organization, or other entity that
11 organizes or hosts a lecture, conference, convention,
12 meeting, round table, or any other type of program
13 with the purpose of sharing educational information
14 related to aerospace with a broad audience, the Ad-
15 ministrator shall—

16 “(A) strongly consider accepting an invita-
17 tion to attend, present, and contribute to con-
18 tent generation; and

19 “(B) make efforts to share information
20 each year, putting a particular emphasis on
21 reaching audiences consisting of representatives
22 of the Administrator and entities regulated en-
23 tities by the Administrator.

24 “(4) CONTENT.—In planning for the opportuni-
25 ties under paragraph (3), the Administrator shall

1 maintain presentations and content covering topics
2 of broad relevance, including—

3 “(A) ethical decision-making and the re-
4 sponsibilities of aerospace professionals;

5 “(B) managing a workforce, encouraging
6 proper reporting of prospective safety issues,
7 and educating employees on safety management
8 systems; and

9 “(C) responsibilities as a designee or rep-
10 resentative of the Administrator.”.

11 **SEC. 327. HUMAN FACTORS PROFESSIONALS.**

12 The Administrator of the Federal Aviation Adminis-
13 tration shall establish a new work code for human factors
14 professionals who—

15 (1) perform work involving the design and test-
16 ing of technologies, processes, and systems which re-
17 quire effective and safe human performance;

18 (2) generate and apply theories, principles,
19 practical concepts, systems, and processes related to
20 the design and testing of technologies, systems, and
21 training programs to support and evaluate human
22 performance in work contexts; and

23 (3) meet education or experience requirements
24 as determined by the Administrator.

1 **SEC. 328. AEROMEDICAL INNOVATION AND MODERNIZA-**
2 **TION WORKING GROUP.**

3 (a) ESTABLISHMENT.—Not later than 180 days after
4 the date of enactment of this Act, the Administrator of
5 the Federal Aviation Administration shall establish a
6 working group (in this section referred to as the “working
7 group”) to review the medical processes, policies, and pro-
8 cedures of the Administration and to make recommenda-
9 tions to the Administrator on modernizing such processes,
10 policies, and procedures to ensure timely and efficient cer-
11 tification of airmen.

12 (b) MEMBERSHIP.—

13 (1) IN GENERAL.—The working group shall
14 consist of—

15 (A) 2 co-chairs described in paragraph (2);

16 and

17 (B) not less than 15 individuals appointed
18 by the Administrator, each of whom shall have
19 knowledge or a background in aerospace medi-
20 cine, psychology, neurology, cardiology, or inter-
21 nal medicine.

22 (2) CO-CHAIRS.—The working group shall be
23 co-chaired by—

24 (A) the Federal Air Surgeon of the Fed-
25 eral Aviation Administration; and

1 (B) a member described under paragraph
2 (1)(A) to be selected by members of the work-
3 ing group.

4 (3) PREFERENCE.—The Administrator, in ap-
5 pointing members pursuant to paragraph (1)(B),
6 shall give preference to—

7 (A) Aviation Medical Examiners (as de-
8 scribed in section 183.21 of title 14, Code of
9 Federal Regulations);

10 (B) licensed medical physicians;

11 (C) practitioners holding a pilot certificate;

12 (D) individuals having demonstrated re-
13 search and expertise in aeromedical research or
14 sciences; and

15 (E) representatives of organizations with
16 memberships affected by the medical processes,
17 policies, and procedures of the Administration.

18 (c) ACTIVITIES.—In reviewing the aeromedical deci-
19 sion-making processes, policies, and procedures of the Ad-
20 ministration in accordance with subsection (a), the work-
21 ing group, at a minimum, shall—

22 (1) assess the medical conditions an Aviation
23 Medical Examiner may issue a medical certificate di-
24 rectly to an individual;

- 1 (2) determine the appropriateness of expanding
2 the list of such medical conditions;
- 3 (3) assess the special issuance process;
- 4 (4) determine whether the renewal of a special
5 issuance can be based on a medical evaluation and
6 treatment plan by the treating medical specialist of
7 the individual with concurrence from an Aviation
8 Medical Examiner;
- 9 (5) evaluate advancements in technologies to
10 address forms of red-green color blindness;
- 11 (6) determine whether such technologies may be
12 approved for use by airmen;
- 13 (7) review policies and guidance relating to At-
14 tention-Deficit Hyperactivity Disorder and Attention
15 Deficit Disorder;
- 16 (8) evaluate whether medications used to treat
17 such disorders may be safely prescribed to an air-
18 man;
- 19 (9) review protocols pertaining to the Human
20 Intervention Motivation Study of the Federal Avia-
21 tion Administration;
- 22 (10) review protocols and policies relating to—
23 (A) neurological disorders; and

1 (B) cardiovascular conditions to ensure
2 alignment with medical best practices, latest re-
3 search;

4 (11) review mental health protocols, including
5 mental health conditions such as depression and
6 anxiety;

7 (12) evaluate medications approved for treating
8 such mental health conditions;

9 (13) assess processes and protocols pertaining
10 to recertification of an airman receiving disability in-
11 surance post-recovery from the medical condition, in-
12 jury, or disability that precludes an airman from ex-
13 ercising the privileges of an airman certificate; and

14 (14) assess processes and protocols pertaining
15 to the certification of veterans reporting a disability
16 rating from the Department of Veterans Affairs.

17 (d) PILOT MENTAL HEALTH TASK GROUP.—

18 (1) ESTABLISHMENT.—Not later than 120 days
19 after the working group pursuant to subsection (a)
20 is established, the co-chairs of such working groups
21 shall establish a pilot mental health task group (re-
22 ferred to in this subsection as the “task group”) to
23 develop and provide recommendations related to sup-
24 porting the mental health of aircraft pilots.

1 (2) COMPOSITION.—The co-chairs of such
2 working group shall appoint—

3 (A) a Chair of the task group; and

4 (B) members of the task group from
5 among the members of the working group ap-
6 pointed by the Administrator under subsection
7 (b)(1).

8 (3) DUTIES.—The duties of the task group
9 shall include—

10 (A) carrying out the activities described in
11 subsection (c)(11) and subsection (c)(12);

12 (B) reviewing and evaluating guidance
13 issued by the International Civil Aviation Orga-
14 nization on pilot mental health; and

15 (C) providing recommendations for—

16 (i) best practices for detecting, assess-
17 ing, and reporting mental health conditions
18 and treatment options as part of pilot
19 aeromedical assessments;

20 (ii) improving the training of aviation
21 medical examiners to identify mental
22 health conditions among pilots, including
23 guidance on referrals to a mental health
24 provider or other aeromedical resource;

1 (iii) expanding and improving mental
2 health outreach, education, and assistance
3 programs for pilots; and

4 (iv) reducing the stigma of assistance
5 for mental health in the aviation industry.

6 (4) REPORT.—Not later than 2 years after the
7 date of the establishment of the task group, the task
8 group shall submit to the Secretary, the Committee
9 on Transportation and Infrastructure of the House
10 of Representatives, and the Committee on Com-
11 merce, Science, and Transportation of the Senate a
12 report detailing—

13 (A) the results of the review and evalua-
14 tion under paragraph (3)(A); and

15 (B) recommendations developed pursuant
16 to paragraph (3)(C).

17 (d) SUPPORT.—The Administrator shall seek to enter
18 into one or more agreements with the National Academies
19 to support the activities of the working group described
20 in subsection (c).

21 (e) FINDINGS; RECOMMENDATIONS.—

22 (1) FINDINGS.—The working group shall report
23 annually to the Administrator, the Committee on
24 Transportation and Infrastructure of the House of
25 Representatives, and the Committee on Commerce,

1 Science, and Transportation of the Senate on find-
2 ings resulting from the activities carried out pursu-
3 ant to subsection (c).

4 (2) RECOMMENDATIONS.—Findings reported
5 pursuant to paragraph (1) shall be accompanied by
6 recommendations for regulatory, policy, or legislative
7 action to improve or modernize the medical certifi-
8 cation and aeromedical processes, procedures, and
9 policies of the Administration.

10 (f) IMPLEMENTATION.—The Administrator shall im-
11 plement, as appropriate, the recommendations of the
12 working group.

13 (g) SUNSET.—The working group shall terminate on
14 September 30, 2028.

15 **SEC. 329. FRONTLINE MANAGER WORKLOAD STUDY.**

16 (a) IN GENERAL.—Not later than 2 years after the
17 date of enactment of this Act, the Chief Operating Officer
18 of the Air Traffic Organization of the Federal Aviation
19 Administration shall conduct a study on frontline manager
20 workload challenges in air traffic control facilities.

21 (b) CONSIDERATIONS.—In conducting the study re-
22 quired under subsection (a), the Chief Operating Officer
23 may—

24 (1) consider—

25 (A) workload challenges including—

- 1 (i) the managerial tasks expected to
2 be performed by frontline managers, in-
3 cluding employee development, manage-
4 ment, and counseling;
- 5 (ii) the number of supervisory posi-
6 tions of operations requiring watch cov-
7 erage in each air traffic control facility;
- 8 (iii) the complexity of traffic and
9 managerial responsibilities; and
- 10 (iv) proficiency and training require-
11 ments;
- 12 (B) facility type;
- 13 (C) facility staffing levels; and
- 14 (D) any other factors as the Chief Oper-
15 ating Officer considers appropriate; and
- 16 (2) describe recommendations for updates to
17 the Frontline Manager's Quick Reference Guide that
18 reflect current operational standards.
- 19 (c) BRIEFING.—Not later than 3 years after the date
20 of enactment of this Act, the Chief Operating Officer shall
21 brief the Committee on Transportation and Infrastructure
22 of the House of Representatives and the Committee on
23 Commerce, Science, and Transportation of the Senate on
24 the results of the study conducted under subsection (a).

1 **SEC. 330. AGE STANDARDS FOR PILOTS.**

15 be able to receive appropriate emission credits
16 (as described in section 47139), and”;

17 (F) in subparagraph (P) by striking “im-
18 prove the reliability and efficiency of the air-
19 port’s power supply” and inserting “improve re-
20 liability and efficiency of the airport’s power
21 supply or meet current and future electrical
22 power demand”; and

23 (G) by adding at the end the following:

24 “(S) construction or renovation of
25 childcare facilities for the exclusive use of air-

1 port employees or other individuals who work
2 on airport property, including for air carriers

15 “(i) a primary airport; or

16 “(ii) a general aviation airport that is
17 designated as a Federal staging area by
18 the Administrator of the Federal Emer-

20 “(V) any other activity that the Secretary
21 concludes will reasonably improve or contribute
22 to the maintenance of the safety, efficiency, or
23 capacity of the airport.”;

24 (3) in paragraph (5) by inserting after subpara-

1 “(D) assessing current and future elec-
2 trical power demand.”;

5 or to be found in violation of a grant assurance
6 made under this section, or under any other provi-
7 sion of law, as a condition for the receipt of Federal
8 financial assistance for airport development, solely
9 because the sponsor has—

10 “(A) entered into an agreement, including
11 a revised agreement, with a local government
12 providing for the use of airport property for an
13 interim compatible recreational purpose at
14 below fair market value; or

15 “(B) permanently restricted the use of air-
16 port property to compatible recreational and
17 public park use without paying or otherwise ob-
18 taining payment of fair market value for the
19 property.

20 “(2) RESTRICTIONS.—

21 “(A) INTERIM COMPATIBLE REC-
22 REATIONAL PURPOSE.—Paragraph (1) shall
23 apply, with respect to a sponsor that has taken
24 the action described in subparagraph (A) of
25 such paragraph, only—

1 “(i) to an agreement regarding airport
2 property that was initially entered into be-
3 fore the publication of the Federal Aviation
4 Administration’s Policy and Procedures
5 Concerning the Use of Airport Revenue,
6 dated February 16, 1999;

7 “(ii) if the agreement between the
8 sponsor and the local government is subor-
9 dinate to any existing or future agreements
10 between the sponsor and the Secretary, in-
11 cluding agreements related to a grant as-
12 surance under this section;

13 “(iii) to airport property that was ac-
14 quired under a Federal airport develop-
15 ment grant program;

16 “(iv) if the airport sponsor has pro-
17 vided a written statement to the Adminis-
18 trator that the property made available for
19 a recreational purpose will not be needed
20 for any aeronautical purpose during the
21 next 10 years;

22 “(v) if the agreement includes a term
23 of not more than 2 years to prepare the
24 airport property for the interim compatible

1 recreational purpose and not more than 10
2 years of use for that purpose;

3 “(vi) if the recreational purpose will
4 not impact the aeronautical use of the air-
5 port;

6 “(vii) if the airport sponsor provides a
7 certification that the sponsor is not respon-
8 sible for preparation, startup, operations,
9 maintenance, or any other costs associated
10 with the recreational purpose; and

11 “(viii) if the recreational purpose is
12 consistent with Federal land use compat-
13 ibility criteria under section 47502.

14 “(B) PERMANENT RECREATIONAL USE.—
15 Paragraph (1) shall apply, with respect to a
16 sponsor that has taken the action described in
17 subparagraph (B) of such paragraph, only—

18 “(i) to airport property that was pur-
19 chased using funds from a Federal grant
20 for acquiring land issued prior to Decem-
21 ber 30, 1987;

22 “(ii) to airport property that has been
23 continuously used as a recreational and
24 public park since January 1, 1995;

1 “(iii) if the airport sponsor has pro-
2 vided a written statement to the Adminis-
3 trator that the property to be permanently
4 restricted for recreational and public park
5 use is not needed for any aeronautical use
6 at the time the written statement is pro-
7 vided and is not expected to be needed for
8 any aeronautical use at any time after
9 such statement is provided;

10 “(iv) if the recreational and public
11 park use does not impact the aeronautical
12 use of the airport;

13 “(v) if the airport sponsor provides a
14 certification that the sponsor is not respon-
15 sible for operations, maintenance, or any
16 other costs associated with the recreational
17 and public park use;

18 “(vi) if the recreational purpose is
19 consistent with Federal land use compat-
20 ibility criteria under section 47502;

21 “(vii) if, in the event the airport spon-
22 sor leases the property, the lease will be to
23 a local government entity or nonprofit enti-
24 ty to operate and maintain the property at
25 no cost the airport sponsor; and

1 “(viii) if, in the event the airport
2 sponsor sells the property, the sale will be
3 to a local government entity and subject to
4 a permanent deed restriction ensuring
5 compatible airport use under regulations
6 issued pursuant to section 47502.

7 “(3) REVENUE FROM CERTAIN SALES OF AIR-
8 PORT PROPERTY.—Notwithstanding any other provi-
9 sion of law, an airport sponsor selling a portion of
10 airport property as described in paragraph
11 (2)(B)(viii)(II) may—

12 “(A) sell such portion of airport property
13 for less than fair market value; and

14 “(B) subject to the requirements of sub-
15 section (b), retain the revenue from the sale of
16 such portion of airport property.

17 “(4) STATUTORY CONSTRUCTION.—Nothing in
18 this subsection may be construed as permitting a di-
19 version of airport revenue for the capital or oper-
20 ating costs associated with the community use of
21 airport land.”.

13 sistance under a grant approved under this chapter
14 or chapter 475, the amount may be increased—

15 “(A) for an airport development project, by
16 not more than 15 percent; and

17 “(B) to acquire an interest in land for an
18 airport (except a primary airport), by not more
19 than the greater of the following, based on cur-
20 rent creditable appraisals or a court award in a
21 condemnation proceeding:

22 “(i) 15 percent; or

23 “(ii) 25 percent of the total increase
24 in allowable project costs attributable to
25 acquiring an interest in land.

1 “(3) PRICE ADJUSTMENT PROVISIONS.—

2 “(A) IN GENERAL.—The Secretary may in-
3 corporate a provision in a project grant agree-
4 ment under which the Secretary agrees to pay
5 more than the maximum amount otherwise
6 specified in the agreement if the Secretary finds
7 that commodity or labor prices have increased
8 since the agreement was made.

9 “(B) DECREASE IN COSTS.—A provision
10 incorporated in a project grant agreement
11 under this paragraph shall ensure that the Sec-
12 retary realizes any financial benefit associated
13 with a decrease in material or labor costs for
14 the project.”;

15 (3) by striking subsection (c); and

16 (4) by redesignating subsections (d) and (e) as
17 subsections (c) and (d), respectively.

18 **SEC. 407. ALLOWABLE PROJECT COSTS AND LETTERS OF**
19 **INTENT.**

10 (3) in subsection (e)(2)(C) by striking “com-
11 mercial service airport having at least 0.25 percent
12 of the boardings each year at all such airports” and
13 inserting “medium hub airport or large hub air-
14 port”;

15 (4) in subsection (h) by striking “section
16 47114(d)(3)(A)” and inserting “section

18 (5) by striking subsection (i).

19 **SEC. 408. SMALL AIRPORT LETTERS OF INTENT.**

20 (a) **IN GENERAL.**—Section 47110 of title 49, United
21 States Code, is further amended by adding at the end the
22 following:

23 “(i) **SMALL AIRPORT LETTERS OF INTENT.**—

24 “(1) **IN GENERAL.**—The Secretary may issue a
25 letter of intent to a sponsor stating an intention to

1 obligate an amount from future budget authority for
2 an airport development project (including costs of
3 formulating the project) at a nonhub airport or an
4 airport that is not a primary airport. The letter shall
5 establish a schedule under which the Secretary will
6 reimburse the sponsor for the Government's share of
7 allowable project costs, as amounts become available,
8 if the sponsor, after the Secretary issues the letter,
9 carries out the project without receiving amounts
10 under this subchapter.

11 “(2) LIMITATIONS.—The amount the Secretary
12 intends to obligate in a letter of intent issued under
13 this subsection shall not exceed the larger of—

14 “(A) the Government's share of allowable
15 project costs; or

16 “(B) \$10,000,000.

17 “(3) FINANCING.—Allowable project costs
18 under paragraph (1) may include costs associated
19 with making payments for debt service on indebted-
20 ness incurred to carry out the project.

21 “(4) REQUIREMENTS.—The Secretary shall
22 only issue a letter of intent under paragraph (1) if—

23 “(A) the sponsor notifies the Secretary, be-
24 fore the project begins, of the sponsor's intent

1 to carry out the project and requests a letter of
2 intent; and

3 “(B) the sponsor agrees to comply with all
4 statutory and administrative requirements that
5 would apply to the project if it were carried out
6 with amounts made available under this sub-
7 chapter.

8 “(5) ASSESSMENT.—In reviewing a request for
9 a letter of intent under this subsection, the Sec-
10 retary shall consider the grant history of an airport,
11 the airport’s enplanements or operations, and such
12 other factors as the Secretary determines appro-
13 priate.

14 “(6) PRIORITIZATION.—In issuing letters of in-
15 tent under this subsection, the Secretary shall—

16 “(A) prioritize projects that—

17 “(i) cannot reasonably be funded by
18 an airport sponsor using funds apportioned
19 under section 47114(c), 47114(d)(2)(A)(i),
20 or 47114(d)(6), including funds appor-

24 “(ii) are necessary to an airport’s con-
25 tinued safe operation or development; and

1 “(B) structure the reimbursement sched-
2 ules under such letters in a manner that mini-
3 mizes unnecessary or undesirable project seg-
4 mentation.

5 “(7) REQUIRED USE.—

6 “(A) IN GENERAL.—Beginning in fiscal
7 year 2028, and in each fiscal year thereafter,
8 the Secretary shall ensure that not less than
9 \$100,000,000 is committed to be reimbursed in
10 such fiscal year pursuant to letters of intent
11 issued under this subsection.

12 “(B) WAIVER.—The Secretary may waive
13 the requirement under subparagraph (A) for a
14 fiscal year if the Secretary determines there are
15 insufficient letter of intent requests that meet
16 the requirements of paragraph (4). Upon such
17 waiver, the Secretary shall provide a briefing to
18 the Committee on Transportation and Infra-
19 structure of the House of Representatives and
20 the Committee on Commerce, Science, and
21 Transportation of the Senate on the reasons
22 contributing to the need for such waiver and
23 the actions the Secretary intends to take to en-
24 sure that there are sufficient letter of intent re-
25 quests that meet the requirements of paragraph

1 (4) in the fiscal year succeeding the fiscal year
2 for which the Secretary issued such waiver.

3 “(C) RESTRICTION.—The total estimated
4 amount of future Government obligations cov-
5 ered by all outstanding letters of intent under
6 paragraph (1) may not be more than the
7 amount authorized to carry out section 48103
8 of this title, less an amount reasonably esti-
9 mated by the Secretary to be needed for grants
10 under section 48103 that are not covered by a
11 letter.

12 “(8) NO OBLIGATION OR COMMITMENT.—A let-
13 ter of intent issued under this subsection is not an
14 obligation of the Government under section 1501 of
15 title 31, and the letter is not deemed to be an ad-
16 ministrative commitment for financing. An obliga-
17 tion or administrative commitment may be made
18 only as amounts are provided in authorization and
19 appropriation laws.

20 “(9) LIMITATION ON STATUTORY CONSTRUC-
21 TION.—Nothing in this section shall be construed to
22 prohibit the obligation of amounts pursuant to a let-
23 ter of intent under this subsection in the same fiscal
24 year as the letter of intent is issued.”.

1 torney General, publish and annually update a list of
2 entities manufacturing airport passenger boarding
3 bridges—

4 “(A) that are owned, directed, or sub-
5 sidized by the People’s Republic of China; and

6 “(B) that—

7 “(i) have been determined by a Fed-
8 eral court to have misappropriated intellec-
9 tual property or trade secrets from an enti-
10 ty organized under the laws of the United
11 States or any jurisdiction within the
12 United States; or

13 “(ii) own or control, are owned or
14 controlled by, are under common owner-
15 ship or control with, or are successors to,
16 an entity described in clause (i).”.

17 **SEC. 410. FUEL INFRASTRUCTURE.**

18 Section 47110 of title 49, United States Code, is fur-

14 “(ii) fueling systems for type certifi-
15 cated hydrogen-powered aircraft; and

16 “(B) may include capital costs for fuel
17 farms and other equipment and infrastructure
18 used for the delivery and storage of fuel.”.

19 **SEC. 411. APPORTIONMENTS.**

20 (a) PRIMARY, COMMERCIAL SERVICE, AND CARGO
21 AIRPORTS.—

14 400,000 passenger boardings at the airport
15 during the prior calendar year;

16 “(iv) \$1.30 for each of the next
17 500,000 passenger boardings at the airport
18 during the prior calendar year; and

19 “(v) \$1.00 for each additional pas-
20 senger boarding at the airport during the
21 prior calendar year.

22 “(B) MINIMUM AND MAXIMUM APPORTION-
23 MENTS.—Not less than \$1,300,000 nor more
24 than \$22,000,000 may be apportioned under

1 subparagraph (A) to an airport sponsor for a
2 primary airport for each fiscal year.

3 “(C) NEW AIRPORT.—Notwithstanding
4 subparagraph (A), the Secretary shall apportion
5 in the first fiscal year following the official
6 opening of a new airport with scheduled pas-
7 senger air transportation an amount equal to
8 \$1,300,000 to the sponsor of such airport.

9 “(D) NONPRIMARY COMMERCIAL SERVICE
10 AIRPORT APPORTIONMENT.—

11 “(i) IN GENERAL.—The Secretary
12 shall apportion to each commercial service
13 airport that is not a primary airport an
14 amount equal to—

15 “(I) \$60 for each of the first
16 2,500 passenger boardings at the air-
17 port during the prior calendar year;
18 and

19 “(II) \$153.33 for each of the
20 next 7,499 passenger boardings at the
21 airport during the prior calendar year.

22 “(ii) APPLICABILITY.—Paragraphs (4)
23 and (5) of subsection (d) shall apply to
24 funds apportioned under this subpara-
25 graph.

1 “(E) SPECIAL RULE FOR AIR RESERVE
2 STATIONS.—Notwithstanding section 47102,
3 the Secretary shall consider a public-use airport
4 that is co-located with an air reserve station to
5 be a primary airport for purposes of this chap-
6 ter.

7 “(F) SPECIAL RULE FOR FISCAL YEARS
8 2024 AND 2025.—Notwithstanding any other
9 provision of this paragraph or the absence of
10 scheduled passenger service at an airport, the
11 Secretary shall apportion in fiscal years 2024
12 and 2025 to the sponsor of an airport an
13 amount based on the number of passenger
14 boardings at the airport during whichever of
15 the following years that would result in the
16 highest apportioned amount under this para-
17 graph:

18 “(i) Calendar year 2018.

19 “(ii) Calendar year 2019.

20 “(iii) The prior full calendar year
21 prior to the current fiscal year.”.

22 (2) CARGO AIRPORTS.—Section 47114(e)(2) of
23 title 49, United States Code, is amended—

24 (A) in subparagraph (A)—

1 (i) by striking “3.5” and inserting
2 “4”; and

3 (ii) by striking “100,000,000 pounds”
4 and inserting “25,000,000 pounds”;

5 (B) by striking subparagraph (C); and

6 (C) by redesignating subparagraphs (D)
7 and (E) as subparagraphs (C) and (D), respec-
8 tively.

9 (b) GENERAL AVIATION AIRPORTS.—Section
10 47114(d) of title 49, United States Code, is amended—

23 and level of detail for any program agreements and
24 documentation that the Administrator would per-

1 form with respect to such action if the State did not

12 tions, and enforcement for proposed improve-
13 ments on airport properties not associated with

15 “(D) Land use determinations under sec-
16 tion 163 of the FAA Reauthorization Act of
17 2018 (49 U.S.C. 47107 note), compatibility
18 planning, and airport layout plan review and
19 approval for projects not funded by amounts
20 available under this subchapter.

21 “(E) Nonaeronautical and special event
22 recommendations and approvals.

23 “(F) Instrument approach procedure eval-
24 uations and determinations.

1 “(G) Environmental review for projects not
2 funded by amounts available under this sub-
3 chapter.

4 “(H) Review and approval of land leases,
5 land releases, changes in on-airport land-use
6 designation, and through-the-fence agree-
7 ments.”.

8 (d) REPORT.—The Comptroller General of the
9 United States shall issue a report on the Office of Airports
10 of the Federal Aviation Administration and the airport im-
11 provement program under subchapter I of chapter 471
12 and chapter 475 of title 49, United States Code, and in-
13 clude in such report a description of—

14 (1) the responsibilities of States participating in
15 the block grant program under section 47128 of title
16 49, United States Code; and

17 (2) the impact of title VIII of division J of the
18 Infrastructure Investment and Jobs Act (Public Law
19 117–58) and other Federal administrative funding
20 sources on the ability of such States to disburse and
21 administer airport improvement program funds.

22 (e) SENSE OF CONGRESS.—It is the sense of Con-
23 gress that Congress supports the disbursement of a per-
24 centage of administrative funds made available under the
25 heading “Federal Aviation Administration—Airport Infra-

1 structure Grants” in title VIII of division J of the Infra-
2 structure Investment and Jobs Act (Public Law 117–58)
3 to non-primary airports participating in the State’s block
4 grant program each fiscal year of the Airport Infrastruc-
5 ture Grants program.

17 or subcontract to an entity on or after the date of

13 **SEC. 425. NATIONAL PRIORITY SYSTEM FORMULAS.**

14 (a) IN GENERAL.—Not later than 1 year after the
15 date of enactment of this Act, the Secretary of Transpor-
16 tation shall review and update the National Priority Sys-
17 tem prioritization formulas contained in Federal Aviation
18 Administration Order 5090.5 to account for the amend-
19 ments to chapter 471 of title 49, United States Code,
20 made by this Act.

21 (b) REQUIRED CONSULTATION.—In revising the for-
22 mulas under subsection (a), the Secretary shall consult
23 with representatives of the following:

24 (1) Primary airports, including large, medium,
25 small, and nonhub airports.

5 (4) State aviation officials, including associa-
6 tions representing such officials.

10 (c) PRIORITY PROJECTS.—In revising the formulas
11 under subsection (a), the Secretary shall assign the high-
12 est priority to projects that increase or maintain the safe-
13 ty, efficiency, and capacity of the aviation system.

14 **SEC. 426. MINORITY AND DISADVANTAGED BUSINESS PAR-**
15 **TICIPATION.**

16 (a) FINDINGS.—Congress finds the following:

17 (1) While significant progress has occurred due
18 to the establishment of the airport disadvantaged
19 business enterprise program and the airport conces-
20 sions disadvantaged business enterprise program
21 under sections 47113 and 47107(e) of title 49,
22 United States Code, respectively, discrimination and
23 related barriers continue to pose significant obstacles
24 for minority- and women-owned businesses seeking

1 to do business in airport-related markets across the
2 Nation.

3 (2) Congress has received and reviewed testi-
4 mony and documentation of race and gender dis-
5 crimination from numerous sources, including con-
6 gressional hearings and roundtables, scientific re-
7 ports, reports issued by public and private agencies,
8 news stories, reports of discrimination by organiza-
9 tions and individuals, and discrimination lawsuits.
10 Such testimony and documentation show that race-
11 and gender-neutral efforts alone are insufficient to
12 address the problem.

13 (3) The testimony and documentation described
14 in paragraph (2) demonstrate that race and gender
15 discrimination poses a barrier to full and fair par-
16 ticipation in airport-related businesses of women
17 business owners and minority business owners in the
18 racial groups detailed in parts 23 and 26 of title 49,
19 Code of Federal Regulations, and has impacted firm
20 development and other aspects of airport-related
21 business in the public and private markets.

22 (4) The testimony and documentation described
23 in paragraph (2) provide a strong basis that there
24 is a compelling need for the continuation of the air-
25 port disadvantaged business enterprise program and

1 the airport concessions disadvantaged business en-
2 terprise program to address race and gender dis-
3 crimination in airport-related business.

4 (b) SUPPORTIVE SERVICES.—Section 47113 of title
5 49, United States Code, is amended by adding at the end
6 the following:

7 “(f) SUPPORTIVE SERVICES.—

8 “(1) IN GENERAL.—The Secretary of Transpor-
9 tation, in coordination with the Administrator of the
10 Federal Aviation Administration, may, at the re-
11 quest of an airport sponsor, provide assistance under
12 a grant issued under this subchapter to develop, con-
13 duct, and administer training programs and assist-
14 ance programs in connection with any airport im-
15 provement project subject to part 26 of title 49,
16 Code of Federal Regulations, for small business con-
17 cerns referred to in subsection (b) to achieve pro-
18 ficiency to compete, on an equal basis for contracts
19 and subcontracts related to such projects.

20 “(2) ELIGIBLE ENTITIES.—An entity eligible to
21 receive assistance under this section is—

22 “(A) a State;

23 “(B) a political subdivision of a State or
24 local government;

25 “(C) a Tribal government;

1 “(D) an airport sponsor;

2 “(E) a metropolitan planning organization;

3 “(F) a group of entities described in sub-
4 paragraphs (A) through (E); or

5 “(G) any other organization considered ap-
6 propriate by the Secretary.”.

7 **SEC. 427. AIRPORT ACCESS ROADS IN REMOTE LOCATIONS.**

8 Section 162 of the FAA Reauthorization Act of 2018
9 (49 U.S.C. 47102 note) is amended in the matter pre-
10 ceding paragraph (1) by striking “2023” and inserting
11 “2028”.

12 **SEC. 428. LIMITED REGULATION OF NONFEDERALLY SPON-**
13 **SORED PROPERTY.**

14 Section 163 of the FAA Reauthorization Act of 2018
15 (49 U.S.C. 47107 note) is amended—

16 (1) by striking subsection (a) and inserting the
17 following:

18 “(a) IN GENERAL.—

19 “(1) LIMITED REGULATION.—Except as pro-
20 vided in subsection (b), the Secretary of Transpor-
21 tation may not require an airport to seek approval
22 for (including in the submission of an airport layout
23 plan), or directly or indirectly regulate (including
24 through any grant assurance)—

1 “(A) the acquisition, use, lease, encum-
2 brance, transfer, or disposal of land (including
3 any portion of such land) by an airport sponsor;
4 or

5 “(B) the construction, development, im-
6 provement, use, or removal of any facility (in-
7 cluding any portion of such facility) upon such
8 land.

9 “(2) BURDEN OF DEMONSTRATING APPLICA-
10 BILITY.—The burden of demonstrating the non-
11 applicability of paragraph (1), or the applicability of
12 an exception under subsection (b), shall be on the
13 Secretary.”;

14 (2) in subsection (b)—

15 (A) in paragraph (1)—

16 (i) in the matter preceding subpara-
17 graph (A) by striking “regulation” and in-
18 serting “law, regulation, or grant assur-
19 ance”; and

20 (ii) in subparagraph (A) by striking
21 “aircraft operations” and inserting “air-
22 craft operations that occur or are projected
23 to occur at an airport as described in an
24 airport’s master plan”;

1 (B) in paragraph (2) by striking “facility”
2 and inserting “facility that the Secretary dem-
3 onstrates was”; and

4 (C) in paragraph (3) by striking “con-
5 tained” and inserting “that the Secretary dem-
6 onstrates is contained”; and

7 (3) by striking subsection (e) and inserting the
8 following:

9 “(c) **RULE OF CONSTRUCTION.**—Nothing in this sec-
10 tion shall be construed—

11 “(1) to affect the applicability of sections
12 47107(b) or 47133 of title 49, United States Code,
13 to revenues generated by the use, lease, encum-
14 brance, transfer, or disposal of land under sub-
15 section (a), facilities upon such land, or any portion
16 of such land or facilities; or

17 “(2) to limit the Secretary’s authority to ap-
18 prove or regulate airport projects (or portions of air-
19 port projects) that are not subject to the provisions
20 of subsection (a).”.

21 **SEC. 429. MOTORCOACH ENPLANEMENT PILOT PROGRAM.**

22 With respect to fiscal years 2024 through 2028, pas-
23 sengers who board a motorcoach at an airport that is char-
24 tered or provided by an air carrier to transport such pas-
25 sengers to another airport at which the passengers board

1 an aircraft in service in air commerce, that entered the
2 sterile area of the airport at which such passengers ini-
3 tially boarded the motorcoach, shall be deemed to be in-
4 cluded under the term “passenger boardings” in section
5 47102 of title 49, United States Code.

6 **SEC. 430. POPULOUS COUNTIES WITHOUT AIRPORTS.**

7 Notwithstanding any other provision of law, the Sec-
8 retary of Transportation may not deny inclusion in the
9 national plan of integrated airport systems maintained
10 under section 47103 of title 49, United States Code, to
11 an airport or proposed airport if the airport or proposed
12 airport—

13 (1) is located in the most populous county (as
14 such term is defined in section 2 of title 1, United
15 States Code) of a State that does not have an air-
16 port listed in the national plan;

17 (2) has an airport sponsor that was established
18 before January 1, 2017;

19 (3) is located more than 15 miles away from
20 another airport listed in the national plan;

21 (4) demonstrates how the airport will meet the
22 operational activity required, through a forecast vali-
23 dated by the Secretary, within the first 10 years of
24 operation;

1 (5) meets Federal Aviation Administration air-
2 port design standards;

3 (6) submits a benefit-cost analysis;

4 (7) presents a detailed financial plan to accom-
5 plish construction and ongoing maintenance; and

6 (8) has the documented support of the State
7 government for the entry of the airport or proposed
8 airport into the national plan.

9 **SEC. 431. CONTINUED AVAILABILITY OF AVIATION GASO-**
10 **LINE.**

11 (a) IN GENERAL.—The Administrator of the Federal
12 Aviation Administration shall ensure that any of such va-
13 rieties of aviation gasoline as may be necessary to fuel any
14 model of piston-engine aircraft remain available for pur-
15 chase at each airport listed on the national plan of inte-
16 grated airport systems (as described in section 47103 of
17 title 49, United States Code) at which aviation gasoline
18 was available for purchase as of October 5, 2018.

19 (b) REMOVAL OF AVAILABILITY.—The Administrator
20 shall consider a prohibition or restriction on the sale of
21 such varieties of aviation gasoline to violate assurance 22
22 (or any successor assurance related to economic non-
23 discrimination) of grant assurances associated with the
24 airport improvement program under subchapter I of chap-
25 ter 471 and chapter 475 of title 49, United States Code.

1 (c) AVIATION GASOLINE DEFINED.—In this section,
2 the term “aviation gasoline” means a gasoline on which
3 a tax is imposed under section 4081(a)(2)(A)(ii) of the
4 Internal Revenue Code of 1986.

5 (d) RULE OF CONSTRUCTION.—Nothing in this sec-
6 tion may be construed to—

7 (1) affect any airport sponsor found to be out
8 of compliance with the grant assurance described in
9 subsection (b) before the date of enactment of this
10 Act;

11 (2) affect any investigation of an airport spon-
12 sor initiated by the Administrator under parts 13 or
13 16 of title 14, Code of Federal Regulations, relating
14 to the availability of aviation gasoline; or

15 (3) require any particular action by the Admin-
16 istrator if the Administrator determines through
17 such investigation that such airport sponsor has vio-
18 lated a grant assurance.

19 **SEC. 432. AIP HANDBOOK UPDATE.**

20 (a) IN GENERAL.—Not later than 4 years after the
21 date of enactment of this Act, the Administrator of the
22 Federal Aviation Administration shall revise the Airport
23 Improvement Program Handbook (Order 5100.38D) (in
24 this section referred to as the “Handbook”) to account
25 for legislative changes to the airport improvement pro-

1 gram under subchapter I of chapter 471 and chapter 475
2 of title 49, United States Code, and to make such other
3 changes as the Administrator determines necessary.

4 (b) REQUIREMENTS.—In updating the Handbook,
5 the Administrator may not impose any additional require-
6 ments or restrictions on the use of Airport Improvement
7 Program funds except as specifically directed by legisla-
8 tion.

9 (c) CONSULTATION AND PUBLIC COMMENT.—

10 (1) CONSULTATION.—In developing the revised
11 Handbook under this section, the Administrator
12 shall consult with aviation stakeholders, including
13 airports and air carriers.

14 (2) PUBLIC COMMENT.—

15 (A) IN GENERAL.—Not later than 30
16 months after the date of enactment of this Act,
17 the Administrator shall publish a draft revision
18 of the Handbook and make such draft available
19 for public comment for a period of not less than
20 90 days.

21 (B) REVIEW.—The Administrator shall re-
22 view all comments submitted during the public
23 comment period described under subparagraph
24 (A) and, as the Administrator considers appro-

1 appropriate, incorporate changes based on such com-
2 ments into the final revision of the Handbook.

3 (d) INTERIM IMPLEMENTATION OF CHANGES.—Not
4 later than 1 year after the date of enactment of this Act,
5 the Administrator shall issue program guidance letters to
6 provide for the interim implementation of amendments to
7 the Airport Improvement Program made by this Act.

8 **SEC. 433. GAO AUDIT OF AIRPORT FINANCIAL REPORTING**
9 **PROGRAM.**

10 (a) AUDIT.—Not later than 18 months after the date
11 of enactment of this Act, the Comptroller General of the
12 United States shall complete an audit of the airport finan-
13 cial reporting program of the Federal Aviation Adminis-
14 tration and provide recommendations to the Administrator
15 of the Federal Aviation Administration on improvements
16 to such program.

17 (b) REQUIREMENTS.—In conducting the audit re-
18 quired under subsection (a), the Comptroller General
19 shall, at a minimum—

20 (1) review relevant Administration guidance to
21 airports, including the version of Advisory Circular
22 150/5100–19, titled “Operating and Financial Sum-
23 mary”, that is in effect on the date of enactment of
24 this Act;

1 (2) evaluate the information requested or re-
2 quired by the Administrator from airports for com-
3 pleteness and usefulness by the Administration and
4 the public;

5 (3) assess the costs associated with collecting,
6 reporting, and maintaining such information for air-
7 ports and the Administration;

8 (4) determine if such information provided is—

9 (A) updated on a regular basis to make
10 such information useful; and

11 (B) audited and verified in an appropriate
12 manner;

13 (5) assess if the Administration has addressed
14 the issues the Administration discovered during the
15 apportionment and disbursement of relief funds to
16 airports under the Coronavirus Aid, Relief, and Eco-
17 nomic Security Act (Public Law 116–136) using in-
18 accurate and aged airport financial data; and

19 (6) determine whether the airport financial re-
20 porting program as structured as of the date of en-
21 actment provides value to the Administration, the
22 aviation industry, or the public.

23 (c) REPORT TO CONGRESS.—Not later than 3
24 months after the completion of the audit required under
25 subsection (a), the Comptroller General shall submit to the

1 Committee on Transportation and Infrastructure of the
2 House of Representatives and the Committee on Com-
3 merce, Science, and Transportation of the Senate a report
4 containing the findings of such audit and any rec-
5 ommendations provided to the Administrator to improve
6 or alter the airport financial reporting program.

7 **SEC. 434. GAO REVIEW OF NONAERONAUTICAL REVENUE**
8 **STREAMS AT AIRPORTS.**

9 (a) REVIEW.—Not later than 2 years after the date
10 of enactment of this Act, the Comptroller General of the
11 United States shall initiate a review of non-aeronautical
12 revenue streams currently used by hub airports of varying
13 size, assess the impact of nonaeronautical revenue on air-
14 ports, and evaluate opportunities for revenue that are un-
15 utilized or are underutilized by such airports.

16 (b) SCOPE.—In conducting the review required under
17 subsection (a), the Comptroller General shall, at a min-
18 imum—

19 (1) examine the nonaeronautical revenue
20 streams at a variety of public-use airports in the
21 United States;

22 (2) examine nonaeronautical revenue streams
23 used by foreign airports;

1 (3) examine revenue streams used by similar
2 types of infrastructure operators like train stations,
3 bus depots, and shopping malls;

4 (4) determine the revenue effects of entering
5 into, or choosing not to enter into, concessionaire
6 agreements with companies operating at airports
7 that are not a party to such agreements; and

8 (5) examine users and beneficiaries of airport
9 services, facilities, property, and passengers, and de-
10 termine if any such users or beneficiaries could or
11 should be considered as a source of nonaeronautical
12 revenue for an airport.

13 (c) CONSULTATION.—As part of the review required
14 under subsection (a), the Comptroller General shall con-
15 sult with representatives of airport concessionaires, airport
16 sponsors, airport governance entities, airport financial
17 planning consultants, and any other relevant stakeholders
18 the Comptroller General determines appropriate.

19 (d) FINDINGS, BEST PRACTICES, AND REC-
20 OMMENDATIONS.—As part of the review required under
21 subsection (a), the Comptroller General shall produce best
22 practices and recommendations that can be adopted by
23 public-use airports to increase non-aeronautical revenue.

24 (e) REPORT TO CONGRESS.—Not later than 3
25 months after the completion of the review required under

1 subsection (a), the Comptroller General shall submit to the
2 Committee on Transportation and Infrastructure of the
3 House of Representatives and the Committee on Com-
4 merce, Science, and Transportation of the Senate a report
5 containing the findings, best practices, and recommenda-
6 tions of such review.

7 **SEC. 435. MAINTAINING SAFE FIRE AND RESCUE STAFFING**
8 **LEVELS.**

9 (a) **UPDATE TO REGULATION.**—The Administrator of
10 the Federal Aviation Administration shall update the reg-
11 ulations contained in section 139.319 of title 14, Code of
12 Federal Regulations, to ensure that paragraph (4) of such
13 section provides that at least 1 individual maintains cer-
14 tification at the emergency medical technician basic level,
15 or higher.

16 (b) **STAFFING REVIEW.**—Not later than 2 years after
17 the date of enactment of this Act, the Administrator shall
18 conduct a review of airport environments and related regu-
19 lations to evaluate sufficient staffing levels necessary for
20 firefighting and rescue services and response at airports
21 certified under part 139 of title 14, Code of Federal Regu-
22 lations.

23 (c) **REPORT.**—Not later than 1 year after completing
24 the review under subsection (b), the Administrator shall
25 submit to the Committee on Transportation and Infra-

1 structure of the House of Representatives and the Com-
2 mittee on Commerce, Science, and Transportation of the
3 Senate a report containing the results of the review.

4 **SEC. 436. GAO STUDY OF ONSITE AIRPORT GENERATION.**

5 (a) STUDY.—Not later than 1 year after the date of
6 enactment of this Act, the Comptroller General of the
7 United States shall initiate a study on the feasibility of
8 installation and adoption of certain power generation
9 property at airports which receive funding from the Fed-
10 eral Government.

11 (b) CONTENT.—In carrying out the study required
12 under subsection (a), the Comptroller General shall exam-
13 ine—

14 (1) any safety impacts of the installation and
15 operation of such power generation property, either
16 in aggregate or around certain locations or struc-
17 tures at the airport;

18 (2) regulatory barriers to adoption;

19 (3) benefits to adoption;

20 (4) previous examples of adoptions;

21 (5) impacts on other entities; and

22 (6) previous examples of adoption and factors
23 pertaining to previous examples of adoption, includ-
24 ing—

1 (A) novel uses beyond supplemental power
2 generation, such as expanding nonresidential
3 property around airports to minimize noise,
4 power generation resilience, and market forces;

5 (B) challenges identified in the installation
6 process;

7 (C) upfront and long-term costs, both fore-
8 seen and unforeseen;

9 (D) funding sources used to pay for up-
10 front costs; and

11 (E) long-term savings.

12 (c) REPORT.—Not later than 2 years after the initi-
13 ation of the study under subsection (a), the Comptroller
14 General shall submit to the Committee on Transportation
15 and Infrastructure of the House of Representatives and
16 the Committee on Commerce, Science, and Transportation
17 of the Senate a report and recommendations on the results
18 of the study.

19 (d) POWER GENERATION PROPERTY DEFINED.—In
20 this section, the term “power generation property” means
21 equipment defined in section 48(a)(3)(A) of the Internal
22 Revenue Code of 1986.

1 **SEC. 437. TRANSPORTATION DEMAND MANAGEMENT AT**
2 **AIRPORTS.**

3 (a) **IN GENERAL.**—Not later than 1 year after the
4 date of enactment of this Act, the Comptroller General
5 of the United States shall conduct a study to examine the
6 efficacy of transportation demand management strategies
7 at United States airports.

8 (b) **CONSIDERATIONS.**—In conducting the study
9 under subsection (a), the Comptroller General shall exam-
10 ine, at minimum—

11 (1) whether transportation demand manage-
12 ment strategies should be considered by airports
13 when making infrastructure planning and construc-
14 tion decisions;

15 (2) the impact of transportation demand man-
16 agement strategies on existing multimodal options to
17 and from airports in the United States; and

18 (3) best practices for developing transportation
19 demand management strategies that can be used to
20 improve access to airports for passengers and air-
21 port and airline personnel.

22 (c) **REPORT.**—Upon completion of the study con-
23 ducted under subsection (a), the Comptroller General shall
24 submit to the Committee on Transportation and Infra-
25 structure of the House of Representatives and the Com-

1 mittee on Commerce, Science, and Transportation of the
2 Senate a report on such study.

3 (d) DEFINITION.—In this section, the term “trans-
4 portation demand management strategy” means the use
5 of planning, programs, policy, marketing, communica-
6 tions, incentives, pricing, data, and technology to optimize
7 travel modes, routes used, departure times, and number
8 of trips.

9 **SEC. 438. COASTAL AIRPORTS ASSESSMENT.**

10 (a) IN GENERAL.—Not later than 2 years after the
11 date of enactment of this Act, the Administrator of the
12 Federal Aviation Administration shall, in coordination
13 with the Chief of Engineers and Commanding General of
14 the United States Army Corps of Engineers, initiate an
15 assessment on the resiliency of coastal airports in the
16 United States.

17 (b) CONTENTS.—The assessment required under sub-
18 section (a) shall—

19 (1) examine the impact of sea-level rise and
20 other environmental factors that pose risks to coast-
21 al airports; and

22 (2) identify and evaluate current initiatives to
23 prevent and mitigate the impacts of factors de-
24 scribed in paragraph (1) on coastal airports.

1 (c) REPORT.—Upon completion of the assessment,
2 the Administrator of the Federal Aviation Administration
3 shall submit to the Committee on Transportation and In-
4 frastructure of the House of Representatives and the Com-
5 mittee on Commerce, Science, and Transportation of the
6 Senate a report on—

7 (1) the results of the assessment required under
8 subsection (a); and

9 (2) recommendations to improve the resiliency
10 of coastal airports in the United States.

11 **SEC. 439. AIRPORT INVESTMENT PARTNERSHIP PROGRAM.**

12 Section 47134(b) of title 49, United States Code, is
13 amended by adding at the end the following:

14 “(4) BENEFIT-COST ANALYSIS.—Prior to ap-
15 proving an application submitted under subsection
16 (a), the Secretary may require a benefit-cost anal-
17 ysis. If a benefit-cost analysis is required, the Sec-
18 retary shall issue a preliminary and conditional find-
19 ing, which shall—

20 “(A) be issued not later than 60 days after
21 the date on which the sponsor submits all infor-
22 mation required by the Secretary;

23 “(B) be based upon a collaborative review
24 process that includes the sponsor or sponsor’s
25 representative;

1 “(C) not constitute the issuance of a Fed-
2 eral grant or obligation to issue a grant under
3 this chapter or other provision of law; and

4 “(D) not constitute any other obligation on
5 the part of the Federal Government until the
6 conditions specified in the final benefit-cost
7 analysis are met.”.

8 **SEC. 440. GAO STUDY ON PER-TRIP AIRPORT FEES FOR TNC**
9 **CONSUMERS.**

10 (a) **STUDY.**—Not later than 90 days after the date
11 of enactment of this Act, the Comptroller General of the
12 United States shall conduct a study of fees that airports
13 assess against customers of transportation network com-
14 panies.

15 (b) **CONTENTS.**—In carrying out the study required
16 under subsection (a), the Comptroller General shall ad-
17 dress—

18 (1) the methodology used by airports to set a
19 fee for customers of TNCs;

20 (2) expenditures by airports of fees assessed
21 against customers of TNCs; and

22 (3) a comparison of the fees imposed by air-
23 ports on customers of TNCs and other comparable
24 modes of for-hire transportation, such as taxi.

1 (c) REPORT.—Not later than 12 months after the
2 date of enactment of this Act, the Comptroller General
3 shall submit to the Committee on Transportation and In-
4 frastructure of the House of Representatives and the Com-
5 mittee on Commerce, Science, and Transportation of the
6 Senate a report on the results of the study.

7 (d) TRANSPORTATION NETWORK COMPANY DE-
8 FINED; TNC DEFINED.—In this section, the term “trans-
9 portation network company” or “TNC”—

10 (1) means a corporation, partnership, sole pro-
11 prietorship, or other entity that uses a digital net-
12 work to connect riders to drivers affiliated with the
13 entity in order for the driver to transport the rider
14 using a vehicle owned, leased, or otherwise author-
15 ized for use by the driver to a point chosen by the
16 rider; and

17 (2) does not include a shared-expense carpool or
18 vanpool arrangement that is not intended to gen-
19 erate profit for the driver.

20 **SEC. 441. SPECIAL RULE FOR RECLASSIFICATION OF CER-**
21 **TAIN UNCLASSIFIED AIRPORTS.**

22 (a) REQUEST FOR RECLASSIFICATION.—

23 (1) IN GENERAL.—Not later than September
24 30, 2024, a privately owned reliever airport (as such
25 term is defined in section 47102 of title 49, United

1 States Code) that is identified as unclassified in the
2 National Plan of Integrated Airport Systems, 2021–
3 2025 (as published under section 47103 of title 49,
4 United States Code) may submit to the Secretary of
5 Transportation a request to reclassify the airport ac-
6 cording to the criteria used to classify a publicly
7 owned airport.

8 (2) REQUIRED INFORMATION.—In submitting a
9 request under paragraph (1), a privately owned re-
10 liever airport shall include the following information:

11 (A) A sworn statement and accompanying
12 documentation that demonstrates how the air-
13 port would satisfy the requirements of Federal
14 Aviation Administration Order 5090.5, titled
15 “Formulation of the NPIAS and ACIP” (or
16 any successor guidance), to be classified as
17 “Local” or “Basic” if the airport was publicly
18 owned.

19 (B) A report that—

20 (i) identifies the role of the airport to
21 the aviation system; and

22 (ii) describes the long-term fiscal via-
23 bility of the airport based on demonstrated
24 aeronautical activity and associated reve-

1 nues relative to ongoing operating and
2 maintenance costs.

3 (b) ELIGIBILITY REVIEW.—

4 (1) IN GENERAL.—Not later than 60 days after
5 receiving a request from a privately owned reliever
6 airport under subsection (a), the Secretary shall per-
7 form an eligibility review with respect to the airport,
8 including an assessment of the airport’s safety, secu-
9 rity, capacity, access, compliance with Federal grant
10 assurances, and protection of natural resources and
11 the quality of the environment, as prescribed by the
12 Secretary.

13 (2) PUBLIC SPONSOR.—In performing the eligi-
14 bility review under paragraph (1), the Secretary—

15 (A) may require the airport requesting re-
16 classification to provide information regarding
17 the outlook (whether positive or negative) for
18 obtaining a public sponsor; and

19 (B) may not require the airport to obtain
20 a public sponsor.

21 (c) RECLASSIFICATION BY THE SECRETARY.—

22 (1) IN GENERAL.—Not later than 60 days after
23 receiving a request from a privately owned reliever
24 airport under subsection (a)(1), the Secretary shall
25 grant such request if the following criteria are met:

1 (A) The request includes the required in-
2 formation under subsection (a)(2).

3 (B) The privately owned reliever airport, to
4 the satisfaction of the Secretary—

5 (i) passes the eligibility review per-
6 formed under subsection (b); or

7 (ii) submits a corrective action plan in
8 accordance with paragraph (2).

9 (2) CORRECTIVE ACTION PLAN.—With respect
10 to a privately owned reliever airport that does not,
11 to the satisfaction of the Secretary, pass the eligi-
12 bility review performed under subsection (b), such
13 airport may resubmit to the Secretary a reclassifica-
14 tion request along with a corrective action plan
15 that—

16 (A) resolves any shortcomings identified in
17 such eligibility review; and

18 (B) proves that any necessary corrective
19 action has been completed by the airport.

20 (d) EFFECTIVE DATE.—The reclassification of any
21 privately owned reliever airport under this section shall
22 take effect not later than—

23 (1) September 30, 2026, for any request grant-
24 ed under subsection (c)(1); and

1 (2) September 30, 2027, for any request grant-
2 ed after the submission of a corrective action plan
3 under subsection (c)(2).

4 **SEC. 442. PERMANENT SOLAR POWERED TAXIWAY EDGE**
5 **LIGHTING SYSTEMS.**

6 Not later than 18 months after the date of enactment
7 of this Act, the Administrator of the Federal Aviation Ad-
8 ministration shall produce an engineering brief that de-
9 scribes the acceptable use of permanent solar powered
10 taxiway edge lighting systems at regional, local, and basic
11 nonprimary airports (as categorized in the most recent
12 National Plan of Integrated Airport Systems).

13 **SEC. 443. SECONDARY RUNWAYS.**

14 In approving grants for projects with funds made
15 available pursuant to title VIII of division J of the Infra-
16 structure Investment and Jobs Act (Public Law 117–58)
17 under the heading “Federal Aviation Administration—
18 Airport Infrastructure Grants”, the Administrator of the
19 Federal Aviation Administration shall consider permitting
20 a nonhub or small hub airport to use such funds to extend
21 secondary runways, notwithstanding the level of oper-
22 ational activity as such airport.

1 **SEC. 444. INCREASING THE ENERGY EFFICIENCY OF AIR-**
2 **PORTS AND MEETING CURRENT AND FUTURE**
3 **ELECTRICAL POWER DEMANDS.**

4 (a) IN GENERAL.—Section 47140 of title 49, United
5 States Code, is amended to read as follows:

6 **“§ 47140. Meeting current and future electrical power**
7 **demand**

8 “(a) IN GENERAL.—The Secretary of Transportation
9 shall establish a program under which the Secretary
10 shall—

11 “(1) encourage the sponsor of each public-use
12 airport to—

13 “(A) conduct airport planning that as-
14 sesses the airport’s—

15 “(i) current and future electrical
16 power requirements, including—

17 “(I) heating and cooling;

18 “(II) on-road airport vehicles, in-
19 cluding ground support equipment;

20 “(III) gate electrification; and

21 “(IV) electric aircraft charging;

22 and

23 “(ii) existing electrical infrastructure
24 condition, location and capacity, including
25 base load and backup power, to meet the

1 current and future electrical power demand
2 as identified in this subparagraph; and

3 “(B) conduct airport development to in-
4 crease energy efficiency or meet future electrical
5 power demands as identified in subparagraph
6 (A); and

7 “(2) reimburse the airport sponsor for the costs
8 incurred in conducting the assessment under para-
9 graph (1).

10 “(b) GRANTS.—The Secretary may make grants from
11 amounts made available under section 48103 to assist air-
12 port sponsors that have completed the assessment de-
13 scribed in subsection (a)(1)—

14 “(1) to acquire or construct equipment that will
15 increase energy efficiency at the airport; and

16 “(2) to pursue an airport development project
17 described in subsection (a)(1)(B).”.

18 (b) CLERICAL AMENDMENT.—The analysis for chap-
19 ter 471 of title 49, United States Code, is amended by
20 striking the item relating to section 47140 and inserting
21 the following:

“47140. Meeting current and future electrical power demand.”.

22 **SEC. 445. ELECTRIC AIRCRAFT INFRASTRUCTURE PILOT**
23 **PROGRAM.**

24 (a) IN GENERAL.—The Secretary of Transportation
25 may establish a pilot program under which the sponsors

1 of public-use airports may use funds made available under
2 chapter 471 or section 48103 of title 49, United States
3 Code, for use at up to 10 airports to carry out—

4 (1) activities associated with the acquisition, by
5 purchase or lease, operation, and installation of
6 equipment to support the operations of electric air-
7 craft, including interoperable electric vehicle charg-
8 ing equipment; and

9 (2) the construction or modification of infra-
10 structure to facilitate the delivery of power or serv-
11 ices necessary for the use of electric aircraft, includ-
12 ing—

13 (A) on airport utility upgrades; and

14 (B) associated design costs.

15 (b) ELIGIBILITY.—A public-use airport is eligible for
16 participation in the pilot program under this section if the
17 Secretary finds that funds made available under sub-
18 section (a) would support—

19 (1) electric aircraft operators at such airport, or
20 using such airport; or

21 (2) electric aircraft operators planning to oper-
22 ate at such airport with an associated agreement in
23 place.

1 (c) SUNSET.—The pilot program established under
2 subsection (a) shall sunset 5 years after the date of enact-
3 ment of this Act.

4 **SEC. 446. CURB MANAGEMENT PRACTICES.**

5 Nothing in this Act shall be construed to—

6 (1) prevent airports from engaging in curb
7 management practices, including determining and
8 assigning curb designations, regulations, and to in-
9 stall and maintain upon any of the roadways or
10 parts of roadways as many curb zones as necessary
11 to aid in the regulation, control, and inspection of
12 passenger loading and unloading; or

13 (2) prevent airports from enforcing curb zones
14 using sensor, camera, automated license plate rec-
15 ognition, and software technologies and issuing cita-
16 tions by mail to the registered owner of the vehicle.

18 clause (i), the Administration shall con-

24 cooperating agencies;

1 “(III) overall size and complexity
2 of the project;

3 “(IV) the overall time required
4 by an agency to conduct an environ-
5 mental review and make decisions
6 under applicable Federal law relating
7 to a project (including the issuance or
8 denial of a permit or license) and the
9 cost of the project; and

10 “(V) the sensitivity of the natural
11 and historic resources that could be
12 affected by the project.

13 “(iii) MAXIMUM PROJECT SCHED-
14 ULE.—To the maximum extent practicable
15 and consistent with applicable Federal law,
16 the Administrator shall develop, in concur-
17 rence with the project sponsor, a maximum
18 schedule for the project described or des-
19 ignated under subsection (b) that is not
20 more than 2 years for the completion of
21 the environmental review process for such
22 projects, as measured from, as applicable
23 the date of publication of a notice of intent
24 to prepare an environmental impact state-
25 ment to the record of decision.

1 “(iv) DISPUTE RESOLUTION.—

2 “(I) IN GENERAL.—Any issue or
3 dispute that arises between the Ad-
4 ministrator and participating agencies
5 (or amongst participating agencies)
6 during the environmental review proc-
7 ess will be addressed expeditiously to
8 avoid delay.

9 “(II) RESPONSIBILITIES.—The
10 Administrator and participating agen-
11 cies shall—

12 “(aa) implement the require-
13 ments of this section consistent
14 with any dispute resolution proc-
15 ess established in an applicable
16 law, regulation, or legally binding
17 agreement to the maximum ex-
18 tent permitted by law; and

19 “(bb) seek to resolve issues
20 or disputes at the earliest pos-
21 sible time at the project level
22 through agency employees who
23 have day-to-day involvement in
24 the project.

1 “(III) ELEVATION FOR MISSED
2 MILESTONE.—If a dispute between
3 the Administrator and participating
4 agencies (or amongst participating
5 agencies) causes a milestone to be
6 missed or extended, or the Adminis-
7 trator anticipates that a permitting
8 timetable milestone will be missed or
9 will need to be extended, then the dis-
10 pute shall be elevated to an official
11 designated by the relevant agency for
12 resolution. Such elevation should take
13 place as soon as practicable after the
14 Administrator becomes aware of the
15 dispute or potential missed milestone.

16 “(IV) EXCEPTION.—Disputes
17 that do not impact the ability of an
18 agency to meet a milestone may be
19 elevated as appropriate.

20 “(V) FURTHER EVALUATION.—
21 Once a dispute has been elevated to
22 the designated official, if no resolution
23 has been reached at the end of 30
24 days after the relevant milestone date
25 or extension date, then the relevant

1 agencies shall elevate the dispute to
2 senior agency leadership for resolu-
3 tion.

4 “(C) CONSISTENCY WITH OTHER TIME PE-
5 RIODS.—A schedule under subparagraph (B)
6 shall be consistent with any other relevant time
7 periods established under Federal law.

8 “(D) MODIFICATION.—

9 “(i) IN GENERAL.—Except as pro-
10 vided in clause (ii), the Administrator may
11 lengthen or shorten a schedule established
12 under subparagraph (B) for good cause. A
13 decision by a project sponsor to change,
14 modify, expand, or reduce the scope of a
15 project may be considered as good cause
16 for lengthening or shortening of such
17 schedule as appropriate and based on the
18 nature and extent of the proposed project
19 adjustment.

20 “(ii) LIMITATIONS.—

21 “(I) LENGTHENED SCHEDULE.—
22 The Administrator may lengthen a
23 schedule under clause (i) for a cooper-
24 ating Federal agency by not more
25 than 1 year after the latest deadline

1 established for the project described
2 or designated under subsection (b) by
3 the Administration.

4 “(II) SHORTENED SCHEDULE.—
5 The Administrator may not shorten a
6 schedule under clause (i) if doing so
7 would impair the ability of a cooper-
8 ating Federal agency to conduct nec-
9 essary analyses or otherwise carry out
10 relevant obligations of the Federal
11 agency for the project.

12 “(E) FAILURE TO MEET DEADLINE.—If a
13 cooperating Federal agency fails to meet a
14 deadline established under subparagraph
15 (D)(ii)(I)—

16 “(i) the cooperating Federal agency
17 shall, not later than 10 days after meeting
18 the deadline, submit to the Administrator
19 a report that describes the reasons why the
20 deadline was not met; and

21 “(ii) the Secretary shall—

22 “(I) submit to the Committee on
23 Transportation and Infrastructure of
24 the House of Representatives and the
25 Committee on Commerce, Science,

1 and Transportation of the Senate a
2 copy of the report under clause (i);
3 and

4 “(II) make the report under
5 clause (i) publicly available on the
6 website of the agency.

7 “(F) DISSEMINATION.—A copy of a sched-
8 ule under subparagraph (B), and of any modi-
9 fications to the schedule, shall be—

10 “(i) provided to all participating agen-
11 cies and to the State transportation de-
12 partment of the State in which the project
13 is located (and, if the State is not the
14 project sponsor, to the project sponsor);
15 and

16 “(ii) made available to the public.

17 “(2) COMMENT DEADLINES.—The Adminis-
18 trator shall establish the following deadlines for com-
19 ment during the environmental review process for a
20 project:

21 “(A) For comments by agencies and the
22 public on a draft environmental impact state-
23 ment, a period of not more than 60 days after
24 publication in the Federal Register of notice of

1 the date of public availability of such statement,
2 unless—

3 “(i) a different deadline is established
4 by agreement of the lead agency, the
5 project sponsor, and all participating agen-
6 cies; or

7 “(ii) the deadline is extended by the
8 lead agency for good cause.

9 “(B) For all other comment periods estab-
10 lished by the lead agency for agency or public
11 comments in the environmental review process,
12 a period of no more than 30 days from avail-
13 ability of the materials on which comment is re-
14 quested, unless—

15 “(i) a different deadline is established
16 by agreement of the Administrator, the
17 project sponsor, and all participating agen-
18 cies; or

19 “(ii) the deadline is extended by the
20 lead agency for good cause.

21 “(3) DEADLINES FOR DECISIONS UNDER
22 OTHER LAWS.—In any case in which a decision
23 under any Federal law relating to a project de-
24 scribed or designated under subsection (b) (including
25 the issuance or denial of a permit or license) is re-

1 quired to be made by the later of the date that is
2 180 days after the date on which the Administrator
3 made all final decisions of the lead agency with re-
4 spect to the project, or 180 days after the date on
5 which an application was submitted for the permit
6 or license, the Administrator shall submit to the
7 Committee on Transportation and Infrastructure of
8 the House of Representatives and the Committee on
9 Commerce, Science, and Transportation of the Sen-
10 ate, and publish on the website of the Administra-
11 tion—

12 “(A) as soon as practicable after the 180-
13 day period, an initial notice of the failure of the
14 Federal agency to make the decision; and

15 “(B) every 60 days thereafter until such
16 date as all decisions of the Federal agency re-
17 lating to the project have been made by the
18 Federal agency, an additional notice that de-
19 scribes the number of decisions of the Federal
20 agency that remain outstanding as of the date
21 of the additional notice.

22 “(4) INVOLVEMENT OF THE PUBLIC.—Nothing
23 in this subsection shall reduce any time period pro-
24 vided for public comment in the environmental re-

1 view process under existing Federal law, including a
2 regulation.

3 “(n) CONCURRENT REVIEWS AND SINGLE NEPA
4 DOCUMENT.—

5 “(1) CONCURRENT REVIEWS.—Each partici-
6 pating agency and cooperating agency under the ex-
7 pedited and coordinated environmental review proc-
8 ess established under this section shall—

9 “(A) carry out the obligations of that
10 agency under other applicable law concurrently,
11 and in conjunction, with the review required
12 under the National Environmental Policy Act of
13 1969 (42 U.S.C. 4321 et seq.), unless doing so
14 would impair the ability of the Federal agency
15 to conduct needed analysis or otherwise carry
16 out such obligations; and

17 “(B) formulate and implement administra-
18 tive, policy, and procedural mechanisms to en-
19 able the agency to ensure completion of the en-
20 vironmental review process in a timely, coordi-
21 nated, and environmentally responsible manner.

22 “(2) SINGLE NEPA DOCUMENT.—

23 “(A) IN GENERAL.—Except as inconsistent
24 with subsection (a), to the maximum extent
25 practicable and consistent with Federal law, all

1 Federal permits and reviews for a project shall
2 rely on a single environment document prepared
3 under the National Environmental Policy Act of
4 1969 (42 U.S.C. 4321 et seq.) under the lead-
5 ership of the Administrator of the Federal Avia-
6 tion Administration.

7 “(B) USE OF DOCUMENT.—

8 “(i) IN GENERAL.—To the maximum
9 extent practicable, the Administrator shall
10 develop an environmental document suffi-
11 cient to satisfy the requirements for any
12 Federal approval or other Federal action
13 required for the project, including permits
14 issued by other Federal agencies.

15 “(ii) COOPERATION OF PARTICI-
16 PATING AGENCIES.—Other participating
17 agencies shall cooperate with the lead
18 agency and provide timely information to
19 help the lead agency carry out this sub-
20 paragraph.

21 “(C) TREATMENT AS PARTICIPATING AND
22 COOPERATING AGENCIES.—A Federal agency
23 required to make an approval or take an action
24 for a project, as described in this paragraph,
25 shall work with the Administration for the

1 project to ensure that the agency making the
2 approval or taking the action is treated as being
3 both a participating and cooperating agency for
4 the project.

5 “(3) PARTICIPATING AGENCY RESPONSIBIL-
6 ITIES.—An agency participating in the expedited
7 and coordinated environmental review process under
8 this section shall—

9 “(A) provide comments, responses, studies,
10 or methodologies on those areas within the spe-
11 cial expertise or jurisdiction of the agency; and

12 “(B) use the process to address any envi-
13 ronmental issues of concern to the agency.

14 “(o) ENVIRONMENTAL IMPACT STATEMENT.—

15 “(1) IN GENERAL.—In preparing a final envi-
16 ronmental impact statement under the National En-
17 vironmental Policy Act of 1969 (42 U.S.C. 4321 et
18 seq.) for a project described or designated under
19 subsection (b), if the Administrator modifies the
20 statement in response to comments that are minor
21 and are confined to factual corrections or expla-
22 nations of why the comments do not warrant addi-
23 tional agency response, the Administrator may write
24 on errata sheets attached to the statement instead

1 of rewriting the draft statement, subject to the con-
2 dition that the errata sheets—

3 “(A) cite the sources, authorities, and rea-
4 sons that support the position of the agency;
5 and

6 “(B) if appropriate, indicate the cir-
7 cumstances that would trigger agency re-
8 appraisal or further response.

9 “(2) SINGLE DOCUMENT.—To the maximum
10 extent practicable, for a project subject to a coordi-
11 nated review process under this section, the Admin-
12 istrator shall expeditiously develop a single document
13 that consists of a final environmental impact state-
14 ment and a record of decision, unless—

15 “(A) the final environmental impact state-
16 ment or record of decision makes substantial
17 changes to the project that are relevant to envi-
18 ronmental or safety concerns; or

19 “(B) there is a significant new cir-
20 cumstance or information relevant to environ-
21 mental concerns that bears on the proposed ac-
22 tion or the environmental impacts of the pro-
23 posed action.

24 “(3) LENGTH OF ENVIRONMENTAL DOCU-
25 MENT.—

1 “(A) IN GENERAL.—Except as provided in
2 subparagraph (B), an environmental impact
3 statement shall not exceed 150 pages, not in-
4 cluding any citations or appendices.

5 “(B) EXTRAORDINARY COMPLEXITY.—An
6 environmental impact statement for a proposed
7 agency action of extraordinary complexity shall
8 not exceed 300 pages, not including any cita-
9 tions or appendices.

10 “(p) INTEGRATION OF PLANNING AND ENVIRON-
11 MENTAL REVIEW.—

12 “(1) IN GENERAL.—Subject to paragraph (5)
13 and to the maximum extent practicable and appro-
14 priate, the following agencies may adopt or incor-
15 porate by reference, and use a planning product in
16 proceedings relating to, any class of action in the en-
17 vironmental review process of a project described or
18 designated under subsection (b):

19 “(A) The lead agency for a project, with
20 respect to an environmental impact statement,
21 environmental assessment, categorical exclusion,
22 or other document prepared under the National
23 Environmental Policy Act of 1969 (42 U.S.C.
24 4321 et seq.).

1 “(B) A cooperating agency with responsi-
2 bility under Federal law with respect to the
3 process for and completion of any environ-
4 mental permit, approval, review, or study re-
5 quired for a project under any Federal law
6 other than the National Environmental Policy
7 Act of 1969 (42 U.S.C. 4321 et seq.), if con-
8 sistent with that law.

9 “(2) IDENTIFICATION.—If the relevant agency
10 makes a determination to adopt or incorporate by
11 reference and use a planning product under para-
12 graph (1), such agency shall identify the agencies
13 that participated in the development of the planning
14 products.

15 “(3) ADOPTION OR INCORPORATION BY REF-
16 ERENCE OF PLANNING PRODUCTS.—The relevant
17 agency may—

18 “(A) adopt or incorporate by reference an
19 entire planning product under paragraph (1); or

20 “(B) select portions of a planning project
21 under paragraph (1) for adoption or incorpora-
22 tion by reference.

23 “(4) TIMING.—The adoption or incorporation
24 by reference of a planning product under paragraph
25 (1) may—

1 “(A) be made at the time the relevant
2 agencies decide the appropriate scope of envi-
3 ronmental review for the project; or

4 “(B) occur later in the environmental re-
5 view process, as appropriate.

6 “(5) CONDITIONS.—The relevant agency in the
7 environmental review process may adopt or incor-
8 porate by reference a planning product under this
9 section if the relevant agency determines, with the
10 concurrence of the lead agency and, if the planning
11 product is necessary for a cooperating agency to
12 issue a permit, review, or approval for the project,
13 with the concurrence of the cooperating agency, that
14 the following conditions have been met:

15 “(A) The planning product was developed
16 through a planning process conducted pursuant
17 to applicable Federal law.

18 “(B) The planning product was developed
19 in consultation with appropriate Federal and
20 State resource agencies and Indian Tribes.

21 “(C) The planning process included broad
22 multidisciplinary consideration of systems-level
23 or corridor-wide transportation needs and po-
24 tential effects, including effects on the human
25 and natural environment.

1 “(D) The planning process included public
2 notice that the planning products produced in
3 the planning process may be adopted during
4 any subsequent environmental review process in
5 accordance with this section.

6 “(E) During the environmental review
7 process, the relevant agency has—

8 “(i) made the planning documents
9 available for public review and comment by
10 members of the general public and Fed-
11 eral, State, local, and Tribal governments
12 that may have an interest in the proposed
13 project;

14 “(ii) provided notice of the intention
15 of the relevant agency to adopt or incor-
16 porate by reference the planning product;
17 and

18 “(iii) considered any resulting com-
19 ments.

20 “(F) There is no significant new informa-
21 tion or new circumstance that has a reasonable
22 likelihood of affecting the continued validity or
23 appropriateness of the planning product or por-
24 tions thereof.

1 “(G) The planning product has a rational
2 basis and is based on reliable and reasonably
3 current data and reasonable and scientifically
4 acceptable methodologies.

5 “(H) The planning product is documented
6 in sufficient detail to support the decision or
7 the results of the analysis and to meet require-
8 ments for use of the information in the environ-
9 mental review process.

10 “(I) The planning product is appropriate
11 for adoption or incorporation by reference and
12 use in the environmental review process for the
13 project and is incorporated in accordance with,
14 and is sufficient to meet the requirements of,
15 the National Environmental Policy Act of 1969
16 (42 U.S.C. 4321 et seq.) and section 1502.21
17 of title 40, Code of Federal Regulations.

18 “(6) EFFECT OF ADOPTION OR INCORPORATION
19 BY REFERENCE.—Any planning product or portions
20 thereof adopted or incorporated by reference by the
21 relevant agency in accordance with this subsection
22 may be—

23 “(A) incorporated directly into an environ-
24 mental review process document or other envi-
25 ronmental document; and

1 “(B) relied on and used by other Federal
2 agencies in carrying out reviews of the project.

3 “(q) REPORT ON NEPA DATA.—

4 “(1) IN GENERAL.—The Administrator of the
5 Federal Aviation Administration shall carry out a
6 process to track, and annually submit to the Com-
7 mittee on Transportation and Infrastructure of the
8 House of Representatives and the Committee on
9 Commerce, Science, and Transportation of the Sen-
10 ate a report on projects described in subsection
11 (b)(1) that contains the information described in
12 paragraph (3).

13 “(2) TIME TO COMPLETE.—For purposes of
14 paragraph (3), the NEPA process—

15 “(A) for an environmental impact state-
16 ment—

17 “(i) begins on the date on which a no-
18 tice of intent is published in the Federal
19 Register; and

20 “(ii) ends on the date on which the
21 Administrator issues a record of decision,
22 including, if necessary, a revised record of
23 decision; and

24 “(B) for an environmental assessment—

1 “(i) begins on the date on which the
2 Administrator makes a determination to
3 prepare an environmental assessment; and

4 “(ii) ends on the date on which the
5 Administrator issues a finding of no sig-
6 nificant impact or determines that prepa-
7 ration of an environmental impact state-
8 ment is necessary.

9 “(3) INFORMATION DESCRIBED.—The informa-
10 tion referred to in paragraph (1) is, with respect to
11 the Federal Aviation Administration—

12 “(A) the number of proposed actions for
13 which a categorical exclusion was applied by the
14 Administration during the reporting period;

15 “(B) the number of proposed actions for
16 which a documented categorical exclusion was
17 applied by the Administration during the re-
18 porting period;

19 “(C) the number of proposed actions pend-
20 ing on the date on which the report is sub-
21 mitted for which the issuance of a documented
22 categorical exclusion by the Administration is
23 pending;

24 “(D) the number of proposed actions for
25 which an environmental assessment was issued

1 by the Administration during the reporting pe-
2 riod;

3 “(E) the length of time the Administration
4 took to complete each environmental assessment
5 described in subparagraph (D);

6 “(F) the number of proposed actions pend-
7 ing on the date on which the report is sub-
8 mitted for which an environmental assessment
9 is being drafted by the Administration;

10 “(G) the number of proposed actions for
11 which a final environmental impact statement
12 was completed by the Administration during the
13 reporting period;

14 “(H) the length of time that the Adminis-
15 tration took to complete each environmental im-
16 pact statement described in subparagraph (G);

17 “(I) the number of proposed actions pend-
18 ing on the date on which the report is sub-
19 mitted for which an environmental impact
20 statement is being drafted; and

21 “(J) for the proposed actions reported
22 under subparagraphs (F) and (I), the percent-
23 age of those proposed actions for which—

24 “(i) project funding has been identi-
25 fied; and

1 “(ii) all other Federal, State, and
2 local activities that are required to allow
3 the proposed action to proceed are com-
4 pleted.

5 “(4) DEFINITIONS.—In this section:

6 “(A) ENVIRONMENTAL ASSESSMENT.—The
7 term ‘environmental assessment’ has the mean-
8 ing given the term in section 1508.1 of title 40,
9 Code of Federal Regulations (or a successor
10 regulation).

11 “(B) ENVIRONMENTAL IMPACT STATE-
12 MENT.—The term ‘environmental impact state-
13 ment’ means a detailed statement required
14 under section 102(2)(C) of the National Envi-
15 ronmental Policy Act of 1969 (42 U.S.C.
16 4332(2)(C)).

17 “(C) NEPA PROCESS.—The term ‘NEPA
18 process’ means the entirety of the development
19 and documentation of the analysis required
20 under the National Environmental Policy Act of
21 1969 (42 U.S.C. 4321 et seq.), including the
22 assessment and analysis of any impacts, alter-
23 natives, and mitigation of a proposed action,
24 and any interagency participation and public in-

1 volvement required to be carried out before the
2 Administrator undertakes a proposed action.

3 “(D) PROPOSED ACTION.—The term ‘pro-
4 posed action’ means an action (within the
5 meaning of the National Environmental Policy
6 Act of 1969 (42 U.S.C. 4321 et seq.)) under
7 this title that the Administrator proposes to
8 carry out.

9 “(E) REPORTING PERIOD.—The term ‘re-
10 porting period’ means the fiscal year prior to
11 the fiscal year in which a report is issued under
12 subsection (a).”.

13 **SEC. 474. SUBCHAPTER III DEFINITIONS.**

14 Section 47175 of title 49, United States Code, is
15 amended—

16 (1) in paragraph (3)(A) by striking “and” at
17 the end and inserting “or”;

18 (2) in paragraph (4)—

19 (A) in subparagraph (A) by striking “and”
20 at the end; and

21 (B) in subparagraph (B)—

22 (i) by striking “(B)”; and

23 (ii) by redesignating clauses (i) and
24 (ii) as subparagraphs (B) and (C), respec-
25 tively;

1 (3) by striking paragraph (5);

2 (4) by redesignating paragraphs (3), (1), (4),
3 (2), (6), and (8) as paragraphs (1), (2), (3), (4),
4 (5), and (6), respectively; and

5 (5) by adding at the end the following:

6 “(8) **TERMINAL DEVELOPMENT.**—The term
7 ‘terminal development’ has the same meaning given
8 such term in section 47102.”.

9 **SEC. 475. PILOT PROGRAM EXTENSION.**

10 Section 190(i) of the FAA Reauthorization Act of
11 2018 (49 U.S.C. 47104 note) is amended by striking “5
12 years” and all that follows through the period at the end
13 and inserting “on October 1, 2028.”.

14 **SEC. 476. PART 150 NOISE STANDARDS UPDATE.**

15 (a) **IN GENERAL.**—Not later than 1 year after the
16 date of enactment of this Act, the Administrator of the
17 Federal Aviation Administration shall review and revise
18 part 150 of title 14, Code of Federal Regulations, to re-
19 flect all relevant laws and regulations, including part 161
20 of title 14, Code of Federal Regulations.

21 (b) **OUTREACH.**—As part of the review conducted
22 under subsection (a), the Administrator shall clarify exist-
23 ing and future noise policies and standards and seek feed-
24 back from airports, airport users, and individuals living

1 in the vicinity of airports before implementing any changes
2 to any noise policies or standards.

3 (c) BRIEFING.—Not later than 90 days after the date
4 of enactment of this Act, and every 6 months thereafter,
5 the Administrator shall brief the Committee on Transpor-
6 tation and Infrastructure of the House of Representatives
7 and the Committee on Commerce, Science, and Transpor-
8 tation of the Senate regarding the review conducted under
9 subsection (a).

10 (d) SUNSET.—The requirement under subsection (c)
11 shall terminate on September 30, 2028.

12 **SEC. 477. REDUCING COMMUNITY AIRCRAFT NOISE EXPO-**
13 **SURE.**

14 In implementing or revising a flight procedure, the
15 Administrator of the Federal Aviation Administration
16 shall seek to take the following actions (to the extent that
17 such actions do not negatively affect aviation safety or ef-
18 ficiency) to reduce undesirable aircraft noise:

19 (1) Implement flight procedures that can miti-
20 gate the impact of aircraft noise.

21 (2) Work with airport sponsors and potentially
22 impacted neighboring communities in establishing or
23 modifying aircraft arrival and departure routes.

24 (3) Discourage local encroachment of residen-
25 tial or other buildings near airports that could create

1 future aircraft noise complaints or impact airport
2 operations or aviation safety.

3 **SEC. 478. CATEGORICAL EXCLUSIONS.**

4 (a) CATEGORICAL EXCLUSION FOR PROJECTS OF
5 LIMITED FEDERAL ASSISTANCE.—An action by the Ad-
6 ministrator of the Federal Aviation Administration to ap-
7 prove, permit, finance, or otherwise authorize any airport
8 project that is undertaken by the sponsor, owner, or oper-
9 ator of a public-use airport shall be presumed to be cov-
10 ered by a categorical exclusion under Federal Aviation Ad-
11 ministration Order 1050.1F, or any successor document,
12 if such project—

13 (1) receives less than \$6,000,000 (as adjusted
14 annually by the Administrator to reflect any in-
15 creases in the Consumer Price Index prepared by
16 the Department of Labor) of Federal funds or funds
17 from charges collected under section 40117 of title
18 49, United States Code; or

19 (2) with a total estimated cost of not more than
20 \$35,000,000 (as adjusted annually by the Adminis-
21 trator to reflect any increases in the Consumer Price
22 Index prepared by the Department of Labor) and
23 Federal funds comprising less than 15 percent of the
24 total estimated project cost.

1 (b) CATEGORICAL EXCLUSION IN EMERGENCIES.—
2 An action by the Administrator to approve, permit, fi-
3 nance, or otherwise authorize an airport project that is
4 undertaken by the sponsor, owner, or operator of a public-
5 use airport shall be presumed to be covered by a categor-
6 ical exclusion under Federal Aviation Administration
7 Order 1050.1F, or any successor document, if such project
8 is—

9 (1) for the repair or reconstruction of any air-
10 port facility, runway, taxiway, or similar structure
11 that is in operation or under construction when
12 damaged by an emergency declared by the Governor
13 of the State and concurred in by the Administrator,
14 or for a disaster or emergency declared by the Presi-
15 dent pursuant to the Robert T. Stafford Disaster
16 Relief and Emergency Assistance Act (42 U.S.C.
17 5121 et seq.);

18 (2) in the same location with the same capacity,
19 dimensions, and design as the original airport facil-
20 ity, runway, taxiway, or similar structure as before
21 the declaration described in this section; and

22 (3) commenced within a 2-year period begin-
23 ning on the date of a declaration described in this
24 section.

1 (c) EXTRAORDINARY CIRCUMSTANCES.—The pre-
2 sumption that an action is covered by a categorical exclu-
3 sion under subsections (a) and (b) shall not apply if the
4 Administrator determines that extraordinary cir-
5 cumstances exist with respect to such action.

6 (d) RULE OF CONSTRUCTION.—Nothing in this sec-
7 tion shall be construed to impact any aviation safety au-
8 thority of the Administrator.

9 (e) DEFINITIONS.—In this section:

10 (1) CATEGORICAL EXCLUSION.—The term “cat-
11 egorical exclusion” has the meaning given the term
12 in section 1508.1(d) of title 40, Code of Federal
13 Regulations.

14 (2) PUBLIC-USE AIRPORT; SPONSOR.—The
15 terms “public-use airport” and “sponsor” have the
16 meaning given such terms in section 47102 of title
17 49, United States Code.

18 **SEC. 479. CRITICAL HABITAT ON OR NEAR AIRPORT PROP-**
19 **ERTY.**

20 (a) FEDERAL AGENCY REQUIREMENTS.—The Ad-
21 ministrator of the Federal Aviation Administration, to the
22 maximum extent practicable, shall collaborate with the
23 heads of appropriate Federal agencies to ensure that des-
24 ignations of critical habitat, as such term is defined in

1 section 3 of the Endangered Species Act of 1973 (16
2 U.S.C. 1532), on or near airport property do not—

3 (1) result in conflicting statutory, regulatory, or
4 Federal grant assurance requirements for airports or
5 aircraft operators;

6 (2) interfere with the safe operation of aircraft;
7 or

8 (3) occur on airport-owned lands that have be-
9 come attractive habitat for a threatened or endan-
10 gered species because such lands—

11 (A) have been prepared for future develop-
12 ment;

13 (B) have been designated as noise buffer
14 land; or

15 (C) are held by the airport to prevent en-
16 croachment of uses that are incompatible with
17 airport operations.

18 (b) STATE REQUIREMENTS.—In a State in which a
19 State agency is authorized to designate land on or near
20 airport property for the conservation of a threatened or
21 endangered species in the State, the Administrator, to the
22 maximum extent practicable, shall collaborate with the
23 State in the same manner as the Administrator collabo-
24 rates with the heads of Federal agencies under subsection
25 (a).

1 **SEC. 480. UPDATING PRESUMED TO CONFORM LIMITS.**

2 Not later than 24 months after the date of enactment
3 of this Act, the Administrator of the Federal Aviation Ad-
4 ministration shall take such actions as are necessary to
5 update the Administration's list of actions that are pre-
6 sumed to conform to a State implementation plan pursu-
7 ant to section 93.153(f) of title 40, Code of Federal Regu-
8 lations, to include projects relating to the construction of
9 aircraft hangars.

10 **SEC. 481. RECOMMENDATIONS ON REDUCING ROTORCRAFT**
11 **NOISE IN DISTRICT OF COLUMBIA.**

12 (a) STUDY.—The Comptroller General of the United
13 States shall conduct a study on reducing rotorcraft noise
14 in the District of Columbia.

15 (b) CONTENTS.—The study conducted under sub-
16 section (a) shall consider—

17 (1) the extent to which military operators con-
18 sider operating over unpopulated areas outside of
19 the District of Columbia for training missions;

20 (2) the extent to which vehicles or aircraft other
21 than conventional rotorcraft (such as unmanned air-
22 craft) could be used for emergency and law enforce-
23 ment response; and

24 (3) the extent to which relevant operators and
25 entities have assessed and addressed, as appropriate,

1 the noise impacts of various factors of operating
2 rotorcraft, including, at a minimum—

- 3 (A) altitude;
- 4 (B) the number of flights;
- 5 (C) flight paths;
- 6 (D) time of day of flights;
- 7 (E) types of aircraft;
- 8 (F) operating procedures; and
- 9 (G) pilot training.

10 (c) REPORT.—Not later than 1 year after the date
11 of enactment of this Act, the Comptroller General of the
12 United States shall brief the Committee on Transportation
13 and Infrastructure of the House of Representatives and
14 the Committee on Commerce, Science, and Transportation
15 of the Senate on preliminary observations with a report
16 to follow at a date agreed upon at the time of the briefing
17 containing—

18 (1) the contents of the study conducted under
19 subsection (a); and

20 (2) any recommendations for the reduction of
21 rotorcraft noise in the District of Columbia.

22 (d) RELEVANT OPERATORS AND ENTITIES DE-
23 FINED.—In this section, the term “relevant operators and
24 entities” means—

1 (1) the Chief of Police of the Metropolitan Po-
2 lice Department of the District of Columbia;

3 (2) any medical rotorcraft operator that rou-
4 tinely flies a rotorcraft over the District of Colum-
5 bia; and

6 (3) any other operator that routinely flies a
7 rotorcraft over the District of Columbia.

8 **SEC. 482. UFP STUDY.**

9 (a) **IN GENERAL.**—Not later than 180 days after the
10 date of enactment of this Act, the Administrator of the
11 Federal Aviation Administration shall enter into an agree-
12 ment with the National Academies under which the Na-
13 tional Research Council shall carry out a study examining
14 airborne ultrafine particles and the effect of such particles
15 on human health.

16 (b) **SCOPE OF STUDY.**—The study conducted under
17 subsection (a) shall—

18 (1) summarize the relevant literature and stud-
19 ies done on airborne UPFs worldwide;

20 (2) focus on large hub airports;

21 (3) examine airborne UFPs and their potential
22 effect on human health, including—

23 (A) characteristics of UFPs present in the
24 air;

1 (B) spatial and temporal distributions of
2 UFP concentrations;

3 (C) primary sources of UFPs;

4 (D) the contribution of aircraft and airport
5 operations to the distribution of UFP con-
6 centrations compared to other sources;

7 (E) potential health effects associated with
8 elevated UFP exposures, including outcomes re-
9 lated to cardiovascular disease, respiratory in-
10 fection and disease, degradation of
11 neurocognitive functions, and other health ef-
12 fects; and

13 (F) potential UFP exposures, especially to
14 susceptible groups;

15 (4) identify measures intended to reduce the re-
16 lease of UFPs; and

17 (5) identify information gaps related to under-
18 standing potential relationships between UFP expo-
19 sures and health effects, contributions of aviation-re-
20 lated emissions to UFP exposures, and the effective-
21 ness of mitigation measures.

22 (c) COORDINATION.— The Administrator may coordi-
23 nate with the heads of such other agencies that the Ad-
24 ministrator considers appropriate to provide data and
25 other assistance necessary for the study.

1 (d) REPORT.—Not later than 180 days after the Na-
2 tional Research Council submits of the results of the study
3 to the Administrator, the Administrator shall submit to
4 the Committee on Transportation and Infrastructure of
5 the House of Representatives and the Committee on Com-
6 merce, Science, and Transportation of the Senate a report
7 containing the results of the study carried out under sub-
8 section (a), including any recommendations based on such
9 study.

10 (e) DEFINITION OF ULTRAFINE PARTICLE.—In this
11 section, the terms “ultrafine particle” and “UFP” mean
12 particles with diameters less than or equal to 100 nano-
13 meters.

14 **SEC. 483. AVIATION AND AIRPORT COMMUNITY ENGAGE-**
15 **MENT.**

16 (a) ESTABLISHMENT OF TASK FORCE.—

17 (1) IN GENERAL.—Not later than 90 days after
18 the date of enactment of this Act, the Administrator
19 of the Federal Aviation Administration shall estab-
20 lish an airport community of interest task force (in
21 this section referred to as the “Task Force”) to
22 evaluate and improve existing processes and mecha-
23 nisms for engaging communities impacted by airport
24 development and aviation operations.

25 (2) ACTIVITIES.—The Task Force shall—

1 (A) review research on aircraft noise im-
2 pacts to identify potential actions the Adminis-
3 trator could take;

4 (B) review processes and practices of the
5 Administration for engaging communities prior
6 to or after air traffic pattern changes that im-
7 pact such communities, including with how such
8 processes and practices compare to best prac-
9 tices from organizations with expertise in grass-
10 roots community organizing and collaboration;

11 (C) assess Federal efforts to mitigate noise
12 impacts on communities, including costs and
13 benefits of such efforts;

14 (D) assess the various actions that State
15 and local government officials and community
16 planners could take when considering changes
17 to airport infrastructure, including planned air-
18 port projects or surrounding airport community
19 developments;

20 (E) identify potential improvements to
21 Federal, State, and local airport development
22 policy and planning processes to better balance
23 which communities experience negative
24 externalities as a result of airport operations;

1 (F) consider guidance to airports and air-
2 port communities to improve engagement with
3 the Administration, as recommended by the
4 document titled “Aircraft Noise: FAA Could
5 Improve Outreach Through Enhanced Noise
6 Metrics, Communication, and Support to Com-
7 munities”, issued in September 2021 (GAO-
8 21-103933);

9 (G) consider mechanisms and opportunities
10 for the Administration to facilitate better ex-
11 change of helicopter noise information with op-
12 erators in communities adversely impacted by
13 helicopter noise, as recommended by the Comp-
14 troller General in the document titled “Aircraft
15 Noise: Better Information Sharing Could Im-
16 prove Responses to Washington, D.C. Area Hel-
17 icopter Noise Concerns” (GAO-21-200); and

18 (H) review air traffic controller guidance
19 on use and development of noise abatement pro-
20 cedures of the Administration to identify areas
21 for improvement or efficiency that do not ad-
22 versely impact aviation safety.

23 (3) COMPOSITION.—

24 (A) APPOINTMENT.—The Administrator
25 shall appoint the members of the Task Force.

1 (B) CHAIRPERSON.—The Task Force shall
2 be chaired by the Administrator’s executive
3 level designee.

4 (C) REPRESENTATION.—The Task Force
5 shall be comprised of representatives from—

6 (i) airport communities or a rep-
7 resentative organization of an airport com-
8 munity;

9 (ii) airport operators;

10 (iii) airlines;

11 (iv) experts with specific knowledge of
12 air traffic planning;

13 (v) aircraft manufacturers;

14 (vi) local government officials; and

15 (vii) such other representatives as the
16 Administrator considers appropriate.

17 (4) COMPENSATION.—Members of the Task
18 Force shall serve without compensation.

19 (5) NONAPPLICABILITY OF FACIA.—Chapter 10
20 of title 5, United States Code, shall not apply to the
21 Task Force established under this section.

22 (6) CONSULTATION.—The Task Force shall, as
23 appropriate, consult with relevant experts and stake-
24 holders not listed in paragraph (3)(C) in conducting
25 the activities described in paragraph (2).

1 (7) REPORTS.—

2 (A) RECOMMENDATIONS.—Not later than
3 1 year after the date of the establishment of the
4 Task Force and every year thereafter through
5 fiscal year 2028, the Task Force shall provide
6 to the Committee on Transportation and Infra-
7 structure of the House of Representatives, the
8 Committee on Commerce, Science, and Trans-
9 portation of the Senate, and the Administrator
10 recommendations to improve the processes and
11 mechanisms for engaging communities impacted
12 by airport development and aviation operations.

13 (B) BRIEFING.—Not later than 60 days
14 after the submission of the annual rec-
15 ommendations under subparagraph (A), the Ad-
16 ministrator shall brief the committees described
17 in such subparagraph on any plans of the Ad-
18 ministration to implement the recommendations
19 of the Task Force, including explanations for
20 each of the recommendations the Administrator
21 does not intend to adopt.

22 (b) ENGAGEMENT EVENTS.—

23 (1) ANNUAL EVENT.—The Administrator shall
24 seek to convene at least 1 annual event in each geo-

1 graphic region of the Administration to engage with
2 aviation communities on issues of regional import.

3 (2) PURPOSE.—The purpose of the engagement
4 events described under paragraph (1) shall be to fos-
5 ter open and transparent communication between
6 the Federal Government and aviation-impacted com-
7 munities prior to, during, and after decision making
8 at the Federal level.

9 (3) TOPICS OF CONSIDERATION.—The topics of
10 consideration of such engagement events shall be ap-
11 proved by the Regional Administrator or the Re-
12 gional Community Engagement Officer of the appli-
13 cable region, in consultation with regional interest
14 groups. Topic areas shall be driven by local and re-
15 gional feedback and may focus on—

16 (A) noise concerns from low-flying com-
17 mercial aircraft;

18 (B) purchase and installation of aircraft
19 noise reduction measures;

20 (C) new development projects in close
21 proximity to airports and realistic noise expect-
22 tations for such projects;

23 (D) proposed airport expansion projects
24 and the potential noise implications of such
25 projects;

1 (E) the establishment of new, or changes
2 to existing, approach and departure routes and
3 the community impacts of such changes;

4 (F) upcoming events with an aviation com-
5 ponent; or

6 (G) any other topic or issue considered rel-
7 evant by an aviation-impacted community.

8 (4) PARTICIPATION.—

9 (A) COORDINATION.—All events described
10 in paragraph (3) shall be convened by or in co-
11 ordination with the regional offices of the Ad-
12 ministration.

13 (B) ATTENDANCE BY REPRESENTA-
14 TIVES.—The Administrator shall ensure rep-
15 resentatives from relevant program offices of
16 the Administration are in attendance at such
17 events.

18 (C) APPROPRIATE PARTICIPATION.—The
19 Administrator shall collaborate with community
20 groups at the State, municipal, city, or local
21 government level to ensure appropriate partici-
22 pation by as many relevant parties on a given
23 issue as practicable. Such relevant parties may
24 include—

25 (i) State or local government officials;

- 1 (ii) local or municipal planning and
2 zoning officials;
3 (iii) neighborhood representatives;
4 (iv) aircraft operators, flight school
5 representatives, or other local aviation enti-
6 ties;
7 (v) airport operators; and
8 (vi) any other parties as appropriate.

9 (D) COORDINATION.—The Administrator
10 shall coordinate Federal participation that is
11 not under the Administration through the Fed-
12 eral Interagency Committee on Aviation Noise
13 to encourage appropriate Federal representa-
14 tion at all such events, based on the topic areas
15 of consideration.

16 **SEC. 484. COMMUNITY COLLABORATION PROGRAM.**

17 (a) ESTABLISHMENT.—Not later than 90 days after
18 the date of enactment of this Act, the Administrator of
19 the Federal Aviation Administration shall establish a
20 Community Collaboration Program (in this section re-
21 ferred to as the “Program”) within the Office for Policy,
22 International Affairs, and Environment of the Administra-
23 tion.

24 (b) STAFF.—The Program shall be comprised of rep-
25 resentatives from—

1 (1) the Office for Policy, International Affairs,
2 and Environment of the Administration;

3 (2) the Office of Airports of the Administration;

4 (3) the Air Traffic Organization of the Admin-
5 istration; and

6 (4) other entities as considered appropriate by
7 the Administrator.

8 (c) RESPONSIBILITIES.—

9 (1) IN GENERAL.—The Program shall facilitate
10 and harmonize, as appropriate, policies and proce-
11 dures carried out by the entities listed in subsection
12 (b) pertaining to community engagement relating
13 to—

14 (A) airport planning and development;

15 (B) noise and environmental policy;

16 (C) NextGen implementation;

17 (D) air traffic route changes;

18 (E) integration of new and emerging en-
19 trants; and

20 (F) other topics with respect to which com-
21 munity engagement is critical to program suc-
22 cess.

23 (2) SPECIFIED RESPONSIBILITIES.—The re-
24 sponsibilities of the Program lead shall include—

1 (A) the establishment of, and membership
2 selection for, the Airport Community of Interest
3 Task Force, established under section 483;

4 (B) joint execution with Federal Aviation
5 Administration Regional Administrators of re-
6 gional community engagement events, as de-
7 scribed in section 483;

8 (C) updating the internal guidance of the
9 Administration for community engagement
10 based on recommendations from such Task
11 Force and best practices of other Federal agen-
12 cies and external organizations with expertise in
13 community engagement;

14 (D) coordinating with the Air Traffic Or-
15 ganization on community engagement efforts
16 related to air traffic procedure changes to en-
17 sure that impacted communities are consulted
18 in a meaningful way;

19 (E) oversight of Regional Ombudsmen of
20 the Administration;

21 (F) oversight, streamlining, and increasing
22 the responsiveness of the noise complaint proc-
23 ess of the Administration by—

1 (i) centralizing noise complaint data
2 and improving data collection methodolo-
3 gies;

4 (ii) increasing public accessibility to
5 such Regional Ombudsmen;

6 (iii) ensuring such Regional Ombuds-
7 men are consulted in local air traffic proce-
8 dure development decisions;

9 (iv) collecting feedback from such Re-
10 gional Ombudsmen to inform national pol-
11 icymaking efforts; and

12 (v) other recommendations made by
13 the Airport Community of Interest Task
14 Force;

15 (G) timely implementation of the rec-
16 ommendations, as appropriate, made by the
17 Comptroller General of the United States to the
18 Secretary of Transportation contained in the re-
19 port titled “Aircraft Noise: FAA Could Improve
20 Outreach Through Enhanced Noise Metrics,
21 Communication, and Support to Communities”,
22 issued in September 2021 (GAO-21-103933)
23 to improve the outreach of the FAA to local
24 communities impacted by aircraft noise, includ-
25 ing—

1 (i) any recommendations to—
2 (I) identify appropriate supple-
3 mental metrics for assessing noise im-
4 pacts and circumstances for their use
5 to aid in the internal assessment of
6 the Administration of noise impacts
7 related to proposed flight path
8 changes;

9 (II) update guidance to incor-
10 porate additional tools to more clearly
11 convey expected impacts, such as
12 other noise metrics and visualization
13 tools; and

14 (III) improve guidance to air-
15 ports and communities on effectively
16 engaging with the Administration; and

17 (ii) any other recommendations in-
18 cluded in the report that would assist the
19 agency in improving outreach to commu-
20 nities affected by aircraft noise; and

21 (H) other responsibilities as considered ap-
22 propriate by the Administrator.

23 (d) REPORT.—Not later than 2 years after the Ad-
24 ministrator implements the recommendations described in
25 subsection (c)(2)(H), the Administrator shall brief the

1 Committee on Transportation and Infrastructure of the
2 House of Representatives and the Committee on Com-
3 merce, Science, and Transportation of the Senate describ-
4 ing—

5 (1) the implementation of each such rec-
6 ommendation;

7 (2) how any recommended actions are assisting
8 the Administrator in improving outreach to commu-
9 nities affected by aircraft noise and other commu-
10 nity engagement concerns; and

11 (3) any challenges or barriers that limit or pre-
12 vent the ability of the Administrator to take such ac-
13 tions.

14 **SEC. 485. THIRD PARTY STUDY ON AVIATION NOISE**
15 **METRICS.**

16 (a) STUDY.—Not later than 180 days after the date
17 of enactment of this Act, the Administrator of the Federal
18 Aviation Administration shall enter into an agreement
19 with the National Academies to conduct a study on avia-
20 tion noise metrics.

21 (b) CONTENTS.—The study required under sub-
22 section (a) shall include an assessment of—

23 (1) the efficacy of the day-night average sound
24 level (in this section referred to as “DNL”) noise
25 metric compared to other alternative models;

1 (2) the disadvantages of the DNL noise metric
2 in effect as of the date of enactment of this Act
3 compared to other alternative models;

4 (3) any potential changes that should be made
5 to the DNL noise metric in effect as of the date of
6 enactment of this Act; and

7 (4) the data collected by the Neighborhood En-
8 vironmental Survey of the Administration using al-
9 ternative noise metrics.

10 (c) **REPORT TO CONGRESS.**—Not later than 2 years
11 after the date of enactment of this Act, the National Acad-
12 emies shall submit to the Administrator, the Committee
13 on Transportation and Infrastructure of the House of
14 Representatives, and the Committee on Commerce,
15 Science, and Transportation of the Senate a report—

16 (1) on the results of the study described in sub-
17 section (a); and

18 (2) containing recommendations regarding the
19 most appropriate metric to adequately assess the
20 public health impacts of aircraft noise.

21 **SEC. 486. INFORMATION SHARING REQUIREMENT.**

22 (a) **IN GENERAL.**—Not later than 180 days after the
23 date of enactment of this Act, the Secretary of Transpor-
24 tation, acting through the Administrator of the Federal
25 Aviation Administration, shall establish a mechanism to

1 make helicopter noise complaint data accessible to the
2 Federal Aviation Administration, to helicopter operators
3 operating in the Washington, D.C. area, and to the public
4 on a website of the Administration, based on the rec-
5 ommendation of the Government Accountability Office in
6 the report published on January 7, 2021, titled “Aircraft
7 Noise: Better Information Sharing Could Improve Re-
8 sponses to Washington, D.C. Area Helicopter Noise Con-
9 cerns”.

10 (b) COOPERATION.—Any helicopter operator oper-
11 ating in the Washington, D.C. area shall provide heli-
12 copter noise complaint data to the Federal Aviation Ad-
13 ministration through the mechanism established under
14 subsection (a).

15 (c) DEFINITIONS.—In this section:

16 (1) HELICOPTER NOISE COMPLAINT DATA.—

17 The term “helicopter noise complaint data”—

18 (A) means general data relating to a com-
19 plaint made by an individual about helicopter
20 noise in the Washington, D.C. area and may in-
21 clude—

22 (i) the location and description of the
23 event that is the subject of the complaint;

24 (ii) the start and end time of such
25 event;

1 (iii) a description of the aircraft that
2 is the subject of the complaint; and

3 (iv) the airport name associated with
4 such event; and

5 (B) does not include the personally identi-
6 fiable information of the individual who sub-
7 mitted the complaint.

8 (2) WASHINGTON, D.C. AREA.—The term
9 “Washington, D.C. area” means the area inside of
10 a 30-mile radius surrounding Ronald Reagan Wash-
11 ington National Airport.

12 **TITLE V—AVIATION SAFETY**

13 **Subtitle A—General Provisions**

14 **SEC. 501. ZERO TOLERANCE FOR NEAR MISSES, RUNWAY** 15 **INCURSIONS, AND SURFACE SAFETY RISKS.**

16 (a) POLICY.—

17 (1) IN GENERAL.—Section 47101(a) of title 49,
18 United States Code, is amended—

19 (A) by redesignating paragraphs (2)
20 through (13) as paragraphs (3) through (14),
21 respectively; and

22 (B) by inserting after paragraph (1) the
23 following:

24 “(2) that projects, activities, and actions that
25 prevent runway incursions serve to—

1 “(A) improve airport surface surveillance;
2 and

3 “(B) mitigate surface safety risks that are
4 essential to ensuring the safe operation of the
5 airport and airway system;”.

6 (2) CONFORMING AMENDMENTS.—Section
7 47101 of title 49, United States Code, is amended—

8 (A) in subsection (g) by striking “sub-
9 section (a)(5)” and inserting “subsection
10 (a)(6)”; and

11 (B) in subsection (h) by striking “sub-
12 section (a)(6)” and inserting “subsection
13 (a)(7)”.

14 (3) CONTINUOUS EVALUATION.—In carrying
15 out section 47101(a) of title 49, United States Code,
16 as amended by this subsection, the Administrator of
17 the Federal Aviation Administration shall establish a
18 process to continuously track and evaluate ground
19 traffic and air traffic activity and related incidents
20 at airports.

21 (b) RUNWAY SAFETY COUNCIL.—

22 (1) IN GENERAL.—Not later than 6 months
23 after the date of enactment of this Act, the Adminis-
24 trator of the Federal Aviation Administration shall
25 establish a council, to be known as the “Runway

1 Safety Council” (in this section referred to as the
2 “Council”), to develop a systematic proactive man-
3 agement strategy to address surface safety risks.

4 (2) DUTIES.—The duties of the Council shall
5 include, at a minimum, advancing the development
6 of risk-based, data driven, integrated systems solu-
7 tions and strategies to enhance surface safety risk
8 mitigation.

9 (3) MEMBERSHIP.—

10 (A) IN GENERAL.—In establishing the
11 Council, the Administrator shall appoint at
12 least 1 member from each of the following:

13 (i) Airport operators.

14 (ii) Air carriers.

15 (iii) Aircraft operators.

16 (iv) Avionics manufacturers.

17 (v) Flight schools.

18 (vi) The certified bargaining rep-
19 resentative of aviation safety inspectors for
20 the Administration.

21 (vii) The exclusive bargaining rep-
22 resentative of the air traffic controllers cer-
23 tified under section 7111 of title 5, United
24 States Code.

1 (viii) Other safety experts the Admin-
2 istrator determines appropriate.

3 (B) ADDITIONAL MEMBERS.—The Admin-
4 istrator may appoint members representing any
5 other stakeholder organization that the Admin-
6 istrator determines appropriate to the Runway
7 Safety Council.

8 (c) AIRPORT SURFACE SURVEILLANCE.—

9 (1) IDENTIFICATION.—Not later than 180 days
10 after the date of enactment of this Act, the Adminis-
11 trator shall, in coordination with the Council, con-
12 sult with relevant stakeholders to identify tech-
13 nologies, equipment, and systems that—

14 (A) may provide airport surface surveil-
15 lance capabilities at airports lacking such capa-
16 bilities;

17 (B) may augment existing airport surface
18 surveillance systems; or

19 (C) may provide onboard situational
20 awareness to pilots.

21 (2) CRITERIA.—Not later than 1 year after the
22 date of enactment of this Act, the Administrator
23 shall—

24 (A) based on the information obtained pur-
25 suant to paragraph (1), identify airport surface

1 surveillance systems that meet the standards of
2 the Administration and may be able to—

3 (i) provide airport surface surveillance
4 capabilities at airports lacking such capa-
5 bilities; or

6 (ii) augment existing airport surface
7 surveillance systems; and

8 (B) establish clear and quantifiable criteria
9 relating to operational factors, including ground
10 traffic and air traffic activity and the rate of
11 runway and terminal airspace safety events (in-
12 cluding runway incursions), that determine
13 when the installation and deployment of an air-
14 port surface surveillance system, or other run-
15 way safety system (including runway status
16 lights), at an airport is required.

17 (3) DEPLOYMENT.—Not later than 5 years
18 after the date of enactment of this Act, the Adminis-
19 trator shall ensure that airport surface surveillance
20 systems are deployed and operational at—

21 (A) all airports described in paragraph
22 (2)(A); and

23 (B) all medium and large hub airports.

24 (4) REPORT.—Not later than 4 years after the
25 date of enactment of this Act, the Administrator

1 shall brief the Committee on Transportation and In-
2 frastructure of the House of Representatives and the
3 Committee on Commerce, Science, and Transpor-
4 tation of the Senate on the progress of the deploy-
5 ment described in paragraph (3).

6 (d) FOREIGN OBJECT DEBRIS DETECTION.—

7 (1) IN GENERAL.—Not later than 3 years after
8 the date of enactment of this Act, the Administrator
9 shall assess, in coordination with the Council, auto-
10 mated foreign object debris monitoring and detection
11 systems at not less than 3 airports that are using
12 such systems.

13 (2) CONSIDERATIONS.—In conducting the as-
14 sessment under paragraph (1), the Administrator
15 shall consider the following:

16 (A) The categorization of an airport.

17 (B) The potential frequency of foreign ob-
18 ject debris incidents on airport runways or ad-
19 jacent ramp areas.

20 (C) The availability of funding for the in-
21 stallation and maintenance of foreign object de-
22 bris monitoring and detection systems.

23 (D) The impact of such systems on the air-
24 field operations of an airport.

1 (E) The effectiveness of available foreign
2 object debris monitoring and detection systems.

3 (F) Any other factors relevant to assessing
4 the return on investment of foreign object de-
5 bris monitoring and detection systems.

6 (3) CONSULTATION.—In carrying out this sub-
7 section, the Administrator and the Council shall con-
8 sult with manufacturers and suppliers of foreign ob-
9 ject debris detection technology and any other rel-
10 evant stakeholders.

11 (e) RUNWAY SAFETY STUDY.—

12 (1) IN GENERAL.—Not later than 2 years after
13 the date of enactment of this Act, the Administrator
14 shall seek to enter into an agreement with a feder-
15 ally funded research and development center to con-
16 duct a study of runway incursions, surface incidents,
17 operational errors, or losses of standard separation
18 of aircraft in the approach or departure phase of
19 flight to determine how advanced technologies and
20 future airport development projects may be able to
21 reduce the frequency of such events and enhance
22 aviation safety.

23 (2) CONSIDERATIONS.—In conducting the study
24 under paragraph (1), the federally funded research
25 and development center shall—

1 (A) examine data relating to recurring
2 runway incursions, surface incidents, oper-
3 ational errors, or losses of standard separation
4 of aircraft in the approach or departure phase
5 of flight at airports to identify the underlying
6 factors that caused such events;

7 (B) assess metrics used to identify when
8 such events are increasing at an airport;

9 (C) assess available and developmental
10 technologies, including and beyond such tech-
11 nologies considered in subsection (c), that may
12 augment existing air traffic management capa-
13 bilities of surface surveillance and terminal air-
14 space equipment;

15 (D) consider growth trends in airport size,
16 staffing and communication complexities to
17 identify—

18 (i) future gaps in information ex-
19 change between aerospace stakeholders;
20 and

21 (ii) methods for meeting future near
22 real-time information sharing needs; and

23 (E) examine airfield safety training pro-
24 grams used by airport tenants and other stake-
25 holders operating on airfields of airports, in-

1 including airfield familiarization training pro-
2 grams for employees, to assess scalability to
3 handle future growth in airfield capacity and
4 traffic.

5 (3) RECOMMENDATIONS.—In conducting the
6 study required by paragraph (1), the federally fund-
7 ed research and development center shall develop
8 recommendations for the strategic planning efforts
9 of the Administration to appropriately maintain sur-
10 face safety considering future increases in air traffic
11 and based on the considerations described in para-
12 graph (2).

13 (4) REPORT TO CONGRESS.—Not later than 90
14 days after the completion of the study required by
15 paragraph (1), the Administrator shall submit to the
16 Committee on Transportation and Infrastructure of
17 the House of Representatives and the Committee on
18 Commerce, Science, and Transportation of the Sen-
19 ate a report on the findings of such study and any
20 recommendations developed under paragraph (3).

21 (f) AIRPORT SURFACE DETECTION AND SURVEIL-
22 LANCE SYSTEM DEFINED.—In this section, the term “air-
23 port surface detection and surveillance system” means an
24 airport surveillance system that is—

1 (1) designed to track surface movement of air-
2 craft and vehicles; and

3 (2) capable of alerting air traffic controllers or
4 flight crew members of a possible runway incursion,
5 misaligned approach, or other safety event.

6 **SEC. 502. GLOBAL AVIATION SAFETY.**

7 (a) IN GENERAL.—Section 40104(d) of title 49,
8 United States Code, (as redesignated by section 325) is
9 amended—

10 (1) in the subsection heading by inserting “AND
11 ASSISTANCE” after “INTERNATIONAL ROLE”;

12 (2) in paragraph (1) by striking “The Adminis-
13 trator” and inserting “In carrying out subsection
14 (a), the Administrator”;

15 (3) by redesignating paragraph (2) as para-
16 graph (4); and

17 (4) by inserting after paragraph (1) the fol-
18 lowing:

19 “(2) INTERNATIONAL PRESENCE.—The Admin-
20 istrator shall maintain an international presence
21 to—

22 “(A) assist foreign civil aviation authorities
23 in—

24 “(i) establishing robust aviation over-
25 sight practices and policies;

1 “(ii) training staff, to include inspec-
2 tors and accident investigators;

3 “(iii) harmonizing international avia-
4 tion standards for air traffic management,
5 operator certification, aircraft certification,
6 airports, and certificated or credentialed
7 individuals;

8 “(iv) validating and accepting foreign
9 aircraft design and production approvals;

10 “(v) maintaining appropriate levels of
11 air navigation services;

12 “(vi) preparing for new aviation tech-
13 nologies; and

14 “(vii) appropriately adopting con-
15 tinuing airworthiness information, such as
16 airworthiness directives;

17 “(B) encourage the adoption of United
18 States standards, regulations, and policies;

19 “(C) establish, maintain, and update bilat-
20 eral or multilateral aviation safety agreements
21 and the aviation safety information contained
22 within such agreements;

23 “(D) engage in bilateral and multilateral
24 discussions and provide technical assistance as
25 described in paragraph (5);

1 “(E) validate foreign aviation products and
2 ensure reciprocal validation of products for
3 which the United States is the state of design
4 or production;

5 “(F) support accident and incident inves-
6 tigations, particularly such investigations that
7 involve United States persons and certified
8 products and such investigations where the Na-
9 tional Transportation Safety Board is sup-
10 porting an investigation pursuant to annex 13
11 of the International Civil Aviation Organization;

12 “(G) support the international activities of
13 the United States aviation sector;

14 “(H) maintain valuable relationships with
15 entities with aviation equities, including civil
16 aviation authorities, other governmental bodies,
17 non-governmental organizations, and foreign
18 manufacturers; and

19 “(I) perform other activities as determined
20 necessary by the Administrator.”.

21 (b) REVIEW OF INTERNATIONAL FIELD OFFICES.—
22 Section 40104(d) of title 49, United States Code, (as re-
23 designated by section 325) is further amended by inserting
24 after paragraph (2) the following:

1 “(3) INTERNATIONAL OFFICES.—In carrying
2 out the responsibilities described in subsection (a),
3 the Administrator shall—

4 “(A) maintain international offices of the
5 Administration;

6 “(B) every 3 years, review existing inter-
7 national offices to determine—

8 “(i) the effectiveness of such offices in
9 fulfilling the mission described in para-
10 graph (2); and

11 “(ii) the adequacy of resources and
12 staffing to achieve the mission described in
13 paragraph (2);

14 “(C) establish offices to address gaps iden-
15 tified by the review under subparagraph (B)
16 and in furtherance of the mission described in
17 paragraph (2), putting an emphasis on estab-
18 lishing such offices—

19 “(i) where international civil aviation
20 authorities are located;

21 “(ii) where regional intergovernmental
22 organizations are located;

23 “(iii) in countries that have difficulty
24 maintaining a category 1 classification

1 through the International Aviation Safety
2 Assessment program; and

3 “(iv) in regions that have experienced
4 substantial growth in aviation operations
5 or manufacturing.”.

6 (c) BILATERAL AVIATION SAFETY AGREEMENTS.—

7 (1) ESTABLISHMENT.—Section 40104(d) of
8 title 49, United States Code, (as redesignated by
9 section 325) is further amended by inserting after
10 paragraph (4) the following:

11 “(5) BILATERAL AVIATION SAFETY AGREE-
12 MENTS.—

13 “(A) IN GENERAL.—The Administrator
14 shall negotiate, enter into, promote, enforce,
15 evaluate the effectiveness of, and seek to update
16 bilateral or multilateral aviation safety agree-
17 ments, and the parts of such agreements, with
18 international aviation authorities.

19 “(B) PURPOSE.—The Administrator shall
20 seek to enter into bilateral aviation safety
21 agreements under this section to, at a min-
22 imum—

23 “(i) improve global aviation safety;

24 “(ii) increase harmonization of, and
25 reduce duplicative, requirements, processes,

1 and approvals to advance the aviation in-
2 terests of the United States;

3 “(iii) ensure access to international
4 markets for operators, service providers,
5 and manufacturers from the United States;
6 and

7 “(iv) put in place procedures for re-
8 course when a party to such agreements
9 fails to meet the obligations of such party
10 under such agreements.

11 “(C) SCOPE.—The scope of a bilateral
12 aviation safety agreement entered into under
13 this section shall, as appropriate, cover existing
14 aviation users and concepts and establish a
15 process by which bilateral aviation safety agree-
16 ments can be updated to include new and novel
17 concepts on an ongoing basis.

18 “(D) CONTENTS.—Bilateral aviation safety
19 agreements entered into under this section
20 shall, as appropriate and consistent with United
21 States law and regulation, include topics such
22 as—

23 “(i) airworthiness, certification, and
24 validation;

25 “(ii) maintenance;

1 “(iii) operations and pilot training;

2 “(iv) airspace access, efficiencies, and
3 navigation services;

4 “(v) transport category aircraft;

5 “(vi) fixed-wing aircraft, rotorcraft,
6 and powered-lift aircraft;

7 “(vii) aerodrome certification;

8 “(viii) unmanned aircraft and associ-
9 ated elements of such aircraft;

10 “(ix) flight simulation training de-
11 vices;

12 “(x) new or emerging technologies and
13 technology trends; and

14 “(xi) other topics as determined ap-
15 propriate by the Administrator.

16 “(E) RULE OF CONSTRUCTION.—Bilateral
17 or multilateral aviation safety agreements en-
18 tered into under this subsection shall not be
19 construed to diminish or alter any authority of
20 the Administrator under any other provision of
21 law.”.

22 (2) AUDIT OF VALIDATION ACTIVITIES UNDER
23 BILATERAL AVIATION SAFETY AGREEMENTS.—

24 (A) IN GENERAL.—Not later than 2 years
25 after the date of enactment of this Act, the in-

1 spector general of the Department of Transpor-
2 tation shall initiate an audit of bilateral compli-
3 ance with respect to the validation of aircraft
4 and aircraft parts as set forth in bilateral or
5 multilateral aviation safety agreements between
6 the Federal Aviation Administration and the
7 civil aviation authorities of—

- 8 (i) the European Union;
9 (ii) Canada;
10 (iii) Brazil;
11 (iv) China;
12 (v) the United Kingdom; and
13 (vi) any other country as determined
14 by the inspector general.

15 (B) REVIEW CONTENTS.—As part of the
16 review required under this subsection, the in-
17 spector general shall evaluate the performance
18 of validation programs by assessing—

- 19 (i) validation timelines and milestones
20 for individual projects;
21 (ii) trends relating to the repeated use
22 of nonbasic criteria to review systems and
23 methods of compliance that have been vali-
24 dated previously in similar contexts;

1 (iii) the extent to which implementa-
2 tion tools such as validation workplans and
3 safety emphasis items have addressed vali-
4 dation issues;

5 (iv) the perspective of Administration
6 employees;

7 (v) the perspective of employees of
8 other civil aviation authorities, who wish to
9 provide such perspective, on the validation
10 of products certified in the United States
11 and the validation of products by the
12 United States of products certified abroad;
13 and

14 (vi) the perspective of domestic and
15 foreign industry applicants seeking valida-
16 tion of aircraft and aircraft parts.

17 (C) REPORT AND RECOMMENDATIONS.—

18 Not later than 14 months after beginning the
19 audit under paragraph (1), the Comptroller
20 General shall provide to the Administrator of
21 the Federal Aviation Administration, the Com-
22 mittee on Transportation and Infrastructure of
23 the House of Representatives and the Com-
24 mittee on Commerce, Science, and Transpor-
25 tation of the Senate a report summarizing the

1 findings of the audit and any recommendations
2 to increase compliance and improve the valida-
3 tion timeframes of aircraft and aircraft parts.

4 (d) INTERNATIONAL ENGAGEMENT STRATEGY.—
5 Section 40104(d) of title 49, United States Code, (as re-
6 designated by section 325) is further amended by inserting
7 after paragraph (5) the following:

8 “(6) STRATEGIC PLAN.—The Administrator
9 shall maintain a strategic plan for the international
10 engagement of the Administration that includes—

11 “(A) all elements of the report required in
12 section 243(b)(1) of the FAA Reauthorization
13 Act of 2018 (49 U.S.C. 44701 note);

14 “(B) measures to fulfill the mission de-
15 scribed in paragraph (2);

16 “(C) initiatives to attain greater expertise
17 among employees of the Federal Aviation Ad-
18 ministration in issues related to dispute resolu-
19 tion, intellectual property, and expert control
20 laws;

21 “(D) policy regarding the future direction
22 and strategy of the United States engagement
23 with the International Civil Aviation Organiza-
24 tion;

1 “(E) procedures for acceptance of manda-
2 tory airworthiness information, such as air-
3 worthiness directives, and other safety-related
4 regulatory documents, including procedures to
5 implement the requirements of section
6 44701(e)(5);

7 “(F) all factors, including funding and
8 resourcing, necessary for the Administration to
9 maintain leadership in the global activities re-
10 lated to aviation safety and air transportation;
11 and

12 “(G) establishment of, and a process to
13 regularly track and update, metrics to measure
14 the effectiveness of, and foreign civil aviation
15 authority compliance with, bilateral aviation
16 safety agreements.”.

17 **SEC. 503. AVAILABILITY OF PERSONNEL FOR INSPECTIONS,**
18 **SITE VISITS, AND TRAINING.**

19 Section 40104 of title 49, United States Code, is fur-
20 ther amended by adding at the end the following:

21 “(f) TRAVEL.—The Administrator and the Secretary
22 of Transportation shall, in carrying out the responsibilities
23 described in subsection (a), delegate to the appropriate su-

9 approaches on standards and recommended practices

12 ed by the United States and standards promulgated
13 under section 44714;

14 “(4) supporting the acceptance of Administra-
15 tion design and production approvals by other civil
16 aviation authorities;

17 “(5) training Administration personnel and
18 training provided to other persons;

19 “(6) engaging with regulated entities, including
20 performing site visits;

21 “(7) activities associated with subsections (c)
22 through (f) of this section; and

23 “(8) other activities as determined by the Ad-
24 ministrator.”.

1 **SEC. 504. HELICOPTER AIR AMBULANCE OPERATIONS.**

2 (a) OUTDATED AIR AMBULANCE RULEMAKING RE-
3 QUIREMENT.—Section 44730 of title 49, United States
4 Code, is amended—

5 (1) in subsection (a)(1) by striking “not later
6 than 180 days after the date of enactment of this
7 section,”;

13 through other means, the following”; and

14 (4) in subsection (e)—

15 (A) in the heading by striking “SUBSE-
16 QUENT RULEMAKING” and inserting “SUBSE-
17 QUENT ACTIONS”;

18 (B) in paragraph (1) by striking “shall
19 conduct a follow-on rulemaking to address the
20 following:” and inserting “shall address through
21 a follow-on rulemaking, or through such other
22 means that the Administrator considers appro-
23 priate, the following:”;

24 (C) by striking paragraph (2); and

25 (D) by redesignating paragraph (3) as
26 paragraph (2).

1 (b) SAFETY MANAGEMENT SYSTEMS BRIEFING.—
2 Not later than 180 days after the date of enactment of
3 this Act, the Administrator of the Federal Aviation Ad-
4 ministration shall brief the Committee on Transportation
5 and Infrastructure of the House of Representatives and
6 the Committee on Commerce, Science, and Transportation
7 of the Senate on how the proposed rule published on Janu-
8 ary, 11, 2023, titled “Safety Management System” (88
9 Fed. Reg. 1932) will—

10 (1) improve helicopter air ambulance operations
11 and piloting; and

12 (2) consider the use of safety equipment by
13 flight crew and medical personnel on a helicopter
14 conducting an air ambulance operation.

15 (c) IMPROVEMENT OF PUBLICATION OF HELICOPTER
16 AIR AMBULANCE OPERATIONS DATA.—Section 44731 of
17 title 49, United States Code, is amended—

18 (1) by striking subsection (d);

19 (2) in subsection (e)—

20 (A) in paragraph (1) by striking “and” at
21 the end; and

22 (B) by striking paragraph (2) and insert-
23 ing the following:

24 “(2) make publicly available, in part or in
25 whole, on the website of the Federal Aviation Ad-

1 ministration website, the database developed pursu-
2 ant to subsection (c); and

3 “(3) analyze the data submitted under sub-
4 section (a) periodically and use such data to inform
5 efforts to improve the safety of helicopter airambu-
6 lance operations.”; and

7 (3) by redesignating subsections (e) and (f) as
8 subsections (d) and (e), respectively.

9 **SEC. 505. GLOBAL AIRCRAFT MAINTENANCE SAFETY IM-**
10 **PROVEMENTS.**

11 (a) FAA OVERSIGHT OF REPAIR STATIONS LOCATED
12 OUTSIDE THE UNITED STATES.—

13 (1) IN GENERAL.—Section 44733 of title 49,
14 United States Code, is amended—

15 (A) in the heading by striking “**Inspection**”
16 and inserting “**Oversight**”;

17 (B) in subsection (a) by striking “Not
18 later than 1 year after the date of enactment of
19 this section, the” and inserting “The”;

20 (C) in subsection (e)—

21 (i) by inserting “, without prior notice
22 to such repair stations,” after “annually”;

23 (ii) by inserting “and the applicable
24 laws of the country in which the repair sta-

1 tion is located” after “international agree-
2 ments”; and

3 (iii) by striking the last sentence and
4 inserting “The Administrator may carry
5 out announced or unannounced inspections
6 in addition to the annual unannounced in-
7 spection required under this subsection
8 based on identified risks and in a manner
9 consistent with United States obligations
10 under international agreements and the
11 applicable laws of the country in which the
12 part 145 repair station is located.”;

13 (D) by redesignating subsection (g) as sub-
14 section (j); and

15 (E) by inserting after subsection (f) the
16 following:

17 “(g) DATA ANALYSIS.—

18 “(1) IN GENERAL.—Each fiscal year in which a
19 part 121 air carrier has had heavy maintenance
20 work performed on an aircraft owned or operated by
21 such carrier, such carrier shall provide to the Ad-
22 ministrator, not later than the end of the following
23 fiscal year, a report containing the information de-
24 scribed in paragraph (2).

1 “(2) INFORMATION REQUIRED.—A report under
2 paragraph (1) shall contain the following:

3 “(A) The location where any heavy mainte-
4 nance work on aircraft was performed outside
5 the United States.

6 “(B) A description of the work performed
7 at each such location.

8 “(C) The date of completion of the work
9 performed at each such location.

10 “(D) A list of all failures, malfunctions, or
11 defects affecting the safe operation of such air-
12 craft identified by the air carrier not later than
13 30 days after the date on which an aircraft is
14 returned to service, organized by reference to
15 aircraft registration number, that—

16 “(i) requires corrective action after
17 the aircraft is approved for return to serv-
18 ice; and

19 “(ii) results from such work per-
20 formed on such aircraft.

21 “(E) The certificate number of the person
22 approving such aircraft or on-wing aircraft en-
23 gine, for return to service following completion
24 of the work performed at each such location.

25 “(3) ANALYSIS.—The Administrator shall—

1 “(A) analyze information provided under
2 this subsection and sections 121.703, 121.705,
3 121.707, and 145.221 of title 14, Code of Fed-
4 eral Regulations, or any successor provisions of
5 such title, to detect safety issues associated
6 with heavy maintenance work on aircraft per-
7 formed outside the United States; and

8 “(B) require appropriate actions by an air
9 carrier or repair station in response to any safe-
10 ty issue identified by the analysis conducted
11 under subparagraph (A).

12 “(4) CONFIDENTIALITY.—Information provided
13 under this subsection shall be subject to the same
14 protections given to voluntarily provided safety or
15 security related information under section 40123.

16 “(h) APPLICATIONS AND PROHIBITION.—

17 “(1) IN GENERAL.—The Administrator may not
18 approve any new application under part 145 of title
19 14, Code of Federal Regulations, from a person lo-
20 cated or headquartered in a country that the Admin-
21 istration, through the International Aviation Safety
22 Assessment program, has classified as Category 2.

23 “(2) EXCEPTION.—Paragraph (1) shall not
24 apply to an application for the renewal of a certifi-

1 cate issued under part 145 of title 14, Code of Fed-
2 eral Regulations.

3 “(3) MAINTENANCE IMPLEMENTATION PROCE-
4 DURES AGREEMENT.—The Administrator may elect
5 not to enter into a new maintenance implementation
6 procedures agreement with a country classified as
7 Category 2, for as long as the country remains clas-
8 sified as Category 2.

9 “(3) PROHIBITION ON CONTINUED HEAVY
10 MAINTENANCE WORK.—No part 121 air carrier may
11 enter into a new contract for heavy maintenance
12 work with a person located or headquartered in a
13 country that the Administrator, through the Inter-
14 national Aviation Safety Assessment program, has
15 classified as Category 2, for as long as such country
16 remains classified as Category 2.

17 “(i) MINIMUM QUALIFICATIONS FOR MECHANICS
18 AND OTHERS WORKING ON U.S. REGISTERED AIR-
19 CRAFT.—

20 “(1) IN GENERAL.—Not later than 2 years
21 after the date of enactment of this subsection, the
22 Administrator shall require that, at each covered re-
23 pair station—

24 “(A) all supervisory personnel of such sta-
25 tion are appropriately certificated as a me-

1 chanic or repairman under part 65 of title 14,
2 Code of Federal Regulations, or under an
3 equivalent certification or licensing regime, as
4 determined by the Administrator; and

5 “(B) all personnel of such station author-
6 ized to approve an article for return to service
7 are appropriately certificated as a mechanic or
8 repairman under part 65 of such title, or under
9 an equivalent certification or licensing regime,
10 as determined by the Administrator.

11 “(2) AVAILABLE FOR CONSULTATION.—Not
12 later than 2 years after the date of enactment of
13 this subsection, the Administrator shall require any
14 individual who is responsible for approving an article
15 for return to service or who is directly in charge of
16 heavy maintenance work performed on aircraft oper-
17 ated by a part 121 air carrier be available for con-
18 sultation while work is being performed at a covered
19 repair station.”.

20 (2) DEFINITIONS.—

21 (A) IN GENERAL.—Section 44733(j) of
22 title 49, United States Code (as redesignated by

10 ‘covered repair station’ means a facility that—

11 “(A) is located outside the United States;

12 “(B) is a part 145 repair station; and

13 “(C) performs heavy maintenance work on
14 aircraft operated by a part 121 air carrier.”.

15 (B) TECHNICAL AMENDMENT.—Section
16 44733(a)(3) of title 49, United States Code, is
17 amended by striking “covered part 145 repair
18 stations” and inserting “part 145 repair sta-
19 tions”.

20 (3) CONFORMING AMENDMENTS.—The analysis
21 for chapter 447 of title 49, United States Code, is
22 amended by striking the item relating to section
23 44733 and inserting the following:

“44733. Oversight of repair stations located outside the United States.”.

24 (b) INTERNATIONAL STANDARDS FOR SAFETY OVER-
25 SIGHT OF EXTRATERRITORIAL REPAIR STATIONS.—

1 (1) ESTABLISHMENT.—Not later than 1 year
2 after the date of enactment of this Act, the Adminis-
3 trator of the Federal Aviation Administration shall
4 invite other civil aviation authorities to convene with
5 the Administration an extraterritorial repair station
6 working group (hereinafter referred to as the
7 “Working Group”) to conduct a review of the certifi-
8 cation and oversight of extraterritorial repair sta-
9 tions and to identify any future enhancements or
10 harmonization that might be appropriate to

22 (i) civil aviation authorities respon-
23 sible for certificating extraterritorial repair

1 (ii) civil aviation authorities of coun-
2 tries in which extraterritorial repair sta-
3 tions are located.

4 (3) CONSULTATION.—In conducting the review
5 under this section, the Working Group shall, as ap-
6 propriate, consult with relevant experts and stake-
7 holders.

8 (4) RECOMMENDATIONS.—The Working Group
9 shall make recommendations with respect to any fu-
10 ture enhancements that might be appropriate to—

11 (A) strengthen oversight of extraterritorial
12 repair stations; and

13 (B) better leverage the resources of other
14 civil aviation authorities to conduct such over-
15 sight.

16 (5) REPORTS.—

17 (A) REPAIR STATION WORKING GROUP RE-
18 PORT.—In establishing the Working Group, the
19 Administrator shall task the Working Group
20 with submitting to the participating civil avia-
21 tion authorities a report containing the findings
22 of the recommendations made under paragraph
23 (4).

24 (B) FAA REPORT.—

1 (i) TRANSMISSION OF REPAIR STA-
2 TION WORKING GROUP REPORT.—The Ad-
3 ministrator shall submit to the Committee
4 on Transportation and Infrastructure of
5 the House of Representatives, and the
6 Committee on Commerce, Science, and
7 Transportation of the Senate a copy of the
8 report required under subparagraph (A) as
9 soon as is practicable after the receipt of
10 such report.

11 (ii) FAA BRIEFING TO CONGRESS.—
12 Not later than 45 days after receipt of the
13 report under paragraph (1), the Adminis-
14 trator shall brief the Committee on Trans-
15 portation and Infrastructure of the House
16 of Representatives and the Committee on
17 Commerce, Science, and Transportation of
18 the Senate on—

19 (I) whether the Administrator
20 concurs or does not concur with each
21 recommendation contained in the re-
22 port required under subparagraph
23 (A);

24 (II) any recommendation with
25 which the Administrator does not con-

1 cur, a detailed explanation as to why
2 the Administrator does not concur;

3 (III) a plan to implement each
4 recommendation with which the Ad-
5 ministrator concurs; and

6 (IV) a plan to work with the
7 international community to implement
8 the recommendations applicable to
9 both the FAA as well as other civil
10 aviation authorities.

11 (6) TERMINATION.—The Working Group shall
12 terminate 90 days after the date of submission of
13 the report under paragraph (5)(A), unless the Ad-
14 ministrator or another participant of the Working
15 Group requests for an extension of the Working
16 Group in order to inform the implementation and
17 harmonization of any recommendation applicable to
18 multiple civil aviation authorities.

19 (7) DEFINITION OF EXTRATERRITORIAL REPAIR
20 STATION.—In this subsection, the term
21 “extraterritorial repair station” means a repair sta-
22 tion that performs heavy maintenance work on an
23 aircraft (including on-wing engines) and that is lo-

1 civil aviation authority which certificated the repair
2 station.

3 (c) ALCOHOL AND DRUG TESTING AND BACK-
4 GROUND CHECKS.—

5 (1) IN GENERAL.—Not later than 2 years after
6 the date of enactment of this Act, and annually
7 thereafter, the Administrator shall submit to the
8 Committee on Transportation and Infrastructure of
9 the House of Representatives and the Committee on
10 Commerce, Science, and Transportation of the Sen-
11 ate a report updating Congress on the progress and
12 challenges involved with carrying out the require-

22 MENT.—With respect to any employee not covered
23 under the requirements of section 1554.101 of title
24 49, Code of Federal Regulations, the Administrator
25 shall initiate a rulemaking or request the head of an-

1 other Federal agency to initiate a rulemaking that
2 requires a covered repair station to confirm that any
3 such employee has successfully completed an assess-
4 ment commensurate with a security threat assess-
5 ment described in subpart C of part 1540 of such
6 title.

7 (d) DEFINITIONS.—In this section:

8 (1) FAA.—The term “FAA” means the Fed-
9 eral Aviation Administration.

10 (2) ADMINISTRATOR.—The term “Adminis-
11 trator” means the Administrator of the FAA.

12 (3) COVERED REPAIR STATION; HEAVY MAINTEN-
13 NANCE WORK.—The terms “covered repair station”
14 and “heavy maintenance work” have the meaning
15 given those terms in section 44733(j) of title 49,
16 United States Code.

17 **SEC. 506. ODA BEST PRACTICE SHARING.**

18 Section 44736(b) of title 49, United States Code, is
19 amended—

20 (1) in paragraph (1) by striking “Not later

12 procedures manual for the delegation;

13 “(D) the prohibition against and reporting
14 procedures for interference from a supervisor or
15 other ODA member described in section 44742;
16 and

17 “(E) any additional information the Ad-
18 ministrator considers relevant to maintaining
19 ethical and professional standards across all
20 ODA holders and unit members.

21 “(2) FAA REVIEW.—

22 “(A) REVIEW OF TRAINING PROGRAM.—
23 The Organization Designation Authorization
24 Office of the Administration shall review each
25 ODA holders’ recurrent training program to en-

1 sure such program includes all elements de-
2 scribed in paragraph (1).

3 “(B) CHANGES TO PROGRAM.—Such Office
4 may require changes to the training program
5 considered necessary to maintain ethical and
6 professional standards across all ODA holders
7 and unit members.

8 “(3) TRAINING.—As part of the recurrent
9 training required under paragraph (1), not later
10 than 60 business days after being designated as an
11 ODA unit member, and annually thereafter, each
12 ODA unit member shall complete the ethics training
13 required by the ODA holder of the respective ODA

7 **SEC. 510. DON YOUNG ALASKA AVIATION SAFETY INITIA-**
8 **TIVE.**

9 (a) IN GENERAL.—Chapter 447 of title 49, United
10 States Code, is amended by adding at the end the fol-
11 lowing:

12 **“§ 44745. Don Young Alaska Aviation Safety Initia-**
13 **tive.**

14 “(a) IN GENERAL.—The Administrator of the Fed-
15 eral Aviation Administration shall redesignate the FAA
16 Alaska Aviation Safety Initiative of the Administration as
17 the Don Young Alaska Aviation Safety Initiative (in this
18 section referred to as the ‘Initiative’), under which the Ad-
19 ministrator shall carry out the provisions of this section
20 and take such other actions as the Administrator deter-
21 mines appropriate to improve aviation safety in covered
22 locations.

23 “(b) OBJECTIVE.—The objective of the Initiative
24 shall be to work cooperatively with aviation stakeholders
25 and other stakeholders towards the goal of—

1 “(1) reducing the rate of fatal aircraft acci-
2 dents in covered locations by 90 percent from 2019
3 to 2033; and

4 “(2) by January 1, 2033, eliminating fatal acci-
5 dents of aircraft operated by an air carrier that op-
6 erates under part 135 of title 14, Code of Federal
7 Regulations.

8 “(c) LEADERSHIP.—

9 “(1) IN GENERAL.—The Administrator shall
10 designate the Regional Administrator for the Alas-
11 kan Region of the Administration to serve as the Di-
12 rector of the Initiative.

13 “(2) REPORTING CHAIN.—In all matters relat-
14 ing to the Initiative, the Director of the Initiative
15 shall report directly to the Administrator.

16 “(3) COORDINATION.—The Director of the Ini-
17 tiative shall coordinate with the heads of other of-
18 fices and lines of business of the Administration, in-
19 cluding the other regional administrators, to carry
20 out the Initiative.

21 “(d) AUTOMATED WEATHER SYSTEMS.—

22 “(1) REQUIREMENT.—The Administrator shall
23 ensure, to the greatest extent practicable, that a cov-
24 ered automated weather system is installed and op-

1 erated at each covered airport not later than Decem-
2 ber 31, 2030.

3 “(2) WAIVER.—In complying with the require-
4 ment under paragraph (1), the Administrator may
5 waive any positive benefit-cost ratio requirement for
6 the installation and operation of a covered auto-
7 mated weather system.

8 “(3) PRIORITIZATION.—In developing the in-
9 stallation timeline of a covered automated weather
10 system at a covered airport pursuant to this sub-
11 section, the Administrator shall—

12 “(A) coordinate and consult with the gov-
13 ernments with jurisdiction over covered loca-
14 tions, covered airports, air carriers operating in
15 covered locations, private pilots based in cov-
16 ered locations, and such other members of the
17 aviation community in covered locations; and

18 “(B) prioritize early installation at covered
19 airports that would enable the greatest number
20 of instrument flight rule operations by air car-
21 riers operating under part 121 or 135 of title
22 14, Code of Federal Regulations.

23 “(4) RELIABILITY.—

1 “(A) IN GENERAL.—Pertaining to both
2 Federal and non-Federal systems, the Adminis-
3 trator shall be responsible for ensuring—

4 “(i) the reliability of covered auto-
5 mated weather systems; and

6 “(ii) the availability of weather infor-
7 mation from such systems.

8 “(B) SPECIFICATIONS.—The Adminis-
9 trator shall establish data availability and
10 equipment reliability specifications for covered
11 automated weather systems.

12 “(C) SYSTEM RELIABILITY AND RESTORA-
13 TION PLAN.—Not later than 2 years after the
14 date of enactment of this section, the Adminis-
15 trator shall establish an automated weather sys-
16 tem reliability and restoration plan. Such plan
17 shall document the Administrator’s strategy for
18 ensuring covered automated weather system re-
19 liability, including the availability of weather in-
20 formation from such system, and for restoring
21 service in as little time as possible.

22 “(D) TELECOMMUNICATIONS OR OTHER
23 FAILURES.—If a covered automated weather
24 system is unable to broadly disseminate weather
25 information due to a telecommunications failure

1 or a failure other than an equipment failure,
2 the Administrator shall take such actions as
3 may be necessary to restore the full
4 functionality and connectivity of the covered
5 automated weather system. The Administrator
6 shall take actions under this subparagraph with
7 the same urgency as the Administrator would
8 take an action to repair a covered automated
9 weather system equipment failure or data fidel-
10 ity issue.

11 “(E) RELIABILITY DATA.—In tabulating
12 data relating to the operational status of cov-
13 ered automated weather systems (including in-
14 dividually or collectively), the Administrator
15 may not consider a covered automated weather
16 system that is functioning nominally but is un-
17 able to broadly disseminate weather information
18 telecommunications failure or a failure other
19 than an equipment failure as functioning reli-
20 ably.

21 “(5) INVENTORY.—The Administrator shall
22 consider storing excess inventory necessary for air
23 traffic control equipment, including commonly re-
24 quired replacement parts, in covered locations to re-
25 duce the amount of time necessary to acquire such

1 equipment or such parts necessary to replace or re-
2 pair air traffic control system components.

3 “(6) VISUAL WEATHER OBSERVATION SYS-
4 TEM.—Not later than 1 year after the date of enact-
5 ment of this section, the Administrator shall take
6 such actions as may be necessary to—

7 “(A) deploy visual weather observation sys-
8 tems; and

9 “(B) ensure that such systems are capable
10 of meeting the definition of covered automated
11 weather systems.

12 “(e) WEATHER CAMERAS.—

13 “(1) IN GENERAL.—The Director shall continu-
14 ously assess the state of the weather camera systems
15 in covered locations to ensure the operational suffi-
16 ciency and reliability of such systems.

17 “(2) APPLICATIONS.—The Director shall—

18 “(A) accept applications from persons to
19 install weather cameras; and

20 “(B) consult with the governments with ju-
21 risdiction over covered locations, covered air-
22 ports, air carriers operating in covered loca-
23 tions, private pilots based in covered locations,
24 and such other members of the aviation com-
25 munity in covered locations as the Adminis-

1 trator determines appropriate to solicit addi-
2 tional locations at which to install and operate
3 weather cameras.

4 “(3) PRESUMPTION.—Unless the Director has
5 clear and compelling evidence to the contrary, the
6 Director shall presume that the installation of a
7 weather camera at a covered airport, or that is rec-
8 ommended by a government with jurisdiction over a
9 covered location, is cost beneficial and will improve
10 aviation safety.

11 “(f) COOPERATION WITH OTHER AGENCIES.—In
12 carrying out this section, the Administrator shall cooper-
13 ate with the heads of other Federal or State agencies with
14 responsibilities affecting aviation safety in covered loca-
15 tions, including the collection and dissemination of weath-
16 er data.

17 “(g) SURVEILLANCE AND COMMUNICATION.—

18 “(1) IN GENERAL.—The Director shall take
19 such actions as may be necessary to—

20 “(A) encourage and incentivize the equi-
21 page of aircrafts that operate under part 135 of
22 title 14, Code of Federal Regulations, with
23 automatic dependent surveillance and broadcast
24 out equipment; and

1 “(B) improve aviation surveillance and
2 communications in covered locations.

3 “(2) REQUIREMENT.—Not later than December
4 31, 2030, the Administrator shall ensure that auto-
5 matic dependent surveillance and broadcast coverage
6 is available at 5,000 feet above ground level
7 throughout each covered location.

8 “(3) WAIVER.—In complying with the require-
9 ment under paragraph (2), the Administrator shall
10 waive any positive benefit-cost ratio requirement for
11 the installation and operation of equipment and fa-
12 cilities necessary to implement such requirement.

13 “(4) SERVICE AREAS.—The Director shall con-
14 tinuously identify additional automatic dependent
15 surveillance–broadcast service areas in which the de-
16 ployment of automatic dependent surveillance–broad-
17 cast receivers and equipment would improve aviation
18 safety.

19 “(h) OTHER PROJECTS.—The Director shall continue
20 to build upon other initiatives recommended in the reports
21 of the FAA Alaska Aviation Safety Initiative of the Ad-
22 ministration published before the date of enactment of this
23 section.

24 “(i) ANNUAL REPORT.—

1 “(1) IN GENERAL.—The Director shall submit
2 an annual report on the status and progress of the
3 Initiative to the Committee on Transportation and
4 Infrastructure of the House of Representatives and
5 the Committee on Commerce, Science, and Trans-
6 portation of the Senate.

7 “(2) OBJECTIVES AND REQUIREMENTS.—The
8 report under paragraph (1) shall include a detailed
9 description of the Director’s progress in and plans
10 for meeting the objectives of the Initiative under
11 subsection (b) and the other requirements of this
12 section.

13 “(3) STAKEHOLDER COMMENTS.—The Director
14 shall append stakeholder comments, organized by
15 topic, to each report submitted under paragraph (1)
16 in the same manner as appendix 3 of the report ti-
17 tled ‘FAA Alaska Aviation Safety Initiative FY21
18 Final Report’, dated September 30, 2021.

19 “(j) FUNDING.—

20 “(1) IN GENERAL.—Notwithstanding any other
21 provision of law, in fiscal years 2024 through
22 2028—

23 “(A) the Administrator may, upon applica-
24 tion from the government with jurisdiction over
25 a covered location, use amounts apportioned to

1 a covered location under subsection (d)(2)(B)
2 or subsection (e)(5) of section 47114 to carry
3 out the Initiative; or

4 “(B) the sponsor of an airport in a covered
5 location that receives an apportionment under
6 subsection (d)(2)(B) or subsection (e) of section
7 47114 may use such apportionment for any
8 purpose contained in this section.

9 “(2) SUPPLEMENTAL FUNDING.—Out of
10 amounts made available under section 106(k) and
11 section 48101, not more than a total of \$25,000,000
12 for each of fiscal year 2024 through 2028 is author-
13 ized to be expended to carry out the Initiative.

14 “(k) DEFINITIONS.—In this section:

15 “(1) COVERED AIRPORT.—The term ‘covered
16 airport’ means an airport in a covered location that
17 is included in the national plan of integrated airport
18 systems required under section 47103 and that has
19 a status other than unclassified in such plan.

20 “(2) COVERED AUTOMATED WEATHER SYS-
21 TEM.—The term ‘covered automated weather sys-
22 tem’ means an automated or visual weather report-
23 ing facility that enables a pilot to begin an instru-
24 ment procedure approach to an airport under section

1 91.1039 or 135.225 of title 14, Code of Federal
2 Regulations.

3 “(3) COVERED LOCATION.—The term ‘covered
4 location’ means Alaska, Hawaii, Puerto Rico, Amer-
5 ican Samoa, Guam, the Northern Mariana Islands,
6 and the United States Virgin Islands.

7 “(l) CONFORMITY.—The Administrator shall conduct
8 all activities required under this section in conformity with
9 section 44720.”.

10 (b) REMOTE POSITIONS.—Section 40122(g) of title
11 49, United States Code, is amended by adding at the end
12 the following:

13 “(7) REMOTE POSITIONS.—

14 “(A) IN GENERAL.—If the Administrator
15 determines that a covered position has not been
16 filled after multiple vacancy announcements and
17 that there are unique circumstances affecting
18 the ability of the Administrator to fill such posi-
19 tion, the Administrator may consider, in con-
20 sultation with the appropriate labor union, ap-
21 plicants for the covered position who apply
22 under a vacancy announcement recruiting from
23 the State or territory in which the position is
24 based.

1 “(B) COVERED POSITION DEFINED.—In
2 this paragraph, the term ‘covered position’
3 means a safety-critical position based in Alaska,
4 Hawaii, Puerto Rico, American Samoa, Guam,
5 the Northern Mariana Islands, and the Virgin
6 Islands.”.

7 (c) RUNWAY LENGTH.—Notwithstanding any other
8 provision of law, the Secretary of Transportation may not
9 require an airport to shorten a runway or prevent airport
10 improvement grants made by the Secretary to be used for
11 reconstructing and rehabilitating a primary runway on the
12 basis that the airport does not have a sufficient number
13 of aircraft operations requiring a certain runway length
14 if—

- 15 (1) the airport is located in a covered location;
16 (2) the airport is not connected to the road
17 transportation network; and
18 (3) the runway length is utilized by aircraft to
19 deliver necessary cargo, including heating fuel and
20 gasoline, for the community served by the airport.

21 (d) ALASKAN REGIONAL ADMINISTRATOR.—

22 (1) SENSE OF CONGRESS.—It is the sense of
23 Congress that—

- 24 (A) the Regional Administrator for the
25 Alaskan Region is a uniquely important position

1 that contributes to aviation safety in the State
2 of Alaska;

3 (B) vacancies in any Federal Aviation Ad-
4 ministration office have a deleterious effect on
5 the efficacy of the Alaskan Region office;

6 (C) a prolonged vacancy in the position of
7 Regional Administrator for the Alaskan Region
8 may be detrimental to the effective administra-
9 tion of such region and the Don Young Alaska
10 Aviation Safety Initiative; and

11 (D) the Administrator of the Federal Avia-
12 tion Administration should ensure that any va-
13 cancy in the position of Regional Administrator
14 for the Alaskan Region is filled with a highly
15 qualified candidate as expeditiously as possible.

16 (2) VACANCY NOTIFICATION REQUIREMENTS.—

17 (A) INITIAL VACANCY.—The Administrator
18 of the Federal Aviation Administration shall no-
19 tify the appropriate committees of Congress
20 when there is a vacancy for the position of Re-
21 gional Administrator for the Alaskan Region.

22 (B) STATUS UPDATES.—Not later than 90
23 days after the notification under subparagraph
24 (A) (and every 30 days thereafter until the va-
25 cancy described under subparagraph (A) is

1 filled), the Administrator shall notify the appro-
2 priate committees of Congress of any vacancy
3 of such position, if so, provide an estimated
4 timeline for filling such vacancy.

5 (C) APPROPRIATE COMMITTEES OF CON-
6 GRESS DEFINED.—In this paragraph, the term
7 “appropriate committees of Congress” means
8 the Committee on Transportation and Infra-
9 structure of the House of Representatives and
10 the Committee on Commerce, Science, and
11 Transportation of the Senate.

12 (D) SUNSET.—This paragraph shall cease
13 to be effective after September 30, 2028.

14 (e) IMPLEMENTATION OF NTSB RECOMMENDA-
15 TIONS.—

16 (1) IN GENERAL.—Not later than 3 years after
17 the date of enactment of this Act, the Administrator
18 shall take such actions as may be necessary to im-
19 plement National Transportation Safety Board rec-
20 ommendations A–22–25 and A–22–26 (as contained
21 in Aviation Investigation Report AIR–22–09, adopt-
22 ed November 16, 2022).

23 (2) COORDINATION.—In taking actions under
24 paragraph (1), the Administrator shall coordinate
25 with the State of Alaska, airports in Alaska, air car-

1 riers operating in Alaska, private pilots (including
2 tour operators) based in Alaska, and such other
3 members of the Alaska aviation community or other
4 stakeholders as the Administrator determines appro-
5 priate.

6 (f) CLERICAL AMENDMENT.—The analysis for chap-
7 ter 447 of title 49, United States Code, is amended by
8 adding at the end the following:

“44745. Don Young Alaska Aviation Safety Initiative.”.

9 **SEC. 511. CONTINUED OVERSIGHT OF FAA COMPLIANCE**
10 **PROGRAM.**

11 Section 122 of the Aircraft Certification, Safety, and
12 Accountability Act (Public Law 116–260; 134 Stat. 2344)
13 is amended—

14 (1) in subsection (b) by striking paragraph (2)
15 and inserting the following:

16 “(2) conduct an annual agency-wide evaluation
17 of the Compliance Program through fiscal year 2028
18 to assess the functioning and effectiveness of such
19 program and to determine—

20 “(A) the need for long-term metrics that,
21 to the maximum extent practicable, apply to all
22 program offices to assess the effectiveness of
23 the program;

24 “(B) if the program ensures the highest
25 level of compliance with safety standards; and

1 “(C) if the program has met its stated
2 safety goals and purpose;”;

3 (2) in subsection (c)(4) by striking “2023” and
4 inserting “2028”; and

5 (3) in subsection (d) by striking “2023” and in-
6 serting “2028”.

7 **SEC. 512. SCALABILITY OF SAFETY MANAGEMENT SYSTEMS.**

8 In conducting any rulemaking to require, or imple-
9 menting a regulation requiring, a safety management sys-
10 tem, the Administrator of the Federal Aviation Adminis-
11 tration shall consider the scalability of such safety man-
12 agement system requirements to the full range of entities
13 in terms of size or complexity that may be affected by such
14 rulemaking or regulation, including—

15 (1) how an entity can demonstrate compliance
16 using various documentation, tools, and methods, in-
17 cluding, as appropriate, systems with multiple small
18 operators collectively monitoring for and addressing
19 risks;

20 (2) a review of traditional safety management
21 techniques and the suitability of such techniques for
22 small entities;

23 (3) the applicability of existing safety manage-
24 ment system programs implemented by an entity;

1 (4) the suitability of existing requirements
2 under part 5 of title 14, Code of Federal Regula-
3 tions, for small entities; and

4 (5) other unique challenges relating to small en-
5 tities the Administrator determines appropriate to
6 consider.

7 **SEC. 513. FINALIZE SAFETY MANAGEMENT SYSTEM RULE-**
8 **MAKING.**

9 (a) **IN GENERAL.**—Not later than 180 days after the
10 date of enactment of this Act, the Administrator of the
11 Federal Aviation Administration shall issue a final rule
12 relating to the Notice of Proposed Rulemaking of the Fed-
13 eral Aviation Administration titled “Safety Management
14 Systems”, issued on January 11, 2023.

15 (b) **APPLICABILITY.**—In issuing a final rule under
16 subsection (a), the Administrator shall ensure that the
17 safety management system requirement under the Notice
18 of Proposed Rulemaking described in subsection (a) is ap-
19 plied to all certificate holders operating under the rules
20 for commuter and on-demand operations under part 135
21 of title 14, Code of Federal Regulations, commercial air
22 tour operators operating under section 91.147 of such
23 title, production certificate holders that are holders or li-
24 censees of a type certificate for the same product, and

1 holders of a type certificate who license out such certifi-
2 cate for production under part 21 of such title.

3 **SEC. 514. IMPROVEMENTS TO AVIATION SAFETY INFORMA-**
4 **TION ANALYSIS AND SHARING.**

5 (a) IN GENERAL.—Not later than 3 years after the
6 date of enactment of this Act, the Administrator of the
7 Federal Aviation Administration shall implement improve-
8 ments to the Aviation Safety Information Analysis and
9 Sharing Program with respect to safety data sharing and
10 risk mitigation.

11 (b) REQUIREMENTS.—In carrying out subsection (a),
12 the Administrator shall—

13 (1) identify methods to increase the rate at
14 which data is collected, processed, and analyzed to
15 expeditiously share safety intelligence;

16 (2) develop predictive capabilities to anticipate
17 emerging safety risks;

18 (3) identify methods to improve shared data en-
19 vironments with external stakeholders;

20 (4) establish a robust process for prioritizing
21 requests for safety information;

22 (5) establish guidance to encourage regular
23 safety inspector review of non-confidential aviation
24 safety and performance data;

1 (6) identify industry segments not yet included
2 and conduct outreach to such industry segments to
3 increase the rate of participation, including—

4 (A) general aviation;

5 (B) rotorcraft;

6 (C) air ambulance; and

7 (C) maintenance facilities; and

8 (7) establish processes for obtaining and ana-
9 lyzing comprehensive and aggregate data for new
10 and future industry segments.

11 (c) RULE OF CONSTRUCTION.—Nothing in this sec-
12 tion shall be construed—

13 (1) to require the Administrator to share con-
14 fidential or proprietary information and data to safe-
15 ty inspectors for purposes of enforcement; or

16 (2) to limit the applicability of section 44735 of
17 title 49, United States Code, to the Aviation Safety
18 Information Analysis and Sharing Program.

19 (d) BRIEFING.—Not later than 180 days after the
20 date of enactment of this Act, and every 6 months there-
21 after until the improvements under subsection (a) are
22 made, the Administrator shall brief the Committee on
23 Transportation and Infrastructure of the House of Rep-
24 resentatives and the Committee on Commerce, Science,
25 and Transportation of the Senate on the progress of im-

1 plementation of the Aviation Safety Information Analysis
2 and Sharing Program and steps taken to make improve-
3 ments under subsection (a).

4 **SEC. 515. IMPROVEMENT OF CERTIFICATION PROCESSES.**

5 (a) IN GENERAL.—The Administrator of the Federal
6 Aviation Administration shall continually look for opportu-
7 nities and methods to improve the processing of applica-
8 tions, consideration of applications, communication with
9 applicants, and quality of feedback provided to applicants,
10 for aircraft certification projects.

11 (b) CERTIFICATION IMPROVEMENTS.—Not later than
12 270 days after the date of enactment of this Act, the Ad-
13 ministrator shall enter into an appropriate arrangement
14 with a qualified third-party organization or consortium to
15 identify and assess digital tools and software systems to
16 allow for efficient and virtual evaluation of an applicant
17 design, associated documentation, and software or systems
18 engineering product, including in digital 3 dimensional
19 formats or using model-based systems engineering design
20 techniques for aircraft certification projects.

21 (c) PARTIES TO REVIEW.—In identifying digital tools
22 and software systems as described in subsection (b), the
23 Administrator shall ensure that the qualified third-party
24 organization or consortium entering into an arrangement

1 under this section shall, throughout the review, consult
2 with—

3 (1) the aircraft certification and flight stand-
4 ards offices or services of the Administration; and

5 (2) at least 3 industry members representing
6 aircraft and aircraft part manufacturing interests.

7 (d) DIGITAL TOOL AND SOFTWARE SYSTEM RE-
8 QUIREMENTS.—In identifying digital tools and software
9 systems under subsection (b), the qualified third-party or-
10 ganization or consortium shall—

11 (1) consider the interoperability of such systems
12 to the extent practicable;

13 (2) consider the scalability and usability of such
14 systems for differing use-cases by aircraft manufac-
15 turers, aircraft operators, and the Administration,
16 including cross-office use-cases within the Adminis-
17 tration;

18 (3) consider such systems currently in use by
19 United States manufacturers or other civil aviation
20 authorities for certification and engineering pur-
21 poses;

22 (4) consider the—

23 (A) available technology support for such
24 systems; and

1 (B) ability for such systems to be updated
2 and adapted over time to improve user inter-
3 faces, including providing additional
4 functionalities and addressing gaps;

5 (5) consider the ability of digital tools and soft-
6 ware systems to aid in the electronic review of soft-
7 ware components of aircraft and aircraft systems;

8 (6) consider the ability of the Administration
9 and aircraft designers to use digital tools and soft-
10 ware systems for corrective actions and modifica-
11 tions in a more rapid fashion;

12 (7) determine if each system provides adequate
13 protections for the exchange of information between
14 governmental and nongovernmental entities, includ-
15 ing—

16 (A) intellectual property protections;

17 (B) cyber and network security protec-
18 tions; and

19 (C) the ability for governmental and non-
20 governmental entities to control what is accept-
21 able and what is restricted for other parties;

22 (8) evaluate the estimated ease of adoption and
23 any impediments to adoption for personnel of the
24 Federal Aviation Administration; and

1 (9) evaluate the ability for nongovernmental or-
2 ganizations of various sizes to adopt and utilize the
3 digital and software systems identified under sub-
4 section (b) to improve the aircraft certification appli-
5 cation and coordination processes with the Adminis-
6 tration.

7 (e) ASSESSMENT.—After reviewing digital and soft-
8 ware systems under subsection (b), the qualified third-
9 party organization or consortium shall provide an assess-
10 ment to the Administrator as to—

11 (1) whether or not digital and software systems
12 and tools would improve the coordination of the Ad-
13 ministration with industry;

14 (2) whether or not such systems and tools
15 would improve the ability of the Administration to
16 validate and verify aircraft and software designs in
17 non-paper formats; and

18 (3) the potential safety benefits or safety risks
19 of using such systems and tools.

20 (f) CONTENT OF ASSESSMENT.—In the event the
21 qualified third-party organization or consortium finds that
22 digital and software systems and tools would assist the
23 work of the Administration and improve certification
24 projects processing, the assessment described under sub-
25 section (e) shall also include—

1 (1) a prioritization, expected costs, and timeline
2 of acquisitions and training based on immediate and
3 future needs and benefits; and

4 (2) suggest actions the Administration could
5 take in order to institutionalize the use of such tech-
6 nologies at the headquarters and field offices of the
7 Administration, and to protect information shared
8 through such technologies, including recommended
9 updates to orders issued by the Administration.

10 (g) IMPLEMENTATION.—Based on the assessment re-
11 quired in subsections (e) and (f), if the qualified third-
12 party organization finds that the use of digital software
13 systems and tools would assist the work of the agency,
14 the Administrator shall—

15 (1) provide the Committee on Transportation
16 and Infrastructure of the House of Representatives
17 and the Committee on Commerce, Science, and
18 Transportation of the Senate with a briefing on the
19 intended actions of the Administrator;

20 (2) not later than 60 days after receiving such
21 assessment develop a plan to—

22 (A) work towards the acquisition of the
23 systems and tools recommended, subject to the
24 availability of appropriations;

1 (B) update any applicable orders and guid-
2 ance to allow for the use of these new systems
3 and tools by personnel of the Administration
4 and nongovernmental entities applying to or co-
5 ordinating with the Administration on certifi-
6 cation related activities, at the discretion of the
7 applicant or nongovernmental entity;

8 (C) on an ongoing basis review and modify
9 orders and guidance to improve the use of these
10 systems and tools as well as addressing any in-
11 tellectual property vulnerabilities; and

12 (h) BRIEFING.—Not later than 30 months after re-
13 ceiving such assessment, the Administrator shall provide
14 the committees described in paragraph (1) with a briefing
15 on the use, benefits, and any drawbacks of the systems
16 and tools, including comparisons between certification pro-
17 grams using and not using digital and software systems
18 and tools.

19 **SEC. 516. INSTRUCTIONS FOR CONTINUED AIRWORTHINESS**
20 **AVIATION RULEMAKING COMMITTEE.**

21 (a) IN GENERAL.—Not later than 90 days after the
22 date of enactment of this Act, the Administrator of the
23 Federal Aviation Administration shall convene an aviation
24 rulemaking committee to review, and develop findings and
25 recommendations regarding, instructions for continued

1 airworthiness (as described in section 21.50 of title 14,
2 Code of Federal Regulations), and provide to the Adminis-
3 trator a report on such findings and recommendations and
4 for other related purposes as determined by the Adminis-
5 trator.

6 (b) COMPOSITION.—The aviation rulemaking com-
7 mittee established pursuant to subsection (a) shall consist
8 of members appointed by the Administrator, including
9 representatives of—

10 (1) holders of type certificates (as described in
11 subpart B of part 21, title 14, Code of Federal Reg-
12 ulations);

13 (2) holders of production certificates (as de-
14 scribed in subpart G of part 21, title 14, Code of
15 Federal Regulations);

16 (3) holders of parts manufacturer approvals (as
17 described in subpart K of part 21, title 14, Code of
18 Federal Regulations);

19 (4) holders of technical standard order author-
20 izations (as described in subpart O of part 21, title
21 14, Code of Federal Regulations);

22 (5) operators under parts 121, 125, or 135 of
23 title 14, Code of Federal Regulations;

1 (6) holders of repair station certificates (as de-
2 scribed in section 145 of title 14, Code of Federal
3 Regulations);

4 (7) the certified bargaining representative of
5 aviation safety inspectors for the Administration;

6 (8) general aviation operators;

7 (9) mechanics certificated under part 65 of title
8 14, Code of Federal Regulations;

9 (10) holders of supplemental type certificates
10 (as described in subpart E of part 21 of title 14,
11 Code of Federal Regulations);

12 (11) designated engineering representatives em-
13 ployed by repair stations; and

14 (12) aviation safety experts with specific knowl-
15 edge of instructions for continued airworthiness poli-
16 cies and regulations.

17 (c) CONSIDERATIONS.—The aviation rulemaking
18 committee established pursuant to subsection (a) shall
19 consider—

20 (1) existing standards, regulations, certifi-
21 cations, assessments, and guidance related to in-
22 structions for continued airworthiness and the clar-
23 ity of such standards, regulations, certifications, as-
24 sessments, and guidance to all parties;

1 (2) the sufficiency of safety data used in pre-
2 paring instructions for continued airworthiness;

3 (3) the sufficiency of maintenance data used in
4 preparing instructions for continued airworthiness;

5 (4) the protection of proprietary information
6 and intellectual property in instructions for contin-
7 ued airworthiness;

8 (5) the availability of instructions for continued
9 airworthiness, as needed, for maintenance activities;

10 (6) the need to harmonize or deconflict pro-
11 posed and existing regulations with other Federal
12 regulations, guidance, and policies;

13 (7) international collaboration, where appro-
14 priate and consistent with the interests of safety in
15 air commerce and national security, with other civil
16 aviation authorities, international aviation and
17 standards organizations, and any other appropriate
18 entities; and

19 (8) any other matter the Administrator deter-
20 mines appropriate.

21 (d) DUTIES.—The Administrator shall—

22 (1) not later than 1 year after the date of en-
23 actment of this Act, submit to the Committee on
24 Transportation and Infrastructure of the House of
25 Representatives and the Committee on Commerce,

1 Science, and Transportation of the Senate a copy of
2 the aviation rulemaking committee report under sub-
3 section (a); and

4 (2) not later than 180 days after the date of
5 submission of the report under paragraph (1), ini-
6 tiate a rulemaking activity or make such policy and
7 guidance updates necessary to address any con-
8 sensus recommendations reached by the aviation
9 rulemaking committee established pursuant to sub-
10 section (a), as determined appropriate by the Ad-
11 ministrator.

12 **SEC. 517. CLARITY FOR SUPPLEMENTAL TYPE CERTIFI-**
13 **CATE REQUIREMENTS.**

14 (a) IN GENERAL.—The Administrator of the Federal
15 Aviation Administration shall issue or update guidance,
16 policy documents, orders, job aids, or regulations to clarify
17 the conditions under which a major alteration will require
18 a supplemental type certificate under part 21 of title 14,
19 Code of Federal Regulations.

20 (b) CONTENTS.—Issuances or updates under sub-
21 section (a) shall include providing clarity around—

22 (1) the terms “might appreciatively effect” and
23 “no appreciable effect pursuant to sections 1.1 and
24 21.93 of title 14, Code of Federal Regulations, re-
25 spectively”; and

1 (2) whether the term “other approved design”,
2 as such term appears in part 21.1 of title 14, Code
3 of Federal Regulations, includes engineering data
4 approved by the Administrator by means other than
5 through a supplemental type certificate.

6 (c) CONSIDERATIONS.—In satisfying subsection (a),
7 the Administrator shall make such updates as necessary
8 to provide consideration for the level of effort required by
9 an applicant to make a major alteration and the associated
10 level of risk to the national airspace system for a single
11 aircraft or multiple aircraft using such alteration.

12 **SEC. 518. USE OF ADVANCED TOOLS IN CERTIFYING AERO-**
13 **SPACE PRODUCTS.**

14 (a) IN GENERAL.—Not later than 30 months after
15 the date of enactment of this Act, the Administrator of
16 the Federal Aviation Administration shall complete an as-
17 sessment of the use of advanced tools during the testing,
18 analysis, and verification stages of aerospace certification
19 projects to reduce the risks associated with high-risk flight
20 profiles and performing limit testing.

21 (b) CONSIDERATIONS.—In carrying out the assess-
22 ment under subsection (a), the Administrator shall con-
23 sider—

24 (1) instances where high risk flight profiles and
25 limit testing have already occurred in the certifi-

1 cation process and the applicability of such test data
2 for use in other aspects of flight testing;

3 (2) the safety of pilots during such testing;

4 (3) the value and accuracy of data collected
5 using such advanced tools;

6 (4) the ability to produce more extensive data
7 sets using such advanced tools;

8 (5) any aspects of testing for which the use of
9 such tools would not be valuable or applicable;

10 (6) the cost of using such advanced tools; and

11 (7) the best practices of other civil aviation au-
12 thorities that permit the use of advanced tools dur-
13 ing aerospace certification projects.

14 (c) CONSULTATION.—In carrying out the assessment
15 under subsection (a), the Administrator shall consult
16 with—

17 (1) aircraft manufacturers, including manufac-
18 turers that have designed and certified aircraft
19 under—

20 (A) part 23 of title 14, Code of Federal
21 Regulations;

22 (B) part 25 of such title; or

23 (C) part 27 of such title;

24 (2) aircraft manufacturers that have designed
25 and certified, or are in the process of certifying, air-

1 craft with a novel design under part 21.17(b) of
2 such title;

3 (3) associations representing aircraft manufac-
4 turers;

5 (4) researchers and academics in related fields;
6 and

7 (5) pilots who are experts in flight testing.

8 (d) CONGRESSIONAL REPORT.—Not later than 60
9 days after the completion of the assessment under sub-
10 section (a), the Administrator shall brief the Committee
11 on Transportation and Infrastructure of the House of
12 Representatives and the Committee on Commerce,
13 Science, and Transportation of the Senate on—

14 (1) the results of the assessment conducted
15 under subsection (a); and

16 (2) how the Administrator plans to implement
17 the findings of the assessment and any changes
18 needed to Administration policy, guidance, and regu-
19 lations to allow for and optimize the use of advanced
20 tools during the certification of aerospace products
21 in order to reduce risk and improve safety outcomes.

22 **SEC. 519. TRANSPORT AIRPLANE AND PROPULSION CER-**
23 **TIFICATION MODERNIZATION.**

24 Not later than 1 year after the date of enactment
25 of this Act, the Administrator of the Federal Aviation Ad-

1 ministration shall publish a notice of proposed rulemaking
2 for the rulemaking activity titled “Transport Airplane and
3 Propulsion Certification Modernization”, published in Fall
4 2022 in the Unified Agenda of Federal Regulatory and
5 Deregulatory Actions (RIN 2120–AL42).

6 **SEC. 520. ENGINE FIRE PROTECTION STANDARDS.**

7 (a) IN GENERAL.—Not later than 2 years after the
8 date of enactment of this Act, the Administrator of the
9 Federal Aviation Administration shall establish an inter-
10 nal regulatory review team to review and compare domes-
11 tic and international airworthiness standards and guid-
12 ance for aircraft engine firewalls.

13 (b) REVIEW.—In completing the review under sub-
14 section (a), the regulatory review team shall—

15 (1) identify any significant differences in stand-
16 ards or guidance with respect to test article selec-
17 tion, fire test boundaries, and pass-fail criteria;

18 (2) consider if alternative international stand-
19 ards used by peer civil aviation authorities reflect
20 best practices that should be adopted by the Admin-
21 istration;

22 (3) recommend updates, if appropriate, to the
23 Significant Standards List of the Administration
24 based on any findings;

1 (4) assess whether a selection of aircraft engine
2 firewalls certified by other civil aviation authorities,
3 which were validated by the Administration, comply
4 with the requirements of the Administration;

5 (5) recommend actions the Administration
6 should take during future validation activities or
7 with other civil aviation authorities to address any
8 gaps in requirements; and

9 (6) consult with industry stakeholders during
10 such review.

11 (c) BRIEFING.—Not later than 120 days after the
12 completion of the review under subsection (a), the Admin-
13 istrator shall brief the Committee on Transportation and
14 Infrastructure of the House of Representatives and the
15 Committee on Commerce, Science, and Transportation of
16 the Senate on the findings and recommendations stem-
17 ming from such review.

18 **SEC. 521. RISK MODEL FOR PRODUCTION FACILITY INSPEC-**
19 **TIONS.**

20 (a) IN GENERAL.—Not later than 18 months after
21 the date of enactment of this Act and periodically there-
22 after, the Administrator of the Federal Aviation Adminis-
23 tration shall—

24 (1) conduct a review of the risk-based model
25 used by Federal Aviation Administration certifi-

1 cation management offices to inform the frequency
2 of aircraft manufacturing or production facility in-
3 spections; and

4 (2) update the model to ensure such model ade-
5 quately accounts for risk at facilities during periods
6 of increased production.

7 (b) BRIEFINGS.—Not later than 60 days after the
8 date on which the review is conducted under subsection
9 (a), the Administrator shall brief the Committee on Trans-
10 portation and Infrastructure of the House of Representa-
11 tives and the Committee on Commerce, Science, and
12 Transportation of the Senate on—

13 (1) the results of the review;

14 (2) any changes made to the risk-based model
15 described in subsection (a); and

16 (3) how such changes would help improve the
17 in-plant inspection process.

18 **SEC. 522. SECONDARY COCKPIT BARRIERS.**

19 (a) IN GENERAL.—Not later than 6 months after the
20 issuance of a final rule on the proposed rule of the Federal
21 Aviation Administration titled “Installation and Operation
22 of Flightdeck Installed Physical Secondary Barriers on
23 Transport Category Airlines in Part 121 Service”, and
24 issued on August 1, 2022 (87 Fed. Reg. 46892), the Ad-
25 ministrator of the Federal Aviation Administration shall

1 convene an aviation rulemaking committee to review and
2 develop findings and recommendations to require installa-
3 tion of a secondary cockpit barrier on aircraft operated
4 under the provisions of part 121 of title 14, Code of Fed-
5 eral Regulations, that are not captured under another reg-
6 ulation or proposed regulation.

7 (b) MEMBERSHIP.—The Administrator shall appoint
8 the members of the rulemaking committee convened under
9 subsection (a), which shall be comprised of at least 1 rep-
10 resentative each of—

- 11 (1) mainline air carriers;
- 12 (2) regional air carriers;
- 13 (3) cargo air carriers;
- 14 (4) aircraft manufacturers;
- 15 (5) a labor group representing pilots;
- 16 (6) a labor group representing flight attend-
17 ants; and
- 18 (7) other stakeholders the Administrator deter-
19 mines appropriate.

20 (c) CONSIDERATIONS.—The aviation rulemaking
21 committee convened under subsection (a) shall consider—

- 22 (1) minimum dimension requirements for sec-
23 ondary barriers on all aircraft types operated under
24 part 121 of title 14, Code of Federal Regulations;

1 (2) secondary barrier performance standards
2 manufacturers and air carriers must meet for such
3 aircraft types;

4 (3) the availability of certified secondary bar-
5 riers suitable for use on such aircraft types;

6 (4) the development, certification, testing, man-
7 ufacturing, installation, and training for secondary
8 barriers for such aircraft types;

9 (5) flight duration and stage length;

10 (6) the location of lavatory on such aircraft as
11 related to operational complexities;

12 (7) operational complexities;

13 (8) any risks to safely evacuate passengers of
14 such aircraft; and

15 (9) other considerations the Administrator de-
16 termines appropriate.

17 (d) REPORT TO CONGRESS.—Not later than 18
18 months after the convening of the aviation rulemaking
19 committee described in subsection (a), the Administrator
20 shall submit to the Committee on Transportation and In-
21 frastructure of the House of Representatives and the Com-
22 mittee on Commerce, Science, and Transportation of the
23 Senate, a report based on the findings and recommenda-
24 tions of the aviation rulemaking committee convened
25 under subsection (a), to include—

1 (1) if applicable, any dissenting positions on the
2 findings and the rationale for each position; and

3 (2) any disagreements, including the rationale
4 for each position and the reasons for the disagree-
5 ment.

6 **SEC. 523. REVIEW OF FAA USE OF AVIATION SAFETY DATA.**

7 (a) **IN GENERAL.**—Not later than 1 year after the
8 date of enactment of this Act, the Administrator of the
9 Federal Aviation Administration shall enter into an appro-
10 priate arrangement with a qualified third-party organiza-
11 tion or consortium to evaluate the Administration’s collec-
12 tion, collation, analysis, and use of aviation data across
13 the Administration.

14 (b) **CONSULTATION.**—In completing the evaluation
15 under subsection (a), the qualified third-party organiza-
16 tion or consortium shall—

17 (1) seek the input of experts in data analytics,
18 including at least 1 expert in the commercial data
19 services or analytics solutions sector;

20 (2) consult with the National Transportation
21 Safety Board and the Transportation Research
22 Board; and

23 (3) consult with appropriate federally funded
24 research and development centers, to the extent that

1 such centers are not already involved in the evalua-
2 tion.

3 (c) SUBSTANCE OF EVALUATION.—In completing the
4 evaluation under subsection (a), the qualified third-party
5 organization or consortium shall—

6 (1) compile a list of internal and external
7 sources, databases, and streams of information the
8 Administration receives or has access to that provide
9 the Administration with operational or safety infor-
10 mation and data about the national airspace system,
11 its users, and other regulated entities of the Admin-
12 istration;

13 (2) review data sets to determine completeness
14 and accuracy of relevant information;

15 (3) identify gaps in information that the Ad-
16 ministration could fill through sharing agreements,
17 partnerships, or other means that would add value
18 during safety trend analysis;

19 (4) assess the Administration’s capabilities, in-
20 cluding analysis systems and workforce skillsets, to
21 analyze relevant data and information to make in-
22 formed decisions;

23 (5) review data and information for proper stor-
24 age, identification controls, and data privacy—

25 (A) as required by law; and

1 (B) consistent with best practices for data
2 collection, storage, and use;

3 (6) review the format of such data and identify
4 methods to improve the usefulness of such data;

5 (7) assess internal and external access to data
6 for—

7 (A) appropriateness based on data type
8 and level of detail;

9 (B) proper data access protocols and pre-
10 cautions; and

11 (C) maximizing availability of safety-re-
12 lated data that could support the improvement
13 of safety management systems of and trend
14 identification by regulated entities and the Ad-
15 ministration;

16 (8) examine the collation and dissemination of
17 data within offices and between offices of the Ad-
18 ministration;

19 (9) review and recommend improvements to the
20 data analysis techniques of the Administration; and

21 (10) recommend investments the Administra-
22 tion should consider to better collect, manage, and
23 analyze data sets, including within and between of-
24 fices of the Administration.

1 (d) ACCESS TO INFORMATION.—The Administration
2 shall provide the qualified third-party organization or con-
3 sortium and the experts described in subsection (b) with
4 adequate access to safety and operational data collected
5 by and held by the agency across all offices of the Admin-
6 istration, except if specific access is otherwise prohibited
7 by law.

8 (e) NONDISCLOSURE.—Prior to participating in the
9 review, the Administrator shall ensure that each person
10 participating in the evaluation under this section enters
11 into an agreement with the Administrator in which the
12 person shall be prohibited from disclosing at any time, ex-
13 cept as required by law, to any person, foreign or domes-
14 tic, any non-public information made accessible to the fed-
15 erally funded research and development center under this
16 section.

17 (f) REPORT.—The qualified third-party organization
18 or consortium carrying out the evaluation under this sec-
19 tion shall provide a report of the findings of the center
20 to the Administrator and include recommendations to im-
21 prove the Administration’s collection, collation, analysis,
22 and use of aviation data, including recommendations to—
23 (1) improve data access across offices within
24 the Administration, as necessary, to support efficient

1 execution of safety analysis and programs across
2 such offices;

3 (2) improve data storage best practices;

4 (3) develop or refine methods for collating data
5 from multiple administration and industry sources;
6 and

7 (4) procure or use available analytics tools to
8 draw conclusions and identify previously unrecog-
9 nized trends or miscategorized risks in the aviation
10 system, particularly when identification of such in-
11 formation requires the analysis of multiple sets of
12 data from multiple sources.

13 (g) IMPLEMENTATION OF RECOMMENDATIONS.—Not
14 later than 6 months after the receipt of the report under
15 subsection (f), the Administrator shall review, develop an
16 implementation plan, and begin the implementation of the
17 recommendations received in such report.

18 (h) REVIEW OF IMPLEMENTATION.—The qualified
19 third-party organization or consortium that conducted the
20 initial evaluation, and any experts who contributed to such
21 evaluation pursuant to subsection (b)(1), shall provide
22 regular feedback and advice to the Administrator on the
23 implementation plan developed under subsection (g) and
24 any implementation activities for at least 2 years begin-

1 ning on the date of the receipt of the report under sub-
2 section (f).

3 (i) **REPORT TO CONGRESS.**—The Administrator shall
4 submit to the Committee on Transportation and Infra-
5 structure of the House of Representatives and the Com-
6 mittee on Commerce, Science, and Transportation of the
7 Senate the report described in subsection (f) and the im-
8 plementation plan described in subsection (g).

9 (j) **EXISTING REPORTING SYSTEMS.**—Consistent
10 with section 132 of the Aircraft Certification, Safety, and
11 Accountability Act (Public Law 116–260), the Executive
12 Director of the Transportation Research Board, in con-
13 sultation with the Secretary of Transportation and the Ad-
14 ministrator, may further harmonize data and sources fol-
15 lowing the implementation of recommendations contained
16 in the report required under subsection (g).

17 **SEC. 524. PART 135 DUTY AND REST.**

18 (a) **PART 91 TAIL-END FERRY RULEMAKING.**—Not
19 later than 3 years after the date of enactment of this Act,
20 the Administrator of the Federal Aviation Administration
21 shall require that any operation conducted by a flightcrew
22 member during an assigned duty period under the oper-
23 ational control of an operator holding a certificate under
24 part 135 of title 14, Code of Federal Regulations, before,
25 during, or after the duty period (including any operations

1 under part 91 of title 14, Code of Federal Regulations),
2 without an intervening rest period, shall count towards the
3 flight time and duty period limitations of such flightcrew
4 member under part 135 of title 14, Code of Federal Regu-
5 lations.

6 (b) RECORD KEEPING.—Not later than 1 year after
7 the date of enactment of this Act, the Administrator shall
8 update any Administration policy and guidance regarding
9 complete and accurate record keeping practices for opera-
10 tors holding a certificate under part 135 of title 14, Code
11 of Federal Regulations, in order to properly document, at
12 a minimum—

- 13 (1) flightcrew assignments;
- 14 (2) flightcrew rest notifications;
- 15 (3) compliance with flight and duty times limi-
16 tations and post-duty rest requirements; and
- 17 (4) duty period start and end times.

18 (c) SAFETY MANAGEMENT SYSTEM OVERSIGHT.—
19 The Administrator, in performing oversight of the safety
20 management system of an operator holding a certificate
21 under part 135 of title 14, Code of Federal Regulations,
22 following the implementation of the final rule issued based
23 on the rulemaking titled “Safety Management Systems”,
24 and published on January 11, 2023 (88 Fed. Reg 1932),
25 shall ensure such operator is evaluating and appropriately

1 mitigating aviation safety risks, including, at minimum,
2 risks associated with—

3 (1) inadequate flightcrew member duty and rest
4 periods; and

5 (2) incomplete records pertaining to flightcrew
6 rest, duty, and flight times.

7 **SEC. 525. COCKPIT VOICE AND VIDEO RECORDERS.**

8 (a) IN GENERAL.—Chapter 447 of title 49, United
9 States Code, is further amended by adding at the end the
10 following:

11 **“§ 44746. Cockpit recording device**

12 “(a) IN GENERAL.—Not later than 18 months after
13 the date of enactment of this section, the Administrator
14 of the Federal Aviation Administration shall complete a
15 rulemaking proceeding to—

16 “(1) require that, not later than 4 years after
17 the date of enactment of this section, all applicable
18 aircraft are fitted with a cockpit voice recorder and
19 a flight data recorder that are each capable of re-
20 cording the most recent 25 hours of data;

21 “(2) prohibit any person from deliberately eras-
22 ing or tampering with any recording on such a cock-
23 pit voice recorder or flight data recorder following a
24 National Transportation Safety Board reportable
25 event under part 830 of title 49, Code of Federal

1 Regulations, and provide for civil and criminal pen-
2 alties for such deliberate erasing or tampering,
3 which may be assessed in accordance with section
4 1155 and section 32 of title 18;

5 “(3) require that such a cockpit voice recorder
6 has the capability for an operator to use an erasure
7 feature, such as an installed bulk erase function,
8 consistent with applicable law and regulations;

9 “(4) require that, in the case of such a cockpit
10 voice recorder or flight data recorder that uses a
11 solid state recording medium in which activation of
12 a bulk erase function assigns a random discrete code
13 to the deleted recording, only the manufacturer of
14 the recorder and National Transportation Safety
15 Board have access to the software necessary to de-
16 termine the code in order to extract the deleted re-
17 corded data; and

18 “(5) ensure that data on such a cockpit voice
19 recorder or a flight data recorder, through technical
20 means other than encryption (such as overwriting or
21 the substitution of a blank recording medium before
22 the recorder is returned to the owner) is not dis-
23 closed for use other than for accident or incident in-
24 vestigation purposes.

1 “(b) PROHIBITED USE.—A cockpit voice recorder re-
2 cording shall not be used by the Administrator or any em-
3 ployer for any certificate action, civil penalty, or discipli-
4 nary proceedings against flight crewmembers.

5 “(c) APPLICABLE AIRCRAFT DEFINED.—In this sec-
6 tion, the term ‘applicable aircraft’ means an aircraft that
7 is—

8 “(1) operated under part 121 of title 14, Code
9 of Federal Regulations; and

10 “(2) required by regulation to have a cockpit
11 voice recorder or a flight data recorder.”.

12 (b) CLERICAL AMENDMENT.—The analysis for chap-
13 ter 447 of title 49, United States Code, is further amend-
14 ed by adding at the end the following:

“44746. Cockpit recording device.”.

15 **SEC. 526. FLIGHT DATA RECOVERY FROM OVERWATER OP-**
16 **ERATIONS.**

17 (a) IN GENERAL.—The Administrator of the Federal
18 Aviation Administration shall direct the Aviation Rule-
19 making Advisory Committee (hereinafter referred to as
20 the “Committee” in this section) to review regulations re-
21 garding flight data recovery for aircraft—

22 (1) operated under part 121 of title 14, Code
23 of Federal Regulations; and

24 (2) used in extended overwater operations.

1 (b) CONSIDERATIONS.—In carrying out the review
2 pursuant to subsection (a), the Committee shall provide
3 to the Administrator any consensus recommendations for
4 the equipage of aircraft described in subsection (a) with
5 a cockpit voice recorder and a flight data recorder that—

6 (1) provide a means, in the event of an acci-
7 dent, to recover mandatory flight data parameters in
8 a manner that does not require the underwater re-
9 trieval of the cockpit voice recorder or flight data re-
10 corder;

11 (2) is equipped with a tamper-resistant method
12 to broadcast sufficient information to a ground sta-
13 tion to establish the location where an aircraft ter-
14 minates flight as the result of an accident within 6
15 nautical miles of the point of impact of the aircraft;
16 and

17 (3) is equipped with an airframe low-frequency
18 underwater locating device that functions for at least
19 90 days and that can be detected by appropriate
20 equipment.

21 (c) RECOMMENDATIONS.—Not later than 18 months
22 after tasking the aviation rulemaking advisory committee
23 under subsection (a), the committee shall submit to the
24 Administrator any consensus recommendations developed
25 under subsection (b).

1 (d) RULEMAKING.—Not later than 1 year after re-
2 ceiving any recommendations pursuant to subsection (c),
3 the Administrator shall initiate a rulemaking activity
4 based on such consensus recommendations, if determined
5 appropriate.

6 (e) BRIEFING.—If the Administrator decides not to
7 issue a final rule with respect to the rulemaking initiated
8 under subsection (d), the Administrator shall brief the
9 Committee on Transportation and Infrastructure of the
10 House of Representatives and the Committee on Com-
11 merce, Science, and Transportation of the Senate on the
12 justification for such decision.

13 **SEC. 527. EMERGENCY MEDICAL EQUIPMENT ON PAS-**
14 **SENGER AIRCRAFT.**

15 (a) IN GENERAL.—Not later than 12 months after
16 date of enactment of this Act, the Administrator of the
17 Federal Aviation Administration shall review and update,
18 as appropriate, part 121 of title 14, Code of Federal Regu-
19 lations, regarding emergency medical equipment, including
20 the contents of emergency medical kits, and training re-
21 quired for flight crew.

22 (b) CONSIDERATION.—In carrying out subsection (a),
23 the Administrator shall consider—

24 (1) the benefits and costs (including the costs
25 of flight diversions and emergency landings) of re-

1 quiring any new medications or equipment necessary
2 to be included in approved emergency medical kits
3 under part 121 of title 14, Code of Federal Regula-
4 tions; and

5 (2) whether the contents of the emergency med-
6 ical kits include the appropriate medications and
7 equipment that can practicably be administered to
8 address—

9 (A) the emergency medical needs of chil-
10 dren and pregnant women;

11 (B) opioid overdose;

12 (C) anaphylaxis; and

13 (D) cardiac arrest.

14 (c) CONSULTATION.—In conducting the review re-
15 quired under subsection (a), the Administrator shall con-
16 sult with associations representing aerospace medical pro-
17 fessionals.

18 **SEC. 528. NAVIGATION AIDS STUDY.**

19 (a) IN GENERAL.—Not later than 180 days after the
20 date of enactment of this Act, the inspector general of the
21 Department of Transportation shall initiate a study exam-
22 ining the effects of reclassifying navigation aids to Design
23 Assurance Level–A from Design Assurance Level–B, in-
24 cluding the following navigation aids:

25 (1) Distance measuring equipment.

1 (2) Very high frequency omni-directional range.

2 (3) Tactical air navigation.

3 (4) Wide area augmentation system.

4 (b) CONTENTS.—In conducting the study required
5 under subsection (a), the inspector general shall address—

6 (1) the cost-benefit analyses associated with the
7 reclassification described in such subsection;

8 (2) the findings from the operational safety as-
9 sessments and preliminary hazard analyses of the
10 navigation aids listed in such subsection;

11 (3) the risks of such reclassification on naviga-
12 tion aid equipment currently in use;

13 (4) the potential impacts on global interoper-
14 ability of navigational aids; and

15 (5) what additional actions should be taken
16 based on the findings of this subsection.

17 (c) REPORT.—Not later than 24 months after the
18 date of enactment of this Act, the inspector general shall
19 submit to the Committee on Transportation and Infra-
20 structure of the House of Representatives and the Com-
21 mittee on Commerce, Science, and Transportation of the
22 Senate a report describing the results of the study con-
23 ducted under subsection (a).

24 **SEC. 529. REMOTE TOWERS.**

25 (a) STUDY.—

1 (1) IN GENERAL.—Not later than 90 days after
2 the date of enactment of this Act, the Administrator
3 of the Federal Aviation Administration shall seek to
4 enter into an agreement with a qualified organiza-
5 tion to conduct a study examining the viability and
6 feasibility of remote tower technology available on
7 the date of enactment of this Act to accommodate
8 existing air traffic activity at non-towered, public-use
9 airports and airports with a visual flight rule air
10 traffic control tower.

11 (2) CONSIDERATIONS.—In the study conducted
12 under subsection (a), the qualified organization se-
13 lected under such subsection shall consider and in-
14 clude in such study—

15 (A) the effectiveness and adequacy of the
16 pilot program established under section 161 of
17 the FAA Reauthorization Act of 2018 (49
18 U.S.C. 47104 note) in—

19 (i) assessing the installation, mainte-
20 nance, and operational costs and benefits
21 of remote tower technology; and

22 (ii) establishing a clear process for the
23 safety and operational certification of such
24 technology;

1 (B) a description of actions that the Ad-
2 ministration has undertaken to carry out such
3 pilot program;

4 (C) any barriers related to the safety and
5 operational certification of such technology;

6 (D) the number and type of non-towered
7 airports in the national airspace system;

8 (E) the availability and development of re-
9 mote tower technology;

10 (F) the potential to use remote tower sys-
11 tems to control air traffic at multiple airports
12 and from a single physical location, similar to
13 a terminal radar approach control facility;

14 (G) staffing flexibility to support seasonal
15 staffing of remote towers;

16 (H) safety factors related to the potential
17 need for such remote tower technology;

18 (I) the potential to use remote tower sys-
19 tems to surveil for unmanned aircraft, in con-
20 junction with unmanned aircraft system traffic
21 management systems, to enhance air traffic
22 management of manned air traffic;

23 (J) factors related to the demand for re-
24 mote tower technology;

1 (K) an examination of remote tower use in
2 other countries;

3 (L) projected costs associated with install-
4 ing and maintain remote tower technology at a
5 single airport; and

6 (M) recommendations regarding the most
7 cost-effective approach to provide air traffic
8 control services at non-towered airports in the
9 national airspace system.

10 (3) INPUT.—In carrying out the study under
11 subsection (a), the qualified organization selected
12 under such subsection shall—

13 (A) seek coordination with the Air Traffic
14 Organization and other offices of the Adminis-
15 tration; and

16 (B) seek the participation of representa-
17 tives of—

18 (i) the exclusive bargaining represent-
19 atives of air traffic controllers certified
20 under section 7111 of title 5, United
21 States Code;

22 (ii) manufacturers of remote towers;

23 (iii) airport operators; and

24 (iv) other stakeholders that the Ad-
25 ministrator determines appropriate.

1 (4) REPORT.—Not later than 1 year after the
2 date of enactment of this Act, the Administrator
3 shall submit to the Committee on Transportation
4 and Infrastructure of the House of Representatives
5 and the Committee on Commerce, Science, and
6 Transportation of the Senate a report detailing the
7 results of the study under subsection (a).

8 (b) CERTIFICATION PROCESS.—

9 (1) IN GENERAL.—Not later than 1 year after
10 the completion of the study required under sub-
11 section (a), the Administrator shall establish a pro-
12 cess for the certification of system design and oper-
13 ational approval of remote towers for use at public-
14 use airports.

15 (2) CONSULTATION.—In carrying out sub-
16 section (b), the Administrator shall consult with the
17 following:

18 (A) The exclusive bargaining representa-
19 tive of the air traffic controllers certified under
20 section 7111 of title 5, United States Code.

21 (B) Manufacturers of remote towers.

22 (C) Non-towered airport operators.

23 (3) REQUIREMENTS.—In developing the certifi-
24 cation process required under subsection (b), the Ad-
25 ministrator shall—

1 (A) establish requirements for the system
2 design and operational approval of remote tow-
3 ers, including—

4 (i) sensor and camera visual require-
5 ments;

6 (ii) datalink latency requirements; and

7 (iii) visual presentation design re-
8 quirements for monitors used to display
9 sensor and camera feeds;

10 (B) establish tower-closure standards for
11 contingency operations and procedures for re-
12 mote tower failures and malfunctions; and

13 (C) consider the use of—

14 (i) ground- and space-based tele-
15 communications infrastructure; and

16 (ii) any other wireless telecommuni-
17 cations infrastructure that may enable the
18 operation of a remote tower.

19 (4) OPERATIONAL APPROVAL ASSESSMENTS.—

20 In developing the operational approval process re-
21 quired under this subsection, the Administrator
22 shall—

23 (A) determine the appropriate number of
24 air traffic controllers necessary to staff a re-
25 mote tower for safe air traffic control oper-

1 ations at the respective airport based on the ex-
2 isting or projected air traffic activity at the air-
3 port;

4 (B) use a safety risk management panel
5 process to address any safety issues with re-
6 spect to the remote tower;

7 (C) if the remote tower is intended to be
8 installed at a non-towered airport, assess the
9 safety benefits of the remote tower against the
10 lack of an existing tower; and

11 (D) establish, to the satisfaction of the Ad-
12 ministrator and using performance-based cri-
13 teria, to the extent appropriate, published in
14 advance, the level of safety necessary for the
15 operation of the remote tower at the airport.

16 (5) AIRPORT OPERATORS.—An airport operator
17 seeking to install or construct a certified remote
18 tower shall submit to the Administrator an applica-
19 tion in such form and containing such information
20 as the Administrator may require.

21 (6) IMPLEMENTATION.—In carrying out this
22 section, the Administrator shall—

23 (A) identify air traffic control information
24 and data that assists the Administrator in cat-

1 egorically certifying remote towers at different
2 types of airports;

3 (B) implement processes necessary to col-
4 lect the information and data identified in sub-
5 paragraph (A); and

6 (C) develop criteria from the information
7 and data identified in subparagraph (A) to as-
8 sess remote towers for widespread use at cat-
9 egories of public-use airports.

10 (7) PRIORITIZATION OF REMOTE TOWER CER-
11 TIFICATION APPLICANTS.—With respect to applica-
12 tions submitted as required by paragraph (4), the
13 Administrator shall prioritize—

14 (A) airports that do not have a permanent
15 air traffic control tower at the time of applica-
16 tion;

17 (B) airports that would provide small and
18 rural community air service; or

19 (C) airports that have been newly accepted
20 as of the date of enactment of this Act into the
21 Contract Tower Program.

22 (8) BRIEFING.—Not later than 180 days after
23 receiving the report required under subsection (a),
24 and annually thereafter through fiscal year 2028,
25 the Administrator shall brief the Committee on

1 Transportation and Infrastructure of the House of
2 Representatives and the Committee on Commerce,
3 Science, and Transportation of the Senate on the
4 status of the activities required under this section.

5 (c) DEFINITIONS.—In this section:

6 (1) AIR TRAFFIC ACTIVITY.—The term “air
7 traffic activity” means the number of takeoffs, land-
8 ings, and simulated approaches of an airport and
9 the time of which such takeoffs, landings, and simu-
10 lated approaches occur.

11 (2) CONTRACT TOWER PROGRAM.—The term
12 “Contract Tower Program” has the meaning given
13 such term in section 47124(e) of title 49, United
14 States Code.

15 (3) QUALIFIED ORGANIZATION.—The term
16 “qualified organization” means an independent non-
17 profit organization that recommends solutions to
18 public policy challenges through objective analysis.

19 (4) REMOTE TOWER.—The term “remote
20 tower” has the meaning given such term in section
21 161(a)(9) of the FAA Reauthorization Act of 2018
22 (49 U.S.C. 47104 note).

23 **SEC. 530. WEATHER REPORTING SYSTEMS STUDY.**

24 (a) IN GENERAL.—Not later than 180 days after the
25 date of enactment of this Act, the Comptroller General

1 of the United States shall initiate a study to examine how
2 to improve the procurement, functionality, and sustain-
3 ability of weather reporting systems, including—

4 (1) automated weather observing systems;

5 (2) automated surface observing systems;

6 (3) visual weather observing systems; and

7 (4) non-Federal weather reporting systems.

8 (b) CONTENTS.—In conducting the study required
9 under section (a), the Comptroller General shall address—

10 (1) the current state of the supply chain related
11 to weather reporting systems and the components of
12 such systems, including—

13 (A) the adequacy of suppliers of such sys-
14 tems and components;

15 (B) the affordability of such systems and
16 components; and

17 (C) the availability and affordability of re-
18 placement parts;

19 (2) the average age of weather reporting sys-
20 tems infrastructure installed in the national airspace
21 system;

22 (3) challenges to maintaining and replacing
23 weather reporting systems, including—

24 (A) root causes of weather reporting sys-
25 tem outages, including failures of such systems,

1 and supporting systems such as telecommuni-
2 cations infrastructure; and

3 (B) the degree to which such outages af-
4 fect weather reporting in the national airspace
5 system;

6 (4) mitigation measures to maintain aviation
7 safety during such an outage; and

8 (5) alternative means of obtaining weather ele-
9 ments at airports, including wind direction, wind
10 speed, barometric pressure setting, and cloud cov-
11 erage, including visibility.

12 (c) CONSULTATION.—In conducting the study re-
13 quired under subsection (a), the Comptroller General shall
14 consult with the appropriate stakeholders and Federal
15 agencies involved in installing, managing, and supporting
16 weather reporting systems in the national airspace system.

17 (d) REPORT.—

18 (1) IN GENERAL.—Not later than 2 years after
19 the date of enactment of this Act, the Comptroller
20 General shall submit to the Committee on Transpor-
21 tation and Infrastructure of the House of Represent-
22 atives and the Committee on Commerce, Science,
23 and Transportation of the Senate a report describ-
24 ing the results of the study conducted under sub-
25 section (a).

1 (2) RECOMMENDATIONS.—The Comptroller
2 General shall include in the report submitted under
3 paragraph (1) recommendations for—

4 (A) ways to improve the resiliency and re-
5 dundancy of weather reporting systems;

6 (B) alternative means of compliance for
7 obtaining weather elements at airports; and

8 (C) if necessary, changes to Orders of the
9 Administration, including the following:

10 (i) Surface Weather Observing, Joint
11 Order 7900.5.

12 (ii) Notices to Air Missions, Joint
13 Order 7930.2.

14 **SEC. 531. GAO STUDY ON EXPANSION OF THE FAA WEATH-**
15 **ER CAMERA PROGRAM.**

16 (a) STUDY.—The Comptroller General of the United
17 States shall conduct a study on the feasibility and benefits
18 and costs of expanding the Weather Camera Program of
19 the Federal Aviation Administration to locations in the
20 United States that lack weather camera services.

21 (b) CONSIDERATIONS.—In conducting the study re-
22 quired under subsection (a), the Comptroller General shall
23 review—

1 (1) the potential effects of the existing Weather
2 Camera Program on weather-related aviation acci-
3 dents and flight interruptions;

4 (2) the potential benefits and costs associated
5 with expanding the Weather Camera Program;

6 (3) limitations on the real-time access of weath-
7 er camera information by pilots and aircraft opera-
8 tors;

9 (4) non-safety related regulatory structures or
10 barriers to the allowable use of weather camera in-
11 formation for the purposes of aircraft operations;

12 (5) limitations of existing weather camera sys-
13 tems at the time of the study;

14 (6) alternative sources of viable weather data;

15 (7) funding mechanisms for weather camera in-
16 stallation and operations; and

17 (8) other considerations the Comptroller Gen-
18 eral determines appropriate.

19 (c) REPORT TO CONGRESS.—Not later than 28
20 months after the date of enactment of this Act, the Comp-
21 troller General shall submit to the Committee on Trans-
22 portation and Infrastructure of the House of Representa-
23 tives and the Committee on Commerce, Science, and
24 Transportation of the Senate a report on the results of
25 the study required under subsection (a).

1 **SEC. 532. AUDIT ON AVIATION SAFETY IN ERA OF WIRELESS**
2 **CONNECTIVITY.**

3 (a) IN GENERAL.—Not later than 180 days after the
4 date of enactment of this Act, the inspector general of the
5 Department of Transportation shall initiate an audit of
6 the Federal Aviation Administration’s internal processes
7 and procedures to communicate the position of civil avia-
8 tion operators and the safety of the national airspace sys-
9 tem to the National Telecommunications and Information
10 Administration regarding proposed spectrum reallocations
11 or auction decisions.

12 (b) ASSESSMENT.—In conducting the audit described
13 in subsection (a), the inspector general shall assess best
14 practices and policy recommendations for the Federal
15 Aviation Administration to—

16 (1) improve internal processes by which pro-
17 posed spectrum reallocations or auctions are thor-
18 oughly reviewed in advance to ensure that any com-
19 ments or technical concerns regarding aviation safe-
20 ty from civil aviation stakeholders are communicated
21 to the National Telecommunications and Informa-
22 tion Administration that are to be submitted to the
23 Federal Communications Commission;

24 (2) develop internal processes and procedures to
25 assess the effects a proposed spectrum reallocation
26 or auction may have on the [National Airspace Sys-

1 tem/national airspace system] in a timely manner to
2 ensure safety of the national airspace system;

3 (3) improve external communication processes
4 to better inform civil aviation stakeholders, including
5 owners and operators of civil aircraft, on any com-
6 ments or technical concerns of the Federal Aviation
7 Administration relating to a proposed spectrum re-
8 allocation or auction that may impact the national
9 airspace system; and

10 (4) better communicate to the National Tele-
11 communications and Information Administration
12 when a proposed spectrum reallocation or auction
13 may pose a potential risk to aviation safety.

14 (c) STAKEHOLDER VIEWS.—In conducting the audit
15 pursuant to subsection (a), the inspector general shall con-
16 sult with relevant stakeholders, including—

17 (1) air carriers operating under part 121 of
18 title 14, Code of Federal Regulations;

19 (2) manufacturers of aircraft and aircraft com-
20 ponents;

21 (3) wireless communication carriers;

22 (4) labor unions representing pilots;

23 (5) air traffic system safety specialists;

24 (6) other representatives of the communications
25 industry;

1 (7) aviation safety experts;

2 (8) the National Telecommunications and Infor-
3 mation Administration; and

4 (9) the Federal Communications Commission.

5 (d) REPORT.—Not later than 2 years after the date
6 on which the audit is conducted pursuant to subsection
7 (a), the inspector general shall complete and submit a re-
8 port on findings and recommendations to—

9 (1) the Administrator of the Federal Aviation
10 Administration;

11 (2) the Committee on Transportation and In-
12 frastructure of the House of Representatives;

13 (3) the Committee on Energy and Commerce of
14 the House of Representatives; and

15 (4) the Committee on Commerce, Science, and
16 Technology of the Senate.

17 **SEC. 533. RAMP WORKER SAFETY CALL TO ACTION.**

18 (a) CALL TO ACTION RAMP WORKER SAFETY RE-
19 VIEW.—Not later than 180 days after the date of enact-
20 ment of this Act, the Administrator of the Federal Avia-
21 tion Administration shall initiate a Call to Action safety
22 review of airport ramp worker safety in order to bring
23 stakeholders together to share best practices and imple-
24 ment actions to address airport ramp worker safety.

1 (b) CONTENTS.—The Call to Action safety review re-
2 quired pursuant to subsection (a) shall include—

3 (1) a review of Administration regulations,
4 guidance, and directives related to airport ramp
5 worker procedures and oversight of such processes;

6 (2) a review of reportable accidents and inci-
7 dents involving airport ramp workers, including any
8 identified contributing factors to the reportable acci-
9 dent or incident;

10 (3) a review of training and related educational
11 materials for airport ramp workers, including super-
12 visory employees;

13 (4) a review of devices and methods for commu-
14 nication on the ramp;

15 (5) a review of markings on the ramp that de-
16 fine restriction, staging, safety, or hazard zones;

17 (6) a review of aircraft jet blast and engine in-
18 take safety markings; and

19 (7) a process for stakeholders, including air-
20 lines, aircraft manufacturers, airports, labor, and
21 aviation safety experts, to provide feedback and
22 share best practices.

23 (c) REPORT AND ACTIONS.—Not later than 180 days
24 after the conclusion of the Call to Action safety review
25 pursuant to subsection (a), the Administrator shall—

1 (1) submit to the Committee on Transportation
2 and Infrastructure of the House of Representatives
3 and the Committee on Commerce, Science, and
4 Transportation of the Senate a report on the results
5 of the review and any recommendations for actions
6 or best practices to improve airport ramp worker
7 safety, including the identification of risks and pos-
8 sible mitigations to be considered in any applicable
9 safety management system of air carriers and air-
10 ports; and

11 (2) initiate such actions as are necessary to act
12 upon the findings of the review under subsection (b).

13 **SEC. 534. SAFETY DATA ANALYSIS FOR AIRCRAFT WITHOUT**
14 **TRANSPONDERS.**

15 (a) IN GENERAL.—Not later than 90 days after the
16 date of enactment of this Act, the Administrator of the
17 Federal Aviation Administration, in coordination with the
18 Chairman of the National Transportation Safety Board,
19 shall collect and analyze data relating to accidents and in-
20 cidents involving covered exempt aircraft that occurred
21 within 30 nautical miles of an airport.

22 (b) REQUIREMENTS.—The analysis required under
23 subsection (a) shall include with respect to covered exempt
24 aircraft a review of—

25 (1) incident and accident data since 2006;

1 (2) incidents and accidents involving midair
2 events, including collisions;

3 (3) incidents and accidents involving ground
4 proximity warning system alerts;

5 (4) incidents and accidents involving traffic col-
6 lision avoidance system alerts;

7 (5) incidents and accidents involving a loss of
8 separation or near miss; and

9 (6) the causes of the accidents and incidents
10 described in paragraphs (1) through (5).

11 (c) REPORT TO CONGRESS.—Not later than 1 year
12 after the date of enactment of this Act, the Administrator
13 shall submit to the Committee on Transportation and In-
14 frastructure of the House of Representatives and the Com-
15 mittee on Commerce, Science, and Transportation of the
16 Senate a report containing the results of the analysis re-
17 quired under subsection (a) and, if appropriate, rec-
18 ommendations on how to reduce the number of incidents
19 and accidents associated with such covered exempt air-
20 craft.

21 (d) COVERED EXEMPT AIRCRAFT DEFINED.—In this
22 section, the term “covered exempt aircraft” means air-
23 craft, balloons, and gliders exempt from air traffic control
24 transponder and altitude reporting equipment and use re-

1 quirements under part 91.215(b)(3) of title 14, Code of
2 Federal Regulations.

3 **SEC. 535. CRASH-RESISTANT FUEL SYSTEMS IN ROTOR-**
4 **CRAFT.**

5 (a) IN GENERAL.—The Administrator of the Federal
6 Aviation Administration shall task the Aviation Rule-
7 making Advisory Committee to—

8 (1) review the data analysis conducted and the
9 recommendations developed by the Aviation Rule-
10 making Advisory Committee Rotorcraft Occupant
11 Protection Working Group of the Administration;

12 (2) update the 2018 report of such working
13 group on rotorcraft occupant protection by—

14 (A) reviewing National Transportation
15 Safety Board data from 2016 through 2023 on
16 post-crash fires in helicopter accidents; and

17 (B) determining whether and to what ex-
18 tent crash-resistant fuel systems could have
19 prevented fatalities; and

20 (3) develop recommendations for either the Ad-
21 ministrator or the helicopter industry to encourage
22 helicopter owners and operators to expedite the in-
23 stallation of crash-resistant fuel systems in the air-
24 craft of such owners and operators regardless of
25 original certification and manufacture date.

1 (b) SCHEDULE.—

2 (1) DEADLINE.—Not later than 18 months
3 after the Administrator tasks the Aviation Rule-
4 making Advisory Committee under subsection (a),
5 the Committee shall submit the recommendations
6 developed under subsection (a)(2) to the Adminis-
7 trator.

8 (2) IMPLEMENTATION.—If applicable, and not
9 later than 180 days after receiving the recommenda-
10 tions under paragraph (1), the Administrator
11 shall—

12 (A) begin implementing, as appropriate,
13 any consensus safety recommendations the Ad-
14 ministrator receives from the Aviation Rule-
15 making Advisory Committee, and brief the
16 Committee on Transportation and Infrastruc-
17 ture of the House of Representatives and the
18 Committee on Commerce, Science, and Trans-
19 portation of the Senate on any recommenda-
20 tions the Administrator does not implement;
21 and

22 (B) partner with the United States Heli-
23 copter Safety Team, as appropriate, to facilitate
24 implementation of any recommendations for the

1 helicopter industry pursuant to subsection
2 (a)(2)

3 **SEC. 536. REDUCING TURBULENCE ON PART 121 AIRCRAFT**
4 **OPERATIONS.**

5 (a) IN GENERAL.—Not later than 3 years after the
6 date of enactment of this Act, the Administrator of the
7 Federal Aviation Administration shall review and imple-
8 ment, as appropriate, the recommendations made by the
9 Chair of the National Transportation Safety Board to the
10 Administrator contained in the safety research report ti-
11 tled “Preventing Turbulence-Related Injuries in Air Car-
12 rier Operations Conducted Under Title 14 Code of Federal
13 Regulations Part 121”, issued on August 10, 2021
14 (NTSB/SS–21/01).

15 (b) REPORT.—

16 (1) IN GENERAL.—Not later than 1 year after
17 completing the review under subsection (a), and
18 every 2 years thereafter, the Administrator shall
19 submit to the Committee on Transportation and In-
20 frastructure of the House of Representatives and the
21 Committee on Commerce, Science, and Transpor-
22 tation of the Senate a report on the status of the
23 recommendations in the safety research report de-
24 scribed in subsection (a) until the earlier of—

1 (A) the date on which such recommenda-
2 tions have been adopted; or

3 (B) the date that is 10 years after the date
4 of enactment of this Act.

5 (2) CONTENTS.—If the Administrator decides
6 not to implement a recommendation in the safety re-
7 search report described in subsection (a), the Ad-
8 ministrator shall provide, as a part of the report re-
9 quired under paragraph (1), a description of why the
10 Administrator did not implement such recommenda-
11 tion.

12 **SEC. 537. STUDY ON RADIATION EXPOSURE.**

13 (a) STUDY.—Not later than 120 days after the date
14 of enactment of this Act, the Administrator of the Federal
15 Aviation Administration shall seek to enter into an agree-
16 ment with the National Academies of Sciences, Engineer-
17 ing, and Medicine under which the National Research
18 Council of the National Academies shall conduct a study
19 on radiation exposure onboard various aircraft types oper-
20 ated under part 121 of title 14, Code of Federal Regula-
21 tions.

22 (b) SCOPE OF STUDY.—In conducting the study
23 under subsection (a), the National Research Council shall
24 assess—

1 (1) radiation concentrations in such aircraft at
2 takeoff, in-flight at high altitudes, and upon landing;

3 (2) the health risks and impact of radiation ex-
4 posure to flight attendants and passengers onboard
5 aircraft operating at high altitudes; and

6 (3) mitigation measures to prevent and reduce
7 the health and safety impacts of radiation exposure
8 to flight attendants and passengers.

9 (c) **REPORT TO CONGRESS.**—Not later than 16
10 months after the initiation of the study required under
11 subsection (a), the Secretary shall submit to the appro-
12 priate committees of Congress the study conducted by the
13 National Research Council pursuant to this section.

14 (d) **APPROPRIATE COMMITTEES OF CONGRESS DE-**
15 **FINED.**—In this section, the term “appropriate commit-
16 tees of Congress” means the Committee on Transpor-
17 tation and Infrastructure and the Committee on Energy
18 and Commerce of the House of Representatives and the
19 Committee on Commerce, Science, and Transportation of
20 the Senate.

21 **SEC. 538. DETERRING CREWMEMBER INTERFERENCE.**

22 (a) **TASK FORCE.**—

23 (1) **IN GENERAL.**—Not later than 120 days
24 after the date of enactment of this Act, the Adminis-
25 trator of the Federal Aviation Administration shall

1 convene a task force to develop voluntary standards
2 and best practices relating to suspected violations of
3 sections 46318, 46503, and 46504 of title 49,
4 United States Code, including—

5 (A) proper and consistent incident docu-
6 mentation and reporting techniques;

7 (B) best practices for flight crew and cabin
8 crew response, including de-escalation;

9 (C) improved coordination between stake-
10 holders, including flight crew and cabin crew,
11 airport staff, other Federal agencies as appro-
12 priate, and law enforcement; and

13 (D) appropriate enforcement actions.

14 (2) MEMBERSHIP.—The task force convened
15 under paragraph (1) shall be comprised representa-
16 tives of—

17 (A) air carriers;

18 (B) airport sponsors and airport law en-
19 forcement agencies;

20 (C) other Federal agencies determined nec-
21 essary by the Administrator; and

22 (D) labor organizations representing air
23 carrier pilots;

24 (E) labor organizations representing flight
25 attendants; and

1 (F) labor organizations representing
2 ticketing, check-in, or other customer service
3 representatives employed by air carriers.

4 (b) ANNOUNCEMENTS.—Not later than 90 days after
5 the date of enactment of this Act, the Administrator shall
6 initiate such actions as may be necessary to include in the
7 briefing of passengers before takeoff required under sec-
8 tion 121.571 of title 14, Code of Federal Regulations, a
9 statement informing passengers that it is against Federal
10 law to assault or threaten to assault any individual on an
11 aircraft or interfere with the duties of a crewmember.

12 (c) DEFINITIONS.—For purposes of this section, the
13 definitions in section 40102(a) of title 49, United States
14 Code, shall apply to terms in this section.

15 **SEC. 539. CABIN TEMPERATURE STANDARDS.**

16 (a) IN GENERAL.—Not later than 24 months after
17 the date of enactment of this Act, the Administrator of
18 the Federal Aviation Administration shall review existing
19 standards produced by recognized industry standards or-
20 ganizations on safe air temperatures and humidity levels
21 in enclosed environments, including onboard aircraft, and
22 determine the validity of such standards, including the
23 American Society of Heating, Refrigerating and Air-Con-
24 ditioning Engineers (in this section referred to as
25 “ASHRAE”) standards titled “Air Quality within Com-

1 mercial Aircraft” (ASHRAE Guideline 28–2021) and
2 “Thermal Environmental Conditions for Human Occu-
3 pancy” (ASHRAE Standard 55–2020).

4 (b) CONSULTATION.—In conducting the review under
5 subsection (a), the Administrator shall consult with—

6 (1) certificate holders under part 121 of title
7 14, Code of Federal Regulations;

8 (2) certified labor representatives of flight at-
9 tendants, pilots, and other crewmembers;

10 (3) relevant Federal agencies; and

11 (4) other relevant stakeholders, as appropriate.

12 (c) ACADEMIC STUDY.—In the event that the Admin-
13 istrator determines, through the review carried out under
14 subsection (a), that there is not an appropriate standard
15 to determine unsafe temperatures onboard aircraft oper-
16 ated under part 121 of title 14, Code of Federal Regula-
17 tions, the Administrator shall enter into an appropriate
18 agreement with the National Academies to—

19 (1) conduct a study of unsafe aircraft cabin
20 temperatures and aircraft conditions that contribute
21 to such temperatures; and

22 (2) provide recommendations for air carriers
23 and aircraft manufacturers to improve the manage-
24 ment of temperature and related factors onboard
25 aircraft.

1 (d) REPORTS.—

2 (1) FAA.—Not later than 3 months after com-
3 pleting the review required under subsection (a), the
4 Administrator shall submit to the Committee on
5 Transportation and Infrastructure of the House of
6 Representatives and the Committee on Commerce,
7 Science, and Transportation of the Senate a report
8 on the findings and determination of the review.

9 (2) NATIONAL ACADEMIES.—If a report is pro-
10 duced under subsection (c), not later than 1 month
11 after receiving such report the Administrator shall
12 submit to the Committee on Transportation and In-
13 frastructure of the House of Representatives and the
14 Committee on Commerce, Science, and Transpor-
15 tation of the Senate such report.

16 **SEC. 540. CABIN AIR QUALITY.**

17 (a) REPORTING OF SMOKE OR FUME EVENTS ON-
18 BOARD COMMERCIAL AIRCRAFT.—

19 (1) IN GENERAL.—Not later than 180 days
20 after the date of the enactment of this Act, the Ad-
21 ministrator of the Federal Aviation Administration
22 shall develop a standardized system for a flight at-
23 tendants, pilots, and aircraft maintenance techni-
24 cians of air carriers to voluntarily report fume
25 events onboard passenger-carrying aircraft operating

1 under part 121 of title 14, Code of Federal Regula-
2 tions.

3 (2) INFORMATION SUBMISSION.—The system
4 developed under paragraph (1) shall include a meth-
5 od of submission, which shall request at least the
6 following information:

7 (A) Identification of the flight number,
8 type, and registration of the aircraft.

9 (B) The date of the reported fume event
10 onboard the aircraft.

11 (C) Description of smoke or fume in the
12 aircraft, including the nature, intensity, and
13 visual consistency or smell (if any).

14 (D) The location of the smoke or fumes in
15 the aircraft.

16 (E) The source (if discernible) of the
17 smoke or fumes in the aircraft.

18 (F) The phase of flight during which
19 smoke or fumes first became present.

20 (G) The duration of the fume event.

21 (H) Any required onboard medical atten-
22 tion for passengers or crew members.

23 (I) Any additional factors as determined
24 appropriate by the Administrator or crew mem-
25 ber submitting a report.

1 (3) GUIDELINES FOR SUBMISSION.—The Ad-
2 ministrators shall issue guidelines on how to submit
3 the information described in paragraph (2).

4 (4) CONFIRMATION OF SUBMISSION.—Upon
5 submitting the information described in paragraph
6 (2), the submitting party shall receive a duplicate
7 record of the submission and confirmation of receipt.

8 (5) USE OF INFORMATION.—The Adminis-
9 trator—

10 (A) may not publish any information sub-
11 mitted under this section;

12 (B) shall maintain a database of such in-
13 formation;

14 (C) at the request of an air carrier, shall
15 provide to such air carrier any information sub-
16 mitted under this section that is relevant to
17 such air carrier, except any information that
18 may be used to identify the party submitting
19 such information;

20 (D) may not, without validation, assume
21 that information submitted under this section is
22 accurate for the purposes of initiating rule-
23 making or taking an enforcement action;

1 (E) may use information submitted under
2 this section to inform the oversight of the safety
3 management system of an air carrier; and

4 (F) may use information submitted under
5 this section for the purpose of performing a
6 study or supporting a study sponsored by the
7 Administrator.

8 (b) STUDY.—

9 (1) IN GENERAL.—Not later than 3 years after
10 the date of enactment of this Act, the Administrator
11 of the Federal Aviation Administration shall seek to
12 enter into the appropriate arrangements with the
13 National Academies to conduct a study and issue
14 recommendations to be made publicly available per-
15 taining to cabin air quality and any risk of, and po-
16 tential for, persistent and accidental fume events on-
17 board a passenger-carrying aircraft operating under
18 part 121 of title 14, Code of Federal Regulations.

19 (2) SCOPE.—In carrying out a study pursuant
20 to paragraph (1), the National Academies shall ex-
21 amine—

22 (A) the information collected pursuant to
23 subsection (a);

24 (B) the report issued pursuant to section
25 326 of the FAA Reauthorization Act of 2018

1 (49 U.S.C. 40101 note) and any identified as-
2 sumptions or gaps described in such report;

3 (C) any health risks or impacts of fume
4 events on flight crews, including flight attend-
5 ants and pilots, and passengers onboard air-
6 craft operating under part 121 of title 14, Code
7 of Federal Regulations;

8 (D) instances of persistent or regularly oc-
9 ccurring (as determined by the National Acad-
10 emies) fume events in such aircraft;

11 (E) instances of accidental, unexpected, or
12 irregularly occurring (as determined by the Na-
13 tional Academies) fume events on such aircraft,
14 including whether such accidental events are
15 more frequent during various phases of oper-
16 ations, including ground operations, taxiing,
17 take off, cruise, and landing;

18 (F) the likely originating material of, and
19 the air contaminants present during, the situa-
20 tions described in subparagraphs (D) and (E);

21 (G) the frequencies, durations, and likely
22 causes of the situations described in subpara-
23 graphs (D) and (E); and

1 (H) any additional data on fume events as
2 determined appropriate by the National Acad-
3 emies.

4 (3) RECOMMENDATIONS.—The National Acad-
5 emies shall provide recommendations based on the
6 study conducted under paragraph (1)—

7 (A) that shall, at minimum, address how
8 to—

9 (i) improve overall cabin air quality of
10 passenger-carrying aircraft;

11 (ii) improve the detection, accuracy,
12 and reporting of fume events; and

13 (iii) reduce the frequency and impact
14 of fume events; and

15 (B) for any updates to standards, guide-
16 lines, or regulations that could help achieve the
17 recommendations described in subparagraph
18 (A).

19 (4) REPORT TO CONGRESS.—Not later than 1
20 month after the completion of the study conducted
21 under paragraph (1), the Administrator shall submit
22 to the Committee on Transportation and Infrastruc-
23 ture of the House of Representatives and the Com-
24 mittee on Commerce, Science, and Transportation of
25 the Senate a copy of such study.

1 (c) FUME EVENT DEFINED.—In this section, the
2 term “fume event” means the presence of fumes in the
3 cabin, including smoke.

4 **SEC. 541. EVACUATION STANDARDS FOR TRANSPORT CAT-**
5 **EGORY AIRPLANES.**

6 (a) IN GENERAL.—Not later than 6 months after the
7 date of enactment of this Act, the Administrator of the
8 Federal Aviation Administration shall task the Aviation
9 Rulemaking Advisory Committee with reviewing and pro-
10 posing updates to the evacuation requirements under sec-
11 tion 25.803 of title 14, Code of Federal Regulations, and
12 appendix J to part 25 of such title.

13 (b) CONSIDERATIONS.—In tasking the Aviation Rule-
14 making Advisory Committee under subsection (a), the Ad-
15 ministrator shall, at a minimum, task the Committee to—

16 (1) evaluate whether the representative pas-
17 senger loads, prescribed in regulation on the date of
18 enactment of this Act, represent a realistic composi-
19 tion of passengers on an aircraft operated under
20 part 121 of title 14, Code of Federal Regulations,
21 including accounting for—

22 (A) children, including infants;

23 (B) passengers who do not speak English;

24 (C) passengers with disabilities; and

1 (D) service animals (as such term is de-
2 fined in section 35.104 and 36.104 of title 28,
3 Code of Federal Regulations, or successor regu-
4 lations); and

5 (2) determine if there are technologies or tech-
6 niques that can be used to more accurately represent
7 categories of passengers who are unable to provide
8 consent during evacuation testing, but should be
9 simulated in such testing;

10 (3) evaluate whether the requirements pre-
11 scribed in regulation on the date of enactment of
12 this Act adequately consider the varying sizes,
13 weight, and matter or baggage present in an aircraft
14 cabin; and

15 (4) determine whether the evacuation testing
16 performed, associated with section 25.803 of title
17 14, Code of Federal Regulations, considers the seat
18 size, seat pitch, seating layout, aisle width, and aisle
19 layout of the aircraft type being tested.

20 (c) CONSULTATION.—In tasking the Aviation Rule-
21 making Advisory Committee under subsection (a), the Ad-
22 ministrator shall allow such Committee to consult with the
23 National Transportation Safety Board, transport category
24 aircraft manufacturers, air carriers certificated under part
25 121 of title 14, Code of Federal Regulations, crew mem-

1 bers of such air carriers, emergency responders, groups
2 representing passengers and passengers with disabilities,
3 and other relevant experts.

4 (d) RULEMAKING.—Not later than 18 months after
5 receiving such recommendations to update section 25.803
6 of title 14, Code of Federal Regulations, and appendix J
7 to part 25 of such title, the Administrator shall issue a
8 final rulemaking based on the recommendations provided
9 by the aviation rulemaking advisory committee tasked
10 under this section, as necessary.

11 (e) PASSENGER WITH DISABILITIES.—In this sec-
12 tion, the term “passenger with disabilities” means any
13 qualified individual with a disability, as such term is de-
14 fined in section 382.3 of title 14, Code of Federal Regula-
15 tions, or successor regulations.

16 **SEC. 542. LITHIUM-ION POWERED WHEELCHAIRS.**

17 (a) IN GENERAL.—Not later than 1 year after the
18 date of enactment of this Act, the Secretary of Transpor-
19 tation shall task the Air Carrier Access Act Advisory Com-
20 mittee (in this section referred to as the “Committee”)
21 to conduct a review of regulations regarding lithium-ion
22 battery powered wheelchairs and mobility aids and provide
23 recommendations to the Secretary to ensure safe transport
24 of such wheelchairs and mobility aids in air transpor-
25 tation.

1 (b) CONSIDERATIONS.—In conducting the review re-
2 quired under subsection (a), the Committee shall consider
3 the following:

4 (1) Any existing or necessary standards for lith-
5 ium-ion batteries, including casings or other similar
6 components, in such wheelchairs and mobility aids.

7 (2) The availability of necessary containment or
8 storage devices, including fire containment covers or
9 fire-resistant storage containers, for such wheel-
10 chairs and mobility aids.

11 (3) The policies of each air carrier (as such
12 term is defined in part 121 of title 14, Code of Fed-
13 eral Regulations) pertaining to lithium-ion battery
14 powered wheelchairs and mobility aids (as in effect
15 on the date of enactment of this Act).

16 (4) Any other considerations the Secretary de-
17 termines appropriate.

18 (c) CONSULTATION REQUIREMENT.—In conducting
19 the review required under subsection (a), the Committee
20 shall consult with the Administrator of the Pipeline and
21 Hazardous Materials Safety Administration.

22 (d) NOTIFICATION.—

23 (1) IN GENERAL.—Upon completion of the re-
24 view conducted under subsection (a), the Committee
25 shall notify the Secretary if an air carrier does not

1 have a policy pertaining to lithium–ion battery pow-
2 ered wheelchairs and mobility aids in effect.

3 (2) NOTIFICATION.—The Secretary shall notify
4 an air carrier described in paragraph (1) of the sta-
5 tus of such air carrier.

6 (e) REPORT TO CONGRESS.—Not later than 90 days
7 after submission of the recommendations to the Secretary,
8 the Secretary shall submit to the Committee on Transpor-
9 tation and Infrastructure of the House of Representatives
10 and the Committee on Commerce, Science, and Transpor-
11 tation of the Senate any recommendations under sub-
12 section (a), in the form of a report.

13 (f) PUBLICATION.—The Secretary shall publish the
14 report required under subsection (e) on the public website
15 of the Department of Transportation.

16 **SEC. 543. NATIONAL SIMULATOR PROGRAM POLICIES AND**
17 **GUIDANCE.**

18 (a) REVIEW.—Not later than 2 years after the date
19 of enactment of this Act, the Administrator of the Federal
20 Aviation Administration shall review relevant policies and
21 guidance, including all advisory circulars, information bul-
22 letins, and directives, pertaining to part 60 of title 14,
23 Code of Federal Regulations.

1 (b) UPDATES.—Upon completion of the review re-
2 quired under subsection (a), the Administrator shall, at
3 a minimum, update the following:

4 (1) Advisory Circular 120–40B, issued July 29,
5 1991.

6 (2) Advisory Circular 120–45A, issued Feb-
7 ruary 5, 1992.

8 (3) Advisory Circular 120–50A, issued Feb-
9 ruary 9, 1996.

10 (4) Advisory Circular 120–63, issued October
11 11, 1994.

12 (c) CONSULTATION.—In carrying out the review re-
13 quired under subsection (a), the Administrator shall con-
14 vene and consult with entities required to comply with part
15 60 of title 14, Code of Federal Regulations, including rep-
16 resentatives of—

17 (1) air carriers;

18 (2) flight schools certificated under part 141 of
19 title 14, Code of Federal Regulations;

20 (3) training centers certificated under part 142
21 of title 14, Code of Federal Regulations; and

22 (4) manufacturers and suppliers of flight sim-
23 ulation training devices (as defined in part 1 of title
24 14, Code of Federal Regulations, and Appendix F to
25 part 60 of such title).

1 **SEC. 544. GAO STUDY ON FAA NATIONAL SIMULATOR PRO-**
2 **GRAM.**

3 (a) IN GENERAL.—Not later than 18 months after
4 the date of enactment of this Act, the Comptroller General
5 of the United States shall conduct a study into the Na-
6 tional Simulator Program of the Federal Aviation Admin-
7 istration that is part of the Air Transportation Division’s
8 Training and Simulation Group.

9 (b) CONSIDERATIONS.—In conducting the study re-
10 quired under subsection (a), the Comptroller General
11 shall, at a minimum, assesses—

12 (1) how the program described under subsection
13 (a), is maintained to reflect and account for ad-
14 vancement in technologies pertaining to flight sim-
15 ulation training devices (as defined in part 1 of title
16 14, Code of Federal Regulations, and appendix F to
17 part 60 of such title);

18 (2) the staffing levels, critical competencies,
19 and skills gaps of Administration personnel respon-
20 sible for carrying out and supporting the program
21 described in subsection (a); and

22 (3) how the program described in subsection (a)
23 engages air carriers and relevant industry stake-
24 holders, including flight schools, to ensure efficient
25 compliance with part 60 of such title.

1 (c) REPORT.—Not later than 18 months after the
2 date of enactment of this Act, the Comptroller General
3 shall submit to the Committee on Transportation and In-
4 frastructure of the House of Representatives and the Com-
5 mittee on Commerce, Science, and Transportation of the
6 Senate a report on the findings of the study conducted
7 under subsection (a).

8 **SEC. 545. GAO STUDY ON FAA ALIGNMENT WITH BEST**
9 **AVAILABLE TECHNOLOGIES AND STAND-**
10 **ARDS.**

11 (a) IN GENERAL.—The Comptroller General of the
12 United States shall conduct a study on the incorporation
13 of best available technologies by the Federal Aviation Ad-
14 ministration to increase aviation safety and improve the
15 health and safety of aviation workers.

16 (b) SCOPE.—In conducting the study under sub-
17 section (a), the Comptroller General shall—

18 (1) analyze the degree to which the Adminis-
19 trator of the Federal Aviation Administration is ena-
20 bling the use or adoption of technologies used by
21 other air navigation service providers to meet ICAO
22 standards; and

23 (2) identify any barriers to adoption of such
24 technologies.

1 (c) REPORT.—Not later than 4 years after the date
2 of enactment of this Act, the Comptroller General shall
3 report to the Committee on Transportation and Infra-
4 structure of the House of Representatives and the Com-
5 mittee on Commerce, Science, and Transportation of the
6 Senate on the findings of the study.

7 (d) ICAO DEFINED.—In this section, the term
8 “ICAO” means the International Civil Aviation Organiza-
9 tion.

10 **SEC. 546. ADVANCED SIMULATION TRAINING.**

11 (a) IN GENERAL.—Notwithstanding section
12 61.159(a)(6) of title 14, Code of Federal Regulations (or
13 any successor regulations), a person who is applying for
14 an airline transport certificate with an airplane category
15 and class rating may obtain up to 150 additional hours
16 of the total aeronautical experience requirement in a full
17 flight simulator representing an airplane that provides six-
18 degrees of freedom motion, provided the aeronautical ex-
19 perience—

20 (1) was accomplished as part of a Federal Avia-
21 tion Administration approved training course in
22 parts 121, 135, 141, or 142 of such title; and

23 (2) does not qualify for flight credit hours for
24 an individual applying for an airline transport pilot
25 certificate with restricted privileges under para-

1 graphs (a), (b), (c), and (d) of section 61.160 of
2 such title (or any successor regulation).

3 (b) RULE OF CONSTRUCTION.—Nothing in this sec-
4 tion shall be construed to affect the ability of a person
5 to also obtain 100 hours of aeronautical experience in a
6 flight training device or full flight simulator under section
7 61.159(a)(6) of title 14, Code of Federal Regulations (or
8 any successor regulations).

9 (c) RULEMAKING.—

10 (1) IN GENERAL.—Not later than 2 years after
11 the date of enactment of this Act, the Administrator
12 of the Federal Aviation Administration shall issue a
13 final rule to update part 61 of title 14, Code of Fed-
14 eral Regulations, to reflect changes made by this
15 section.

16 (2) CONSULTATION.—The Administrator shall
17 consult with the Air Carrier Training Aviation Rule-
18 making Committee—

19 (A) in developing the rule under paragraph
20 (1), and

21 (B) in evaluating, notwithstanding sub-
22 section (a), whether the additional 150 hours
23 allowed under subsection (a) may be accrued in
24 a full flight simulator representing an airplane
25 that provides three-degrees of freedom motion.

1 (3) APPLICABILITY.—Nothing in this sub-
2 section, nor any potential failure of the Adminis-
3 trator to issue a final rule under paragraph (1),
4 shall be construed to prohibit the immediate applica-
5 bility of subsection (a).

6 (d) DEFINITIONS.—In this section, the terms “flight
7 training device” and “full flight simulator” have the
8 meanings given such terms in section 1.1 of title 14, Code
9 of Federal Regulations.

10 **SEC. 547. INCREMENTAL SAFETY IMPROVEMENT.**

11 Section 44704 of title 49, United States Code, is
12 amended by adding at the end the following:

13 “(h) INCREMENTAL SAFETY IMPROVEMENT.—

14 “(1) IN GENERAL.—The Administrator may
15 consider and approve a proposed incremental design
16 change request from a type certificate holder, if such
17 holder is required by the Administrator to make a
18 safety-related design change to bring a product into
19 compliance, even if the proposed incremental design
20 change does not eliminate all noncompliant condi-
21 tions.

22 “(2) PROPOSED INCREMENTAL DESIGN
23 CHANGE.—A proposed incremental design change
24 under paragraph (1) shall—

1 “(A) be related to the required safety-re-
2 lated change described in this subsection; and

3 “(B) improve safety.

4 “(3) FULL COMPLIANCE.—An approval issued
5 under this subsection shall not be construed to re-
6 lieve a type certificate holder from addressing all
7 noncompliant conditions under paragraph (1).”.

8 **Subtitle B—Aviation Cybersecurity**

9 **SEC. 571. FINDINGS.**

10 Congress finds the following:

11 (1) Congress has repeatedly tasked the Federal
12 Aviation Administration with responsibility for se-
13 curing the national airspace system, including the
14 air traffic control system and other air navigation
15 services, civil aircraft, and aeronautical products and
16 articles through safety regulation and oversight.
17 These mandates have routinely included protecting
18 against associated cyber threats affecting aviation
19 safety or the Administration’s provision of safe, se-
20 cure, and efficient air navigation services and air-
21 space management.

22 (2) In 2016, Congress passed the FAA Exten-
23 sion, Safety, and Security Act of 2016, which estab-
24 lished requirements for the Federal Aviation Admin-
25 istration to enhance the national airspace system’s

1 cybersecurity and included mandates for the Admin-
2 istration to—

3 (A) develop a cybersecurity strategic plan;

4 (B) coordinate with other Federal agencies
5 to identify cyber vulnerabilities;

6 (C) develop a cyber threat model; and

7 (D) complete a comprehensive, strategic
8 policy framework to identify and mitigate cyber-
9 security risks to the air traffic control system.

10 (3) In 2018, Congress passed the FAA Reau-
11 thorization Act of 2018 which—

12 (A) authorized funding for the construction
13 of Federal Aviation Administration facilities
14 dedicated to improving the cybersecurity of the
15 national airspace system;

16 (B) required the Federal Aviation Admin-
17 istration to review and update its comprehen-
18 sive, strategic policy framework for cybersecu-
19 rity to assess the degree to which the frame-
20 work identifies and addresses known cybersecu-
21 rity risks associated with the aviation system,
22 and evaluate existing short- and long-term ob-
23 jectives for addressing cybersecurity risks to the
24 national airspace system;

1 (C) created a Chief Technology Officer po-
2 sition within the Federal Aviation Administra-
3 tion to be responsible for, among other things,
4 coordinating the implementation, operation,
5 maintenance, and cybersecurity of technology
6 programs relating to the air traffic control sys-
7 tem with the aviation industry and other Fed-
8 eral agencies; and

9 (D) directed the National Academy of
10 Sciences to study the cybersecurity workforce of
11 the Federal Aviation Administration in order to
12 develop recommendations to increase the size,
13 quality, and diversity of such workforce.

14 (4) Congress has tasked the Federal Aviation
15 Administration with being the primary Federal
16 agency to assess and address the threats posed from
17 cyber incidents relating to Federal Aviation Admin-
18 istration-provided air traffic control and air naviga-
19 tion services and the threats posed from cyber inci-
20 dents relating to civil aircraft, aeronautical products
21 and articles, aviation networks, aviation systems,
22 services, and operations, and the aerospace industry
23 affecting aviation safety or the provision of safe, se-
24 cure, and efficient air navigation services and air-
25 space management by the Administration.

1 (5) Since 2005, the Federal Aviation Adminis-
2 tration has been addressing cyber vulnerabilities in
3 civil aircraft and aeronautical products and articles
4 during the safety certification process.

5 **SEC. 572. AEROSPACE PRODUCT SAFETY.**

6 (a) **CYBERSECURITY STANDARDS.**—Section 44701(a)
7 of title 49, United States Code, is amended—

8 (1) in paragraph (1) by inserting “cybersecu-
9 rity,” after “quality of work,”; and

10 (2) in paragraph (5)—

11 (A) by inserting “cybersecurity and” after
12 “standards for”; and

13 (B) by striking “procedure” and inserting
14 “procedures”.

15 (b) **EXCLUSIVE RULEMAKING AUTHORITY.**—Section
16 44701 of title 49, United States Code, is amended by add-
17 ing at the end the following:

18 “(h) **EXCLUSIVE RULEMAKING AUTHORITY.**—Not-
19 withstanding any other provision of law and except as pro-
20 vided in section 40132, the Administrator, in consultation
21 with the heads of such other agencies as the Administrator
22 determines necessary, shall have exclusive authority to
23 prescribe regulations for purposes of assuring civil air-
24 craft, including unmanned aircraft systems, aircraft en-
25 gine, propeller, and appliance cybersecurity.”.

1 **SEC. 573. FEDERAL AVIATION ADMINISTRATION REGULA-**
2 **TIONS, POLICY, AND GUIDANCE.**

3 (a) IN GENERAL.—Chapter 401 of title 49, United
4 States Code, is further amended by adding at the end the
5 following:

6 **“§ 40132. National airspace system cyber threat man-**
7 **agement process**

8 “(a) ESTABLISHMENT.—The Administrator of the
9 Federal Aviation Administration, in consultation with
10 other agencies as the Administrator determines necessary,
11 shall establish a national airspace system cyber threat
12 management process to protect the national airspace sys-
13 tem cyber environment, including the safety, security, and
14 efficiency of the air navigation services provided by the
15 Administration.

16 “(b) ISSUES TO BE ADDRESSED.—In establishing
17 the national airspace system cyber threat management
18 process under subsection (a), the Administrator shall, at
19 a minimum—

20 “(1) monitor the national airspace system for
21 cybersecurity incidents;

22 “(2) in consultation with appropriate Federal
23 agencies, evaluate the cyber threat landscape for the
24 national airspace system, including updating such
25 evaluation on both annual and threat-based
26 timelines;

1 “(3) conduct national airspace system cyber in-
2 cident analyses;

3 “(4) create a cyber common operating picture
4 for the national airspace system cyber environment;

5 “(5) coordinate national airspace system cyber
6 incident responses with other appropriate Federal
7 agencies;

8 “(6) track cyber incident detection, response,
9 mitigation implementation, recovery, and closure;

10 “(7) establish a process, or utilize existing proc-
11 esses, to collect relevant interagency and stakeholder
12 national airspace system cyber incident data, includ-
13 ing data from other Federal agencies and private
14 persons; and

15 “(8) consider any other matter the Adminis-
16 trator determines appropriate.

17 “(c) DEFINITIONS.—In this section:

18 “(1) CYBER COMMON OPERATING PICTURE.—
19 The term ‘cyber common operating picture’ means
20 the correlation of a detected cyber incident or cyber
21 threat in the national airspace system and other
22 operational anomalies to provide a holistic view of
23 potential cause and impact.

24 “(2) CYBER ENVIRONMENT.—The term ‘cyber
25 environment’ means the information environment

1 consisting of the interdependent networks of infor-
2 mation technology infrastructures and resident data,
3 including the internet, telecommunications networks,
4 computer systems, and embedded processors and
5 controllers.

6 “(3) CYBER INCIDENT.—The term ‘cyber inci-
7 dent’ means an action that creates noticeable deg-
8 radation, disruption, or destruction to the cyber en-
9 vironment and causes a safety or other negative im-
10 pact on operations of—

11 “(A) the national airspace system;

12 “(B) civil aircraft; or

13 “(C) aeronautical products and articles.

14 “(4) CYBER THREAT.—The term ‘cyber threat’
15 means the threat of an action that, if carried out,
16 would constitute a cyber incident or an electronic at-
17 tack.

18 “(5) ELECTRONIC ATTACK.—The term ‘elec-
19 tronic attack’ means the use of electromagnetic spec-
20 trum energy to impede operations in the cyber envi-
21 ronment, including through techniques such as jam-
22 ming or spoofing.”.

23 (b) CLERICAL AMENDMENT.—The analysis for chap-
24 ter 401 of title 49, United States Code, is further amend-
25 ed by adding at the end the following:

“40132. National airspace system cyber threat management process.”.

1 **SEC. 574. CIVIL AVIATION CYBERSECURITY RULEMAKING**
2 **COMMITTEE.**

3 (a) IN GENERAL.—Not later than 1 year after the
4 date of enactment of this Act, the Administrator of the
5 Federal Aviation Administration shall convene an aviation
6 rulemaking committee on civil aircraft cybersecurity to
7 conduct a review and develop findings and recommenda-
8 tions on cybersecurity standards for civil aircraft, aircraft
9 ground support information systems, airports, air traffic
10 control mission systems, and aeronautical products and
11 articles.

12 (b) DUTIES.—The Administrator shall—

13 (1) not later than 2 years after the date of en-
14 actment of this Act, submit to the Committee on
15 Transportation and Infrastructure of the House of
16 Representatives and the Committee on Commerce,
17 Science, and Transportation of the Senate a report
18 based on the findings of the aviation rulemaking
19 committee convened under subsection (a); and

20 (2) not later than 180 days after the date of
21 submission of the report under paragraph (1) and,
22 in consultation with other agencies as the Adminis-
23 trator determines necessary, for consensus rec-
24 ommendations reached by such aviation rulemaking
25 committee—

1 (A) undertake a rulemaking, if appro-
2 priate, based on such recommendations; and

3 (B) submit to the Committee on Transpor-
4 tation and Infrastructure of the House of Rep-
5 resentatives and the Committee on Commerce,
6 Science, and Transportation of the Senate a
7 supplemental report with explanations for each
8 consensus recommendation not addressed, if ap-
9 plicable, by a rulemaking under subparagraph
10 (A).

11 (c) COMPOSITION.—The aviation rulemaking com-
12 mittee convened under subsection (a) shall consist of mem-
13 bers appointed by the Administrator, including representa-
14 tives of—

15 (1) aircraft manufacturers, to include at least 1
16 manufacturer of transport category aircraft;

17 (2) air carriers;

18 (3) unmanned aircraft system stakeholders, in-
19 cluding operators, service suppliers, and manufactur-
20 ers of hardware components and software applica-
21 tions;

22 (4) manufacturers of powered-lift aircraft;

23 (5) airports;

24 (6) original equipment manufacturers of ground
25 and space based aviation infrastructure;

1 (7) aviation safety experts with specific knowl-
2 edge of aircraft cybersecurity; and

3 (8) a non-profit which operates 1 or more feder-
4 ally funded research and development centers with
5 specific knowledge of aviation and cybersecurity.

6 (d) MEMBER ELIGIBILITY.—Prior to a member’s ap-
7 pointment under subsection (c), the Administrator shall
8 determine if there is cause for such member to be re-
9 stricted from possessing sensitive security information.
10 Upon a determination of no cause being found regarding
11 the member, and upon the member voluntarily signing a
12 nondisclosure agreement, the member may be granted ac-
13 cess to sensitive security information that is relevant to
14 the member’s duties on the aviation rulemaking com-
15 mittee. The member shall protect the sensitive security in-
16 formation in accordance with part 1520 of title 49, Code
17 of Federal Regulations.

18 (e) PROHIBITION ON COMPENSATION.—The members
19 of the aviation rulemaking committee convened under sub-
20 section (a) shall not receive pay, allowances, or benefits
21 from the Government by reason of their service on such
22 committee.

23 (f) CONSIDERATIONS.—The Administrator shall di-
24 rect such committee to consider—

- 1 (1) existing cybersecurity standards, regula-
2 tions, policies, and guidance, including those from
3 other Federal agencies;
- 4 (2) threat- and risk-based security approaches
5 used by the aviation industry, including the assess-
6 ment of the potential costs and benefits of cyberse-
7 curity actions;
- 8 (3) data gathered from cybersecurity reporting;
- 9 (4) data gathered from safety reporting;
- 10 (5) the diversity of operations and systems on
11 aircraft and amongst air carriers;
- 12 (6) security of design data;
- 13 (7) the need to harmonize or deconflict pro-
14 posed and existing standards, regulations, policies,
15 and guidance with other Federal standards, regula-
16 tions, policies, and guidance;
- 17 (8) design approval holder aircraft network se-
18 curity guidance for operators;
- 19 (9) the need for such standards, regulations,
20 policies, and guidance as applied to civil aircraft in-
21 formation, data, networks, systems, services, oper-
22 ations, and technology;
- 23 (10) Federal Aviation Administration services,
24 aviation industry services, and aircraft use of posi-
25 tioning, navigation, and timing data in the context

1 of Executive Order 13905, as in effect on the date
2 of enactment of this Act;

3 (11) updates needed to airworthiness regula-
4 tions and systems safety assessment methods used
5 to show compliance with airworthiness requirements
6 for design, function, installation, and certification of
7 civil aircraft, aeronautical products and articles, and
8 aircraft networks;

9 (12) updates needed to air carrier operating
10 and maintenance regulations to ensure continued ad-
11 herence with processes and procedures established in
12 airworthiness regulations to provide cybersecurity
13 protections for aircraft systems, including for contin-
14 ued airworthiness;

15 (13) policies and procedures to coordinate with
16 other Federal agencies, including intelligence agen-
17 cies, and the aviation industry in sharing informa-
18 tion and analyses related to cyber threats to civil
19 aircraft information, data, networks, systems, serv-
20 ices, operations, and technology and aeronautical
21 products and articles;

22 (14) the response of the Administrator and
23 aviation industry to, and recovery from, cyber inci-
24 dents, including by coordinating with other Federal
25 agencies, including intelligence agencies;

1 (15) processes for members of the aviation in-
2 dustry to voluntarily report to the Federal Aviation
3 Administration cyber incidents that may affect avia-
4 tion safety in a manner that protects trade secrets
5 and confidential business information;

6 (16) the unique nature of the aviation industry,
7 including aircraft networks, aircraft systems, and
8 aeronautical products, and the interconnectedness of
9 cybersecurity and aviation safety;

10 (17) appropriate cybersecurity controls for air-
11 craft networks, aircraft systems, and aeronautical
12 products and articles to protect aviation safety, in-
13 cluding airworthiness;

14 (18) appropriate cybersecurity controls for air-
15 ports relative to the size and nature of airside oper-
16 ations of such airports to ensure aviation safety;

17 (19) minimum standards for protecting civil
18 aircraft, aeronautical products and articles, aviation
19 networks, aviation systems, services, and operations
20 from cyber threats and cyber incidents;

21 (20) international collaboration, where appro-
22 priate and consistent with the interests of aviation
23 safety in air commerce and national security, with
24 other civil aviation authorities, international aviation
25 and standards organizations, and any other appro-

1 appropriate entities to protect civil aviation from cyber in-
2 cidents and cyber threats;

3 (21) the recommendations and implementation
4 of the Aircraft System Information Security/Protec-
5 tion report of the aviation rulemaking advisory com-
6 mittee submitted on August 22, 2016; and

7 (22) any other matter the Administrator deter-
8 mines appropriate.

9 (g) DEFINITIONS.—The definitions set forth in sec-
10 tion 40132 of title 49, United States Code (as added by
11 this subtitle), shall apply to this section.

14 **Subtitle A—Unmanned Aircraft**

9 **“§ 44803. Unmanned aircraft system test ranges**

10 “(a) IN GENERAL.—The Administrator of the Fed-
11 eral Aviation Administration shall carry out and update,
12 as appropriate, a program to enable a broad variety of
13 testing and evaluation activities at unmanned aircraft sys-
14 tem test ranges, as in effect on the day before the date
15 of enactment of the Securing Growth and Robust Leader-
16 ship in American Aviation Act, to the extent consistent
17 with aviation safety and efficiency, and for purposes of
18 the safe integration of unmanned aircraft systems into the
19 national airspace system.

20 “(b) AIRSPACE REQUIREMENTS.—In carrying out the
21 program under subsection (a)—

22 “(1) the Administrator may establish non-
23 regulatory special use airspace areas upon the re-
24 quest of a test range sponsor selected by the Admin-
25 istrator under subsection (a), for purposes of accom-

1 modating hazardous testing and evaluation activities
2 to inform the safe integration of unmanned aircraft
3 systems into the national airspace system, or for
4 purposes of other activities authorized by the Ad-
5 ministrator under subsection (g);

6 “(2) each selected test range sponsor for a des-
7 igned test range shall be considered the using
8 agency for purposes of the respective nonregulatory
9 special use airspace areas established by the Admin-
10 istrator under this section; and

11 “(3) the Administrator may require that each
12 selected test range sponsor for a designated test
13 range provide a draft environmental review con-
14 sistent with the National Environmental Policy Act
15 of 1969 (42 U.S.C. 4321 et seq.), subject to the su-
16 pervision and adoption of the Administrator, with re-
17 spect to any request for the establishment of a non-
18 regulatory special use airspace area under this sec-
19 tion.

20 “(c) PROGRAM REQUIREMENT.—In carrying out the
21 program under subsection (a), the Administrator—

22 “(1) may develop operational standards and air
23 traffic requirements for flight operations at test
24 ranges;

1 “(2) shall coordinate with, and leverage the re-
2 sources of, other Federal agencies, as the Adminis-
3 trator considers appropriate;

4 “(3) shall address both civil and public aircraft
5 operations;

6 “(4) shall provide for verification of the safety
7 of flight systems and related navigation procedures
8 as it relates to continued development of standards
9 for integration into the national airspace system;

10 “(5) shall engage test range sponsors, as nec-
11 essary and within available resources, in projects for
12 testing and evaluation of flight systems to facilitate
13 the validation of standards by the Administration for
14 the safe integration of unmanned aircraft systems
15 into the national airspace system, which may include
16 solutions for—

17 “(A) developing and enforcing geographic
18 and altitude limitations;

19 “(B) providing for alerts regarding any
20 hazards or limitations on flight, including prohi-
21 bitions on flight;

22 “(C) sense and avoid capabilities;

23 “(D) technology to support communica-
24 tions, navigation, and surveillance;

1 “(E) unmanned aircraft system operations
2 beyond visual line of sight, at nighttime, or over
3 people;

4 “(F) operation of multiple unmanned air-
5 craft systems by a single remote pilot;

6 “(G) unmanned aircraft systems traffic
7 management capabilities or services;

8 “(H) counter unmanned aircraft system
9 capabilities;

10 “(I) improving privacy protections through
11 the use of advances in unmanned aircraft sys-
12 tems; and

13 “(J) other critical priority areas for which
14 testing and evaluation is needed.

15 “(6) shall coordinate periodically with all test
16 range sponsors to ensure test range sponsors know
17 which data should be collected, how data can be de-
18 identified to flow more readily to the Administration,
19 what procedures should be followed, and what test-
20 ing and evaluations would advance efforts to safely
21 integrate unmanned aircraft systems into the na-
22 tional airspace system; and

23 “(7) shall allow test range sponsors to receive
24 Federal funding, other than from the Federal Avia-
25 tion Administration, including in-kind contributions,

1 from test range participants in the furtherance of
2 testing and evaluation objectives.

3 “(d) EXEMPTION.—Except as provided in subsection
4 (g), the requirements of section 44711, including related
5 implementing regulations, shall not apply to persons ap-
6 proved by the test range sponsor for operation at a des-
7 ignated test range under this section.

8 “(e) RESPONSIBILITIES OF TEST RANGE SPON-
9 SOR.—The sponsor of each test range under subsection
10 (a) shall—

11 “(1) provide access to all interested private and
12 public entities seeking to carry out testing and eval-
13 uation activities at the test range designated pursu-
14 ant to this section, to the greatest extent practicable,
15 consistent with safety and any operating procedures
16 established by the test range sponsor, including ac-
17 cess by small business concerns (as that term is de-
18 scribed in section 3(a) of the Small Business Act (15
19 U.S.C. 632(a));

20 “(2) ensure all activities remain within the geo-
21 graphical boundaries and altitude limitations estab-
22 lished for the nonregulatory special use airspace
23 area covering the test range;

24 “(3) ensure no activity is conducted at the des-
25 ignated test range in a careless or reckless manner;

1 “(4) establish safe operating procedures for all
2 operators approved for activities at the test range,
3 including provisions for maintaining operational control and ensuring protection of persons and property
4 on the ground, subject to approval by the Administrator;
5
6

7 “(5) exercise direct oversight of all operations
8 conducted at the test range;

9 “(6) consult with the Administrator on the nature of planned activities at the test range and
10 whether temporary segregation through the use of a
11 nonregulatory special use airspace area is required
12 to contain such activities is consistent with aviation
13 safety;
14

15 “(7) protect proprietary technology, sensitive
16 data, or sensitive research of any civil or private entity when using the test range;
17

18 “(8) maintain detailed records of all ongoing
19 and completed testing and evaluation activities conducted at the test range and all operators conducting such activities, for inspection by, and reporting to, the Administrator, as required by agreement
20 between the Administrator and the test range sponsor;
21
22
23
24

1 “(9) make all original records available for in-
2 spection upon request by the Administrator; and

3 “(10) provide recommendations to the Adminis-
4 trator to further enable public and private testing
5 and evaluation activities at the test ranges that con-
6 tribute to the safe integration of unmanned aircraft
7 systems by the Administration into the national air-
8 space system, on a quarterly basis until the program
9 terminates.

10 “(f) TESTING.—

11 “(1) IN GENERAL.—The Administrator may au-
12 thorize a sponsor of a test range designated under
13 subsection (a) to host testing and evaluation activi-
14 ties other than those directly related to the integra-
15 tion of unmanned aircraft systems into the national
16 airspace system, provided that the activity is nec-
17 essary to inform the development of standards or
18 policy for integrating new types of flight systems
19 into the national airspace system.

20 “(2) WAIVER.—In carrying out this subsection,
21 the Administrator may waive the requirements of
22 section 44711, including related regulations, to the
23 extent consistent with aviation safety.

24 “(g) AGREEMENTS.—The Administrator may use the
25 transaction authority under section 106(l)(6) to enter into

1 appropriate agreements to direct testing and evaluation
2 activities related to unmanned aircraft systems at any test
3 range designated under subsection (a).

4 “(h) **TERMINATION.**—The program under this sec-
5 tion shall terminate on September 30, 2028.”.

6 (b) **CONFORMING AMENDMENT.**—Section 44801(10)

4 “(ii) within zero-grid airspaces as de-
5 picted on such UAS facility maps, only if
6 operated in life-saving or emergency situa-
7 tions and with prior notification to the Ad-
8 ministration in a manner determined by

11 level within class B, C, D, E, or G airspace
12 only with prior authorization from the Ad-

6 (ii) by striking “do not create” and
7 inserting “does not create”;

8 (3) in subsection (c) to read as follows:

9 “(c) REQUIREMENTS FOR SAFE OPERATION.—

10 “(1) IN GENERAL.—For unmanned aircraft sys-
11 tems that the Administrator determines under this
12 section may operate safely in the national airspace
13 system, the Administrator shall establish risk-based
14 requirements, or a process to accept risk-based pro-
15 posed requirements, for the safe operation of such
16 aircraft systems in the national airspace system, in-

9 20,000 or greater in at least 1 of the preceding 3
10 years;

11 “(3) has defined and static geographical bound-
12 aries; and

13 “(4) is advertised in the public domain.

14 “(f) DEADLINES.—

15 “(1) Not later than March 1, 2024, the Admin-
16 istrator shall publish a notice of proposed rule-
17 making to carry out the requirements of this section.

18 “(2) Not later than 16 months after publishing
19 the notice of proposed rulemaking under paragraph
20 (1), the Administrator shall issue a final rule.”.

21 **SEC. 609. BEYOND VISUAL LINE OF SIGHT RULEMAKING.**

22 (a) IN GENERAL.—Not later than 4 months after the
23 date of enactment of this Act, the Administrator of the
24 Federal Aviation Administration shall issue a notice of
25 proposed rulemaking establishing performance-based air-

1 worthiness criteria and risk-based operational regulations
2 for unmanned aircraft systems operated beyond visual line
3 of sight that are intended to operate primarily at or below
4 400 feet above ground level.

5 (b) CONTENTS.—In carrying out subsection (a), the
6 Administrator shall—

7 (1) establish a means to accept proposed—

8 (A) airworthiness standards for unmanned
9 aircraft;

10 (B) standards for associated elements of
11 unmanned aircraft; and

12 (C) qualification standards for remote pi-
13 lots operating unmanned aircraft beyond visual
14 line of sight;

15 (2) enable the ability for unmanned aircraft to
16 be operated for agricultural purposes;

17 (3) establish a process by which the Adminis-
18 trator may approve or accept third party compliance
19 services in support of the safe integration of un-
20 manned aircraft systems into the national airspace
21 system; and

22 (4) establish protocols, as appropriate, for
23 networked information exchange, including network-
24 based remote identification in support of beyond vis-
25 ual line of sight operations.

1 (c) CONSIDERATIONS.—In carrying out subsection
2 (a), the Administrator may leverage previously gathered
3 data, information, and efforts of the Administration to fi-
4 nalize rulemaking as required under this section.

5 (d) UNMANNED AIRCRAFT AIRWORTHINESS STAND-
6 ARDS.—In carrying out subsection (b)(1)(A), the Adminis-
7 trator shall—

8 (1) define the operational environments for
9 which airworthiness is needed to ensure aviation
10 safety;

11 (2) establish an airworthiness category or cat-
12 egories for unmanned aircraft to be eligible for a
13 special airworthiness certificate; and

14 (3) establish a process to approve standards,
15 means of compliance, and declarations of compli-
16 ance.

17 (e) UNMANNED AIRCRAFT ASSOCIATED ELEMENTS
18 STANDARDS.—

19 (1) IN GENERAL.—In carrying out subsection
20 (b)(1)(B), the Administrator shall establish a proc-
21 ess to accept or approve the associated elements of
22 an unmanned aircraft that, when considered collec-
23 tively with other associated elements and an un-
24 manned aircraft, meet an acceptable performance-
25 based safety standard.

1 (2) CONSIDERATIONS.—In establishing the
2 process under paragraph (1), the Administrator
3 shall consider the ways associated elements of an
4 unmanned aircraft system interact with other associ-
5 ated elements and unmanned aircraft.

6 (f) REMOTE PILOT QUALIFICATIONS.—

7 (1) IN GENERAL.—In carrying out subsection
8 (b)(1)(C), the Administrator shall establish quali-
9 fications and standards, or a means to accept pro-
10 posed qualifications and standards, for remote pilots
11 operating unmanned aircraft systems.

12 (2) CONSIDERATIONS.—In carrying out para-
13 graph (1), the Administrator shall account for the
14 varying levels of automation of unmanned aircraft
15 systems.

16 (3) RULE OF CONSTRUCTION.—Nothing in this
17 subsection may be construed to allow for the estab-
18 lishment of type-ratings that apply specifically and
19 exclusively to an aircraft manufactured by 1 manu-
20 facturer.

21 (g) INTERIM APPROVALS.—Before the date on which
22 the Administrator issues a final rule under this section,
23 the Administrator shall use the process described in sec-
24 tion 44807 of title 49, United States Code, to authorize

1 unmanned aircraft system operations conducted beyond
2 visual line of sight.

3 (h) FINAL RULE.—Not later than 16 months after
4 the date of enactment of this Act, the Administrator shall
5 issue a final rule establishing the regulations required
6 under this section.

7 (i) DEFINITIONS.—In this section:

8 (1) ASSOCIATED ELEMENTS.—The term “asso-
9 ciated elements” means any component of an un-
10 manned aircraft system, not permanently affixed to
11 the unmanned aircraft, required for the remote pilot
12 to operate such aircraft safely and efficiently in the
13 national airspace system.

14 (2) BEYOND VISUAL LINE OF SIGHT.—The
15 term “beyond visual line of sight” means a distance
16 at which the remote pilot in command of an un-
17 manned aircraft system cannot see the unmanned
18 aircraft with vision unaided by any device other than
19 corrective lenses.

20 (3) UNMANNED AIRCRAFT; UNMANNED AIR-
21 CRAFT SYSTEM.—The terms “unmanned aircraft”
22 and “unmanned aircraft system” have the meaning
23 given such terms in section 44801 of title 49, United
24 States Code.

1 **SEC. 610. UAS TRAFFIC MANAGEMENT.**

2 (a) IN GENERAL.—Not later than 1 year after the
3 date of enactment of this Act, the Administrator of the
4 Federal Aviation Administration may enter into agree-
5 ments for purposes of—

6 (1) testing and refining UTM capabilities and
7 services to inform the development of UTM stand-
8 ards in subsection (b);

9 (2) authorizing UTM service providers that
10 meet the requirements described in subsection (b) to
11 provide UTM services to better enable advanced un-
12 manned aircraft systems operations, including—

13 (A) beyond visual line of sight operations;

14 (B) aircraft-to-aircraft communications;

15 and

16 (C) operations in which an individual acts
17 as remote pilot in command of more than 1 un-
18 manned aircraft at the same time; and

19 (3) fostering the safe integration of unmanned
20 aircraft systems using UTM capabilities and services
21 within the national airspace system.

22 (b) STANDARDIZATION.—

23 (1) IN GENERAL.—In carrying out subsection
24 (a), the Administrator shall publish requirements or
25 guidance associated with UTM, including—

1 (A) the types of operations requiring, or
2 benefitting from, the use of UTM capabilities
3 and services described in subsection (a), includ-
4 ing beyond visual line of sight operations;

5 (B) areas of operation or categories of air-
6 space requiring, or benefitting from, the use of
7 UTM capabilities and services;

8 (C) performance-based technical standards
9 for UAS operations using UTM capabilities and
10 services; and

11 (D) application program interfaces that en-
12 able UTM service suppliers to integrate UTM
13 capabilities and services into other systems for
14 use by users of the national airspace system, in-
15 cluding unmanned aircraft system operators.

16 (2) INTERNATIONAL HARMONIZATION.—In car-
17 rying out paragraph (1), the Administrator shall
18 seek to harmonize, to the extent practicable and ad-
19 visable, UTM standards with standards produced by
20 recognized industry standards organizations or other
21 peer civil aviation authorities.

22 (3) FEEDBACK OF CONCEPT OF OPERATIONS.—
23 Not later than 90 days after the date of enactment
24 of this Act, the Administrator shall solicit feedback

1 from stakeholders on the most recently published
2 UTM concept of operations of the Administration.

3 (4) FINALIZATION OF CONCEPT OF OPER-
4 ATIONS.—Not later than 1 year after the date of en-
5 actment of this Act, the Administrator shall publish
6 a final version of the UTM concept of operations of
7 the Administration.

8 (c) STAKEHOLDER PARTNERSHIPS.—In carrying out
9 subsection (a), the Administrator shall establish a means
10 by which the Administrator can enter into cooperative
11 agreements, contracts, other transaction agreements, and
12 other appropriate mechanisms with appropriate persons,
13 partnerships, and consortia to enable qualified third-par-
14 ties to design, build, develop, fund, and manage UTM.

15 (d) RULES OF CONSTRUCTION.—

16 (1) BEYOND VISUAL LINE OF SIGHT OPER-
17 ATIONS.—Nothing in this section shall be construed
18 to prevent or prohibit beyond visual line of sight op-
19 erations through the use of technologies other than
20 UTM capabilities and services.

21 (2) AIRSPACE.—Nothing in this section shall be
22 construed to alter the authority under section 40103
23 of title 49, United States Code.

24 (e) BRIEFING.—Not later than 90 days after the date
25 of enactment of this Act, and annually thereafter, the Ad-

1 administrator shall brief the Committee on Transportation
2 and Infrastructure of the House of Representatives and
3 the Committee on Commerce, Science, and Transportation
4 of the Senate on progress made by the Administration de-
5 tailing the implementation and requirements of this sec-
6 tion and any applicable timelines to completion.

7 (f) DEFINITIONS.—In this section:

8 (1) APPROPRIATE PERSONS.—The term “appro-
9 priate persons” means a Federal, State, local, Trib-
10 al, or territorial governmental entity, or a person.

11 (2) UTM.—The term “UTM” means the man-
12 ner in which the Administration will support oper-
13 ations for unmanned aircraft systems operating in
14 low-altitude airspace.

15 **SEC. 611. RADAR DATA PILOT PROGRAM.**

16 (a) SENSITIVE RADAR DATA FEED PILOT PRO-
17 GRAM.—Not later than 180 days after the date of enact-
18 ment of this Act, the Administrator of the Federal Avia-
19 tion Administration, in coordination with the Secretary of
20 Defense, and other heads of relevant Federal agencies,
21 shall establish a pilot program to make airspace data feeds
22 containing classified or controlled unclassified information
23 available to qualified users, in conjunction with subsection
24 (b).

1 (b) AUTHORIZATION.—In carrying out subsection (a),
2 the Administrator and the heads of other relevant Federal
3 agencies and in coordination with the Secretary of De-
4 fense, shall establish a process to authorize qualified enti-
5 ties to receive airspace data feeds containing classified in-
6 formation related to air traffic within the national airspace
7 system and use such information in an agreed upon man-
8 ner to—

9 (1) provide—

10 (A) air traffic management services; and

11 (B) unmanned aircraft system traffic man-
12 agement services; or

13 (2) to test technologies that may enable or en-
14 hance the provision of the services described in para-
15 graph (1).

16 (c) BRIEFING.—Not later than 90 days after estab-
17 lishing the pilot program under subsection (a), and annu-
18 ally thereafter, the Administrator shall brief the Com-
19 mittee on Transportation and Infrastructure of the House
20 of Representatives and the Committee on Commerce,
21 Science, and Transportation of the Senate on the findings
22 of the Administrator related to the pilot program estab-
23 lished under this section.

24 (d) SUNSET.—This section shall cease to be effective
25 on October 1, 2028.

1 (e) DEFINITION OF QUALIFIED USER.—In this sec-
2 tion, the term “qualified user” means an entity authorized
3 to receive airspace data feeds containing classified or con-
4 trolled unclassified information pursuant to subsection
5 (b).

6 **SEC. 612. ELECTRONIC CONSPICUITY STUDY.**

7 (a) IN GENERAL.—The Comptroller General of the
8 United States shall conduct a study of technologies and
9 methods that may be used by operators of unmanned air-
10 craft systems to detect and avoid manned aircraft that
11 may lawfully operate below 500 feet above ground level
12 and that are—

13 (1) not equipped with a transponder or auto-
14 matic dependent surveillance-broadcast out equip-
15 ment; or

16 (2) otherwise not electronically conspicuous.

17 (b) CONSULTATION.—In conducting the study re-
18 quired under subsection (a), the Comptroller General shall
19 consult with—

20 (1) representatives from—

21 (A) unmanned aircraft systems manufac-
22 turers and operators;

23 (B) general aviation operators;

24 (C) aerial applicators; and

1 (D) helicopter operators, including State
2 and local governments; and

3 (2) any other person the Comptroller General
4 determines appropriate.

5 (c) REPORT.—Not later than 1 year after the date
6 of the enactment of this Act, the Comptroller General shall
7 submit to the Committee on Transportation and Infra-
8 structure of the House of Representatives and the Com-
9 mittee on Commerce, Science, and Transportation of the
10 Senate a report describing the results of such study.

11 **SEC. 613. REMOTE IDENTIFICATION ALTERNATIVE MEANS**
12 **OF COMPLIANCE.**

13 (a) STUDY.—The Administrator of the Federal Avia-
14 tion Administration shall review and evaluate the final
15 rule titled “Remote Identification of Unmanned Aircraft”,
16 issued on January 15, 2021, to determine the feasibility
17 and advisability of whether unmanned aircraft manufac-
18 turers and operators can meet the intent of such final rule
19 through alternative means of compliance, including
20 through network-based remote identification.

21 (b) REPORT.—Not later than 1 year after the date
22 of enactment of this Act, the Administrator shall submit
23 to the Committee on Transportation and Infrastructure
24 of the House of Representatives and the Committee on

1 Commerce, Science, and Transportation of the Senate a
2 report on the results of the study under subsection (a).

3 **SEC. 614. PART 107 WAIVER IMPROVEMENTS.**

4 (a) IN GENERAL.—The Administrator of the Federal
5 Aviation Administration shall adopt a performance– and
6 risk–based approach in reviewing requests for certificates
7 of waiver under section 107.200 of title 14, Code of Fed-
8 eral Regulations.

9 (b) STANDARDIZATION OF WAIVER APPLICATION.—

10 (1) IN GENERAL.—In carrying out subsection
11 (a), the Administrator shall improve the process es-
12 tablished to submit requests for certificates of waiv-
13 er described in subsection (a).

14 (2) FORMAT.—In carrying out paragraph (1),
15 the Administrator may not require the use of open-
16 ended descriptive prompts that are required to be
17 filled out by an applicant, except to provide appli-
18 cants the ability to provide the Administration with
19 information for an unusual or irregular operation.

20 (3) DATA.—

21 (A) IN GENERAL.—In carrying out para-
22 graph (1), the Administrator shall leverage data
23 gathered from previous requests for certificates
24 of waivers.

1 (B) CONSIDERATIONS.—In carrying out
2 subparagraph (A), the Administrator shall safe-
3 ly use—

- 4 (i) big data analytics; and
5 (ii) machine learning.

6 (c) CONSIDERATION OF PROPERTY OWNERSHIP IN-
7 TEREST.—

8 (1) IN GENERAL.—In determining whether to
9 issue a certificate of waiver under section 107.200 of
10 title 14, Code of Federal Regulations, the Adminis-
11 trator shall—

12 (A) consider whether the waiver applicant
13 has control over access to all real property on
14 the ground within the area of operation; and

15 (B) recognize and account for the safety
16 enhancements of such controlled access.

17 (2) RULE OF CONSTRUCTION.—Nothing in this
18 subsection shall be construed to direct the Adminis-
19 trator to consider the lack of control over access to
20 all real property on the ground within an area of op-
21 eration, or a lack of property interest in such area
22 of operation, as negatively affecting the safety of the
23 operation intended to be conducted under such cer-
24 tificate of waiver.

25 (d) PUBLIC AVAILABILITY OF WAIVERS.—

1 (1) IN GENERAL.—The Administrator shall
2 publish all certificates of waiver issued under section
3 107.200 of title 14, Code of Federal Regulations, on
4 the website of the Administration, including, with re-
5 spect to each issued certificate of waiver—

6 (A) the terms, conditions, and limitations;
7 and

8 (B) the class of airspace and any restric-
9 tions related to operating near airports or heli-
10 ports.

11 (2) PUBLICATION.—In carrying out paragraph
12 (1), the Administrator shall ensure that published
13 information is made available in a manner that pre-
14 vents inappropriate disclosure of proprietary infor-
15 mation.

16 (e) PRECEDENTIAL USE OF PREVIOUSLY APPROVED
17 WAIVERS.—

18 (1) WAIVER APPROVAL PRECEDENT.—Except
19 as provided in paragraph (3), if the Administrator
20 determines, using criteria for a particular waiver,
21 that an application for a certificate of waiver issued
22 under section 107.200 of title 14, Code of Federal
23 Regulations, is substantially similar (or is comprised
24 of elements that are substantially similar) to an ap-
25 plication for a certificate of waiver that the Adminis-

1 trator has previously approved, the Administrator
2 may streamline, as appropriate, the approval of ap-
3 plications with substantially similar conditions and
4 limitations as a previously approved application.

5 (2) RULE OF CONSTRUCTION.—Nothing in
6 paragraph (1) shall be construed to preclude an ap-
7 plicant for a certificate of waiver from applying to
8 modify a condition, or remove a limitation of, such
9 certificate.

10 (f) MODIFICATION OF WAIVERS.—

11 (1) IN GENERAL.—The Administrator shall es-
12 tablish an expedited review process for a request to
13 modify or renew certificates of waiver previously
14 issued under section 107.200 of title 14, Code of
15 Federal Regulations, as appropriate.

16 (2) USE OF REVIEW PROCESS.—The review
17 process established under paragraph (1) shall be
18 used to review certificates of waiver that cover oper-
19 ations that are substantially similar in all material
20 facts to operations covered under a subsequently
21 issued certificate of waiver.

22 **SEC. 615. ACCEPTABLE LEVELS OF RISK AND RISK ASSESS-**
23 **MENT METHODOLOGY.**

24 (a) IN GENERAL.—Not later than 90 days after the
25 date of enactment of this Act, the Administrator of the

1 Federal Aviation Administration shall establish acceptable
2 levels of risk, and develop a risk assessment methodology
3 associated with such levels of risk, to enable unmanned
4 aircraft system operations conducted—

5 (1) under waivers issued to part 107 of title 14,
6 Code of Federal Regulations;

7 (2) pursuant to section 44807 of title 49,
8 United States Code; or

9 (3) pursuant to future regulations promulgated
10 by the Administrator, as appropriate.

11 (b) ACCEPTABLE LEVELS OF RISK.—In carrying out
12 subsection (a), the Administrator shall establish accept-
13 able levels of risk for unmanned aircraft system operations
14 in the national airspace system and a method for assessing
15 the operational risk of a proposed operation in accordance
16 with such acceptable level.

17 (c) RISK ASSESSMENT METHODOLOGY.—In carrying
18 out subsections (a) and (b), the Administrator shall de-
19 velop a risk assessment methodology to allow remote pilots
20 in command operating unmanned aircraft systems pursu-
21 ant to subsection (a) to determine the risk associated with
22 a specific operation, and mitigate such a risk, as nec-
23 essary.

24 (d) RISK ASSESSMENT METHODOLOGY CONSIDER-
25 ATIONS.—In establishing the risk assessment methodology

1 described under this section, the Administrator shall con-
2 sider—

3 (1) the time of day of the operation;

4 (2) the population density of the area of oper-
5 ation;

6 (3) the class of airspace and such requirements
7 necessary for airspace users to legally operate in
8 each class of airspace;

9 (4) the proximity to infrastructure, to the ex-
10 tent that proximity mitigates risk to other operators
11 of the national airspace system;

12 (5) the nature of the detect and avoid mitiga-
13 tion measures of an unmanned aircraft system; and

14 (6) the attributes and characteristics of the un-
15 manned aircraft of the unmanned aircraft system,
16 including the—

17 (A) size;

18 (B) visibility;

19 (C) maximum takeoff weight;

20 (D) maximum indicated airspeed; and

21 (E) payload.

22 (e) PUBLICATION.—The Administrator shall make
23 the risk assessment methodology established under this
24 section available to the public on an appropriate website
25 of the Administration.

1 (f) DEFINITIONS OF UNMANNED AIRCRAFT AND UN-
2 MANNED AIRCRAFT SYSTEM.—In this section, the terms
3 “unmanned aircraft” and “unmanned aircraft system”
4 have the meanings given such terms in section 44801 of
5 title 49, United States Code.

6 **SEC. 616. ENVIRONMENTAL REVIEW.**

7 (a) GUIDANCE UPDATES.—Not later than 180 days
8 after the date of enactment of this Act, the Administrator
9 of the Federal Aviation Administration shall publish un-
10 manned aircraft system-specific guidance and implementa-
11 tion procedures. Such guidance and implementation proce-
12 dures shall—

13 (1) provide guidance to streamline environ-
14 mental assessments at a programmatic level, as the
15 Administrator considers appropriate, for an un-
16 manned aircraft system operator’s network of oper-
17 ations within a defined geographical region, includ-
18 ing within and over approved commercial or indus-
19 trial sites closed or restricted to the public;

20 (2) provide guidance for nationwide pro-
21 grammatic approaches for large scale distributed un-
22 manned aircraft system operations whereby a Pro-
23 grammatic Environmental Assessment or Environ-
24 mental Impact Statement can be leveraged for sub-

1 sequent related actions to ensure efficient environ-
2 mental review;

3 (3) consider additional Categorical Exclusions
4 based on previously prepared and finalized Environ-
5 mental Assessments or in consultation with the
6 Council on Environmental Quality;

7 (4) prioritize proposed projects or activities that
8 may—

9 (A) offset or limit the impacts of non-zero
10 emission activities;

11 (B) offset or limit the release of environ-
12 mental pollutants to soil or water; or

13 (C) demonstrate other factors to the ben-
14 efit of the environment as determined by the
15 Administrator;

16 (5) contain intra-agency process improvements
17 to avoid providing conflicting safety and environ-
18 mental feedback to operators;

19 (6) contain standards and criteria for engaging
20 specialized third parties to support the Administra-
21 tion's preparation and review of documentation re-
22 lating to the requirements of the National Environ-
23 mental Policy Act of 1969 (42 U.S.C. 4321 et seq.)
24 to ensure streamlined timelines for complex reviews;
25 and

1 (7) any other modifications the Administrator
2 considers necessary within the stated environmental
3 objectives of the National Environmental Policy Act
4 of 1969 (42 U.S.C. 4321 et seq.) and the Federal
5 priority to maintain global leadership in aviation in-
6 novation.

7 (b) BRIEFING.—No later than 90 days after the date
8 of enactment of this Act, the Administrator shall brief the
9 Committee on Transportation and Infrastructure of the
10 House of Representatives and the Committee on Com-
11 merce, Science, and Transportation of the Senate on the
12 plan of the Administration to implement subsection (b),
13 including each of the considerations specified in the sub-
14 section, and an explanation for any consideration the Ad-
15 ministrator does not intend to implement.

16 (c) CONCURRENT REVIEWS.—If the Administrator
17 determines that the review of an unmanned aircraft sys-
18 tem’s design, construction, maintenance and operational
19 sustainability, airworthiness approval, or operational ap-
20 proval requires environmental assessment, including re-
21 quirements under the National Environmental Policy Act
22 of 1969 (42 U.S.C. 4321 et seq.), the Administrator shall,
23 to the maximum extent practicable, conduct such reviews
24 and analyses concurrent with one another.

1 (d) RULE OF CONSTRUCTION.—Nothing in this sec-
2 tion shall be construed as prohibiting, restricting or other-
3 wise limiting the authority of the Secretary of Transpor-
4 tation or the Administrator from implementing or com-
5 plying with the requirements of the National Environ-
6 mental Policy Act of 1969 (42 U.S.C. 4321 et seq.) and
7 any related requirements to ensure the protection of the
8 environment and aviation safety.

9 (e) ASSOCIATED UAS CERTIFICATION STAND-
10 ARDS.—

11 (1) OPTION TO SUSPEND NOISE CERTIFICATION
12 REQUIREMENT PENDING STANDARDS DEVELOP-
13 MENT.—Notwithstanding the requirements of sec-
14 tion 44715 of title 49, United States Code, the Ad-
15 ministrator may waive the determination of compli-
16 ance with part 36 of title 14, Code of Federal Regu-
17 lations, for an applicant seeking an unmanned air-
18 craft system type and airworthiness certification,
19 provided the Administrator has developed appro-
20 priate noise measurement procedures for such sys-
21 tems and the Administrator has received the noise
22 measurements results based on such procedures
23 from the applicant.

24 (2) DEVELOPMENT OF CRITERIA.—Not later
25 than 90 days after the date of enactment of this

1 Act, the Administrator shall develop and establish
2 substantive criteria and standards metrics used by
3 the Administrator to determine whether to approve
4 or disapprove the airworthiness of an unmanned air-
5 craft pursuant to part 36 of title 14, Code of Fed-
6 eral Regulations.

7 (3) SUBSTANTIVE CRITERIA AND STANDARDS
8 METRICS.—In establishing the substantive criteria
9 and standards metrics as required under paragraph
10 (2), the Administrator shall include such criteria and
11 metrics related to the airworthiness of unmanned
12 aircraft for the following:

13 (A) Noise impacts.

14 (B) Visual impacts.

15 (4) PUBLICATION.—The Administrator shall
16 publish in the Federal Register and post on a
17 website of the Federal Aviation Administration the
18 criteria and metrics established pursuant to para-
19 graph (2).

20 (f) DEFINITION OF UNMANNED AIRCRAFT SYS-
21 TEM.—In this section, the term “unmanned aircraft sys-
22 tem” has the meaning given such term in section 44801
23 of title 49, United States Code.

1 **SEC. 617. CARRIAGE OF HAZARDOUS MATERIALS.**

2 (a) NEAR-TERM APPROVALS.—Not later than 180
3 days after the date of enactment of this Act, the Adminis-
4 trator of the Federal Aviation Administration shall coordi-
5 nate with the Administrator of the Pipeline and Haz-
6 ardous Materials Safety Administration to revise processes
7 in effect on the date of enactment of this Act for the car-
8 riage of hazardous materials by unmanned aircraft sys-
9 tems to provide that—

10 (1) special conditions, waivers, or other require-
11 ments necessary to enable the carriage of hazardous
12 materials shall be incorporated into the existing reg-
13 ulatory and operator certification processes of the
14 Federal Aviation Administration for unmanned air-
15 craft operations in which the aircraft—

16 (A) weighs less than 100 pounds; and

17 (B) is capable of carrying less than 10
18 pounds gross weight of limited quantity cargo;
19 and

20 (2) the existing special permitting process or
21 other existing processes carried out by the Adminis-
22 trator of the Pipeline and Hazardous Materials Safe-
23 ty Administration shall be initiated as early as prac-
24 ticable, and in conjunction with the existing regu-
25 latory and operator certification processes of the

1 Federal Aviation Administration, for unmanned air-
2 craft operations in which the unmanned aircraft—

3 (A) weighs 100 pounds or more; or

4 (B) is capable of carrying 10 pounds or
5 more gross weight of limited quantity cargo.

6 (b) RULEMAKING.—

7 (1) IN GENERAL.—Not later than 1 year after
8 the date of enactment of this Act, the Secretary of
9 Transportation shall revise requirements, guidance,
10 standards, or other policy materials governing the
11 carriage of hazardous materials to allow for the car-
12 riage of a de minimis amount of hazardous materials
13 by an unmanned aircraft.

14 (2) CONSIDERATIONS.—In carrying out para-
15 graph (1), the Administrator shall consider—

16 (A) whether a hazardous material is a con-
17 sumer commodity;

18 (B) requirements for common carriage and
19 private carriage;

20 (C) whether the transportation of a de
21 minimis volume, weight, or amount of a haz-
22 ardous material would pose an unreasonable
23 risk to health and safety or property;

24 (D) whether the volume, weight, or amount
25 of a hazardous material is large enough to per-

1 mit the transportation of a commercially mean-
2 ingful volume, weight, or amount; and

3 (E) the altitude at which unmanned air-
4 craft operations are conducted.

5 (3) IMPLEMENTATION.—

6 (A) PETITION.—The Secretary shall estab-
7 lish a process for a person to petition to estab-
8 lish or revise a de minimis amount or a haz-
9 ardous material.

10 (B) PERIODIC UPDATES.—The Secretary
11 shall—

12 (i) periodically review, as necessary,
13 de minimis amounts of hazardous mate-
14 rials established under paragraph (1);

15 (ii) determine whether such amounts
16 of Hazardous materials should be revised,
17 based on operational and safety data or
18 other factors; and

19 (iii) assess whether to establish a de
20 minimis amount for a hazardous material
21 for which a de minimis volume, weight, or
22 amount has previously not been estab-
23 lished.

24 (c) SAVING CLAUSE.—Nothing in this section shall
25 be construed to—

1 (1) limit the authority of the Secretary, the Ad-
2 ministrator of the Federal Aviation Administration,
3 or the Administrator of the Pipeline and Hazardous
4 Materials Safety Administration from implementing
5 requirements under existing authorities to ensure
6 the safe carriage of hazardous materials by aircraft;
7 and

8 (2) confer upon the Administrator of the Fed-
9 eral Aviation Administration the authorities of the
10 Administrator of the Pipeline and Hazardous Mate-
11 rials Safety Administration, as described in part 175
12 of title 49, Code of Federal Regulations, and chapter
13 51 of title 49, United States Code.

14 (d) EXEMPTION.—The authorities of the Adminis-
15 trator related to the transportation, packaging, marking,
16 or description of hazardous materials in section 106(g)(1)
17 of title 49, United States Code, shall not apply to the ex-
18 tent necessary to enact the requirements of this section.

19 (e) DEFINITIONS.—In the section:

20 (1) UNMANNED AIRCRAFT SYSTEM.—The term
21 “unmanned aircraft system” has the meaning given
22 the term in section 44801 of title 49, United States
23 Code.

24 (2) CONSUMER COMMODITY.—The term “con-
25 sumer commodity” has the meaning given such term

1 in section 171.8 of title 49, Code of Federal Regula-
2 tions.

3 **SEC. 618. UNMANNED AIRCRAFT SYSTEM USE IN WILDFIRE**
4 **RESPONSE.**

5 (a) UNMANNED AIRCRAFT SYSTEMS IN WILDFIRE
6 RESPONSE.—

7 (1) IN GENERAL.—Not later than 1 year after
8 the date of enactment of this Act, the Administrator
9 of the Federal Aviation Administration, in coordina-
10 tion with the United States Forest Service and any
11 other Federal entity or contracted operator the Ad-
12 ministrator considers appropriate, shall develop a
13 plan on the use of unmanned aircraft systems by
14 public entities in wildfire response efforts, including
15 wildfire detection, mitigation, and suppression.

16 (2) PLAN CONTENTS.—The plan under sub-
17 section (a) shall provide recommendations to—

18 (A) identify and designate areas of public
19 land with high potential for wildfires in which
20 public entities may conduct unmanned aircraft
21 system beyond visual line of sight operations as
22 part of wildfire response efforts, including wild-
23 fire detection, mitigation, and suppression;

24 (B) develop a process to facilitate the safe
25 and efficient operation of unmanned aircraft

1 systems beyond the visual line of sight in wild-
2 fire response efforts in areas designated under
3 paragraph (A), including the waiver process
4 under section 91.113 or section 107.31 of title
5 14, Code of Federal Regulations, for public en-
6 tities that use unmanned aircraft systems for
7 aerial wildfire detection, mitigation, and sup-
8 pression; and

9 (C) improve coordination between the rel-
10 evant Federal agencies and public entities on
11 the use of unmanned aircraft systems in wild-
12 fire response efforts.

13 (3) PLAN SUBMISSION.—Upon completion of
14 the plan under subsection (a), the Administrator of
15 the Federal Aviation Administration shall submit
16 such plan to, and provide a briefing for, the Com-
17 mittee on Transportation and Infrastructure of the
18 House of Representatives and the Committee on
19 Commerce, Science, and Transportation of the Sen-
20 ates.

21 (4) PUBLICATION.—Upon submission of the
22 plan under subsection (a), the Administrator of the
23 Federal Aviation Administration shall publish such
24 plan on a publicly available website of the Adminis-
25 tration.

1 (b) APPLICABILITY.—This section shall only apply to
2 unmanned aircraft systems that are—

3 (1) operated by, or on behalf of, a public entity;

4 (2) operated in airspace covered by a wildfire-
5 related temporary flight restriction under section
6 91.137 of title 14, Code of Federal Regulations; and

7 (3) under the operational control of, or other-
8 wise are being operationally coordinated by, an au-
9 thorized aviation coordinator responsible for coordi-
10 nating disaster relief aircraft within the airspace
11 covered by such temporary flight restriction.

12 (c) INTERAGENCY COORDINATION.—Not later than
13 180 days after the date of enactment of this Act, the Ad-
14 ministrator shall seek to enter into the necessary agree-
15 ments to provide a liaison of the Administration to the
16 National Interagency Fire Center to facilitate the use of
17 manned and unmanned aircraft in wildfire response ef-
18 forts, including wildfire detection, mitigation, and suppres-
19 sion.

20 (d) SAVINGS CLAUSE.—Nothing in this Act shall be
21 construed to confer upon the Administrator of the Federal
22 Aviation Administration the authorities of the Administra-
23 tion of the Federal Emergency Management Agency on
24 wildfire response under section 611 of the Robert T. Staf-

1 ford Disaster Relief and Emergency Assistance Act (42
2 U.S.C. 5196).

3 (e) DEFINITIONS.—In this section:

4 (1) PUBLIC ENTITY.—The term “public entity”
5 means—

6 (A) a Federal agency;

7 (B) a State government;

8 (C) a local government;

9 (D) a Tribal government; and

10 (E) a territorial government.

11 (2) PUBLIC LAND.—The term “public land”
12 has the meaning given such term in section 205 of
13 the Sikes Act (16 U.S.C. 670k).

14 (3) UNMANNED AIRCRAFT SYSTEM.—The term
15 “unmanned aircraft system” has the meaning given
16 such term in section 44801 of title 49, United
17 States Code.

18 (4) WILDFIRE.—The term “wildfire” has the
19 meaning given that term in section 2 of the Emer-
20 gency Wildfire Suppression Act (42 U.S.C. 1856m).

21 **SEC. 619. PILOT PROGRAM FOR UAS INSPECTIONS OF FAA**
22 **INFRASTRUCTURE.**

23 (a) IN GENERAL.—Not later than 180 days after the
24 date of enactment of this Act, the Secretary of Transpor-
25 tation shall establish and initiate a pilot program to sup-

1 plement appropriate inspection and oversight activities of
2 the department with unmanned aircraft systems for the
3 purposes of increasing employee safety, enhancing data
4 collection, increasing the accuracy of inspections, reducing
5 costs, and other purposes the Secretary considers to be
6 in the broader interests of good government.

7 (b) GROUND-BASED AVIATION INFRASTRUCTURE.—
8 Under the program required in subsection (a), the Admin-
9 istrator of the Federal Aviation Administration shall
10 evaluate the use of unmanned aircraft systems to inspect
11 ground-based aviation infrastructure that may require vis-
12 ual inspection in hard-to-reach areas, including—

- 13 (1) navigational aids;
- 14 (2) air traffic control towers;
- 15 (3) radar facilities;
- 16 (4) communication facilities; and
- 17 (5) other air traffic control facilities.

18 (c) COORDINATION.—In carrying out the pilot pro-
19 gram established under subsection (a), the Secretary shall
20 consult with the labor union certified under section 7111
21 of title 5, United States Code, to represent personnel re-
22 sponsible for the inspection of the ground-based aviation
23 infrastructure described in subsection (b).

24 (d) COVERED FOREIGN UNMANNED AIRCRAFT SYS-
25 TEM.—The Secretary may not carry out an inspection

1 under this section using an unmanned aircraft system
2 manufactured by—

3 (1) an entity included on the Consolidated
4 Screening list or Entity List as designated by the
5 Secretary of Commerce;

6 (2) an entity domiciled in the People’s Republic
7 of China or the Russian Federation; or

8 (3) an entity, or a subsidiary or affiliate of an
9 entity, that is subject to influence or control by—

10 (A) the Government of the People’s Repub-
11 lic of China;

12 (B) the Chinese Communist Party; or

13 (C) the Russian Federation.

14 (e) BRIEFING.—Not later than 2 years after the date
15 of enactment of this Act, and annually thereafter until the
16 termination of the pilot program under this section, the
17 Secretary shall provide to the Committee on Transpor-
18 tation and Infrastructure of the House of Representatives
19 and the Committee on Commerce, Science, and Transpor-
20 tation of the Senate a briefing on the status and results
21 of the pilot program established under subsection (a), in-
22 cluding—

23 (1) cost saving;

24 (2) a description of how unmanned aircraft sys-
25 tems were used to supplement existing inspection,

1 data collection, or oversight activities of Department
2 employees, including the number of operations and
3 types of activities performed;

4 (3) efficiency or safety improvements, if any,
5 associated with the use of unmanned aircraft sys-
6 tems to supplement conventional inspection, data
7 collection, or oversight activities;

8 (4) the fleet of unmanned aircraft systems
9 maintained by the Department of Transportation for
10 the program, or an overview of the services used as
11 part of the pilot program; and

12 (5) recommendations for improving the use or
13 efficacy of unmanned aircraft systems to supplement
14 the Department's conventional inspection, data col-
15 lection, or oversight activities.

16 (f) SUNSET AND INCORPORATION INTO STANDARD
17 PRACTICE.—

18 (1) SUNSET.—The pilot program established
19 under subsection (a) and the reporting requirement
20 under subsection (f) shall terminate on the date that
21 is 50 months after the date of enactment of this Act.

22 (2) INCORPORATION INTO STANDARD PRAC-
23 TICE.—Upon termination of the pilot program, the
24 Secretary shall assess the results of the pilot pro-
25 gram under this section and determine whether to

1 permanently incorporate the use of unmanned air-
2 craft systems into the regular inspection, data collec-
3 tion, and oversight activities of the Department.

4 (3) REPORT TO CONGRESS.—Not later than 3
5 months after the termination of the pilot program
6 under paragraph (1), the Secretary shall submit to
7 the Committee on Transportation and Infrastructure
8 of the House of Representatives and the Committee
9 on Commerce, Science, and Transportation of the
10 Senate a report on the final results of the pilot pro-
11 gram and the actions taken by the Administrator
12 pursuant to paragraph (2).

13 **SEC. 620. DRONE INFRASTRUCTURE INSPECTION GRANT**
14 **PROGRAM.**

15 (a) AUTHORITY.—Not later than 180 days after the
16 date of enactment of this Act, the Secretary of Transpor-
17 tation shall establish a drone infrastructure inspection
18 grant program to make grants to governmental entities
19 to facilitate the use of eligible small unmanned aircraft
20 systems to support more efficient inspection, operation,
21 construction, maintenance, modernization, and repair of
22 an element of critical infrastructure to improve worker
23 safety related to critical infrastructure projects.

24 (b) USE OF GRANT AMOUNTS.—A governmental enti-
25 ty may use a grant provided under this section to—

1 (1) purchase or lease eligible small unmanned
2 aircraft systems;

3 (2) support operational capabilities of eligible
4 small unmanned aircraft systems by the govern-
5 mental entity;

6 (3) contract for services performed using an eli-
7 gible small unmanned aircraft system in cir-
8 cumstances in which the governmental entity does
9 not have the resources or expertise to safely carry
10 out or assist in carrying out the activities described
11 under subsection (a); and

12 (4) support the program management capability
13 of the governmental entity to use an eligible small
14 unmanned aircraft system.

15 (c) ELIGIBILITY.—To be eligible to receive a grant
16 under this section, a governmental entity shall submit an
17 application to the Secretary at such time, in such form,
18 and containing such information as the Secretary may re-
19 quire, including an assurance that the governmental entity
20 or any contractor of the governmental entity, will comply
21 with relevant Federal regulations.

22 (d) SELECTION OF APPLICANTS.—In awarding a
23 grant under this section, the Secretary shall prioritize ap-
24 plications that propose to—

1 (1) carry out a critical infrastructure project in
2 a variety of communities, including urban, suburban,
3 rural, tribal, or any other type of community; and

4 (2) address a safety risk in the inspection, oper-
5 ation, construction, maintenance, or repair of an ele-
6 ment of critical infrastructure.

7 (e) LIMITATION.—Nothing in this section shall be
8 construed as to interfere with an agreement between a
9 governmental entity and a labor union, including require-
10 ments under section 5333(b) of title 49, United States
11 Code.

12 (f) REPORT TO CONGRESS.—Not later than 1 year
13 after the first grant is provided under this section, the
14 Secretary shall submit to the Committee on Transpor-
15 tation and Infrastructure of the House of Representatives
16 and the Committee on Commerce, Science, and Transpor-
17 tation of the Senate a report that evaluates the program
18 carried out under this section, including—

19 (1) a description of the number of grants
20 awarded;

21 (2) the amount of each grant;

22 (3) the activities funded under this section; and

23 (4) the effectiveness of such funded activities in
24 meeting the objectives described in subsection (a).

25 (g) FUNDING.—

1 (1) FEDERAL SHARE.—

2 (A) IN GENERAL.—Except as provided in
3 subparagraph (B), the Federal share of the cost
4 of a project carried out using a grant under
5 this section shall not exceed 50 percent of the
6 total project cost.

7 (B) WAIVER.—The Secretary may increase
8 the Federal share requirement under subpara-
9 graph (A) to up to 75 percent for a project car-
10 ried out using a grant under this section by a
11 governmental entity if such entity—

12 (i) submits a written application to
13 the Secretary requesting an increase in the
14 Federal share; and

15 (ii) demonstrates that the additional
16 assistance is necessary to facilitate the ac-
17 ceptance and full use of a grant under this
18 section, such as alleviating economic hard-
19 ship, meeting additional workforce needs,
20 or such other uses that the Secretary de-
21 termines to be appropriate.

22 (2) AUTHORIZATION OF APPROPRIATIONS.—Out
23 of amounts authorized to be appropriated under sec-
24 tion 106(k) of title 49, United States Code, the Sec-

1 retary shall make available to carry out this sec-
2 tion—

- 3 (A) \$2,000,000 for fiscal year 2024;
4 (B) \$12,000,000 for fiscal year 2025;
5 (C) \$12,000,000 for fiscal year 2026;
6 (D) \$12,000,000 for fiscal year 2027; and
7 (E) \$12,000,000 for fiscal year 2028.

8 (h) DEFINITIONS.—In this section:

9 (1) COVERED FOREIGN ENTITY.—The term
10 “covered foreign entity” means an entity—

11 (A) included on the Consolidated Screening
12 List or Entity List as designated by the Sec-
13 retary of Commerce;

14 (B) domiciled in the People’s Republic of
15 China or the Russian Federation;

16 (C) subject to influence or control by the
17 government of the People’s Republic of China
18 or by the Russian Federation; or

19 (D) is a subsidiary or affiliate of an entity
20 described in subparagraphs (A) through (C).

21 (2) CRITICAL INFRASTRUCTURE.—The term
22 “critical infrastructure” has the meaning given such
23 term in subsection (e) of the Critical Infrastructures
24 Protection Act of 2001 (42 U.S.C. 5195e(e)).

1 (3) ELEMENT OF CRITICAL INFRASTRUC-
2 TURE.—The term “element of critical infrastruc-
3 ture” means a critical infrastructure facility or
4 asset, including public bridges, tunnels, roads, high-
5 ways, dams, electric grid, water infrastructure, com-
6 munication systems, pipelines, or other related facili-
7 ties or assets, as determined by the Secretary.

8 (4) ELIGIBLE SMALL UNMANNED AIRCRAFT
9 SYSTEM.—The term “eligible small unmanned air-
10 craft system” means a small unmanned aircraft sys-
11 tem manufactured or assembled by a company that
12 is domiciled in the United States and is not a cov-
13 ered foreign entity.

14 (5) ELIGIBLE SMALL UNMANNED AIRCRAFT
15 SYSTEM TECHNOLOGY.—The term “eligible small
16 unmanned aircraft system technology” means—

17 (A) an eligible small unmanned aircraft
18 system; or

19 (B) a major component of such a system
20 that is not manufactured by or procured from
21 a covered foreign entity.

22 (6) GOVERNMENTAL ENTITY.—The term “gov-
23 ernmental entity” means—

24 (A) a State, the District of Columbia, the
25 Commonwealth of Puerto Rico, a territory of

1 the United States, or a political subdivision
2 thereof;

3 (B) a unit of local government;

4 (C) a Tribal Government;

5 (D) a metropolitan planning organization;

6 or

7 (E) a consortia of more than 1 of the enti-
8 ties described in subparagraphs (A) through
9 (D).

10 (7) PROJECT.—The term “project” means a
11 project for the inspection, operation, maintenance,
12 repair, modernization, or construction of an element
13 of critical infrastructure, including mitigating envi-
14 ronmental hazards to such infrastructure.

15 (8) SMALL UNMANNED AIRCRAFT; UNMANNED
16 AIRCRAFT SYSTEM.—The terms “small unmanned
17 aircraft” and “unmanned aircraft system” have the
18 meanings given such terms in section 44801 of title
19 49, United States Code.

20 **SEC. 621. DRONE EDUCATION AND WORKFORCE TRAINING**
21 **GRANT PROGRAM.**

22 (a) AUTHORITY.—Not later than 180 days after the
23 date of enactment of this Act, the Secretary of Transpor-
24 tation shall establish a drone education and training grant
25 program to make grants to educational institutions for

1 workforce training for eligible small unmanned aircraft
2 system technology.

3 (b) USE OF GRANT AMOUNTS.—Amounts from a
4 grant under this section shall be used in furtherance of
5 activities authorized under sections 631 and 632 of the
6 FAA Reauthorization Act of 2018 (49 U.S.C. 40101
7 note).

8 (c) ELIGIBILITY.—To be eligible to receive a grant
9 under this section, an educational institution shall submit
10 an application to the Secretary at such time, in such form,
11 and containing such information as the Secretary may re-
12 quire.

13 (d) AUTHORIZATION OF APPROPRIATIONS.—Out of
14 amounts authorized to be appropriated under section
15 106(k) of title 49, United States Code, the Secretary shall
16 make available to carry out this section—

- 17 (1) \$2,000,000 for fiscal year 2024;
18 (2) \$12,000,000 for fiscal year 2025;
19 (3) \$12,000,000 for fiscal year 2026;
20 (4) \$12,000,000 for fiscal year 2027; and
21 (5) \$12,000,000 for fiscal year 2028.

22 (e) DEFINITIONS.—In this section:

- 23 (1) COVERED FOREIGN ENTITY.—The term
24 “covered foreign entity” means an entity—

1 (A) included on the Consolidated Screening
2 List or Entity List as designated by the Sec-
3 retary of Commerce;

4 (B) domiciled in the People’s Republic of
5 China or the Russian Federation;

6 (C) subject to influence or control by the
7 government of the People’s Republic of China
8 or by the Russian Federation; or

9 (D) is a subsidiary or affiliate of an entity
10 described in subparagraphs (A) through (C).

11 (2) EDUCATIONAL INSTITUTION.—The term
12 “educational institution” means an institution of
13 higher education (as defined in section 101 of the
14 High Education Act of 1965 (20 U.S.C. 1001)) that
15 participates in a program authorized under sections
16 631 and 632 of the FAA Reauthorization Act of
17 2018 (49 U.S.C. 40101 note).

18 (3) ELIGIBLE SMALL UNMANNED AIRCRAFT
19 SYSTEM.—The term “eligible small unmanned air-
20 craft system” means a small unmanned aircraft sys-
21 tem manufactured or assembled by a company that
22 is domiciled in the United States and is not a cov-
23 ered foreign entity.

24 (4) SMALL UNMANNED AIRCRAFT; UNMANNED
25 AIRCRAFT SYSTEM.—The terms “small unmanned

1 aircraft” and “unmanned aircraft system” have the
2 meanings given such terms in section 44801 of title
3 49, United States Code.

4 **SEC. 622. DRONE WORKFORCE TRAINING PROGRAM STUDY.**

5 (a) IN GENERAL.—Not later than 1 year after the
6 date of enactment of this Act, the Comptroller General
7 of the United States shall initiate a study of the effective-
8 ness of the Collegiate Training Initiative Program for Un-
9 manned Aircraft Systems, established pursuant to section
10 632 of the FAA Reauthorization Act 2018 (49 U.S.C.
11 40101 note).

12 (b) REPORT.—Upon completion of the study under
13 subsection (a), the Comptroller General shall submit to the
14 Committee on Transportation and Infrastructure of the
15 House of Representatives and the Committee on Com-
16 merce, Science, and Transportation of the Senate a report
17 describing—

18 (1) the findings of the study; and

19 (2) any recommendations to improve and ex-
20 pand the Collegiate Training Initiative Program for
21 Unmanned Aircraft Systems.

22 **SEC. 623. UAS INTEGRATION OFFICE.**

23 The Executive Director of the UAS Integration Of-
24 fice of the Federal Aviation Administration shall—

1 (1) support, and provide substantive rec-
2 ommendations for, rulemaking proceedings, in co-
3 ordination with other relevant services and offices
4 and the Assistant Administrator of Rulemaking and
5 Regulatory Improvement, regarding the integration
6 of unmanned aircraft systems into the national air-
7 space system;

8 (2) support, and make substantive rec-
9 ommendations to inform, the review and adjudica-
10 tion of submissions under the processes established
11 under section 44807 of title 49, United States Code,
12 as amended by section 605;

13 (3) support, and make substantive rec-
14 ommendations to inform, the development, modifica-
15 tion, and acceptance or approval of relevant con-
16 sensus standards, means of compliance, and declara-
17 tions of compliance related to unmanned aircraft
18 systems;

19 (4) ensure the timely consideration of airworthi-
20 ness and operational determinations related to un-
21 manned aircraft systems by relevant offices of the
22 Administration;

23 (5) consult, advise, coordinate with, and make
24 substantive recommendations to relevant lines of
25 business and staff offices of the Administration to

1 support the activities of the Administration and effi-
2 ciently carry out the duties described in this section;

3 (6) hire full-time equivalent employees, as nec-
4 essary, to build expertise within the UAS Integration
5 Office to assess unmanned aviation technologies and
6 related operational risk mitigation; and

7 (7) engage in any other activities determined
8 necessary by the Executive Director or the Adminis-
9 trator of the Federal Aviation Administration, to ful-
10 fill the duties described in this section.

11 **SEC. 624. TERMINATION OF ADVANCED AVIATION ADVI-**
12 **SORY COMMITTEE.**

13 The Secretary of Transportation may not renew the
14 charter of the Advanced Aviation Advisory Committee
15 (chartered by the Secretary on June 10, 2022).

16 **SEC. 625. UNMANNED AND AUTONOMOUS FLIGHT ADVI-**
17 **SORY COMMITTEE.**

18 (a) IN GENERAL.—Not later than 1 year after the
19 termination of the Advanced Aviation Advisory Committee
20 pursuant to section 624, the Administrator of the Federal
21 Aviation Administration shall establish an Unmanned and
22 Autonomous Flight Advisory Committee (in this section
23 referred to as the “Advisory Committee”).

24 (b) DUTIES.—The Advisory Committee shall provide
25 the Administrator advice on policy- and technical-level

1 issues related to unmanned and autonomous aviation oper-
2 ations and activities, including, at a minimum, the fol-
3 lowing:

4 (1) The safe integration of unmanned aircraft
5 systems and autonomous flight operations into the
6 national airspace system, including feedback on—

7 (A) the certification and operational stand-
8 ards of highly automated aircraft, unmanned
9 aircraft, and associated elements of such air-
10 craft;

11 (B) coordination of procedures for oper-
12 ations in controlled airspace; and

13 (C) communication protocols.

14 (2) The use cases of unmanned aircraft sys-
15 tems, including evaluating and assessing the poten-
16 tial benefits of using unmanned aircraft systems.

17 (3) The development of processes and meth-
18 odologies to address safety concerns related to the
19 operation of unmanned aircraft systems, including
20 risk assessments and mitigation strategies.

21 (4) Unmanned aircraft system training, edu-
22 cation, and workforce development programs, includ-
23 ing evaluating aeronautical knowledge gaps in the
24 unmanned aircraft system workforce, assessing the
25 workforce needs of unmanned aircraft system oper-

1 ations, and establishing a strong pipeline to ensure
2 a robust unmanned aircraft system workforce.

3 (5) The analysis of unmanned aircraft system
4 data and trends.

5 (6) Unmanned aircraft system infrastructure,
6 including the use of existing aviation infrastructure
7 and the development of necessary infrastructure.

8 (c) MEMBERSHIP.—

9 (1) IN GENERAL.—The Advisory Committee
10 shall be composed of not more than 12 members.

11 (2) REPRESENTATIVES.—The Advisory Com-
12 mittee shall include at least 1 representative of each
13 of the following:

14 (A) Small unmanned aircraft system com-
15 mercial operators.

16 (B) Small unmanned aircraft system man-
17 ufacturers.

18 (C) Manufacturers of unmanned aircraft
19 weighing 55 pounds or more pursuing or hold-
20 ing a certificate for design or production of
21 such unmanned aircraft.

22 (D) Counter-unmanned aircraft system
23 manufacturers.

1 (E) Federal Aviation Administration ap-
2 proved unmanned aircraft system service sup-
3 pliers.

4 (F) Unmanned aircraft system test sites
5 under section 44803 of title 49, United States
6 Code.

7 (G) An unmanned aircraft system physical
8 infrastructure network provider.

9 (H) Community advocates.

10 (I) Certified labor organizations rep-
11 resenting commercial airline pilots, air traffic
12 control specialists employed by the Administra-
13 tion, certified aircraft maintenance technicians,
14 certified aircraft dispatchers, and aviation safe-
15 ty inspectors.

16 (d) REPORTING.—

17 (1) IN GENERAL.—The Advisory Committee
18 shall submit to the Secretary an annual report of the
19 activities, findings, and recommendations of the
20 Committee.

21 (2) CONGRESSIONAL REPORTING.—The Sec-
22 retary shall submit to the Committee on Transpor-
23 tation and Infrastructure of the House of Represent-
24 atives and the Committee on Commerce, Science,

1 and Transportation of the Senate the reports re-
2 quired under paragraph (1).

3 (e) DEFINITION OF UNMANNED AIRCRAFT.—In this
4 section, the term “unmanned aircraft” has the meaning
5 given such term in section 44801 of title 49, United States
6 Code.

7 **SEC. 626. NEXTGEN ADVISORY COMMITTEE MEMBERSHIP**
8 **EXPANSION.**

9 (a) IN GENERAL.—Not later than 90 days after the
10 date of enactment of this Act, the Secretary of Transpor-
11 tation shall take such actions as may be necessary to ex-
12 pand the membership of the NextGen Advisory Committee
13 chartered by the Secretary on June 15, 2022, and any
14 subsequent chartered committees, to include a representa-
15 tive from the unmanned aircraft system industry and a
16 representative from the powered-lift industry.

17 (b) QUALIFICATIONS.—The representatives required
18 under subsection (a) shall have the following qualifica-
19 tions, as applicable:

20 (1) Demonstrated expertise in the design, man-
21 ufacture, and operation of unmanned aircraft sys-
22 tems.

23 (2) Demonstrated experience in the develop-
24 ment or implementation of unmanned aircraft sys-
25 tems policies and procedures.

1 (3) Demonstrated commitment to advancing the
2 safe integration of unmanned aircraft systems into
3 the national airspace system.

4 **SEC. 627. TEMPORARY FLIGHT RESTRICTION INTEGRITY.**

5 (a) IN GENERAL.—Section 40103(b) of title 49,
6 United States Code, is amended by adding at the end the
7 following:

8 “(5)(A) In issuing a temporary flight restriction, the
9 Administrator shall—

10 “(i) ensure there is a specific and articulable
11 safety or security basis for the size, scope, and dura-
12 tion of such restriction;

13 “(ii) immediately distribute a notice of the tem-
14 porary flight restriction via the Notice to Air Mis-
15 sions system; and

16 “(iii) detail in the notice required under clause
17 (ii)—

18 “(I) the safety basis for the restriction;

19 and

20 “(II) how a covered person may lawfully
21 and expeditiously operate an aircraft within the
22 restriction.

23 “(B) In this paragraph, the term ‘covered person’
24 means—

25 “(i) a public safety agency;

- 1 “(ii) a first responder;
- 2 “(iii) an accredited news representative; or
- 3 “(iv) any other person as determined appro-
- 4 priate by the Administrator.”.

5 **SEC. 628. INTERAGENCY COORDINATION.**

6 (a) SENSE OF CONGRESS.—It is the sense of Con-

7 gress that—

8 (1) the purpose of the joint Department of De-

9 fense-Federal Aviation Administration executive

10 committee (referred to in this subsection as “Execu-

11 tive Committee”) on conflict and dispute resolution

12 as described in Section 1036(b) of the Duncan Hun-

13 ter National Defense Authorization Act for Fiscal

14 Year 2009 (Public Law 110–417) is to resolve dis-

15 putes on the matters of policy and procedures be-

16 tween the Department of Defense and the Federal

17 Aviation Administration relating to airspace, aircraft

18 certifications, aircrew training, and other issues, in-

19 cluding the access of unmanned aerial systems of the

20 Department of Defense to the national airspace sys-

21 tem;

22 (2) by mutual agreement of Executive Com-

23 mittee leadership, operating with the best of inten-

24 tions, the current scope of activities and membership

25 of the Executive Committee has exceeded the origi-

1 nal intent of, and tasking to, the Executive Com-
2 mittee; and

3 (3) the expansion described in paragraph (2)
4 has resulted in an imbalance in the oversight of cer-
5 tain Federal entities in matters concerning civil avia-
6 tion safety and security.

7 (b) IN GENERAL.—

8 (1) CHARTER REVISION.—Not later than 180
9 days after the date of enactment of this Act, the Ad-
10 ministrator of the Federal Aviation Administration
11 shall seek to revise the charter of the Executive
12 Committee to reflect the scope, objectives, member-
13 ship, and activities described in such section 1036(b)
14 in order to achieve the increasing, and ultimately
15 routine, access of unmanned aircraft systems (as de-
16 fined in section 44801 of title 49, United States
17 Code) into the national airspace system.

18 (2) SUNSET.—Not earlier than 2 years after
19 the date of enactment of this Act, the Administrator
20 shall seek to sunset Executive Committee activities
21 by joint agreement of the Administrator and the
22 Secretary of Defense.

1 **SEC. 629. REVIEW OF REGULATIONS TO ENABLE**
2 **UNESCORTED UAS OPERATIONS.**

3 (a) **IN GENERAL.**—Not later than 2 years after the
4 date of enactment of this Act, the Administrator of the
5 Federal Aviation Administration shall, in coordination
6 with the Secretary of Defense, conduct a review of require-
7 ments necessary to permit an unmanned aircraft systems
8 (excluding small unmanned aircraft systems) operated by
9 a Federal agency or an armed service to be operated in
10 the national airspace system, including outside of re-
11 stricted airspace, without being escorted by a manned air-
12 craft.

13 (b) **REPORT.**—Not later than 2 years after the date
14 of enactment of this Act, the Administrator shall submit
15 to the Committee on Transportation and Infrastructure
16 of the House of Representatives and the Committee on
17 Commerce, Science, and Transportation of the Senate a
18 report on the results of the review, including findings and
19 recommendations on regulatory and statutory changes
20 that can be made to enable the operations described under
21 subsection (a).

22 (c) **DEFINITIONS.**—The definitions under section
23 44801 of title 49, United States Code, shall apply to this
24 section.

1 **SEC. 630. UAS OPERATIONS OVER HIGH SEAS.**

2 (a) IN GENERAL.—An unmanned aircraft system op-
3 eration that begins and ends within the United States or
4 the territorial waters of the United States, shall not be
5 considered international flight regardless of whether the
6 unmanned aircraft system enters international airspace.

7 (b) DEFINITION OF UNMANNED AIRCRAFT SYS-
8 TEM.—In this section, the term “unmanned aircraft sys-
9 tem” has the meaning given such term in section 44801
10 of title 49, United States Code.

11 **SEC. 631. BEYOND BEYOND.**

12 (a) FAA BEYOND PROGRAM EXTENSION.—The
13 Administrator of the Federal Aviation Administration
14 shall extend the BEYOND program of the Administration
15 as in effect on the day before the date of enactment of
16 this Act (referred to in this section as the “Program”)
17 and the existing agreements with State, local, and Tribal
18 governments entered into under the Program until such
19 date, as specified in subsection (b).

20 (b) FAA BEYOND PROGRAM EXPANSION.—

21 (1) IN GENERAL.—Not later than 2 years after
22 the date of enactment of this Act, the Administrator
23 shall expand the Program to additional locations and
24 test the use of new and emerging aviation concepts
25 and technologies, including concepts and tech-
26 nologies unrelated to unmanned aircraft systems, to

1 evaluate and inform Administration policies, rule-
2 making, and guidance related to the safe integration
3 of such concepts and technologies into the national
4 airspace system.

5 (2) SCOPE.—In expanding the Program under
6 this subsection, the Administrator shall address ad-
7 ditional factors, including—

8 (A) increasing automation in civil aircraft,
9 including unmanned aircraft systems and new
10 or emerging aviation technologies;

11 (B) operations of such systems and tech-
12 nologies, including beyond visual line of sight;
13 and

14 (C) the social and economic impacts of
15 such operations.

16 (3) CONTINUATION.—The Administrator shall
17 carry out the expanded Program required under this
18 subsection until such time that the Administrator
19 determines the Program is no longer necessary or
20 useful.

21 **SEC. 632. UAS INTEGRATION STRATEGY.**

22 (a) IN GENERAL.—The Administrator of the Federal
23 Aviation Administration shall implement the recommenda-
24 tions made by—

1 (1) the Comptroller General of the United
2 States to the Secretary of Transportation contained
3 in the report titled “Drones: FAA Should Improve
4 Its Approach to Integrating Drones into the Na-
5 tional Airspace System” issued in January 2023
6 (GAO–23–105189); and

7 (2) the inspector general of the Department of
8 Transportation to the Administrator contained in
9 the audit report titled “FAA Made Progress
10 Through Its UAS Integration Pilot Program, but
11 FAA and Industry Challenges Remain To Achieve
12 Full UAS Integration” issued in April 2022 (Project
13 ID: AV2022027).

14 (b) BRIEFING.—Not later than 12 months after the
15 date of enactment of this Act, the Administrator shall pro-
16 vide a briefing to the Committee on Transportation and
17 Infrastructure of the House of Representatives and the
18 Committee on Commerce, Science, and Transportation of
19 the Senate annually on the status of the activities de-
20 scribed in subsection (a).

21 **SEC. 633. AUTHORIZATION OF APPROPRIATIONS FOR KNOW**
22 **BEFORE YOU FLY CAMPAIGN.**

23 There is authorized to be appropriated to the Admin-
24 istrator \$1,000,000 for each of fiscal years 2024 through
25 2028, out of funds made available under section 106(k)

1 of title 49, United States Code, for the Know Before You
2 Fly educational campaign or similar public informational
3 efforts intended to broaden unmanned aircraft systems
4 safety awareness.

5 **SEC. 634. PUBLIC AIRCRAFT DEFINITION.**

6 Section 40125(a)(2) of title 49, United States Code,
7 is amended—

8 (1) by striking the first instance of “or”; and

9 (2) by inserting “(including data collection on
10 civil aviation systems undergoing research, develop-
11 ment, test, or evaluation at a test range (as such
12 term is defined in section 44801)), infrastructure in-
13 spections, or any other activity undertaken by a gov-
14 ernmental entity that the Administrator determines
15 is inherently governmental” after “biological or geo-
16 logical resource management”.

17 **Subtitle B—Advanced Air Mobility**

18 **SEC. 651. DEFINITION.**

19 In this subtitle, the term “powered-lift aircraft” has
20 the meaning given the term “powered-lift” in section 1.1
21 of title 14, Code of Federal Regulations.

22 **SEC. 652. POWERED-LIFT AIRCRAFT RULEMAKINGS.**

23 (a) FINAL RULEMAKING.—Not later than 13 months
24 after the date of enactment of this Act, the Administrator
25 of the Federal Aviation Administration shall publish a

1 final rule for a special Federal aviation regulation estab-
2 lishing procedures for certifying powered-lift pilots and
3 providing operational rules for powered-lift aircraft.

4 (b) FUTURE RULEMAKING.—Not later than 5 years
5 after the date of enactment of this Act, the Administrator
6 shall initiate a rulemaking activity providing for a perma-
7 nent pathway for the—

8 (1) performance-based certification of powered-
9 lift aircraft;

10 (2) certification of powered-lift airmen; and

11 (3) operation of powered-lift aircraft in com-
12 mercial service and air transportation.

13 (c) RULEMAKING CONSIDERATIONS.—

14 (1) CONTENTS OF RULEMAKINGS.—In the de-
15 velopment of the rulemakings required under sub-
16 sections (a) and (b), the Administrator shall—

17 (A) provide for any aircraft type certifi-
18 cated by the Administrator—

19 (i) a practical pathway for pilot quali-
20 fication and operations; and

21 (ii) performance-based requirements
22 for energy reserves and other range- and
23 endurance-related requirements that reflect
24 the capabilities and intended operations of
25 the aircraft;

1 (B) provide for a combination of pilot
2 training requirements, including simulators, to
3 ensure the safe operation of powered-lift air-
4 craft;

5 (C) grant an individual with an existing
6 commercial airplane (single- or multi-engine) or
7 helicopter pilot certificate the authority to serve
8 as pilot-in-command of a powered-lift aircraft in
9 commercial operation following the completion
10 of a Federal Aviation Administration-approved
11 pilot type rating for such type of aircraft;

12 (D) to the maximum extent practicable,
13 align powered-lift pilot qualifications with sec-
14 tion 2.1.1.4 of the International Civil Aviation
15 Organization's Annex 1; and

16 (E) consider the adoption of the rec-
17 ommendations contained in document 10103 of
18 the International Civil Aviation Organization
19 for powered-lift operations, as appropriate.

20 (2) CONSIDERATIONS FOR FUTURE
21 RULEMAKINGS.—In the development of the
22 rulemakings required under subsection (b), the Ad-
23 ministrators shall—

24 (A) consider and plan for unmanned and
25 remotely piloted powered-lift aircraft systems,

1 and the associated elements of such aircraft,
2 through the promulgation of performance-based
3 regulations;

4 (B) consider and plan for alternative fuel
5 types and propulsion methods, including review-
6 ing the performance-based nature of parts 33
7 and 35 of title 14, Code of Federal Regulations;
8 and

9 (C) work to harmonize the certification
10 and operational requirements of the Federal
11 Aviation Administration with the certification
12 and operational requirements of civil aviation
13 authorities with bilateral safety agreements in
14 place with the United States, to the extent har-
15 monization does not negatively impact domestic
16 manufacturers and operators.

17 (d) INTERIM APPLICATION OF RULES AND PRIVI-
18 LEGES IN LIEU OF RULEMAKING.—Beginning 21 months
19 after the date of enactment of this Act, if a final rule has
20 not been published pursuant to subsection (a)—

21 (1) rules in effect on such date that apply to
22 the operation and the operator of rotorcraft or fixed-
23 wing aircraft under subchapters F, G, H, and I of
24 chapter 1 of title 14, Code of Federal Regulations,
25 shall be—

1 (A) deemed to apply to—

2 (i) the operation of a powered-lift air-
3 craft in the national airspace system; and

4 (ii) the operator of such a powered-lift
5 aircraft; and

6 (B) applicable as determined by the oper-
7 ator of an airworthy powered-lift aircraft in
8 consultation with the Administrator and con-
9 sistent with sections 91.3 and 91.13 of title 14,
10 Code of Federal Regulations; and

11 (2) upon the completion of a type rating for a
12 specific powered-lift aircraft, airmen that hold a
13 pilot or instructor certification with airplane cat-
14 egory ratings in any class or rotorcraft category rat-
15 ings in the helicopter class shall be deemed to have
16 privileges of a powered-lift rating for that aircraft.

17 (e) TERMINATION OF INTERIM RULES AND PRIVI-
18 LEGES.—Subsection (d) shall cease to have effect 1 month
19 after the effective date of a final rule issued pursuant to
20 subsection (a).

21 **SEC. 653. POWERED-LIFT AIRCRAFT ENTRY INTO SERVICE.**

22 (a) IN GENERAL.—The Administrator of the Federal
23 Aviation Administration shall, in consultation with exclu-
24 sive bargaining representatives of air traffic controllers
25 certified under section 7111 of title 5, United States Code,

1 take such actions as may be necessary to safely integrate
2 powered-lift aircraft into the national airspace system, in-
3 cluding in controlled airspace, and learn from any efforts
4 to adopt and update related policy and guidance.

5 (b) AIR TRAFFIC POLICIES FOR ENTRY INTO SERV-
6 ICE.—Not later than 24 months after the date of enact-
7 ment of this Act, the Administrator shall update air traffic
8 orders and policies, to the extent necessary, and address
9 air traffic control system challenges in order to allow for—

10 (1) the use of existing air traffic procedures,
11 where safe, by powered-lift aircraft; and

12 (2) the approval of letters of agreement between
13 air traffic control system facilities and powered-lift
14 operators and infrastructure operators to minimize
15 the amount of active coordination required for safe
16 recurring powered-lift aircraft operations.

17 (c) LONG-TERM AIR TRAFFIC POLICIES.—Based on
18 the implementation of subsection (b), the Administrator
19 shall—

20 (1) continue to update air traffic orders and
21 policies;

22 (2) to the extent necessary, develop powered-lift
23 specific procedures for airports, heliports, and
24 vertiports;

1 (3) evaluate the human factors impacts on con-
2 trollers associated with managing powered-lift air-
3 craft operations, consider the impact of additional
4 operations on air traffic controller staffing, and
5 make necessary changes to staffing, procedures, reg-
6 ulations, and orders; and

7 (4) consider the use of third-party service pro-
8 viders to manage increased operations in controlled
9 airspace to support and supplement the work of air
10 traffic controllers.

11 **SEC. 654. SENSE OF CONGRESS ON PREPARATION FOR**
12 **ENTRY INTO SERVICE OF POWERED-LIFT AIR-**
13 **CRAFT.**

14 It is the sense of Congress that the Administrator
15 of the Federal Aviation Administration should work with
16 manufacturers, prospective operators of powered-lift air-
17 craft, and other stakeholders, to enable the safe entry of
18 such aircraft into commercial service following the publica-
19 tion of the final special Federal Aviation Administration
20 rulemaking titled “Integration of Powered-Lift: Pilot Cer-
21 tification and Operations; Miscellaneous Amendments Re-
22 lated to Rotorcraft and Airplanes”, including by reviewing
23 and providing feedback to such manufacturers and opera-
24 tors on draft pilot training, operations, and maintenance
25 manuals after the publication of the draft special Federal

1 Aviation Administration rulemaking and prior to the pub-
2 lication of a final rule, as appropriate.

3 **SEC. 655. INFRASTRUCTURE SUPPORTING VERTICAL**
4 **FLIGHT.**

5 (a) UPDATES TO REGULATIONS FOR CONSIST-
6 ENCY.—The Administrator of the Federal Aviation Ad-
7 ministration shall update part 1 and part 157 of title 14,
8 Code of Federal Regulations, and other regulations as nec-
9 essary to implement the amendments made by section
10 401.

11 (b) UPDATE TO HELIPORT DESIGN STANDARDS.—
12 The Administrator shall update the version of Advisory
13 Circular 150/5390–2, titled “Heliport Design” in effect on
14 the date of enactment of this Act, to—

15 (1) increase the inclusion of performance-based
16 guidance, including around aircraft fuel type and
17 propulsion method;

18 (2) update guidance to consider risk mitigations
19 and hazards associated with different aircraft fuel
20 types and propulsion methods;

21 (3) affirm the general permissibility of any
22 vertical takeoff and landing capable aircraft to use
23 heliports that can safely accommodate the physical
24 and operating characteristics of such aircraft; and

25 (4) include vertiport as a subclass of heliport.

1 (c) ENGINEERING BRIEF ON VERTIPOINT DESIGN.—
2 The Administrator may update the version of Engineering
3 Brief 105, titled “Vertiport Design” in effect on the date
4 of enactment of this Act, prior to issuing an update to
5 Advisory Circular 150/5390–2, as required under sub-
6 section (b).

7 (d) ENGINEERING BRIEF SUNSET.—The Adminis-
8 trator shall revoke Engineering Brief 105, titled
9 “Vertiport Design”, on the earlier of—

10 (1) the date on which Advisory Circular 150/
11 5390–2 is updated under subsection (b); or

12 (2) 5 years after the date of enactment of this
13 Act.

14 (e) GUIDANCE, FORMS, AND PLANNING.—The Ad-
15 ministrator shall—

16 (1) ensure airport district offices of the Admin-
17 istration have sufficient guidance and policy direc-
18 tion regarding the Administration’s heliport and
19 vertiport design guidance not later than 18 months
20 after the date of enactment of this Act and update
21 such guidance routinely;

22 (2) determine if updates to Administration
23 Form 7460 and Form 7480 are necessary and take
24 such actions, as appropriate; and

1 (3) ensure that the methodology and underlying
2 data sources of the Administration’s Terminal Area
3 Forecast include commercial operations conducted
4 by aircraft regardless of propulsion type or fuel type.

5 **SEC. 656. CHARTING OF AVIATION INFRASTRUCTURE.**

6 (a) IN GENERAL.—The Administrator of the Federal
7 Aviation Administration shall increase efforts to update
8 and keep current the Airport Master Record of the Admin-
9 istration, including by establishing a streamlined process
10 by which the owners and operators of public and private
11 aviation facilities with nontemporary, nonintermittent op-
12 erations are encouraged to keep the information on such
13 facilities current.

14 (b) BRIEFING.—The Administrator shall brief the
15 Committee on Transportation and Infrastructure of the
16 House of Representatives and the Committee on Com-
17 merce, Science, and Transportation of the Senate on the
18 plans of the Administrator to update and keep current the
19 Airport Master Record for private and public airports, hel-
20 iports, and vertiports.

21 **SEC. 657. ADVANCED AIR MOBILITY WORKING GROUP.**

22 Section 2 of the Advanced Air Mobility Coordination
23 and Leadership Act (49 U.S.C. 40101 note) is amended—

24 (1) in subsection (b) by striking “, particularly
25 passenger-carrying aircraft,”;

1 (2) in subsection (d)(1) by striking subpara-
2 graph (D) and inserting the following:

3 “(D) operators of airports, heliports, and
4 vertiports, and fixed-base operators;”;

5 (3) in subsection (e)—

6 (A) in the matter preceding paragraph (1)
7 by striking “1 year” and inserting “18
8 months”;

9 (B) in paragraph (3) by inserting “or that
10 may impede maturation” after “AAM indus-
11 try”;

12 (C) in paragraph (7) by striking “and” at
13 the end;

22 “(8) URBAN AIR MOBILITY.—The term ‘urban
23 air mobility’ means the movement of people or prop-
24 erty by air between 2 intracity or intercity points
25 using an airworthy aircraft that—

1 “(A) advanced technologies, such as dis-
2 tributed propulsion, vertical take-off and land-
3 ing, powered-lift, nontraditional power systems,
4 or autonomous technologies; and

5 “(B) a maximum takeoff weight of greater
6 than 1,320 pounds.”; and

7 (F) by adding at the end the following:

8 “(10) VERTIPOINT.—The term ‘vertipoint’ has
9 the meaning given such term in section 47102 of
10 title 49, United States Code.”;

11 (7) by redesignating subsection (i) as subsection
12 (j); and

13 (8) by inserting after subsection (h) the fol-
14 lowing:

15 “(i) CONSIDERATIONS FOR TERMINATION OF WORK-
16 ING GROUP.—In deciding whether to terminate the work-
17 ing group under subsection (h), the Secretary and the Ad-
18 ministratoꝛ of the Federal Aviation Administration shall
19 consider other interagency coordination activities associ-
20 ated with AAM, or other new or novel users of the national

2 **SEC. 681. REPORT ON NATIONAL SPACEPORTS POLICY.**

3 Section 580(c)(3) of the FAA Reauthorization Act of
4 2018 (Public Law 115–254) is amended by striking
5 “2024” and inserting “2028”.

6 **SEC. 682. INTERMODAL TRANSPORTATION INFRASTRUC-**
7 **TURE IMPROVEMENT PILOT PROGRAM.**

8 (a) **IN GENERAL.**—The Secretary may establish a
9 pilot program to issue grants to operators of launch and
10 reentry sites for projects to construct, repair, maintain,
11 or improve transportation infrastructure and facilities at
12 such sites.

13 (b) **PILOT PROGRAM QUALIFICATIONS.**—The Sec-
14 retary may enter into agreements under this section to
15 issue a grant to an operator only if the operator—

16 (1) has submitted an application to the Sec-
17 retary in such form, at such time, and containing
18 such information as prescribed by the Secretary;

19 (2) demonstrates to the Secretary’s satisfaction
20 that the project for which the application has been
21 submitted is for an eligible purpose under subsection
22 (c); and

23 (3) agrees to maintain such records relating to
24 the grant as the Secretary may require and to make

1 such records available to the Secretary or the Comp-
2 troller General of the United States upon request.

3 (c) PERMITTED USE OF PILOT PROGRAM GRANTS.—

4 An operator may use a grant provided under this sub-
5 section for a project to construct, repair, maintain, or im-
6 prove infrastructure and facilities that—

7 (1) are located at, or adjacent to, a launch or
8 reentry site; and

9 (2) directly enable or support transportation
10 safety or covered transportation activities.

11 (d) PILOT PROGRAM GRANTS.—

12 (1) GRANT FORMULA.—At the beginning of
13 each fiscal year after fiscal year 2024, the Secretary
14 shall issue a grant to an operator that qualifies for
15 the pilot program under subsection (b) an amount
16 equal to the sum of—

17 (A) \$250,000 for each licensed launch or
18 reentry operation conducted from the applicable
19 launch or reentry site or at any adjacent Fed-
20 eral launch range in the previous fiscal year;
21 and

22 (B) \$100,000 for each launch or reentry
23 operation conducted under a permit from the
24 applicable launch or reentry site or at any adja-

1 cent Federal launch range in the previous fiscal
2 year.

3 (2) MAXIMUM GRANT.—Except as provided in
4 subsection (e)(5), a grant issued to an operator
5 under this subsection shall not exceed \$2,500,000
6 for a fiscal year.

7 (3) ADJACENCY.—

8 (A) IN GENERAL.—In issuing a grant to
9 an operator under paragraph (1), the Secretary
10 shall determine whether a launch or reentry site
11 is adjacent to a Federal launch range.

12 (B) LIMITATION.—Only 1 operator may
13 receive an amount under paragraph (1) for
14 each licensed or permitted launch or reentry op-
15 eration described in such subparagraph.

16 (C) MULTIPLE LAUNCH OR REENTRY
17 SITES OPERATED BY 1 OPERATOR.—If an oper-
18 ator holds a license to operate more than 1
19 launch site or more than 1 reentry site that are
20 adjacent to a Federal launch range, the Sec-
21 retary shall consider such launch or reentry
22 sites as 1 launch or reentry site for purposes of
23 subparagraph (A).

24 (e) SUPPLEMENTAL GRANTS IN SUPPORT OF STATE,
25 LOCAL, OR PRIVATE MATCHING.—

1 (1) IN GENERAL.—The Secretary may issue a
2 supplemental grant to an operator, subject to the re-
3 quirements of this paragraph.

4 (2) DOLLAR-FOR-DOLLAR MATCHING.—If a
5 qualified entity provides an operator an amount
6 equal to or greater than the amount of a grant pro-
7 vided in a fiscal year under subsection (d) (for the
8 explicit purpose of matching such grant), the Sec-
9 retary may issue a supplemental grant to the oper-
10 ator that is equal to 25 percent of such grant in the
11 following fiscal year.

12 (3) ADDITIONAL NON-FEDERAL MATCHING.—If
13 a qualified entity provides an operator an amount
14 equal to or greater than two times the amount of a
15 grant provided in a fiscal year to the operator under
16 subsection (d) (for the explicit purpose of matching
17 such grant), the Secretary may issue a supplemental
18 grant to the operator that is equal to 50 percent of
19 such grant in the following fiscal year.

20 (4) SUPPLEMENTAL GRANT LIMITATIONS.—

21 (A) MATCH TIMING.—The Secretary may
22 issue a supplemental grant under paragraph (2)
23 or (3) only if an amount provided by a qualified
24 entity is provided to the operator in the same

1 fiscal year as the grant issued under subsection
2 (d).

3 (B) NON-DUPLICATION OF MATCHING
4 GRANTS.—If the Secretary issues a supple-
5 mental grant to the operator of a launch site
6 under paragraph (3), the Secretary may not
7 issue a supplemental grant under paragraph (2)
8 to the same operator in the same fiscal year.

9 (5) NON-APPLICATION OF GRANT CEILING.—
10 The limitation on a grant amount under subsection
11 (d)(2) shall not apply to supplemental grants issued
12 under this subsection.

13 (f) FUNDING.—

14 (1) PILOT PROGRAM GRANT FUNDS.—The
15 grants issued under this section shall be issued from
16 funds made available out of amounts available under
17 section 106(k) of title 49, United States Code.

18 (2) MAXIMUM ANNUAL LIMIT ON PILOT PRO-
19 GRAM.—

20 (A) IN GENERAL.—The total amount of all
21 grants issued under this section shall not ex-
22 ceed \$20,000,000 in any fiscal year.

23 (B) GRANT REDUCTION.—In complying
24 with subparagraph (A), the Secretary—

1 (i) may proportionally reduce the
2 amount of, or decline to issue, a supple-
3 mental grant under subsection (e); and

4 (ii) if the reduction under clause (i) is
5 insufficient, shall proportionally reduce
6 grants issued under subsection (d).

7 (g) DEFINITIONS.—In this section:

8 (1) COVERED TRANSPORTATION ACTIVITY.—

9 The term “covered transportation activity” means
10 the movement of people or property to, from, or
11 within a launch site and the necessary or incidental
12 activities associated with such movement through
13 the use of—

14 (A) a vehicle (as defined in section 4 of
15 title 1, United States Code);

16 (B) a vessel (as defined in section 3 of title
17 1, United States Code);

18 (C) a railroad (as defined in section 20102
19 of title 49, United States Code);

20 (D) an aircraft (as defined in section
21 40102 of title 49, United States Code); or

22 (E) a pipeline facility (as defined in section
23 60101 of title 49, United States Code).

24 (2) LAUNCH; LAUNCH SITE; LAUNCH VEHICLE;
25 REENTRY SITE; REENTRY VEHICLE.—The terms

1 “launch”, “launch site”, “launch vehicle”, “reentry
2 site”, and “reentry vehicle” have the meanings given
3 those terms in section 50902 of title 51, United
4 States Code.

5 (3) OPERATOR.—The term “operator” means a
6 person licensed by the Secretary to operate a launch
7 or reentry site.

8 (4) QUALIFIED ENTITY.—The term “qualified
9 entity” means a State, local, territorial, or Tribal
10 government or private sector entity, or any combina-
11 tion thereof.

12 (h) PILOT PROGRAM SUNSET.—This section shall
13 cease to be effective on October 1, 2028.

14 **SEC. 683. AIRSPACE ACCESS FOR HIGH-SPEED AIRCRAFT.**

15 (a) HIGH-SPEED AIRCRAFT TESTING.—Not later
16 than 2 years after the date of enactment of this Act, the
17 Administrator of the Federal Aviation Administration, in
18 coordination with any other Federal agency the Adminis-
19 trator determines appropriate, shall ensure that there is
20 a process in which manufacturers and operators of high-
21 speed aircraft can engage in flight testing of such high-
22 speed aircraft, which may include the establishment of
23 high speed testing corridors in the national airspace sys-
24 tem.

1 (b) STUDY ON HIGH-SPEED AIRCRAFT OPER-
2 ATIONS.—

3 (1) IN GENERAL.—The Administrator of the
4 Federal Aviation Administration shall, after con-
5 sultation with aircraft manufacturers, institutions of
6 higher learning, the Administrator of the National
7 Aeronautics and Space Administration, the Sec-
8 retary of Defense, and any other agencies the Ad-
9 ministrator determines appropriate, conduct a study
10 to assess actions necessary to facilitate the safe op-
11 eration and integration of high-speed aircraft into
12 the national airspace system.

13 (2) CONTENTS.—In carrying out the study
14 under paragraph (1), the Administrator shall—

15 (A) assess various altitudes and operating
16 conditions of high-speed aircraft in Class E air-
17 space above the upper boundary of Class A air-
18 space and the resulting aircraft noise levels at
19 the surface;

20 (B) include the development of a frame-
21 work and timeline to establish the appropriate
22 regulatory requirements to conducting high-
23 speed aircraft flights;

24 (C) identify the data required to develop
25 certification, flight standards, and air traffic re-

1 requirements for the deployment and integration
2 of high-speed aircraft;

3 (D) assess cross-agency equities related to
4 high-speed aircraft technologies and flight; and

5 (E) survey global high-speed aircraft-re-
6 lated regulatory and testing developments or ac-
7 tivities.

8 (3) RECOMMENDATIONS.—As part of the study
9 under paragraph (1), the Administrator shall issue
10 recommendations to update, if feasible, regulations
11 for certification, flight standards and air traffic
12 management.

13 (c) REPORT.—Not later than 2 years after the date
14 of enactment of this Act, the Administrator shall submit
15 to the Committee on Transportation and Infrastructure
16 of the House of Representatives and the Committee on
17 Commerce, Science, and Transportation of the Senate a
18 report on the results of the study conducted under sub-
19 section (a), including the recommendations under sub-
20 section (b)(3), to facilitate the safe operation and integra-
21 tion of high-speed aircraft in the national airspace system.

22 (d) STUDY AND RULEMAKING ON HIGH ALTITUDE
23 CLASS E AIRSPACE FLIGHT OPERATIONS.—

24 (1) CONSULTATION.—Not later than 12 months
25 after the date of enactment of this Act, the Adminis-

1 trator, in consultation with the Administrator of the
2 National Aeronautics and Space Administration and
3 relevant stakeholders, including industry and aca-
4 demia, shall identify the minimum altitude above the
5 upper boundary of Class A airspace at or above
6 which flights operating with speeds above Mach 1
7 generate sonic booms that are inaudible at the sur-
8 face under prevailing atmospheric conditions.

9 (2) RULEMAKING.—Not later than 2 years after
10 the date on which the Administrator identifies the
11 minimum altitude described in paragraph (1), the
12 Administrator shall publish in the Federal Register
13 a notice of proposed rulemaking to amend sections
14 91.817 and 91.818 of title 14, Code of Federal Reg-
15 ulations, and such other regulations as appropriate,
16 to permit flight operations with speeds above Mach
17 1 at or above the minimum altitude identified under
18 paragraph (1) without specific authorizations, pro-
19 vided that such flight operations—

20 (A) show compliance with airworthiness re-
21 quirements;

22 (B) do not cause a measurable sonic boom
23 over pressure to reach the surface; and

1 (C) have ordinary instrument flight rules
2 clearances necessary to operate in controlled
3 airspace.

4 (e) DEFINITION.—In this section, the term “high-
5 speed aircraft” means an aircraft operating at speeds in
6 excess of Mach 1, which shall include supersonic and
7 hypersonic aircraft.

8 **SEC. 684. ICAO ACTIVITIES ON NEW TECHNOLOGIES.**

9 (a) IN GENERAL.—The Administrator of the Federal
10 Aviation Administration shall prioritize engagement with
11 the International Civil Aviation Organization and con-
12 tribute to or lead the development of international stand-
13 ards and recommended practices to improve aviation safe-
14 ty and support the entry-into-service of new forms of avia-
15 tion.

16 (b) PARTICULAR ACTIVITIES.—In carrying out sub-
17 section (a), the Administrator shall contribute to or lead
18 International Civil Aviation Organization efforts with re-
19 spect to the development of landing and take-off noise
20 standards for supersonic aircraft.

21 **SEC. 685. AIP ELIGIBILITY FOR CERTAIN SPACEPORT IN-**
22 **FRASTRUCTURE.**

23 (a) IN GENERAL.—Notwithstanding any other provi-
24 sion of law, the Secretary of Transportation may make
25 a grant under subchapter I of chapter 471 of title 49,

1 United States Code, to an airport sponsor to reconstruct,
2 repave, or rehabilitate the full length and width of a run-
3 way existing on the date of enactment of this Act if—

4 (1) the runway is at an airport that is also a
5 launch site or reentry site operated by a person cer-
6 tified under section 50905 of title 51, United States
7 Code;

8 (2) the runway is greater than 12,000 feet long
9 and not less than 200 feet wide; and

10 (3) the airport sponsor certifies to the Secretary
11 that the full length and width of the runway is re-
12 quired to support activities at the launch site.

13 (b) SUNSET.—This section shall cease to be effective
14 on September 30, 2028.

15 **SEC. 686. COMMERCIAL SPACE LAUNCH AND REENTRY STA-**
16 **TISTICS.**

17 Section 329(b) of title 49, United States Code, is
18 amended—

19 (1) in paragraph (2) by striking “aeronautical”
20 and inserting “aerospace”;

21 (2) in paragraph (3) by striking “civil aero-
22 nautics” and inserting “civil aerospace”;

23 (3) by redesignating paragraphs (2) and (3) as
24 paragraphs (3) and (4), respectively; and

1 (4) by inserting after paragraph (1) the fol-
2 lowing:

3 “(2) collect and disseminate information on
4 commercial space launch and reentry operations
5 (other than that collected and disseminated by the
6 National Transportation Safety Board under chapter
7 11) including, at a minimum, information on the
8 number of launches or reentries licensed by the Sec-
9 retary, the number of space flight participants, the
10 number of payloads, and the mass of payloads, orga-
11 nized by class of orbit;”.

12 **SEC. 687. REPORT ON CERTAIN INFRASTRUCTURE NEEDS.**

13 Not later than 120 days after the date of enactment
14 of this Act, the Secretary of Transportation shall submit
15 to the Committee on Transportation and Infrastructure
16 and the Committee on Science, Space, and Technology of
17 the House of Representatives and the Committee on Com-
18 merce, Science, and Transportation of the Senate a report
19 on the infrastructure needs at Federal Aviation Adminis-
20 tration-licensed horizontal and vertical launch sites located
21 in rural communities.

22 **SEC. 688. AIRSPACE INTEGRATION FOR SPACE LAUNCH**
23 **AND REENTRY.**

24 (a) SENSE OF CONGRESS.—It is the Sense of Con-
25 gress that—

1 (1) a safe and efficient national airspace system
2 that successfully supports existing users and inte-
3 grates new entrants is of the utmost importance;

4 (2) both commercial aviation and space launch
5 and reentry operations are vital to United States
6 global leadership, national security, and economic
7 opportunity;

8 (3) aircraft hazard areas are necessary during
9 space launch and reentry operations to ensure public
10 safety; and

11 (4) the Administrator of Federal Aviation Ad-
12 ministration should prioritize the development and
13 deployment of technologies to improve visibility of
14 space launch and reentry operations within Adminis-
15 tration computer systems and minimize operational
16 workload to air traffic controllers associated with
17 routing traffic during spaceflight launch and reentry
18 operations.

19 (b) SPACE LAUNCH AND REENTRY AIRSPACE INTE-
20 GRATION TECHNOLOGY.—There is authorized to be appro-
21 priated \$10,000,000 for each of the fiscal years 2024
22 through 2028, or until such time as the Administrator de-
23 termines that the project has reached an operational sta-
24 tus, for the Administrator to expedite the development, ac-
25 quisition, and deployment of technologies or capabilities

1 to aid in space launch and reentry integration, which may
2 include technologies recommended by the Airspace Access
3 Priorities Aviation Rulemaking Committee in 2019, sys-
4 tems to enable the integration of launch and reentry data
5 directly onto air traffic controller displays, and automated
6 systems to enable near real-time planning and dynamic re-
7 routing of commercial aircraft during and following com-
8 mercial space launch and reentry operations, with the ob-
9 jective of operational readiness not later than December
10 31, 2026.

11 **TITLE VII—PASSENGER**
12 **EXPERIENCE IMPROVEMENTS**
13 **Subtitle A—General Provisions**

14 **SEC. 701. ADVERTISEMENTS AND SOLICITATIONS FOR PAS-**
15 **SENGER AIR TRANSPORTATION.**

16 (a) FULL FARE ADVERTISING.—Section 41712 of
17 title 49, United States Code, is further amended by adding
18 at the end the following:

19 “(e) FULL FARE ADVERTISING.—

20 “(1) IN GENERAL.—It shall not be an unfair or
21 deceptive practice under subsection (a) for a covered
22 entity to state in an advertisement or solicitation for
23 passenger air transportation the base airfare for
24 such air transportation if the covered entity clearly
25 and separately discloses—

1 “(A) the government-imposed taxes and
2 fees associated with the air transportation; and

3 “(B) the total cost of the air transpor-
4 tation.

5 “(2) FORM OF DISCLOSURE.—

6 “(A) IN GENERAL.—For purposes of para-
7 graph (1), the information described in para-
8 graphs (1)(A) and (1)(B) shall be disclosed in
9 the advertisement or solicitation in a manner
10 that clearly presents the information to the con-
11 sumer.

12 “(B) INTERNET ADVERTISEMENTS AND
13 SOLICITATIONS.—For purposes of paragraph
14 (1), with respect to an advertisement or sollicita-
15 tion for passenger air transportation that ap-
16 pears on a website, the information described in
17 paragraphs (1)(A) and (1)(B) may be disclosed
18 through a link or pop-up, as such terms may be
19 defined by the Secretary, in a manner that is
20 easily accessible and viewable by the consumer.

21 “(3) DEFINITIONS.—In this subsection:

22 “(A) BASE AIRFARE.—The term ‘base air-
23 fare’ means the cost of passenger air transpor-
24 tation, excluding government-imposed taxes and
25 fees.

1 “(B) COVERED ENTITY.—The term ‘cov-
2 ered entity’ means an air carrier, including an
3 indirect air carrier, foreign carrier, ticket agent,
4 or other person offering to sell tickets for pas-
5 senger air transportation or a tour, or tour
6 component, that must be purchased with air
7 transportation.”.

8 (b) LIMITATION ON STATUTORY CONSTRUCTION.—
9 Nothing in the amendment made by subsection (b) may
10 be construed to affect any obligation of a person that sells
11 passenger air transportation to disclose the total cost of
12 such air transportation, including government-imposed
13 taxes and fees, prior to purchase of such air transpor-
14 tation.

15 (c) REGULATIONS.—Not later than 1 year after the
16 date of enactment of this Act, the Secretary of Transpor-
17 tation shall issue final regulations to carry out the amend-
18 ment made by subsection (a).

19 (d) STATUTORY CONSTRUCTION.—Nothing in this
20 section may be construed to limit or otherwise affect the
21 authority of the Secretary to regulate the disclosure of air
22 carrier-imposed fees, or alter the requirements under part
23 399 of title 14, Code of Federal Regulations, as such part
24 relates to air carrier-imposed fees.

1 (e) EFFECTIVE DATE.—This section, and the amend-
2 ment made by this section, shall take effect on the date
3 that is 180 days after the date of enactment of this Act.

4 **SEC. 702. MODERNIZATION OF CONSUMER COMPLAINT**
5 **SUBMISSIONS.**

6 Section 42302 of title 49, United States Code, is
7 amended to read as follows:

8 **“§ 42302. Consumer complaints**

9 “(a) IN GENERAL.—The Secretary of Transportation
10 shall—

11 “(1) maintain an accessible website through the
12 Office of Aviation Consumer Protection to accept the
13 submission of complaints from airline passengers re-
14 garding air travel service problems; and

15 “(2) take appropriate actions to notify the pub-
16 lic of such accessible website.

17 “(b) NOTICE TO PASSENGERS ON THE INTERNET.—
18 An air carrier or foreign air carrier providing scheduled
19 air transportation using any aircraft that as originally de-
20 signed has a passenger capacity of 30 or more passenger
21 seats shall include on the accessible website of the car-
22 rier—

23 “(1) the accessible website, e-mail address, or
24 telephone number of the air carrier for the submis-

1 sion of complaints by passengers about air travel
2 service problems; and

3 “(2) the accessible website maintained pursuant
4 to subsection (a).

5 “(c) USE OF ADDITIONAL OR ALTERNATIVE TECH-
6 NOLOGIES.—The Secretary shall periodically evaluate the
7 benefits of using mobile phone applications or other widely
8 used technologies to—

9 “(1) provide additional or alternative means for
10 air passengers to submit complaints; and

11 “(2) provide such additional or alternative
12 means as the Secretary determines appropriate.

13 “(d) AIR AMBULANCE PROVIDERS.—Each air ambu-
14 lance provider shall include the accessible website, or a
15 link to such accessible website, maintained pursuant to
16 subsection (a) and the contact information for the Avia-
17 tion Consumer Advocate established by section 424 of the
18 FAA Reauthorization Act of 2018 (49 U.S.C. 42302 note)
19 on—

20 “(1) any invoice, bill, or other communication
21 provided to a passenger or customer of such pro-
22 vider; and

23 “(2) the accessible website and any related mo-
24 bile device application of such provider.”.

1 **SEC. 703. CODIFICATION OF CONSUMER PROTECTION PRO-**
2 **VISIONS.**

3 (a) PASSENGER RIGHTS.—Subchapter I of chapter
4 417 of title 49, United States Code, is amended by adding
5 at the end the following:

6 **“§ 41727. Passenger rights**

7 “(a) GUIDELINES.—The Secretary of Transportation
8 shall require each air carrier and foreign air carrier to
9 submit a summarized 1-page document that describes the
10 rights of passengers in air transportation, including guide-
11 lines for the following:

12 “(1) Compensation (regarding rebooking op-
13 tions, refunds, meals, and lodging) for flight delays
14 of various lengths.

15 “(2) Compensation (regarding rebooking op-
16 tions, refunds, meals, and lodging) for flight diver-
17 sions.

18 “(3) Compensation (regarding rebooking op-
19 tions, refunds, meals, and lodging) for flight can-
20 cellations.

21 “(4) Compensation for mishandled baggage,
22 wheelchairs, mobility aids and other assistive de-
23 vices, including delayed, damaged, pilfered, or lost
24 baggage, wheelchairs, mobility aids and other assist-
25 ive devices.

1 “(5) Voluntary relinquishment of a ticketed
2 seat due to overbooking or priority of other pas-
3 sengers.

4 “(6) Involuntary denial of boarding and forced
5 removal for whatever reason, including for safety
6 and security reasons.

7 “(b) FILING OF SUMMARIZED GUIDELINES.—Not
8 later than 90 days after each air carrier and foreign air
9 carrier submits the 1-page document to the Secretary
10 under subsection (a), each such air carrier and foreign air
11 carrier shall make available such 1-page document in a
12 prominent location on its website.”.

13 (b) AIRLINE PASSENGERS WITH DISABILITIES BILL
14 OF RIGHTS.—Subchapter I of chapter 417 of title 49,
15 United States Code, is further amended by adding at the
16 end the following:

17 “§ 41728. Airline passengers with disabilities bill of
18 **rights**

19 “(a) AIRLINE PASSENGERS WITH DISABILITIES
20 BILL OF RIGHTS.—The Secretary of Transportation shall
21 develop a document, to be known as the ‘Airline Pas-
22 sengers with Disabilities Bill of Rights’, using plain lan-
23 guage to describe the basic protections and responsibilities
24 of air carriers and foreign air carriers, their employees and

1 contractors, and people with disabilities under section
2 41705.

3 “(b) CONTENT.—In developing the Airline Pas-
4 sengers with Disabilities Bill of Rights under subsection
5 (a), the Secretary shall include, at a minimum, plain lan-
6 guage descriptions of protections and responsibilities pro-
7 vided in law related to the following:

8 “(1) The right of passengers with disabilities to
9 be treated with dignity and respect.

10 “(2) The right of passengers with disabilities to
11 receive timely assistance, if requested, from properly
12 trained air carrier, foreign air carrier, and con-
13 tractor personnel.

14 “(3) The right of passengers with disabilities to
15 travel with wheelchairs, mobility aids, and other as-
16 sistive devices, including necessary medications and
17 medical supplies, including stowage of such wheel-
18 chairs, aids, and devices.

19 “(4) The right of passengers with disabilities to
20 receive seating accommodations, if requested, to ac-
21 commodate a disability

22 “(5) The right of passengers with disabilities to
23 receive announcements in an accessible format.

24 “(6) The right of passengers with disabilities to
25 speak with a complaint resolution officer or to file

1 a complaint with an air carrier, a foreign air carrier,
2 or the Department of Transportation.

3 “(c) RULE OF CONSTRUCTION.—The development of
4 the Airline Passengers with Disabilities Bill of Rights
5 under subsections (a) and (b) shall not be construed as
6 expanding or restricting the rights available to passengers
7 with disabilities on the day before the date of the enact-
8 ment of the FAA Reauthorization Act of 2018 (Public
9 Law 115–254) pursuant to any statute or regulation.

10 “(d) CONSULTATIONS.—In developing the Airline
11 Passengers with Disabilities Bill of Rights under sub-
12 section (a), the Secretary shall consult with stakeholders,
13 including disability organizations and air carriers, foreign
14 air carriers, and their contractors.

15 “(e) DISPLAY.—Each air carrier and foreign air car-
16 rier shall include the Airline Passengers with Disabilities
17 Bill of Rights—

18 “(1) on a publicly available internet website of
19 the carrier; and

20 “(2) in any pre-flight notifications or commu-
21 nications provided to passengers who alert the car-
22 rier in advance of the need for accommodations re-
23 lating to a disability.

24 “(f) TRAINING.—

1 “(1) IN GENERAL.—Air carriers, foreign air
2 carriers, and contractors of such carriers shall sub-
3 mit to the Secretary plans that ensure that employ-
4 ees of such carriers and their contractors receive
5 training on the protections and responsibilities de-
6 scribed in the Airline Passengers with Disabilities
7 Bill of Rights.

8 “(2) REVIEW.—The Secretary shall review such
9 plans to ensure the plans address the matters de-
10 scribed in subsection (b).”.

11 (c) CONFORMING AMENDMENTS.—The analysis for
12 chapter 417 of title 49, United States Code, is amended
13 by inserting after the item relating to section 41726 the
14 following:

“41727. Passenger rights.

“41728. Airline passengers with disabilities bill of rights.”.

15 (d) CONFORMING REPEALS.—Sections 429 and 434
16 of the FAA Reauthorization Act of 2018 (49 U.S.C.
17 42301 note; 41705 note) and the item relating to such
18 sections in the table of contents in section 1(b) of such
19 Act are repealed.

20 **SEC. 704. EXTENSION OF AVIATION CONSUMER PROTEC-**
21 **TION ADVISORY COMMITTEE.**

22 Section 411 of the FAA Modernization and Reform
23 Act of 2012 (49 U.S.C. 42301 note) is amended—

24 (1) in subsection (b)—

1 (A) by redesignating paragraphs (3) and
2 (4) as paragraphs (4) and (5), respectively; and

3 (B) by inserting after paragraph (2) the
4 following:

5 “(3) ticket agents and travel management com-
6 panies;”; and

7 (2) in subsection (h) by striking “2023” and in-
8 serting “2028”; and

9 **SEC. 705. REMOVAL OF OUTDATED REFERENCES TO PAS-**
10 **SENGERS WITH DISABILITIES.**

11 (a) SOVEREIGNTY AND USE OF AIRSPACE.—Section
12 40103(a)(2) of title 49, United States Code, is amended
13 by striking “handicapped individuals” and inserting “indi-
14 viduals with disabilities”.

15 (b) SPECIAL PRICES FOR FOREIGN AIR TRANSPOR-
16 TATION.—Section 41511(b)(4) of title 49, United States
17 Code, is amended by striking “handicap” and inserting
18 “disability”.

19 (c) DISCRIMINATION AGAINST INDIVIDUALS WITH
20 DISABILITIES.—Section 41705 of title 49, United States
21 Code, is amended in the heading by striking “**handi-**
22 **capped individuals**” and inserting “**individuals**
23 **with disabilities**”.

24 (d) CLERICAL AMENDMENT.—The analysis for chap-
25 ter 417 of title 49, United States Code, is amended by

1 striking the item relating to section 41705 and inserting
2 the following:

“41705. Discrimination against individuals with disabilities.”.

3 **SEC. 706. EXTENSION OF AVIATION CONSUMER ADVOCATE**
4 **REPORTING REQUIREMENT.**

5 Section 424(e) of the FAA Reauthorization Act of
6 2018 (49 U.S.C. 42302 note) is amended by striking
7 “2023” and inserting “2028”.

8 **SEC. 707. AIR CARRIER ACCESS ACT ADVISORY COM-**
9 **MITTEE.**

10 (a) IN GENERAL.—Section 439 of the FAA Reau-
11 thorization Act of 2018 (49 U.S.C. 41705 note) is amend-
12 ed—

13 (1) in the section heading by striking “**ADVI-**
14 **SORY COMMITTEE ON THE AIR TRAVEL NEEDS**
15 **OF PASSENGERS WITH DISABILITIES**” and in-
16 sserting “**AIR CARRIER ACCESS ACT ADVISORY**
17 **COMMITTEE**”;

18 (2) in subsection (c)(1) by striking subpara-
19 graph (G) and inserting the following:

20 “(G) Manufacturers of wheelchairs, includ-
21 ing powered wheelchairs, and other mobility
22 aids.”; and

23 (3) in subsection (g) by striking “2023” and in-
24 sserting “2028”.

1 (b) CONFORMING AMENDMENT.—Section 1(b) of the
2 FAA Reauthorization Act of 2018 (Public Law 115–254)
3 is amended by striking the item relating to section 439
4 and inserting the following:

“Sec. 439. Air Carrier Access Act advisory committee.”.

5 **SEC. 708. PASSENGER EXPERIENCE ADVISORY COMMITTEE.**

6 (a) IN GENERAL.—The Secretary of Transportation
7 shall establish an advisory committee to advise the Sec-
8 retary and the Administrator of the Federal Aviation Ad-
9 ministration in carrying out activities relating to the im-
10 provement of the passenger experience in air transpor-
11 tation customer service.

12 (b) MEMBERSHIP.—The Secretary shall appoint the
13 members of the advisory committee, which shall be com-
14 prised of at least 1 representative of each of—

- 15 (1) mainline air carriers;
- 16 (2) air carriers with a low-cost or ultra-low-cost
17 business model;
- 18 (3) regional air carriers;
- 19 (4) large hub airport sponsors and operators;
- 20 (5) medium hub airport sponsors and operators;
- 21 (6) small hub airport sponsors and operators;
- 22 (7) nonhub airport sponsors and operators;
- 23 (8) ticket agents;
- 24 (9) representatives of intermodal transportation
25 companies that operate at airports;

- 1 (10) airport concessionaires;
- 2 (11) nonprofit public interest groups with ex-
3 pertise in consumer protection matters;
- 4 (12) senior managers of the Administration's
5 Air Traffic Organization;
- 6 (13) aircraft manufacturers;
- 7 (14) entities representing individuals with dis-
8 abilities;
- 9 (15) certified labor organizations representing
10 aviation workers, including—
 - 11 (A) Federal Aviation Administration em-
12 ployees;
 - 13 (B) airline pilots working for air carriers
14 operating under part 121 of title 14, Code of
15 Federal Regulations;
 - 16 (C) flight attendants working for air car-
17 riers operating under part 121 of title 14, Code
18 of Federal Regulations; and
 - 19 (D) other customer facing airline and air-
20 port workers;
- 21 (16) other organizations or industry segments
22 as determined by the Secretary; and
- 23 (17) other Federal agencies that directly inter-
24 face with passengers at airports.

1 (c) VACANCIES.—A vacancy in the advisory com-
2 mittee under this section shall be filled in a manner con-
3 sistent with subsection (b).

4 (d) TRAVEL EXPENSES.—Members of the advisory
5 committee under this section shall serve without pay but
6 shall receive travel expenses, including per diem in lieu
7 of subsistence, in accordance with subchapter I of chapter
8 57 of title 5, United States Code.

9 (e) CHAIR.—The Secretary shall designate an indi-
10 vidual among the individuals appointed under subsection
11 (b) to serve as Chair of the advisory committee.

12 (f) DUTIES.—The duties of the advisory committee
13 shall include—

14 (1) evaluating ways to improve the comprehen-
15 sive passenger experience, including—

16 (A) transportation between airport termi-
17 nals and facilities;

18 (B) baggage handling;

19 (C) wayfinding;

20 (D) the security screening process; and

21 (E) the communication of flight delays and
22 cancellations;

23 (2) evaluating ways to improve efficiency in the
24 national airspace system affecting passengers;

1 (3) evaluating ways to improve the cooperation
2 and coordination between the Department of Trans-
3 portation and other Federal agencies that directly
4 interface with aviation passengers at airports;

5 (4) responding to other taskings determined by
6 the Secretary; and

7 (5) providing recommendations to the Secretary
8 and the Administrator, if determined necessary dur-
9 ing the evaluations considered in paragraphs (1)
10 through (4).

11 (g) REPORT TO CONGRESS.—Not later than 1 year
12 after the date of enactment of this Act, and every 2 years
13 thereafter, the Secretary shall submit to Congress a report
14 containing—

15 (1) consensus recommendations made by the
16 advisory committee since such date of enactment or
17 the previous report, as appropriate; and

18 (2) an explanation of how the Secretary has im-
19 plemented such recommendations and, for such rec-
20 ommendations not implemented, the Secretary's rea-
21 son for not implementing such recommendation.

22 (h) DEFINITION.—The definitions in section 40102
23 of title 49, United States Code, shall apply to this section.

24 (i) SUNSET.—This section shall cease to be effective
25 on October 1, 2028.

1 (j) TERMINATION OF DOT ACCESS ADVISORY COM-
2 MITTEE.—The ACCESS Advisory Committee of the De-
3 partment of Transportation shall terminate on the date
4 of enactment of this Act.

5 **SEC. 709. STREAMLINING OF OFFLINE TICKET DISCLO-**
6 **SURES.**

7 (a) IN GENERAL.—Not later than 18 months after
8 the date of enactment of this Act, the Secretary of Trans-
9 portation shall take such action as may be necessary to
10 update the process by which an air carrier or ticket agent
11 is required to fulfill disclosure obligations in ticketing
12 transactions for air transportation not completed through
13 a website.

14 (b) REQUIREMENTS.—The process updated under
15 subsection (a) shall—

16 (1) include means of referral to the applicable
17 air carrier website with respect to disclosures related
18 to air carrier optional fees and policies;

19 (2) include a means of referral to the website
20 of the Department of Transportation with respect to
21 any other required disclosures to air transportation
22 passengers;

23 (3) make no changes to air carrier or ticket
24 agent obligations with respect to—

1 (A) section 41712(c) of title 49, United
2 States Code; or

3 (B) subsections (a) and (b) of section
4 399.84 of title 14, Code of Federal Regulations
5 (or any successor regulations); and

6 (4) require disclosures referred to in para-
7 graphs (1) and (2) to be made in the manner exist-
8 ing prior to the date of enactment of this Act upon
9 passenger request.

10 (c) AIR CARRIER DEFINED.—In this section, the
11 term “air carrier” has the meaning given such term in
12 section 40102(a) of title 49, United States Code.

13 **SEC. 710. TICKET AGENT REFUND OBLIGATIONS.**

14 (a) IN GENERAL.—Not later than 18 months after
15 the date of enactment of this Act, the Secretary of Trans-
16 portation shall issue a final rule to revise section 399.80
17 of title 14, Code of Federal Regulations, to clarify the re-
18 fund obligations of ticket agents.

19 (b) CONDITIONS.—In issuing the final rule under
20 subsection (a), the Secretary shall clarify that a ticket
21 agent shall provide a refund only when such ticket agent
22 possesses, or has access to, the funds of a passenger.

23 (c) DEFINITIONS.—In this section, the term “ticket
24 agent” has the meaning given such term in section
25 40102(a) of title 49, United States Code.

1 **SEC. 711. UPDATING PASSENGER INFORMATION REQUIRE-**
2 **MENT REGULATIONS.**

3 (a) ARAC TASKING.—Not later than 3 years after
4 the date of enactment of this Act, the Administrator of
5 the Federal Aviation Administration shall task the Avia-
6 tion Rulemaking Advisory Committee with—

7 (1) reviewing passenger information require-
8 ment regulations under section 121.317 of title 14,
9 Code of Federal Regulation, and such other related
10 regulations as the Administrator determines appro-
11 priate; and

12 (2) making recommendations to update and im-
13 prove such regulations.

14 (b) FINAL REGULATION.—Not later than 6 years
15 after the date of enactment of this Act, the Administrator
16 of the Federal Aviation Administration shall issue a final
17 regulation revising section 121.317 of title 14, Code of
18 Federal Regulations, and such other related regulations
19 as the Administrator determines appropriate, to—

20 (1) update such section and regulations to in-
21 corporate exemptions commonly issued by the Ad-
22 ministrator;

23 (2) reflect civil penalty inflation adjustments;
24 and

25 (3) incorporate such updates and improvements
26 recommended by the Aviation Rulemaking Advisory

1 Committee that the Administrator determines appro-
2 priate.

3 **SEC. 712. MOBILITY AIDS ON BOARD IMPROVE LIVES AND**
4 **EMPOWER ALL.**

5 (a) PUBLICATION OF CARGO HOLD DIMENSIONS.—

6 (1) IN GENERAL.—Not later than 2 years after
7 the date of enactment of this Act, the Secretary of
8 Transportation shall require air carriers to publish
9 on a prominent and easily accessible place on the
10 public website of the air carrier, information describ-
11 ing the relevant dimensions and other characteristics
12 of the cargo holds of all aircraft types operated by
13 the air carrier, including the dimensions of the cargo
14 hold entry, that would limit the size, weight, and al-
15 lowable type of cargo available.

16 (2) PROPRIETARY INFORMATION.—The Sec-
17 retary shall allow an air carrier to protect the con-
18 fidentiality of any trade secret or proprietary infor-
19 mation submitted in accordance with paragraph (1),
20 as appropriate.

21 (b) REFUND REQUIRED FOR INDIVIDUAL TRAVELING
22 WITH WHEELCHAIR.—In the case of a qualified individual
23 with a disability traveling with a wheelchair who has pur-
24 chased a ticket for a flight from an air carrier, but who
25 cannot travel on the aircraft for such flight because the

1 wheelchair of such qualified individual cannot be phys-
2 ically accommodated in the cargo hold of the aircraft, the
3 Secretary shall require such air carrier to offer a refund
4 to such qualified individual of any previously paid fares,
5 fees, and taxes applicable to such flight.

6 (c) EVALUATION OF DATA REGARDING DAMAGED
7 WHEELCHAIRS.—Not later than 12 months after the date
8 of enactment of this Act, and annually thereafter, the Sec-
9 retary shall—

10 (1) evaluate data regarding the type and fre-
11 quency of incidents of the mishandling of wheel-
12 chairs on aircraft and delineate such data by—

13 (A) types of wheelchairs involved in such
14 incidents; and

15 (B) the ways in which wheelchairs are mis-
16 handled, including the type of damage to wheel-
17 chairs (such as broken drive wheels or casters,
18 bent or broken frames, damage to electrical
19 connectors or wires, control input devices,
20 joysticks, upholstery or other components, loss,
21 or delay of return);

22 (2) determine whether there are trends with re-
23 spect to the data evaluated under paragraph (1);
24 and

1 (3) make available on the public website of the
2 Department of Transportation, in an accessible
3 manner, a report containing the results of the eval-
4 uation of data and determination made under para-
5 graphs (1) and (2) and a description of how the Sec-
6 retary plans to address such results.

7 (d) FEASIBILITY OF IN-CABIN WHEELCHAIR RE-
8 STRAINT SYSTEMS.—

9 (1) ROADMAP.—Not later than 1 year after the
10 date of enactment of this Act, the Secretary shall
11 submit to the Committee on Transportation and In-
12 frastructure of the House of Representatives and the
13 Committee on Commerce, Science, and Transpor-
14 tation of the Senate a publicly available strategic
15 roadmap that describes how the Department of
16 Transportation and the United States Access Board,
17 respectively, shall, in accordance with the rec-
18 ommendations from the National Academies of
19 Science, Engineering, and Mathematics Transpor-
20 tation Research Board Special Report 341—

21 (A) establish a program of research, in col-
22 laboration with the Rehabilitation Engineering
23 and Assistive Technology Society of North
24 America, the assistive technology industry, air
25 carriers, original equipment manufacturers, na-

1 tional disability and disabled veterans organiza-
2 tions, and any other relevant stakeholders, to
3 test and evaluate an appropriate selection of
4 WC19-compliant wheelchairs and accessories in
5 accordance with applicable Federal Aviation Ad-
6 ministration crashworthiness and safety per-
7 formance criteria, including the issues and con-
8 siderations set forth in such Special Report
9 341; and

10 (B) sponsor studies that assess issues and
11 considerations, including those set forth in such
12 Special Report 341, such as—

13 (i) the likely demand for air travel by
14 individuals who are nonambulatory if such
15 individuals could remain seated in their
16 personal wheelchairs in flight; and

17 (ii) the feasibility of implementing
18 seating arrangements that would accommo-
19 date passengers in wheelchairs in the main
20 cabin in flight.

21 (2) STUDY.—If determined to be technically
22 feasible by the Secretary, not later than 2 years
23 after making such determination, the Secretary shall
24 commence a study to assess the economic and finan-
25 cial feasibility of air carriers and foreign air carriers

1 implementing seating arrangements that accommo-
2 date passengers with wheelchairs (including power
3 wheelchairs, manual wheelchairs, and scooters) in
4 the main cabin during flight. Such study shall in-
5 clude an assessment of—

6 (A) the cost of such seating arrangements,
7 equipment, and installation;

8 (B) the demand for such seating arrange-
9 ments;

10 (C) the impact of such seating arrange-
11 ments on passenger seating and safety on air-
12 craft;

13 (D) the impact of such seating arrange-
14 ments on the cost of operations and airfare;
15 and

16 (E) any other information determined ap-
17 propriate by the Secretary.

18 (3) REPORT.—Not later than 1 year after the
19 date on which the study under paragraph (2) is
20 completed, the Secretary shall submit to the Com-
21 mittee on Transportation and Infrastructure of the
22 House of Representatives and the Committee on
23 Commerce, Science, and Transportation of the Sen-
24 ate a publicly available report describing the results
25 of the study conducted under paragraph (2), to-

1 gether with any recommendations the Secretary de-
2 termines appropriate.

3 (e) DEFINITIONS.—In this section:

4 (1) AIR CARRIER.—The term “air carrier” has
5 the meaning given such term in section 40102 of
6 title 49, United States Code.

7 (2) DISABILITY; QUALIFIED INDIVIDUAL WITH
8 A DISABILITY.—The terms “disability” and “quali-
9 fied individual with a disability” have the meanings
10 given such terms in section 382.3 of title 14, Code
11 of Federal Regulations (as in effect on date of en-
12 actment of this Act).

13 (3) WHEELCHAIR.—The term “wheelchair” has
14 the meaning given such term in section 37.3 of title
15 49, Code of Federal Regulations (as in effect on
16 date of enactment of this Act), including power
17 wheelchairs, manual wheelchairs, and scooters.

18 **SEC. 713. PRIORITIZING ACCOUNTABILITY AND ACCESSI-**
19 **BILITY FOR AVIATION CONSUMERS.**

20 (a) ANNUAL REPORT.—Not later than 1 year after
21 the date of enactment of this Act, and annually thereafter,
22 the Secretary of Transportation shall provide to the Com-
23 mittee on Transportation and Infrastructure of the House
24 of Representatives and the Committee on Commerce,
25 Science, and Transportation of the Senate a report on dis-

1 ability-related aviation consumer complaints filed with the
2 Department of Transportation, and shall make each an-
3 nual report publicly available.

4 (b) SCOPE OF REPORT.—In each report required
5 under subsection (a), the Secretary shall include, at min-
6 imum, a description of the following:

7 (1) The number of disability-related aviation
8 consumer complaints filed with the Department of
9 Transportation during the calendar year preceding
10 the year in which such report is submitted.

11 (2) The nature of such complaints, such as re-
12 ported issues with—

13 (A) an air carrier;

14 (B) mishandling of passengers with a dis-
15 ability, including mishandling of a wheelchair,
16 mobility aid, or other accessibility equipment of
17 a passenger by an air carrier;

18 (C) the condition or availability of accessi-
19 bility equipment or materials operated by an air
20 carrier;

21 (D) the accessibility of in-flight services,
22 including accessing and utilizing onboard lava-
23 tories, for passengers with a disability;

1 (E) difficulties experienced by passengers
2 with a disability in communicating with an air
3 carrier employee;

4 (F) difficulties experienced by passengers
5 with a disability in being moved, handled, or
6 otherwise assisted;

7 (G) an air carrier changing the flight
8 itinerary of a passenger with a disability with-
9 out the consent of such passenger;

10 (H) difficulties experienced by passengers
11 with a disability traveling with a service animal;
12 and

13 (I) any other issues the Secretary of
14 Transportation determines appropriate.

15 (3) The review process for such complaints.

16 (4) The average amount of days before the De-
17 partment initiated a formal review of such com-
18 plaints.

19 (5) The average amount of days until such
20 complaints were resolved by the Department.

21 (6) The number of such complaints that re-
22 sulted in dismissal, a civil monetary penalty, or
23 other injunctive relief.

24 (7) Of the complaints that were found to violate
25 section 41705 of title 49, United States Code—

1 (A) the number of such complaints for
2 which a formal enforcement order was issued;
3 and

4 (B) the number of such complaints for
5 which a formal enforcement order was not
6 issued.

7 (8) The number of disability-related aviation
8 consumer complaints filed with the Department of
9 Transportation involving airport staff or other mat-
10 ters under the jurisdiction of the Federal Aviation
11 Administration that were referred to the Federal
12 Aviation Administration.

13 (9) The number of disability-related aviation
14 consumer complaints filed with the Department of
15 Transportation involving Transportation Security
16 Administration staff that were referred to the
17 Transportation Security Administration or the De-
18 partment of Homeland Security.

19 (c) REPORT TO CONGRESS.—The Secretary shall
20 submit annually to the Committee on Transportation and
21 Infrastructure of the House of Representatives and the
22 Committee on Commerce, Science, and Transportation of
23 the Senate the report required under subsection (a).

24 (d) DEFINITIONS.—In this section:

1 (1) IN GENERAL.—Except as otherwise pro-
2 vided, the terms used in this section have the mean-
3 ings given such terms in section 40102 of title 49,
4 United States Code, or section 382.3 of title 14,
5 Code of Federal Regulations, as applicable.

6 (2) AIR CARRIER.—The term “air carrier”
7 means an air carrier conducting passenger oper-
8 ations under part 121 of title 14, Code of Federal
9 Regulations.

10 (3) PASSENGER WITH A DISABILITY.—The term
11 “passenger with a disability” has the meaning given
12 the term “qualified individual with a disability” in
13 section 382.3 of title 14, Code of Federal Regula-
14 tions.

15 **SEC. 714. AIRCRAFT ACCESSIBILITY.**

16 (a) IN GENERAL.—Not later than 180 days after the
17 date of enactment of this Act, the Secretary of Transpor-
18 tation shall initiate a program to study and evaluate im-
19 provements to transport category aircraft accessibility, in-
20 cluding—

21 (1) determining whether and, if so, how per-
22 sonal wheelchairs, including manual and powered
23 wheelchairs, can be safely secured in the passenger
24 seating areas of an aircraft certificated under part
25 25 of title 14, Code of Federal Regulations;

1 (2) considering the safe evacuation processes
2 for such aircraft, including individuals who use man-
3 ual and powered wheelchairs; and

4 (3) determining how various types or aircraft
5 described in paragraph (1) can safely and efficiently
6 be retrofit for accessible lavatories.

7 (b) **REPORT AND RECOMMENDATIONS.**—Not later
8 than 2 years after the date of enactment of this Act, the
9 Secretary shall provide to the Committee on Transpor-
10 tation and Infrastructure of the House of Representatives
11 and the Committee on Commerce, Science, and Transpor-
12 tation of the Senate a report on the findings of the study
13 and evaluation described in subsection (a) and rec-
14 ommendations to address the findings of such study and
15 evaluation.

16 **SEC. 715. ACCESSIBILITY OF WEBSITES, SOFTWARE APPLI-**
17 **CATIONS, AND KIOSKS FOR INDIVIDUALS**
18 **WITH DISABILITIES.**

19 Not later than 2 years after the date of enactment
20 of this Act, the Secretary of Transportation shall, in direct
21 consultation with the United States Architectural and
22 Transportation Barriers Compliance Board, prescribe reg-
23 ulations setting forth minimum standards to ensure that
24 individuals with disabilities are able to access kiosks, soft-
25 ware applications, and websites in a manner that is equal-

1 ly as effective as individuals without disabilities, with a
2 substantially equivalent ease of use. Such standards shall
3 be consistent with the standards set forth in the Web Con-
4 tent Accessibility Guidelines 2.1 Level AA of the Web Ac-
5 cessibility Initiative of the World Wide Web Consortium
6 or any subsequent version.

7 **SEC. 716. REVIEW OF METHODS TO REPORT FLIGHT DELAY**
8 **AND CANCELLATION STATISTICS.**

9 (a) IN GENERAL.—No later than 1 year after the
10 date of enactment of this Act, the Secretary of Transpor-
11 tation, in consultation with the Administrator of the Fed-
12 eral Aviation Administration, shall conduct a review of the
13 means of reporting flight delay and cancellation statistics
14 to the Secretary and the accuracy of such data.

15 (b) COORDINATION REQUIREMENT.—In conducting
16 the review required in paragraph (1), the Secretary shall
17 coordinate and collaborate with air carriers (as such term
18 is defined in section 40102 of title 49, United States
19 Code) to assist in conducting the review and providing rec-
20 ommendations on improving the means of reporting flight
21 delay and cancellation statistics to the Secretary and the
22 accuracy of such data.

23 **SEC. 717. REIMBURSEMENT FOR INCURRED COSTS.**

24 (a) IN GENERAL.—Not later than 1 year after the
25 date of enactment of this Act, the Secretary of Transpor-

1 tation shall direct all air carriers providing scheduled pas-
2 senger interstate or intrastate air transportation to estab-
3 lish policies regarding reimbursement for lodging, trans-
4 portation between such lodging and the airport, and meal
5 costs incurred due to a flight cancellation or significant
6 delay directly attributable to the air carrier.

7 (b) DEFINITION OF SIGNIFICANTLY DELAYED.—In
8 this section, the term “significantly delayed” means, with
9 respect to air transportation, the departure or arrival at
10 the originally ticketed destination associated with such
11 transportation has changed—

12 (1) in the case of air transportation within the
13 United States, by 3 or more hours; or

14 (2) in the case of air transportation to or from
15 a location outside the United States, by 6 or more
16 hours.

17 **SEC. 718. AIRLINE OPERATIONAL RESILIENCY PLANS.**

18 (a) IN GENERAL.—Not later than 1 year after the
19 date of enactment of this Act, the Secretary of Transpor-
20 tation shall require a covered carrier to develop and regu-
21 larly update an operational resiliency strategy to prevent
22 or limit the impact of future flight disruptions on pas-
23 sengers.

1 (b) OPERATIONAL RESILIENCY STRATEGY.—In each
2 operational resiliency strategy developed under subsection
3 (a), a covered carrier shall include a description of—

4 (1) the potential impact of severe weather and
5 other reasonably anticipated disruptive events on the
6 operations of the carrier and how the carrier seeks
7 to prevent or limit the impact of such events on pas-
8 sengers;

9 (2) the potential impact of severe weather
10 events and other reasonably anticipated disruptive
11 events on—

12 (A) staffing models and the preparedness
13 of the current workforce of the carrier to ad-
14 dress such conditions; and

15 (B) the current information and technology
16 systems of the carrier, including crew sched-
17 uling systems, and the preparedness of such
18 systems to continue operations after such an
19 event or disruption;

20 (3) the preparedness of the carrier to maintain
21 operations and limit or prevent the impact of other
22 potential disruptive events identified by the carrier;

23 (4) the extent to which the carrier addresses
24 known cybersecurity risks to prevent potential flight
25 disruptions; and

1 (5) any other issues the Secretary determines
2 appropriate to protect consumers and maintain the
3 operational stability of the airline industry.

4 (c) PROPRIETARY INFORMATION.—The Secretary
5 shall develop a method to protect the confidentiality of any
6 trade secret or proprietary information submitted in an
7 operational resiliency strategy under subsection (b).

8 (d) EVALUATION.—

9 (1) AUDIT.—Not later than 3 years after the
10 date of enactment of this Act, the Comptroller Gen-
11 eral of the United States shall initiate an audit to
12 evaluate the effectiveness of the operational resil-
13 iency strategies developed under this section by cov-
14 ered air carriers.

15 (2) REPORT.—Not later than 1 year after com-
16 pletion of the audit conducted under paragraph (1),
17 the Comptroller General shall submit to the Com-
18 mittee on Transportation and Infrastructure of the
19 House of Representatives and the Committee on
20 Commerce, Science, and Transportation of the Sen-
21 ate a report on the findings of the audit.

22 (e) COVERED CARRIER.—In this section, the term
23 “covered carrier” has the meaning given such term in sec-
24 tion 259.3 of title 14, Code of Federal Regulations (or
25 successor regulations).

1 **SEC. 719. FAMILY SEATING.**

2 (a) IN GENERAL.—Not later than 180 days after the
3 date of enactment of this Act, the Secretary of Transpor-
4 tation shall issue a notice of proposed rulemaking to estab-
5 lish a policy directing air carriers that assign seats, or
6 allow individuals to select seats in advance of the date of
7 departure of a flight, to sit each young child adjacent to
8 an accompanying adult, to the greatest extent practicable,
9 if adjacent seat assignments are available at any time
10 after the ticket is issued for each young child and before
11 the first passenger boards the flight.

12 (b) PROHIBITION ON FEES.—The notice of proposed
13 rulemaking described in subsection (a) shall include a pro-
14 vision that prohibits an air carrier from charging a fee,
15 or imposing an additional cost beyond the ticket price of
16 the additional seat, to seat each young child adjacent to
17 an accompanying adult within the same class of service.

18 (c) RULE OF CONSTRUCTION.—Notwithstanding the
19 requirement in subsection (a), nothing in this section may
20 be construed to allow the Secretary to impose a change
21 in the overall seating or boarding policy of an air carrier
22 that has an open or flexible seating policy in place that
23 generally allows adjacent family seating as described
24 under this section.

1 (d) YOUNG CHILD.—In this section, the term “young
2 child” means an individual who has not attained 14 years
3 of age.

4 **SEC. 720. SEAT DIMENSIONS.**

5 Not later than 60 days after the date of enactment
6 of this Act, the Administrator of the Federal Aviation Ad-
7 ministration shall—

8 (1) initiate a rulemaking activity based on the
9 regulation described in section 577 of the FAA Re-
10 authorization Act of 2018 (49 U.S.C. 42301 note);
11 and

12 (2) if the Administrator decides not to pursue
13 the rulemaking described in paragraph (1), the Ad-
14 ministrator shall brief the Committee on Transpor-
15 tation and Infrastructure of the House of Represent-
16 atives and the Committee on Commerce, Science,
17 and Transportation of the Senate on the justifica-
18 tion of such decision.

19 **SEC. 721. IMPROVED TRAINING STANDARDS FOR ASSIST-**
20 **ING PASSENGERS WHO USE WHEELCHAIRS.**

21 (a) RULEMAKING.—Not later than 6 months after
22 the date of enactment of this Act, the Secretary of Trans-
23 portation shall issue a notice of proposed rulemaking to
24 develop requirements for minimum training standards for
25 airline personnel or contractors who assist wheelchair

1 users who must board or deplane using an aisle chair or
2 other boarding device.

3 (b) REQUIREMENTS.—The training standards devel-
4 oped under subsection (a) shall require, at a minimum,
5 that airline personnel or contractors who assist passengers
6 who use wheelchairs who must board or deplane using an
7 aisle chair or other boarding device—

8 (1) complete refresher training within 18
9 months and be recertified on the job within 18
10 months by a superior in order to remain qualified
11 for providing aisle chair assistance; and

12 (2) be able to successfully demonstrate each of
13 following skills in hands-on training sessions before
14 being allowed to board or deplane a passenger using
15 an aisle chair or other boarding device:

16 (A) How to safely use the aisle chair, or
17 other boarding device, including the use of all
18 straps, brakes, and other safety features.

19 (B) How to assist in the transfer of pas-
20 sengers to and from their wheelchair, the aisle
21 chair, and the aircraft's passenger seat, either
22 by physically lifting the passenger or deploying
23 a mechanical device for the lift or transfer.

24 (C) How to effectively communicate with,
25 and take instruction from, the passenger.

1 (c) CONSIDERATIONS.—In conducting the rulemaking
2 under subsection (a), the Secretary shall consider, at a
3 minimum—

4 (1) whether to require air carriers and foreign
5 air carriers to partner with national disability orga-
6 nizations and disabled veterans organizations rep-
7 resenting individuals with disabilities who use wheel-
8 chairs and scooters in developing and reviewing
9 training; and

10 (2) whether individuals able to provide boarding
11 and deplaning assistance for passengers with limited
12 or no mobility should receive training incorporating
13 procedures from medical professionals on how to
14 properly lift these passengers.

15 (d) FINAL RULE.—Not later than 12 months after
16 the date of enactment of this Act, the Secretary shall issue
17 a final rule pursuant to the rulemaking conducted under
18 this section.

19 (e) PENALTIES.—The Secretary may assess a civil
20 penalty in accordance with section 46301 of title 49,
21 United States Code, to any air carrier or foreign air car-
22 rier who fails to meet the requirements established under
23 the final rule under subsection (d).

1 **SEC. 722. TRAINING STANDARDS FOR STOWAGE OF WHEEL-**
2 **CHAIRS AND SCOOTERS.**

3 (a) RULEMAKING.—Not later than 6 months after
4 the date of enactment of this Act, the Secretary of Trans-
5 portation shall issue a notice of proposed rulemaking to
6 develop minimum training standards related to stowage of
7 wheelchairs and scooters used by passengers with disabil-
8 ities on aircraft.

9 (b) REQUIREMENTS.—The training standards devel-
10 oped under subsection (a) shall require, at a minimum,
11 that personnel and contractors of air carriers and foreign
12 air carriers who stow wheelchairs and scooters on air-
13 craft—

14 (1) complete refresher training within 18
15 months and be recertified on the job within 18
16 months by a superior in order to remain qualified
17 for handling and stowing wheelchairs and scooters;
18 and

19 (2) be able to successfully demonstrate the each
20 of following skills in hands-on training sessions be-
21 fore being allowed to handle or stow a wheelchair or
22 scooter:

23 (A) How to properly handle and configure,
24 at a minimum on a common design for power
25 and manual wheelchairs and scooters for stow-

1 age on each aircraft type operated by the air
2 carrier or foreign air carrier.

3 (B) How to properly review any wheelchair
4 or scooter information provided by the pas-
5 senger or the wheelchair or scooter manufac-
6 turer.

7 (C) How to properly load, secure, and un-
8 load wheelchairs and scooters, including how to
9 use any specialized equipment for loading or
10 unloading, on each aircraft type operated by the
11 air carrier or foreign air carrier.

12 (e) CONSIDERATIONS.—In conducting the rulemaking
13 under subsection (a), the Secretary shall consider, at a
14 minimum whether to require air carriers and foreign air
15 carriers to partner with wheelchair or scooter manufactur-
16 ers, national disability and disabled veterans organizations
17 representing individuals who use wheelchairs and scooters,
18 and aircraft manufacturers, in developing training.

19 (d) FINAL RULE.—Not later than 12 months after
20 the date of enactment of this Act, the Secretary shall issue
21 a final rule pursuant to the rulemaking conducted under
22 this section.

23 (e) PENALTIES.—The Secretary may assess a civil
24 penalty in accordance with section 46301 of title 49,
25 United States Code, to any air carrier or foreign air car-

1 rier who fails to meet the requirements established under
2 the final rule under subsection (d).

3 **SEC. 723. INVESTIGATION OF COMPLAINTS.**

4 Section 41705(c) of title 49, United States Code, is
5 amended by striking paragraph (1), and inserting the fol-
6 lowing:

7 “(1) IN GENERAL.—The Secretary shall—

8 “(A) not later than 120 days after the re-
9 ceipt of any complaint of a violation of this sec-
10 tion or a regulation prescribed under this sec-
11 tion, investigate such complaint; and

12 “(B) provide, in writing, to the individual
13 that filed the complaint and the air carrier or
14 foreign air carrier alleged to have violated this
15 section or a regulation prescribed under this
16 section, the determination of the Secretary with
17 respect to—

18 “(i) whether the air carrier or foreign
19 air carrier violated this section or a regula-
20 tion prescribed under this section;

21 “(ii) the facts underlying the com-
22 plaint; and

23 “(iii) any action the Secretary is tak-
24 ing in response to the complaint.”.

1 **SEC. 724. STANDARDS.**

2 (a) AIRCRAFT ACCESS STANDARDS.—

3 (1) STANDARDS.—

4 (A) ADVANCE NOTICE OF PROPOSED RULE-
5 MAKING.—Not later than 1 year after the date
6 of enactment of this Act, the Secretary of
7 Transportation shall issue an advanced notice
8 of proposed rulemaking regarding standards to
9 ensure that the aircraft boarding and deplaning
10 process is accessible, in terms of design for,
11 transportation of, and communication with, in-
12 dividuals with disabilities, including individuals
13 who use wheelchairs.

14 (B) NOTICE OF PROPOSED RULE-
15 MAKING.—Not later than 1 year after the date
16 on which the advanced notice of proposed rule-
17 making under subparagraph (A) is completed,
18 the Secretary shall issue a notice of proposed
19 rulemaking regarding standards addressed in
20 subparagraph (A).

21 (C) FINAL RULE.—Not later than 1 year
22 after the date on which the notice of proposed
23 rulemaking under subparagraph (B) is com-
24 pleted, the Secretary shall issue a final rule.

1 (2) COVERED AIRPORT, EQUIPMENT, AND FEA-
2 TURES.—The standards prescribed under paragraph
3 (1)(A) shall address, at a minimum—

4 (A) boarding and deplaning equipment;

5 (B) improved procedures to ensure the pri-
6 ority cabin stowage for manual assistive devices
7 pursuant to section 382.67 of title 14, Code of
8 Federal Regulations; and

9 (C) improved cargo hold storage to prevent
10 damage to assistive devices.

11 (3) CONSULTATION.—For purposes of the rule-
12 making under this subsection, the Secretary shall
13 consult with the Access Board and any other rel-
14 evant department or agency to determine appro-
15 priate accessibility standards.

16 (b) IN-FLIGHT ENTERTAINMENT RULEMAKING.—
17 Not later than 1 year after the date of the enactment of
18 this Act, the Secretary shall issue a notice of proposed
19 rulemaking in accordance with the November 22, 2016,
20 resolution of the Department of Transportation ACCESS
21 Committee and the consensus recommendation set forth
22 in the Term Sheet Reflecting Agreement of the Access
23 Committee Regarding In-Flight Entertainment.

1 (c) NEGOTIATED RULEMAKING ON IN-CABIN WHEEL-
2 CHAIR RESTRAINT SYSTEMS AND ENPLANING AND
3 DEPLANING STANDARDS.—

4 (1) TIMING.—

5 (A) IN GENERAL.—Not later than 1 year
6 after completion of the report required by sec-
7 tion 712(d)(3), and if such report finds eco-
8 nomic and financial feasibility of air carriers
9 and foreign air carriers implementing seating
10 arrangements that accommodate individuals
11 with disabilities using wheelchairs (including
12 power wheelchairs, manual wheelchairs, and
13 scooters) in the main cabin during flight, the
14 Secretary shall conduct a negotiated rulemaking
15 on new type certificated aircraft standards for
16 seating arrangements that accommodate such
17 individuals in the main cabin during flight or
18 an accessible route to a minimum of 2 aircraft
19 passenger seats for passengers to access from
20 personal assistive devices of such individuals.

21 (B) REQUIREMENT.—The negotiated rule-
22 making under subparagraph (A) shall include
23 participation of representatives of—

24 (i) air carriers;

25 (ii) aircraft manufacturers;

- 1 (iii) national disability organizations;
- 2 (iv) aviation safety experts; and
- 3 (v) mobility aid manufacturers.

4 (2) NOTICE OF PROPOSED RULEMAKING.—Not
5 later than 1 year after the completion of the nego-
6 tiated rulemaking required under paragraph (1), the
7 Secretary shall issue a notice of proposed rule-
8 making regarding the standards described in para-
9 graph (1).

10 (3) FINAL RULE.—Not later than 1 year after
11 the date on which the notice of proposed rulemaking
12 under paragraph (2) is completed, the Secretary
13 shall issue a final rule regarding the standards de-
14 scribed in paragraph (1).

15 (4) CONSIDERATIONS.—In the negotiated rule-
16 making and rulemaking required under this sub-
17 section, the Secretary shall consider—

18 (A) a reasonable period for the design, cer-
19 tification, and construction of aircraft that meet
20 the requirements;

21 (B) the safety of all persons on-board the
22 aircraft, including necessary wheelchair stand-
23 ards and wheelchair compliance with Federal
24 Aviation Administration crashworthiness and
25 safety performance criteria; and

1 (C) the costs of design, installation, equi-
2 page, and aircraft capacity impacts, including
3 partial fleet equipage and fare impacts.

4 (d) VISUAL AND TACTILELY ACCESSIBLE AN-
5 NOUNCEMENTS.—The Advisory Committee established
6 under section 439(g) of the FAA Reauthorization Act of
7 2018 (49 U.S.C. 41705 note) shall examine technical solu-
8 tions and the feasibility of visually and tactilely accessible
9 announcements on-board aircraft.

10 (e) AIRPORT FACILITIES.—Not later than 2 years
11 after the date of enactment of this Act, the Secretary
12 shall, in direct consultation with the Access Board, pre-
13 scribe regulations setting forth minimum standards under
14 section 41705 of title 49, United States Code, that ensure
15 all gates (including counters), ticketing areas, and cus-
16 tomer service desks covered under such section at airports
17 are accessible to and usable by all individuals with disabil-
18 ities, including through the provision of visually and
19 tactilely accessible announcements and full and equal ac-
20 cess to aural communications.

21 (f) DEFINITIONS.—In this section:

22 (1) ACCESS BOARD.—The term “Access board”
23 means the Architectural and Transportation Bar-
24 riers Compliance Board.

1 (2) AIR CARRIER.—The term “air carrier” has
2 the meaning given such term in section 40102 of
3 title 49, United States Code.

4 (3) INDIVIDUAL WITH A DISABILITY.—The term
5 “individual with a disability” has the meaning given
6 such term in section 382.3 of title 14, Code of Fed-
7 eral Regulations.

8 (4) FOREIGN AIR CARRIER.—The term “foreign
9 air carrier” has the meaning given such term in sec-
10 tion 40102 of title 49, United States Code.

11 **Subtitle B—Air Traffic**

12 **SEC. 741. TRANSFERS OF AIR TRAFFIC SYSTEMS ACQUIRED** 13 **WITH AIP.**

14 Section 44502(e) of title 49, United States Code, is
15 amended—

16 (1) in paragraph (1) by inserting “in a non-
17 contiguous State” after “An airport”;

18 (2) in paragraph (3)—

19 (A) in subparagraph (B) by striking “or”
20 at the end;

21 (B) in subparagraph (C) by striking the
22 period at the end and inserting “; or”; and

23 (C) by adding at the end the following:

1 “(D) a Medium Intensity Approach Light-
2 ing System with Runway Alignment Indicator
3 Lights.”; and

4 (3) by adding at the end the following:

5 “(4) EXCEPTION.—The requirement under
6 paragraph (1) that an eligible air traffic system or
7 equipment be purchased in part using a Government
8 airport aid program, airport development aid pro-
9 gram, or airport improvement project grant shall not
10 apply if the system or equipment is installed at an
11 airport that is categorized as a basic or local general
12 aviation airport under the most recently published
13 national plan of integrated airport systems under
14 section 47103.”.

15 **SEC. 742. NEXTGEN PROGRAMS.**

16 (a) IN GENERAL.—Not later than 180 days after the
17 date of enactment of this Act, and periodically thereafter
18 as the Administrator of the Federal Aviation Administra-
19 tion determines appropriate, the Administrator shall con-
20 vene Administration officials to evaluate and expedite the
21 implementation of NextGen programs and capabilities.

22 (b) NEXTGEN PROGRAM PRIORITIZATION.—In allo-
23 cating amounts appropriated pursuant to section 48101(a)
24 of title 49, United States Code, the Secretary of Transpor-
25 tation shall give priority to the following activities:

1 (1) Performance-based navigation.

2 (2) Data communications.

3 (3) Terminal flight data manager.

4 (4) Aeronautical information management.

5 (c) PERFORMANCE-BASED NAVIGATION.—

6 (1) IN GENERAL.—Not later than 3 years after
7 the date of enactment of this Act, the Administrator
8 shall fully implement performance-based navigation
9 procedures for all terminal and enroute routes, in-
10 cluding approach and departure procedures for cov-
11 ered airports.

12 (2) SPECIFIC PROCEDURES.—Pursuant to para-
13 graph (1), the Administrator shall prioritize the fol-
14 lowing performance-based navigation procedures:

15 (A) Trajectory-based operations.

16 (B) Optimized profile descents.

17 (C) Multiple airport route separation.

18 (D) Established on required navigation
19 performance.

20 (E) Converging runway display aids.

21 (3) PERFORMANCE-BASED NAVIGATION BASE-
22 LINE EQUIPAGE REQUIREMENTS.—In carrying out
23 paragraph (1), the Administrator shall issue such
24 regulations as may be required, and publish applica-
25 ble advisory circulars, to establish the equipage base-

1 line appropriate for aircraft to safely use perform-
2 ance-based navigation procedures.

3 (d) DATA COMMUNICATIONS.—

4 (1) IN GENERAL.—Not later than 2 years after
5 the date of enactment of this Act, the Administrator
6 shall fully implement the use of data communica-
7 tions.

8 (2) SPECIFIC CAPABILITIES.—In carrying out
9 subsection (a) and this subsection, the Administrator
10 shall prioritize the following data communications
11 capabilities:

12 (A) Ground-to-ground message exchange
13 for surface aircraft operations and runway safe-
14 ty at airports.

15 (B) Automated message generation and re-
16 ceipt.

17 (C) Message routing and transmission.

18 (D) Direct communications with aircraft
19 avionics.

20 (E) Implementation of data communica-
21 tions at all Air Route Traffic Control Centers.

22 (F) The Future Air Navigation System.

23 (e) TERMINAL FLIGHT DATA MANAGER.—

24 (1) IN GENERAL.—Not later than 4 years after
25 the date of enactment of this Act, the Administrator

1 shall replace the traffic flow management system
2 with the flow data management system at covered
3 airports.

4 (2) ELECTRONIC FLIGHT STRIPS.—In carrying
5 out paragraph (1), the Administrator shall imple-
6 ment electronic flight strips, at a minimum, at the
7 air traffic control towers of covered airports and all
8 terminal radar approach control and air route traffic
9 control centers.

10 (f) AERONAUTICAL INFORMATION MANAGEMENT
11 SYSTEMS.—

12 (1) IN GENERAL.—Not later than 3 years after
13 the date of enactment of this Act, the Administrator
14 shall fully modernize the aeronautical information
15 management systems of the Federal Aviation Ad-
16 ministration to improve the functionality, useability,
17 durability, and reliability of such systems used in the
18 national airspace system.

19 (2) REQUIREMENTS.—In carrying out para-
20 graph (1), the Administrator shall—

21 (A) improve the distribution of critical
22 safety information to pilots, air traffic control,
23 and other relevant aviation stakeholders;

24 (B) fully develop and implement the Enter-
25 prise Information Display System; and

1 (C) notwithstanding a centralized aero-
2 nautical information management system, re-
3 structure the back-up systems of aeronautical
4 information management systems to be inde-
5 pendent and self-sufficient from one another.

6 (g) EFFECT OF FAILURE TO MEET DEADLINE.—

7 (1) NOTIFICATION OF CONGRESS.—If the Ad-
8 ministrator determines that the Administration has
9 not or will not meet a deadline established under
10 subsection (a), (c), (d), or (e), the Administrator
11 shall, not later than 30 days after such determina-
12 tion, notify the Committee on Transportation and
13 Infrastructure of the House of Representatives and
14 the Committee on Commerce, Science, and Trans-
15 portation of the Senate about the failure to meet the
16 target deadlines.

17 (2) CONTENTS OF NOTIFICATION.—A notifica-
18 tion under paragraph (1) shall be accompanied by
19 the following:

20 (A) An explanation as to why the agency
21 will not or did not meet the target deadlines de-
22 scribed in such paragraph.

23 (B) A description of the actions the Ad-
24 ministration plans to take to meet the target
25 deadlines described in such paragraph.

1 (3) BRIEFING.—If the Administrator is re-
2 quired to provide notice under paragraph (1), the
3 Administrator shall provide the Committee on
4 Transportation and Infrastructure of the House of
5 Representatives and the Committee on Commerce,
6 Science, and Transportation of the Senate bi-
7 monthly, in-person briefings as to the progress made
8 by the Administration regarding implementation
9 under the respective subsection for which the target
10 deadline will not or was not met until such time as
11 the Administrator has completed the required work
12 under such subsection.

13 (h) NEXTGEN ADVISORY COMMITTEE CONSULTA-
14 TION.—

15 (1) IN GENERAL.—The Administrator shall con-
16 sult and task the NextGen Advisory Committee with
17 providing recommendations on ways to expedite,
18 prioritize, and fully implement NextGen programs to
19 realize the operational benefits of such programs.

20 (2) CONSIDERATIONS.—In providing rec-
21 ommendations under paragraph (1), the NextGen
22 Advisory Committee shall consider—

23 (A) air traffic throughput of the national
24 airspace system;

1 (B) daily operational performance, includ-
2 ing delays and cancellations; and

3 (C) the potential need for performance-
4 based operational metrics related to NextGen
5 programs.

6 (i) SUNSET OF NEXTGEN BRAND.—

7 (1) IN GENERAL.— Not later than 3 years after
8 the date of enactment of this Act, the Administrator
9 shall terminate the use of the term “Next Genera-
10 tion Air Transportation System” or “NextGen” to
11 describe any air traffic control modernization pro-
12 gram of the Administration.

13 (2) RULE OF CONSTRUCTION.—Nothing in this
14 subsection shall be construed to—

15 (A) terminate any program of the Admin-
16 istration, including a program that has pre-
17 viously been represented as being a component
18 of the Next Generation Air Transportation Sys-
19 tem or NextGen in budgetary submission or
20 document of the Administration; or

21 (B) prohibit the Administrator from main-
22 taining materials that relate to or reference
23 programs that have previously been represented
24 as being a component of the Next Generation
25 Air Transportation System or NextGen.

1 (j) COVERED AIRPORTS DEFINED.—In this section,
2 the term “covered airports” means the 40 airports in the
3 United States with the highest number of annual aircraft
4 operations, as of the date of enactment of this Act.

5 **SEC. 743. AIRSPACE ACCESS.**

6 (a) COALESCING AIRSPACE.—

7 (1) REVIEW OF NATIONAL AIRSPACE SYSTEM.—

8 Not later than 3 years after the date of enactment
9 of this Act, the Administrator of the Federal Avia-
10 tion Administration, in coordination with the Sec-
11 retary of Defense, shall conduct a comprehensive re-
12 view of the airspace of the national airspace system,
13 including special use airspace.

14 (2) STREAMLINING AND EXPEDITING ACCESS.—

15 In carrying out paragraph (1), the Administrator
16 shall identify methods to streamline, expedite, and
17 provide greater flexibility of access to certain cat-
18 egories of airspace for users of the national airspace
19 system who may not regularly have access to such
20 airspace.

21 (b) REPORT.—

22 (1) IN GENERAL.—Not later than 3 months
23 after the completion of review the under subsection
24 (a), the Administrator shall submit to the Com-
25 mittee on Transportation and Infrastructure of the

1 House of Representatives and the Committee on
2 Commerce, Science, and Transportation of the Sen-
3 ate a report describing the findings of such review
4 and any recommendations and proposed actions to
5 improve access to airspace of the national airspace
6 system for the users of such system.

7 (2) CONTENTS.—In the report submitted under
8 paragraph (1), the Administrator shall include, at a
9 minimum, the following:

10 (A) An identification of current challenges
11 and barriers faced by airspace users in access-
12 ing certain categories of airspace, including spe-
13 cial use airspace.

14 (B) An evaluation of existing procedures,
15 regulations, and requirements that may impede
16 or delay access to certain categories of airspace
17 for certain users of the national airspace sys-
18 tem.

19 (C) Recommendations for streamlining and
20 expediting the airspace access process, including
21 potential regulatory changes, technological ad-
22 vancements, and enhanced coordination among
23 relevant stakeholders and Federal agencies.

24 (D) A proposal for implementing a flexible
25 framework that allows for temporary access to

1 certain categories of airspace, including special
2 use airspace, by users of the national airspace
3 system who do not have regular access to such
4 airspace.

5 (E) An assessment of the impact airspace
6 access improvements may have on safety, effi-
7 ciency, and economic opportunities for airspace
8 users, including—

9 (i) military operators;

10 (ii) commercial operators; and

11 (iii) general aviation operators.

12 (3) IMPLEMENTATION AND FOLLOW-UP.—

13 (A) ACTION PLAN.—Based on the findings,
14 recommendations, and proposals submitted in
15 the report under this subsection, the Adminis-
16 trator shall develop an action plan for imple-
17 menting any recommendations and proposals
18 necessary to improve airspace access.

19 (B) COORDINATION AND COLLABORA-
20 TION.—In developing the action plan under
21 subparagraph (A), the Administrator shall co-
22 ordinate with relevant stakeholders, including
23 airspace users and the Secretary of Defense, to
24 ensure—

1 (i) effective implementation of the ac-
2 tion plan; and

3 (ii) ongoing collaboration in address-
4 ing airspace access challenges.

5 (C) PROGRESS REPORTS.—The Adminis-
6 trator shall provide to the Committee on Trans-
7 portation and Infrastructure of the House of
8 Representatives and the Committee on Com-
9 merce, Science, and Transportation of the Sen-
10 ate periodic progress reports in the form of
11 briefings on the implementation of the action
12 plan developed under this paragraph, including
13 updates on the adoption of streamlined proce-
14 dures, technological enhancements, and any
15 regulatory changes necessary to improve air-
16 space access and flexibility.

17 **SEC. 744. AIRSPACE TRANSITION COMPLETION.**

18 (a) IN GENERAL.—Not later than 180 days after the
19 date of enactment of this Act, the Administrator of the
20 Federal Aviation Administration shall ensure that respon-
21 sibility for the Newark, New Jersey radar sector is moved
22 to the Philadelphia terminal radar approach control facil-
23 ity.

24 (b) STAFFING.—In carrying out subsection (a), the
25 Administrator may not—

1 (1) require the temporary or permanent move-
2 ment of any personnel from the New York terminal
3 radar approach control facility to the Philadelphia
4 terminal radar approach control facility, but may so-
5 licit such personnel to volunteer to temporarily or
6 permanently facilitate the move required under sub-
7 section (a); or

8 (2) reduce the target staffing level of the New
9 York terminal radar approach control facility.

10 (c) CONGRESSIONAL BRIEFINGS.—Not later than
11 180 days after the date of enactment of this Act and every
12 60 days thereafter, the Administrator and the head of the
13 collective bargaining unit representing air traffic control-
14 lers shall brief the Committee on Transportation and In-
15 frastructure of the House of Representatives and the Com-
16 mittee on Commerce, Science, and Transportation of the
17 Senate on the status of the move required under sub-
18 section (a) until such time as the Newark, New Jersey
19 radar sector is under the full responsibility of the Philadel-
20 phia terminal radar approach control facility.

21 **SEC. 745. FAA CONTRACT TOWERS.**

22 (a) OPERATIONAL READINESS INSPECTIONS.—Not
23 later than 180 days after the date of enactment of this
24 Act, the Administrator of the Federal Aviation Adminis-
25 tration shall update applicable regulations, standards, and

1 guidance on operational readiness inspections related to
2 the Federal Aviation Administration Contract Tower pro-
3 gram to provide airport sponsors acting in good faith with
4 7 years to complete such inspections after receiving a ben-
5 efit-to-cost ratio of air traffic control services for an air-
6 port.

7 (b) FCT CONTROLLER AIRSPACE AWARENESS.—

8 (1) IN GENERAL.—Not later than 1 year after
9 the date of enactment of this Act, the Administrator
10 shall authorize the use of advanced technology at
11 Federal Aviation Administration contract towers to
12 enhance air traffic controller situational awareness.

13 (2) EQUIPMENT STANDARDS.—In carrying out
14 paragraph (1), the Administrator shall establish
15 standards and criteria identical to such standards
16 and criteria applicable to Federal Aviation Adminis-
17 tration air traffic controllers for the use of advanced
18 technology in air traffic control towers.

19 (3) RECURRENCE TRAINING.—In carrying out
20 this subsection, the Administrator, in coordination
21 with Federal Aviation Administration contract tower
22 contractors, shall establish an appropriate training
23 program to periodically train air traffic controllers
24 employed by such contractors to ensure proper inte-

1 gration and use of advanced technologies at Federal
2 Aviation Administration contract towers.

3 (c) LIABILITY INSURANCE.—Not later than 2 years
4 after the date of enactment of this Act, the Secretary of
5 Transportation, in consultation with industry experts in-
6 cluding Federal Aviation Administration contract tower
7 contractors and aviation insurance providers, shall—

8 (1) assess existing liability limits for contract
9 tower contractors established by the Secretary; and

10 (2) determine whether such limits should be up-
11 dated.

12 **SEC. 746. FAA CONTRACT TOWER WORKFORCE AUDIT.**

13 (a) IN GENERAL.—Not later than 90 days after the
14 date of enactment of this Act, the inspector general of the
15 Department of Transportation shall initiate an audit of
16 the workforce needs of the Federal Aviation Administra-
17 tion Contract Tower Program.

18 (b) CONTENTS.—In conducting the audit required
19 under subsection (a), the inspector general shall, at a min-
20 imum—

21 (1) review the assumptions and methodologies
22 used in assessing the source of Federal Aviation Ad-
23 ministration contract towers staffing to determine
24 the adequacy of staffing levels at such towers;

1 (2) determine whether there is a need to estab-
2 lish an air traffic controller training program to
3 allow Federal Aviation Administration contract
4 tower contractors to conduct—

5 (A) initial training of air traffic controllers
6 employed by such contractors; or

7 (B) on-the-job training of such controllers;
8 and

9 (3) assess whether establishing pathways to
10 allow Federal Aviation Administration contract
11 tower contractors to use the air traffic technical
12 training academy of the Federal Aviation Adminis-
13 tration, or other means such as higher educational
14 institutions, to provide initial technical training for
15 air traffic controllers employed by such contractors
16 could help address the workforce needs of the FAA
17 contract tower program.

18 (c) REPORT.—Not later than 90 days after the com-
19 pletion of the audit under subsection (a), the inspector
20 general shall submit to the Committee on Transportation
21 and Infrastructure of the House of Representatives and
22 the Committee on Commerce, Science, and Transportation
23 of the Senate a report on the findings of such audit and
24 any recommendations as a result of such audit.

1 **SEC. 747. AVIATION INFRASTRUCTURE SUSTAINMENT.**

2 (a) IN GENERAL.—Not later than 2 years after the
3 date of enactment of this Act, the Administrator of the
4 Federal Aviation Administration shall develop perform-
5 ance metrics with which the Administrator can assess the
6 operation of safety-critical communication, navigation,
7 and surveillance aviation infrastructure within the na-
8 tional airspace system.

9 (b) PERFORMANCE METRICS NECESSARY TO REMAIN
10 IN SERVICE.—

11 (1) IN GENERAL.—After developing the per-
12 formance metrics under subsection (a), the Adminis-
13 trator shall carry out an assessment to determine
14 which applicable aviation infrastructure are to re-
15 main in operational service.

16 (2) CONSIDERATIONS.—In making an assess-
17 ment under paragraph (1), the Administrator shall
18 take into consideration the following:

19 (A) The expected lifespan of such aviation
20 infrastructure.

21 (B) The number and type of mechanical
22 failures of such aviation infrastructure.

23 (C) The average annual costs of maintain-
24 ing such aviation infrastructure over a 5-year
25 timespan and whether such costs exceed the
26 amount to replace such aviation infrastructure.

1 (D) The availability of replacement parts
2 or labor capable of maintaining such aviation
3 infrastructure.

4 (E) Any other factors the Administrator
5 determines are necessary.

6 (c) PUBLICATION.—The Administrator shall make
7 the performance metrics established under subsection (b)
8 available to the public through the website of the Adminis-
9 tration, or other appropriate methods of publication, and
10 shall ensure that any information made available to the
11 public under this subsection is made available in a manner
12 that—

13 (1) does not provide identifying information re-
14 garding an individual or entity;

15 (2) prevents inappropriate disclosure of propri-
16 etary information; and

17 (3) does not disclose information that may pose
18 a cybersecurity risk.

19 **SEC. 748. AIR TRAFFIC CONTROL TOWER SAFETY.**

20 In designing, adopting a design, or constructing an
21 air traffic control tower based on a previously adopted de-
22 sign, the Administrator of the Federal Aviation Adminis-
23 tration shall ensure that the safety of the national airspace
24 system, the safety of employees of the Administration, the
25 operational reliability of air traffic control towers, and the

1 costs of such towers are the primary consideration in such
2 design, adoption, or construction.

3 **SEC. 749. AIR TRAFFIC SERVICES DATA REPORTS.**

4 Section 45303(g)(2)(A) of title 49, United States
5 Code, is amended by striking “8 years” and inserting “14
6 years”.

7 **SEC. 750. CONSIDERATION OF SMALL HUB CONTROL TOW-**
8 **ERS.**

9 In selecting projects for the replacement of federally
10 owned air traffic control towers from funds made available
11 pursuant to title VIII of division J of the Infrastructure
12 Investment and Jobs Act (Public Law 117–58) under the
13 heading “Federal Aviation Administration—Facilities and
14 Equipment”, the Administrator of the Federal Aviation
15 Administration shall consider selecting projects at small
16 hub commercial service airports with control towers that
17 are at least 50 years old.

18 **SEC. 751. AIR TRAFFIC CONTROL TOWER REPLACEMENT**
19 **PROCESS REPORT.**

20 (a) REPORT REQUIRED.—Not later than 120 days
21 after the date of enactment of this Act, the Administrator
22 of the Federal Aviation Administration shall submit to
23 Congress a report on the process by which air traffic con-
24 trol tower facilities are chosen for replacement.

1 (b) CONTENTS.—The report required under sub-
2 section (a) shall contain—

3 (1) the process by which air traffic control
4 tower facilities are chosen for replacement, including
5 which divisions of the Administration control or are
6 involved in the replacement decision making process;

7 (2) the criteria the Administrator uses to deter-
8 mine which air traffic control tower facilities to re-
9 place, including—

10 (A) the relative importance of each such
11 criteria;

12 (B) why the Administrator uses each such
13 criteria; and

14 (C) the reasons for the relative importance
15 of each such criteria;

16 (3) what types of investigation the Adminis-
17 trator carries out to determine if an air traffic con-
18 trol tower facility should be replaced;

19 (4) a timeline of the replacement process for an
20 individual air traffic control tower facility replace-
21 ment;

22 (5) the list of facilities established under sub-
23 section (c), including the reason for selecting each
24 such facility; and

1 (6) any other information the Administrator
2 considers relevant.

3 (c) LIST OF REPLACED AIR TRAFFIC CONTROL
4 TOWER FACILITIES.—The Administrator shall establish,
5 maintain, and publish on the website of the Federal Avia-
6 tion Administration a list of the following:

7 (1) All air traffic control tower facilities re-
8 placed within the previous 10-year period.

9 (2) Any such facilities in the process of being
10 replaced.

11 **SEC. 752. FAA CONTRACT TOWER PILOT PROGRAM.**

12 (a) IN GENERAL.—Not later than 180 days after the
13 date of enactment of this Act, the Administrator of the
14 Federal Aviation Administration shall establish a pilot
15 program to convert up to 3 high-activity contract towers
16 under the Federal Aviation Administration Contract
17 Tower Program under section 47124 of title 49, United
18 States Code, to visual flight rule towers staffed by the Ad-
19 ministration.

20 (b) PRIORITY.—In selecting facilities to participate in
21 the pilot program under subsection (a), the Administrator
22 shall give priority to towers that—

23 (1) had over 200,000 in annual tower oper-
24 ations in calendar year 2022 or a small hub airport

1 with more than 900,000 passenger enplanements in
2 calendar year 2021;

3 (2) have controls towers that are either owned
4 by the Administration or are constructed to Admin-
5 istration standards; and

6 (3) operate within a complex air space, includ-
7 ing space used by air carriers, for general aviation,
8 and by military aircraft.

9 (c) CONTROLLER RETENTION.—The Administrator
10 shall appoint to the position of air traffic controller all
11 air traffic controllers employed as a Federal contract
12 tower operator and assigned to the air traffic control tower
13 pilot program as of the date of enactment of this Act so
14 long as such operator—

15 (1) meets the qualifications contained in section
16 44506(f)(1)(A) of title 49, United States Code; and

17 (2) has all other pre-employment qualifications
18 required by law.

19 **Subtitle C—Small Community Air** 20 **Service**

21 **SEC. 771. ESSENTIAL AIR SERVICE REFORMS.**

22 (a) REDUCTION IN SUBSIDY CAP.—Section
23 41731(a)(1)(C) of title 49, United States Code, is amend-
24 ed to read as follows:

1 “(C) had an average subsidy per pas-
2 senger—

3 “(i) of less than \$1,000 during the
4 most recent fiscal year beginning before
5 October 1, 2026, as determined in sub-
6 paragraph (D) by the Secretary; or

7 “(ii) of \$500 or less during the most
8 recent fiscal year beginning on or after Oc-
9 tober 1, 2026; and”.

10 (b) RESTRICTION ON LENGTH OF ROUTES.—

11 (1) IN GENERAL.—Section 41732(a)(1) of title
12 49, United States Code, is amended by inserting
13 “less than 650 miles from an eligible place (unless
14 such airport or eligible place are located in a non-
15 contiguous State)” after “hub airport”.

16 (2) EXCEPTION.—The amendment made by
17 paragraph (1) shall not apply to any contract or re-
18 newal of such contract with an air carrier for essen-
19 tial air service compensation under subchapter II of
20 chapter 417 of title 49, that was—

21 (A) entered into before the date of enact-
22 ment of this Act; and

23 (B) still in effect on the date of enactment
24 of this Act.

1 (3) SUNSET.—Paragraph (2) shall cease to
2 have effect after September 30, 2028.

3 (c) APPLICANT SELECTION CONSIDERATIONS.—Sec-
4 tion 41733(c)(1) of title 49, United States Code, is
5 amended—

6 (1) by striking “giving substantial weight to”
7 and inserting “including”;

8 (2) in subparagraph (E) by striking “and” at
9 the end;

10 (3) in subparagraph (F) by striking the period
11 at the end and inserting “; and”; and

12 (4) by adding at the end the following:

13 “(G) the total compensation proposed by the air
14 carrier for providing scheduled air service under this
15 section.”.

16 (d) COST SHARE.—

17 (1) SECTION 41737.—Section 41737(a)(1) of
18 title 49, United States Code, is amended—

19 (A) in subparagraph (D) by striking “and”
20 at the end;

21 (B) in subparagraph (E) by striking the
22 period at the end and inserting “; and”; and

23 (C) by adding at the end the following:

24 “(F) require that, for a contract to provide air
25 service that is entered into or renewed under this

1 subchapter after September 30, 2026, the Govern-
2 ment’s share of the compensation is 95 percent.”.

3 (2) SECTION 41731.—Section 41731 of title 49,
4 United States Code, is amended—

5 (A) in subsection (c) by inserting “and sec-

11 **SEC. 772. ESSENTIAL AIR SERVICE AUTHORIZATION.**

12 Section 41742(a)(2) of title 49, United States Code,
13 is amended by striking “\$155,000,000 for fiscal year
14 2018” an all that follows through “\$172,000,000 for fiscal
15 year 2023” and inserting “\$332,000,000 for fiscal year
16 2024, \$312,000,000 for fiscal year 2025, \$300,000,000
17 for fiscal year 2026, \$265,000,000 for fiscal year 2027,
18 and \$252,000,000 for fiscal year 2028”.

19 **SEC. 773. SMALL COMMUNITY AIR SERVICE DEVELOPMENT**
20 **PROGRAM REFORM AND AUTHORIZATION.**

21 (a) SAME PROJECTS LIMIT.—Section 41743(c)(4)(B)
22 of title 49, United States Code, is amended by striking
23 “10-year” and inserting “6-year”.

24 (b) PRIORITIES.—Section 41743(c)(5) of title 49,
25 United States Code, is amended—

1 (1) by redesignating subparagraphs (B)
2 through (G) as subparagraphs (C) through (H), re-
3 spectively; and

4 (2) by adding after subparagraph (A) the fol-
5 lowing—

6 “(B) the community has demonstrated
7 support from at least 1 air carrier to provide
8 service;”.

9 (c) AUTHORIZATION.—Section 41743(e)(2) of title
10 49, United States Code, is amended by striking “2023”
11 and inserting “2028”.

12 **SEC. 774. GAO STUDY ON INCREASED COSTS OF ESSENTIAL**
13 **AIR SERVICE.**

14 (a) STUDY.—The Comptroller General of the United
15 States shall conduct a study of the change in costs of the
16 essential air service program under sections 41731
17 through 41742 of title 49, United States Code.

18 (b) CONTENTS.—In conducting the study required
19 under subsection (a), the Comptroller General shall—

20 (1) assess trends in costs of the essential air
21 service program under sections 41731 through
22 41742 of title 49, United States Code, over the 10-
23 year period ending on the date of enactment of this
24 Act;

1 (2) review potential causes for the increased
2 cost of the essential air service program, including—

3 (A) labor costs;

4 (B) fuel costs;

5 (C) aging aircraft costs;

6 (D) air carrier opportunity costs; and

7 (E) airport costs; and

8 (3) assess the effects of the COVID–19 pan-
9 demic on the costs of the essential air service pro-
10 gram under sections 41731 through 41742 of title
11 49, United States Code.

12 (c) REPORT.—Not later than 18 months after the
13 date of enactment of this Act, the Comptroller General
14 shall submit to the Committee on Transportation and In-
15 frastructure of the House of Representatives and to the
16 Committee on Commerce, Science, and Transportation of
17 the Senate a report on the results of the study conducted
18 under subsection (a).

19 **TITLE VIII—MISCELLANEOUS**

20 **SEC. 801. DIGITALIZATION OF FAA PROCESSES.**

21 (a) IDENTIFICATION.—Not later than 2 years after
22 the date of enactment of this Act, the Administrator of
23 the Federal Aviation Administration shall identify and
24 catalog programs, activities, or processes that require
25 paper-based information exchange between—

- 1 (1) external entities and the Administration; or
- 2 (2) offices within the Administration.

3 (b) DIGITALIZATION.—On an ongoing basis, and as
4 appropriate, the Administrator shall transition the paper-
5 based processes identified under subsection (a) to proc-
6 esses that support secure digital information submission,
7 exchange, collaboration, and approval.

8 (c) BRIEFING.—Not later than 60 days after com-
9 pleting the required identification and catalog in sub-
10 section (a), the Administrator shall brief the Committee
11 on Transportation and Infrastructure of the House of
12 Representatives and the Committee on Commerce,
13 Science, and Transportation of the Senate on the pro-
14 grams, activities, and processes identified under sub-
15 section (a) and such programs, activities, and processes
16 that have been identified for transition under subsection
17 (b).

18 **SEC. 802. FAA TELEWORK.**

19 (a) IN GENERAL.—The Administrator of the Federal
20 Aviation Administration—

- 21 (1) may establish telework policies for employ-
22 ees that allow for the Administration to reduce the
23 office footprint and associated expenses of the Ad-
24 ministration, increase workforce retention, and pro-
25 vide flexibilities that the Administrator believes in-

1 creases efficiency and effectiveness of the Adminis-
2 tration, while requiring that any such policy—

3 (A) does not adversely impact the mission
4 of the Administration;

5 (B) does not reduce the safety and effi-
6 ciency of the national airspace system;

7 (C) for any employee that is designated as
8 an officer or executive in the Federal Aviation
9 Administration Executive System or a political
10 appointee (as such term is defined in section
11 106 of title 49, United States Code)—

12 (i) maximizes time at a duty station
13 for such employee, excluding official travel;
14 and

15 (ii) may include telework provisions as
16 determined appropriate by the Adminis-
17 trator, commensurate with official duties
18 for such employee;

19 (D) provides for on-the-job training oppor-
20 tunities for Administration personnel that are
21 not less than such opportunities available in
22 2019;

23 (E) reflects the appropriate work status of
24 employees based on the job functions of such
25 employee;

1 (F) optimizes the work status of inspec-
2 tors, investigators, and other personnel per-
3 forming safety-related functions to ensure time-
4 ly completion of safety oversight activities;

5 (G) provides for personnel, including such
6 personnel performing work related to aircraft
7 certification and flight standards, who are re-
8 sponsible for actively working with regulated
9 entities, external stakeholders, or other mem-
10 bers of the public to be—

11 (i) routinely available on a predictable
12 basis for in-person and virtual communica-
13 tions with external persons; and

14 (ii) not hindered from meeting with,
15 visiting, auditing, or inspecting facilities or
16 projects of regulated persons due to any
17 telework policy; and

18 (H) provides offices of the Administration
19 opportunities for in-person dialogue, collabora-
20 tion, and ideation for all employees;

21 (2) ensures that locality pay for an employee of
22 the Administrator accurately reflects the telework
23 status and duty station of such employee;

24 (3) may not establish a telework policy for an
25 employee of the Administration unless such em-

1 ployee will be provided with secure network capacity,
2 communications tools, necessary and secure access
3 to appropriate agency data assets and Federal
4 records, and equipment sufficient to enable such em-
5 ployee to be fully productive; and

6 (4) not later than 2 years after the date of en-
7 actment of this Act, shall evaluate and address any
8 telework policies in effect on the day before such
9 date of enactment to ensure that such policies meet
10 the requirements of paragraph (1).

11 (b) CONGRESSIONAL UPDATE.—Not later than 1
12 year after the date of enactment of this Act, and 1 year
13 thereafter, the Administrator shall brief the Committee on
14 Transportation and Infrastructure of the House of Rep-
15 resentatives and the Committee on Commerce, Science,
16 and Transportation of the Senate on any telework policies
17 currently in place, the implementation of such policies,
18 and the benefits of such policies.

19 (c) CONSULTATION.—If the Administrator deter-
20 mines that telework agreements must be updated to imple-
21 ment the requirements of subsection (a), the Adminis-
22 trator shall, prior to updating such agreements, consult
23 with—

1 (1) exclusive bargaining representatives of air
2 traffic controllers certified under section 7111 of
3 title 5, United States Code; and

4 (2) labor organizations certified under such sec-
5 tion as the exclusive bargaining representative of
6 airway transportation systems specialists and avia-
7 tion safety inspectors of the Federal Aviation Ad-
8 ministration.

9 **SEC. 803. REVIEW OF OFFICE SPACE.**

10 (a) FAA REVIEW.—

11 (1) INITIATION OF REVIEW.—Not later than 30
12 months after the date of enactment of this Act, the
13 Secretary of Transportation shall initiate an inven-
14 tory review of the domestic office footprint of the
15 Department of Transportation.

16 (2) COMPLETION OF REVIEW.—Not later than
17 40 months after the date of enactment of this Act,
18 the Secretary shall complete the inventory review re-
19 quired under paragraph (1).

20 (b) CONTENTS OF REVIEW.—In completing the re-
21 view under subsection (a), the Secretary shall—

22 (1) delineate the domestic office footprint into
23 units of property, as determined appropriate by the
24 Secretary;

25 (2) determine unit adequacy related to—

1 (A) the Architectural Barriers Act of 1968
2 (42 U.S.C. 4151 et seq.) and the corresponding
3 accessibility guidelines established under part
4 1191 of title 36, Code of Federal Regulations;
5 and

6 (B) the Americans with Disabilities Act of
7 1990 (42 U.S.C. 12101 et seq.);

8 (3) determine the feasible occupancy of each
9 such unit, and provide the methodology used to
10 make the determination;

11 (4) determine the number of individuals who
12 are full-time equivalent employees, other employees,
13 or contractors that have each such unit as a duty
14 station and determine how telework policies will im-
15 pact the usage of each such unit;

16 (5) calculate the amount of available, unused,
17 or underutilized space in each such unit;

18 (6) consider any lease terms for leased units
19 contained in the domestic office footprint, including
20 cost and effective dates for each such leased unit;
21 and

22 (7) based on the findings in paragraphs (2)
23 through (6), and any other metrics the Secretary de-
24 termines relevant, provide recommendations for opti-
25 mizing the use of units of property across the De-

1 partment in consultation with appropriate employee
2 labor representatives.

3 (c) REPORT.—Not later than 2 months after com-
4 pleting the review under subsection (a), the Secretary shall
5 submit to the Committee on Transportation and Infra-
6 structure of the House of Representatives and the Com-
7 mittee on Commerce, Science, and Transportation of the
8 Senate a final report that proposes opportunities to opti-
9 mize the domestic office footprint of the Administration
10 (and associated costs). In compiling such final report, the
11 Secretary shall describe opportunities for—

12 (1) consolidation of offices within a reasonable
13 distance from one another;

14 (2) the collocation of regional or satellite offices
15 of separate modes of the Department, including the
16 cost benefits of shared amenities; and

17 (3) the use of coworking spaces instead of per-
18 manent offices.

19 (d) DEFINITION OF DOMESTIC OFFICE FOOT-
20 PRINT.—In this section, the term “domestic office foot-
21 print” means buildings, offices, facilities, and other real
22 property rented, owned, or occupied by the Administration
23 or Department—

1 (1) in which employees report for permanent or
2 temporary duty that are not being used for active
3 operations of the air traffic control system; and

4 (2) which are located within the United States.

5 **SEC. 804. AIRCRAFT WEIGHT REDUCTION TASK FORCE.**

6 (a) IN GENERAL.—Not later than 180 days after the
7 date of enactment of this Act, the Administrator of the
8 Federal Aviation Administration shall establish a task
9 force to identify ways to safely reduce covered aircraft
10 weight for purposes of reducing fuel burn.

11 (b) COMPOSITION.—The task force established under
12 subsection (a) shall consist of not more than 20 individ-
13 uals and shall include representatives of—

14 (1) the Federal Aviation Administration;

15 (2) other Federal agencies as the Administrator
16 determines appropriate;

17 (3) air carriers;

18 (4) certified labor organizations representing
19 flight attendants at air carriers operating under part
20 121 of title 14, Code of Federal Regulations;

21 (5) certified labor organizations representing
22 aircraft maintenance technicians;

23 (6) certified labor organizations representing
24 other aviation workers, as appropriate; and

25 (7) aerospace manufacturers.

1 (c) REVIEW.—The task force established under sub-
2 section (a) shall review and evaluate—

3 (1) regulations, requirements, advisory circu-
4 lars, orders, or other such directives of the Adminis-
5 tration related to covered aircraft or covered aircraft
6 operations that may inhibit certification of new ma-
7 terials, manufacturing processes, components, or
8 technologies that could reduce aircraft weight or in-
9 crease fuel efficiency without decreasing safety;

10 (2) aspects of covered aircraft design that are
11 outdated or underutilized on the date of enactment
12 of this Act that may unnecessarily increase covered
13 aircraft weight or reduce aircraft fuel efficiency that
14 are not necessary for the safe operation of such air-
15 craft;

16 (3) novel technologies and manufacturing proc-
17 esses, including the use of advanced materials, that
18 can safely be used in the construction or modifica-
19 tion of covered aircraft, including a component or
20 the interior of such aircraft, to reduce weight or im-
21 prove fuel efficiency; and

22 (4) nonproprietary methods that air carriers
23 have used to safely decrease covered aircraft weight
24 or improve fuel efficiency.

25 (d) REPORT.—

1 (1) TASK FORCE REPORT.—

2 (A) IN GENERAL.—Not later than 3 years
3 after the establishment of the task force under
4 subsection (a), the task force shall submit a re-
5 port on the findings and results of the review
6 and evaluation conducted under subsection (c)
7 to the Administrator.

8 (B) RECOMMENDATIONS.—In submitting
9 the report required under subparagraph (A),
10 the task force shall include recommendations—

11 (i) on actions the Administrator may
12 take to updated regulations, processes, ad-
13 visory circulars, orders, or other such di-
14 rections of the Administration to enable
15 the certification of new materials, compo-
16 nents, manufacturing processes, or tech-
17 nologies that may allow for the safe reduc-
18 tion of covered aircraft weight or the im-
19 provement of fuel efficiency; and

20 (ii) on best practices for air carriers
21 and aerospace manufacturers to certify
22 such materials, components, manufac-
23 turing processes, or technologies.

24 (C) APPROXIMATION OF BENEFITS.—For
25 each recommendation made under subpara-

1 graph (B), the task force shall approximate the
2 fuel savings that could be expected if such rec-
3 ommendation was adopted.

4 (D) SUBMISSION TO CONGRESS.—Not later
5 than 3 days after receipt of the report required
6 under subparagraph (A), the Administrator
7 shall submit to the Committee on Transpor-
8 tation and Infrastructure of the House of Rep-
9 resentatives and the Committee on Commerce,
10 Science, and Transportation of the Senate the
11 report and recommendations.

12 (2) FAA REPORT.—Not later than 120 days
13 after submission of the report under paragraph (1),
14 the Administrator shall submit to the Committee on
15 Transportation and Infrastructure of the House of
16 Representatives and the Committee on Commerce,
17 Science, and Transportation of the Senate a re-
18 port—

19 (A) describing the recommendations of the
20 task force with which the Administrator fully
21 concurs, partially concurs, or does not concur;

22 (B) detailing, for the recommendations
23 with which the Administrator fully or partially
24 concurs—

1 (i) a timeline for implementing such
2 recommendations; and

3 (ii) possible benefits of using new ma-
4 terials, manufacturing processes, compo-
5 nents, or technologies, including fuel sav-
6 ings, increased capacity, or other benefits
7 as determined reasonable by the task force;
8 and

9 (C) explaining, for the recommendations
10 with which the Administrator does not concur,
11 the reason for which the Administrator will not
12 implement such recommendations.

13 (e) SUNSET.—

14 (1) IN GENERAL.—The task force established
15 under subsection (a) shall terminate upon submis-
16 sion of the report required under subsection
17 (d)(1)(A).

18 (2) EXCEPTION.—The Administrator may
19 choose to extend such task force after the submis-
20 sion of the report required under subsection
21 (d)(1)(A), if the Administrator determines that such
22 an extension would be in the public interest.

23 (f) DEFINITION.—In this section:

24 (1) AIR CARRIER.—The term “air carrier”
25 means an air carrier (as such term is defined in sec-

1 tion 40102 of title 49, United States Code) that
2 holds a certificate issued under part 121 of title 14,
3 Code of Federal Regulations.

4 (2) AIRCRAFT WEIGHT.—The term “aircraft
5 weight” means the gross weight of a covered aircraft
6 in operation.

7 (3) COVERED AIRCRAFT.—The term “covered
8 aircraft” means an aircraft that is operated by an
9 air carrier that is operating pursuant to a certificate
10 issued under part 121 of title 14, Code of Federal
11 Regulations.

12 **SEC. 805. AUDIT OF TECHNICAL WRITING RESOURCES AND**
13 **CAPABILITIES.**

14 (a) AUDIT BY INSPECTOR GENERAL.—Not later than
15 90 days after the date of enactment of this Act, the inspec-
16 tor general of the Department of Transportation shall ini-
17 tiate an audit of the technical writing resources and capa-
18 bilities of the Federal Aviation Administration as such re-
19 sources and capabilities relate to producing rulemaking,
20 policy, and guidance, to—

21 (1) determine if such resources and capabilities
22 are adequate; and

23 (2) make recommendations for improvement of
24 such resources and capabilities.

1 (b) REVIEW.—In conducting the review required
2 under subsection (a), the inspector general shall evaluate
3 the technical writing resources and capabilities of the Ad-
4 ministration in each line of business of the Administration,
5 the Office of Policy, International Affairs, and Environ-
6 ment, and the Office of the Chief Counsel, including by
7 reviewing—

8 (1) the process and resources required to
9 produce initial drafts of rulemaking, policy, and
10 guidance documents;

11 (2) the quality of such initial drafts;

12 (3) the amount of edits that are required
13 throughout the production of rulemaking, policy, and
14 guidance documents;

15 (4) writing support and education tools pro-
16 vided to engineers, managers, and other technical
17 staff of the Administration involved in writing or ed-
18 iting such documents; and

19 (5) whether—

20 (A) the Administration has and adheres to
21 best practices for the drafting of rulemaking,
22 policy, and guidance documents; and

23 (B) such best practices are—

1 (i) easily accessible and understand-
2 able by employees of the Administration;
3 and

4 (ii) reflect modern writing conven-
5 tions.

6 (c) RECOMMENDATIONS.—In making the rec-
7 ommendations required under subsection (a)(2), the in-
8 spector general shall make recommendations to the Ad-
9 ministrator of the Federal Aviation Administration on how
10 to improve the quality of written rulemaking, policy, and
11 guidance documents and the speed at which such docu-
12 ments can be produced, internally reviewed, and approved.

13 (d) DECONFLICTING SCOPE.—The inspector general
14 shall ensure that the audit required under subsection (a)
15 does not duplicate the evaluation required under section
16 125, except to the extent that duplication is necessary to
17 fully evaluate the technical writing resources and capabili-
18 ties of the Administration.

19 (e) REPORT.—Not later than 1 year after the inspec-
20 tor general initiates the audit under subsection (a), the
21 inspector general shall submit to the Committee on Trans-
22 portation and Infrastructure of the House of Representa-
23 tives and the Committee on Commerce, Science, and
24 Transportation of the Senate a report on the results of
25 the audit, including findings and recommendations.

1 **SEC. 806. FAA PARTICIPATION IN INDUSTRY STANDARDS**
2 **ORGANIZATIONS.**

3 (a) IN GENERAL.—The Administrator of the Federal
4 Aviation Administration shall ensure the participation of
5 employees of the Administration in the activities of recog-
6 nized industry standards organizations to advance the
7 adoption, reference, and acceptance rate of standards and
8 means of compliance developed by such organizations by
9 the Administrator.

10 (b) PARTICIPATION.—An employee directed by the
11 Administrator to participate in a working group, task
12 group, committee, or similar body of a recognized industry
13 standards organization shall—

14 (1) actively participate in the discussions and
15 work of such organization;

16 (2) accurately represent the position of the Ad-
17 ministration on the subject matter of such discus-
18 sions and work;

19 (3) contribute to the development of work prod-
20 ucts of such organization, unless determined to be
21 inappropriate by such organization;

22 (4) make reasonable efforts to identify and
23 make any concerns of the Administration relating to
24 such work products known to such organization, in-
25 cluding through providing formal comments, as may

1 be allowed for under the procedures of such organi-
2 zation;

3 (5) provide regular updates to other Adminis-
4 tration employees and management on the progress
5 of such work products; and

6 (6) seek advice and input from other Adminis-
7 tration employees and management, as needed.

8 (c) INVITATIONS.—

9 (1) IN GENERAL.—The Administrator may ac-
10 cept an invitation to participate in and contribute to
11 the work of a recognized industry standards organi-
12 zation as described in subsection (b).

13 (2) DECLINATION OF INVITATION.—If the Ad-
14 ministrator declines an invitation described in para-
15 graph (1), the Administrator shall provide—

16 (A) the recognized industry standards or-
17 ganization a written response to the invitation
18 that articulates the reasons for declining the in-
19 vitation; and

20 (B) a copy of such written response to the
21 Committee on Transportation and Infrastruc-
22 ture of the House of Representatives and the
23 Committee on Commerce, Science, and Trans-
24 portation of the Senate not later than 5 days

1 after providing the response to such organiza-
2 tion under subparagraph (A).

3 (d) **RECOGNIZED INDUSTRY STANDARDS ORGANIZA-**
4 **TION DEFINED.**—In this section, the term “recognized in-
5 dustry standards organization” means a domestic or inter-
6 national organization that—

7 (1) uses agreed upon procedures to develop
8 aviation-related industry standards or means of com-
9 pliance, particularly standards or means of compli-
10 ance that satisfy Administration requirements or
11 guidance;

12 (2) is comprised of members of the public, in-
13 cluding subject matter experts, industry representa-
14 tives, academics and researchers, and government
15 employees; and

16 (3) has had at least one standard or means of
17 compliance accepted by the Administrator or ref-
18 erenced in guidance material or a regulation issued
19 by the Federal Aviation Administration after the
20 date of enactment of the Vision 100—Century of
21 Aviation Reauthorization Act (Public Law 108–176).

22 **SEC. 807. SENSE OF CONGRESS ON USE OF VOLUNTARY**
23 **CONSENSUS STANDARDS.**

24 It is the sense of Congress that the Administrator
25 of the Federal Aviation Administration should make every

1 effort to abide by the policies set forth in the Office of
2 Management and Budget Circular A–119, titled “Federal
3 Participation in the Development and Use of Voluntary
4 Consensus Standards and Conformity Assessment Activi-
5 ties”.

6 **SEC. 808. REQUIRED DESIGNATION.**

7 The Administrator of the Federal Aviation Adminis-
8 tration shall designate any aviation rulemaking committee
9 convened under this Act pursuant to section 106(p)(5) of
10 title 49, United States Code.

11 **SEC. 809. SENSITIVE SECURITY INFORMATION.**

12 (a) IN GENERAL.—Chapter 401 of title 49, United
13 States Code, is amended by inserting after section 40118
14 the following:

15 **“§ 40119. Sensitive security information**

16 “(a) IN GENERAL.—Notwithstanding section 552 of
17 title 5, the Secretary of Transportation shall issue regula-
18 tions prohibiting the disclosure of information obtained or
19 developed in the process of ensuring security under this
20 title if the Secretary determines that disclosing the infor-
21 mation would—

22 “(1) be an unwarranted invasion of personal
23 privacy;

24 “(2) reveal a trade secret or privileged or con-
25 fidential commercial or financial information; or

1 “(3) be detrimental to transportation safety.

2 “(b) WITHHELD INFORMATION.—In carrying out
3 subsection (a), the Secretary shall ensure that the prohibi-
4 tions described in such subsection do not apply to any in-
5 formation provided to a committee of Congress authorized
6 to have such information, including the Committee on
7 Transportation and Infrastructure and the Committee on
8 Science, Space, and Technology of the House of Rep-
9 resentatives and the Committee on Commerce, Science,
10 and Transportation of the Senate.

11 “(c) RULE OF CONSTRUCTION.—Nothing in sub-
12 section (a) shall be construed to authorize the designation
13 of information as sensitive security information (as de-
14 fined in section 15.5 of title 49, Code of Federal Regula-
15 tions) to—

16 “(1) conceal—

17 “(A) a violation of law;

18 “(B) inefficiency; or

19 “(C) an administrative error;

20 “(2) prevent embarrassment to a person, orga-
21 nization, or governmental agency;

22 “(3) restrain competition; or

23 “(4) prevent or delay the release of information
24 that does not require protection in the interest of
25 transportation security, including basic scientific re-

1 search information not clearly related to transpor-
2 tation security.

3 “(d) NONDISCLOSURE.—Section 552a of title 5 shall
4 not apply to disclosures that the Administrator of the Fed-
5 eral Aviation Administration may make from the systems
6 of records of the Administration to any Federal law en-
7 forcement, intelligence, protective service, immigration, or
8 national security official in order to assist the official re-
9 ceiving the information in the performance of official du-
10 ties.”.

11 (b) CLERICAL AMENDMENT.—The analysis for chap-
12 ter 401 of title 49, United States Code, is amended by
13 striking the item related to section 40119 and inserting
14 the following:

“40119. Sensitive security information.”.

15 **SEC. 810. PRESERVING OPEN SKIES WHILE ENSURING FAIR**
16 **SKIES.**

17 (a) ADDITION OF LABOR STANDARDS.—Section
18 40101 of title 49, United States Code, is amended—

19 (1) in subsection (a) by adding at the end the
20 following:

3 (b) UPDATE TO FOREIGN AIR CARRIER PERMITS.—
4 Section 41302(2)(B) of title 49, United States Code, is
5 amended by striking “the foreign air transportation” and
6 inserting “after considering the totality of the cir-
7 cumstances, including the matters described in section
8 40101(a), the foreign air transportation”.

9 (c) SAVINGS CLAUSE.—Nothing in this section, or
10 the amendments made by this section, shall be construed
11 to affect the validity of a foreign air carrier permit held,
12 or air transport agreement in place, on the date of enact-
13 ment of this Act.

14 **SEC. 811. COMMERCIAL PREFERENCE.**

15 Section 40110(d) of title 49, United States Code, is
16 further amended—

17 (1) in paragraph (1) by striking “and imple-
18 ment” and inserting “, implement, and periodically
19 update”;

20 (2) in paragraph (2) by striking “the new ac-
21 quisition management system developed and imple-
22 mented” and inserting “the acquisition management
23 system developed, implemented, and periodically up-
24 dated” each place it appears;

25 (3) in paragraph (3)—

1 (A) in the matter preceding subparagraph

2 (A)—

3 (i) by striking “new”; and

4 (ii) by striking “and implemented”

5 and inserting “, implemented, and periodi-

6 cally updated”; and

7 (B) in subparagraph (B) by striking

8 “Within” and all that follows through “the Ad-

9 ministrator” and inserting “The Adminis-

10 trator”;

11 (4) by redesignating paragraph (4) as para-

12 graph (5); and

13 (5) by inserting after paragraph (3) the fol-

14 lowing:

15 “(4) COMMERCIAL PRODUCTS AND SERVICES.—

16 In implementing and updating the acquisition man-

17 agement system pursuant to paragraph (1), the Ad-

18 ministrator shall, whenever possible—

19 “(A) describe the requirements with re-

20 spect to a solicitation for the procurement of

21 supplies or services in terms of—

22 “(i) functions to be performed;

23 “(ii) performance required; or

24 “(iii) essential physical and system

25 characteristics;

1 “(B) ensure that commercial services or
2 commercial products may be procured to fulfill
3 such solicitation, or to the extent that commer-
4 cial products suitable to meet the needs of the
5 Administration are not available, ensure that
6 nondevelopmental items other than commercial
7 products may be procured to fulfill such solici-
8 tation;

9 “(C) provide offerors of commercial serv-
10 ices, commercial products, and nondevelop-
11 mental items other than commercial products
12 an opportunity to compete in any solicitation
13 for the procurement of supplies or services;

14 “(D) revise the procurement policies, prac-
15 tices, and procedures of the Administration to
16 reduce any impediments to the acquisition of
17 commercial products and commercial services;
18 and

19 “(E) ensure that procurement officials—

20 “(i) acquire commercial services, com-
21 mercial products, or nondevelopmental
22 items other than commercial products to
23 meet the needs of the Administration;

24 “(ii) in a solicitation for the procure-
25 ment of supplies or services, state the spec-

1 ifications for such supplies or services in
2 terms that enable and encourage bidders
3 and offerors to supply commercial services
4 or commercial products, or to the extent
5 that commercial products suitable to meet
6 the needs of the Administration are not
7 available, to supply nondevelopmental
8 items other than commercial products;

9 “(iii) require that prime contractors
10 and subcontractors at all levels under con-
11 tracts with the Administration incorporate
12 commercial services, commercial products,
13 or nondevelopmental items other than com-
14 mercial products as components of items
15 supplied to the Administration;

16 “(iv) modify procurement require-
17 ments in appropriate circumstances to en-
18 sure that such requirements can be met by
19 commercial services or commercial prod-
20 ucts, or to the extent that commercial
21 products suitable to meet the needs of the
22 Administration are not available, non-
23 developmental items other than commercial
24 products; and

1 “(v) require training of appropriate
2 personnel in the acquisition of commercial
3 products and commercial services.”.

4 **SEC. 812. CONSIDERATION OF THIRD-PARTY SERVICES.**

5 (a) PLANS AND POLICY.—Section 44501 of title 49,
6 United States Code, is amended—

7 (1) in subsection (a) by striking “development
8 and location of air navigation facilities” and insert-
9 ing “development of air navigation facilities and
10 services”; and

11 (2) in subsection (b)—

12 (A) by striking “and development” and in-
13 serting “procurement, and development” each
14 place it appears;

15 (B) by striking “facilities and equipment”
16 and inserting “facilities, services, and equip-
17 ment”;

18 (C) by striking “first and 2d years” and
19 inserting “first and second years”;

20 (D) by striking “subclauses (A) and (B) of
21 this clause” and inserting “subparagraphs (A)
22 and (B)”;

23 (E) by striking “the 3d, 4th, and 5th” and
24 inserting “the third, fourth, and fifth”;

1 (F) by striking “systems and facilities”
2 and inserting “systems, services, and facilities”;
3 and

4 (G) by striking “growth of aviation” and
5 inserting “growth of the aerospace industry”.

6 (b) SYSTEMS, PROCEDURES, FACILITIES, AND DE-
7 VICES.—Section 44505 of title 49, United States Code,
8 is amended—

9 (1) in subsection (a)—

10 (A) by striking “develop, alter” and insert-
11 ing “develop when necessary, alter”; and

12 (B) by striking “and devices” and insert-
13 ing “services, and devices” each place it ap-
14 pears; and

15 (2) in subsection (b) by striking “develop dy-
16 namic simulation models” and inserting “develop or
17 procure dynamic simulation models and tools” each
18 place it appears.

19 **SEC. 813. CERTIFICATES OF AUTHORIZATION OR WAIVER.**

20 (a) IN GENERAL.—Notwithstanding any other provi-
21 sion of law, the Secretary of Transportation, acting
22 through the Administrator of the Federal Aviation Admin-
23 istration, may issue a certificate of authorization or waiver
24 to a person to operate an aircraft within an area covered
25 by a temporary flight restriction under such conditions as

1 the Administrator may prescribe, except for airspace that
2 is subject to a permanent, continuous flight restriction,
3 unless the authorization or waiver is issued to, or with
4 the concurrence of, the entity for which the flight restric-
5 tion was created.

6 (b) SPECIAL CONSIDERATIONS.—If a temporary
7 flight restriction is related to a sporting event and issued
8 pursuant to section 352 of the Consolidated Appropria-
9 tions Resolution, 2003 (Public Law 108–7), the conditions
10 prescribed by the Administrator under subsection (a) shall
11 include the following:

12 (1) A minimum distance from the center of the
13 temporary flight restriction, which shall not be
14 greater than 0.75 nautical miles, unless the Admin-
15 istrator determines, on a case by case basis, that
16 such mileage is insufficient to maintain public safe-
17 ty.

18 (2) The person may not operate an aircraft (ex-
19 cept for a purpose described under section 352(a)(3)
20 of the Consolidated Appropriations Resolution, 2003
21 (Public Law 108–7)) for a purpose that the Sec-
22 retary determines is directly related to the event for
23 which the temporary flight restriction is active.

24 (c) EXCEPTION.—Subsection (b)(1) shall not apply to
25 aircraft operations associated with an aviation event or

1 airshow for which the Administrator has granted a certifi-
2 cate of authorization or waiver.

3 (d) BRIEFING.—Not later than 18 months after the
4 date of enactment of this Act, the Secretary shall brief
5 the Committee on Transportation and Infrastructure of
6 the House of Representatives and the Committee on Com-
7 merce, Science, and Transportation of the Senate on the
8 implementation of this section, including the number and
9 nature of certificates of authorization or waiver that have
10 been issued under subsection (a) subject to restrictions
11 under subsection (b).

12 (e) OPERATIONAL PURPOSES.—Section 352(a)(3)(B)
13 of Consolidated Appropriations Resolution, 2003 (Public
14 Law 108–7) is amended by inserting “(or attendees ap-
15 proved by)” after “guests”.

16 (f) SUNSET.—Subsection (b) shall cease to have ef-
17 fect on October 1, 2028.

18 **SEC. 814. WING-IN-GROUND-EFFECT CRAFT.**

19 (a) MEMORANDUM OF UNDERSTANDING.—

20 (1) IN GENERAL.—Not later than 24 months
21 after the date of enactment of this Act, the Adminis-
22 trator of the Federal Aviation Administration and
23 the Commandant of the Coast Guard shall execute
24 a memorandum of understanding governing the spe-
25 cific roles, delineations of responsibilities, resources,

1 and commitments of the Federal Aviation Adminis-
2 tration and the Coast Guard, respectively, pertaining
3 to wing-in-ground-effect craft that are—

4 (A) only capable of operating either in
5 water or in ground effect over water; and

6 (B) operated exclusively over waters sub-
7 ject to the jurisdiction of the United States.

8 (2) CONTENTS.—The memorandum of under-
9 standing described in paragraph (1) shall—

10 (A) cover the processes the Federal Avia-
11 tion Administration and the United States
12 Coast Guard will follow to promote communica-
13 tions, efficiency, and nonduplication of effort in
14 carrying out such memorandum of under-
15 standing;

16 (B) account for the special rule in accord-
17 ance with subsection (b); and

18 (C) provide procedures for, at a minimum,
19 the following:

20 (i) Approval of wing-in-ground-effect
21 craft designs.

22 (ii) Operations of wing-in-ground-ef-
23 fect craft.

24 (iii) Pilotage of wing-in-ground-effect
25 craft.

1 (iv) Inspections of wing-in-ground-ef-
2 fect craft.

3 (v) Maintenance of wing-in-ground-ef-
4 fect craft.

5 (b) SPECIAL RULE PROHIBITING SECRETARY FROM
6 REGULATING CERTAIN WIG CRAFT OPERATORS AS AIR
7 CARRIERS.—Notwithstanding any other provision of law
8 or regulation, the Secretary of Transportation may not
9 regulate an operator of a wing-in-ground-effect craft as
10 an air carrier (as such term is defined in section 40102(a)
11 of title 49, United States Code).

12 (c) RULE OF CONSTRUCTION.—Nothing in this sec-
13 tion shall be construed to—

14 (1) limit the authority of the Secretary or the
15 Administrator to regulate aircraft that are not wing-
16 in-ground-effect craft, including aircraft that are—

17 (A) capable of the operations described in
18 subsection (d); and

19 (B) capable of sustained flight out of
20 ground effect;

21 (2) confer upon the Commandant the authority
22 to determine the impact of any civil aircraft oper-
23 ation on the safety or efficiency of the National Air-
24 space System; or

1 (3) confer upon the Administrator the authority
2 to issue a certificate of documentation, with or with-
3 out a registry, fishery or coastwise endorsement, for,
4 or inspect any vessel as that term is defined in sec-
5 tion 115 of title 46, United States Code.

6 (d) WING-IN-GROUND-EFFECT CRAFT DEFINED.—In
7 this section, the term “wing-in-ground-effect craft” means
8 a craft that is capable of operating completely above the
9 surface of the water on a dynamic air cushion created by
10 aerodynamic lift due to the ground effect between the craft
11 and the surface of the water.

12 **SEC. 815. QUASQUICENTENNIAL OF AVIATION.**

13 (a) FINDINGS.—Congress finds the following:

14 (1) December 17, 2028, is the 125th anniver-
15 sary of the first successful manned, free, controlled,
16 and sustained flight by an aircraft.

17 (2) The first flight by Orville and Wilbur
18 Wright in Kitty Hawk, North Carolina, is a defining
19 moment in the history of the United States and the
20 world.

21 (3) The Wright brothers’ achievement is a tes-
22 tament to their ingenuity, perseverance, and commit-
23 ment to innovation, which has inspired generations
24 of aviators and scientists alike.

1 (4) The advent of aviation and the air transpor-
2 tation industry has fundamentally transformed the
3 United States and the world for the better.

4 (5) The 125th anniversary of the Wright broth-
5 ers' first flight is worthy of recognition and celebra-
6 tion to honor their legacy and to inspire a new gen-
7 eration of Americans as aviation reaches an inflec-
8 tion point of innovation and change.

9 (b) SENSE OF CONGRESS.—It is the sense of Con-
10 gress that the Secretary of Transportation, the Adminis-
11 trator of the Federal Aviation Administration, and the
12 heads of other appropriate Federal agencies should facili-
13 tate and participate in local, national, and international
14 observances and activities that commemorate and cele-
15 brate the 125th anniversary of powered flight.

16 **SEC. 816. FEDERAL CONTRACT TOWER WAGE DETERMINA-**
17 **TIONS AND POSITIONS.**

18 The Secretary of Transportation shall request that
19 the Secretary of Labor—

20 (1) review and update, as necessary, including
21 to account for cost-of-living adjustments, the basis
22 for the wage determination for air traffic controllers
23 who are employed at air traffic control towers oper-
24 ated under the Contract Tower Program established
25 under section 47124 of title 49, United States Code;

1 (2) create a new wage determination category
2 or occupation code for managers of air traffic con-
3 trollers who are employed at air traffic control tow-
4 ers in the Contract Tower Program; and

5 (3) consult with the Administrator of the Fed-
6 eral Aviation Administration in carrying out the re-
7 quirements of paragraphs (1) and (2).

8 **SEC. 817. INTERNAL PROCESS IMPROVEMENTS REVIEW.**

9 (a) IN GENERAL.—Not later than 180 days after the
10 date of enactment of this Act, the inspector general of the
11 Department of Transportation shall review the coordina-
12 tion and approval processes of non-regulatory materials
13 produced by the Federal Aviation Administration to im-
14 prove the timeliness, transparency, development, and
15 issuance of such materials.

16 (b) CONTENTS OF REVIEW.—In conducting the re-
17 view under subsection (a), the inspector general shall—

18 (1) provide recommendations for improving
19 processes and eliminating nonvalue-added reviews of
20 non-regulatory materials within the Federal Aviation
21 Administration and Department of Transportation,
22 in consideration of the authority of the Adminis-
23 trator under section 106 of title 49, United States
24 Code, and other applicable laws;

1 (2) consider, with respect to each office within
2 the Federal Aviation Administration and the Depart-
3 ment of Transportation that reviews non-regulatory
4 materials—

5 (A) the timeline assigned to each such of-
6 fice to complete the review of such materials;

7 (B) the actual time spent for such review;
8 and

9 (C) opportunities to reduce the actual time
10 spent for such review;

11 (3) describe any organizational changes and ad-
12 ditional resources that the Administration needs, if
13 necessary, to reduce delays in the development and
14 publication of proposed non-regulatory materials;

15 (4) consider to what extent reporting mecha-
16 nisms and templates could be used to provide the
17 public with more consistent information on the de-
18 velopment status of non-regulatory materials;

19 (5) consider changes to the application of rules
20 governing ex parte communications by the Adminis-
21 trator to provide flexibility for employees of the Ad-
22 ministration to discuss non-regulatory materials with
23 aviation stakeholders and foreign aviation authorities
24 to promote United States aviation leadership;

1 (6) recommend methods by which the Adminis-
2 tration can incorporate standards set by recognized
3 industry standards organizations, as such term is
4 defined in section 806, into non-regulatory materials
5 to keep pace with rapid changes in aerospace tech-
6 nology and processes; and

7 (7) evaluate the processes and best practices
8 other civil aviation authorities and other Federal de-
9 partments and agencies use to produce non-regu-
10 latory materials, particularly the processes of enti-
11 ties that produce such materials in an expedited
12 fashion to respond to safety risks, incidents, or new
13 technology adoption.

14 (c) CONSULTATION.—In conducting the review under
15 subsection (a), the inspector general may, as appropriate,
16 consult with industry stakeholders, academia, and other
17 individuals with relevant background or expertise in im-
18 proving the efficiency of Federal non-regulatory material
19 production.

20 (d) REPORT.—Not later than 1 year after the inspec-
21 tor general initiates the review under subsection (a), the
22 inspector general shall submit to the Administrator a re-
23 port on such review.

24 (e) ACTION PLAN.—

1 (1) IN GENERAL.—The Administrator shall de-
2 velop an action plan to implement the recommenda-
3 tions contained in the report submitted under sub-
4 section (d).

5 (2) BRIEFING.—Not later than 90 days after
6 receiving the report under subsection (d), the Ad-
7 ministrator shall brief the Committee on Transpor-
8 tation and Infrastructure and the Committee on
9 Science, Space, and Technology of the House of
10 Representatives and the Committee on Commerce,
11 Science, and Transportation of the Senate on such
12 plan.

13 (f) NON-REGULATORY MATERIALS DEFINED.—In
14 this section, the term “non-regulatory materials” means
15 orders, advisory circulars, statements of policy, guidance,
16 technical standards, and other materials related to avia-
17 tion safety, training, and operation of aeronautical prod-
18 ucts.

19 **SEC. 818. ACCEPTANCE OF DIGITAL DRIVER'S LICENSE AND**
20 **IDENTIFICATION CARDS.**

21 The Administrator of the Federal Aviation Adminis-
22 tration shall take such actions as may be necessary to ac-
23 cept, in any instance where an individual is required to
24 submit government-issued identification to the Adminis-

1 trator, a digital or mobile driver’s license or identification
2 card issued to such individual by a State.

3 **SEC. 819. BUCKEYE 940 RELEASE OF DEED RESTRICTIONS.**

4 (a) PURPOSE.—The purpose of this section is to au-
5 thorize the Secretary to issue a Deed of Release from all
6 terms, conditions, reservations, restrictions, and obliga-
7 tions contained in the Quitclaim Deed and permit the
8 State of Arizona to deposit all proceeds of the disposition
9 of Buckeye 940 in the appropriate fund for the benefit
10 of the beneficiaries of the Arizona State Land Trust.

11 (b) DEFINITIONS.—In this section:

12 (1) BUCKEYE 940.—The term “Buckeye 940”
13 means all of section 12, T.1 N., R.3 W. and all of
14 adjoining fractional section 7, T.1 N., R.2 W., Gila
15 and Salt River Meridian, Arizona, which property
16 was the subject of the Quitclaim Deed between the
17 United States and the State of Arizona, dated July
18 11, 1949, and which is currently owned by the State
19 of Arizona and held in trust for the beneficiaries of
20 the Arizona State Land Trust.

21 (2) QUITCLAIM DEED.—The term “Quitclaim
22 Deed” means the Quitclaim Deed between the
23 United States and the State of Arizona, dated July
24 11, 1949.

1 (3) SECRETARY.—The term “Secretary” means
2 the Secretary of Transportation.

3 (c) RELEASE OF ANY AND ALL INTEREST IN BUCK-
4 EYE 940.—

5 (1) IN GENERAL.—Notwithstanding any other
6 provision of law, the United States, acting through
7 the Secretary, shall issue to the State of Arizona a
8 Deed of Release to release all terms, conditions, res-
9 ervations, restrictions, and obligations contained in
10 the Quitclaim Deed, including any and all rever-
11 sionary interest of the United States in Buckeye
12 940.

13 (2) TERMS AND CONDITIONS.—The Deed of
14 Release described in paragraph (1) shall be subject
15 to such additional terms and conditions, consistent
16 with such paragraph, as the Secretary considers ap-
17 propriate to protect the interests of the United
18 States.

19 (3) NO RESTRICTION ON USE OF PROCEEDS.—
20 Notwithstanding any other provision of law, the
21 State of Arizona may dispose of Buckeye 940 and
22 any proceeds thereof, including proceeds already col-
23 lected by the State and held in a suspense account,
24 without regard to any restriction imposed by the

1 Quitclaim Deed or by section 155.7 of title 14, Code
2 of Federal Regulations.

3 (4) MINERAL RESERVATION.—The Deed of Re-
4 lease described in paragraph (1) shall include the re-
5 lease of all interests of the United States to the min-
6 eral rights on Buckeye 940 included in the Quit-
7 claim Deed.

8 **SEC. 820. FEDERAL AVIATION ADMINISTRATION INFORMA-**
9 **TION TECHNOLOGY SYSTEM INTEGRITY.**

10 (a) IN GENERAL.—Not later than 180 days after the
11 date of enactment of this Act, the Administrator of the
12 Federal Aviation Administration shall initiate a review to
13 identify and address aging information technology systems
14 within the Administration.

15 (b) CONTENTS.—The review required under sub-
16 section (a) shall—

17 (1) identify and inventory critical software and
18 hardware systems of the Administration;

19 (2) assess the vulnerabilities of such systems to
20 degradation, errors (including human errors), and
21 malicious attacks (including cyber attacks); and

22 (3) identify upgrades to, or replacements for,
23 such systems that are necessary to mitigate such
24 vulnerabilities.

1 (c) MITIGATION.—The Administrator shall take such
2 action as may be necessary to mitigate the vulnerabilities
3 identified under the review conducted under subsection
4 (a).

5 (d) LEVERAGING EXTERNAL EXPERTISE.—To the
6 maximum extent practicable, the actions carried out pur-
7 suant to this section shall—

8 (1) be consistent with the acquisition manage-
9 ment system established and updated pursuant to
10 section 40110(d) of title 49, United States Code;

11 (2) incorporate input from industry, academia,
12 or other external experts on information technology;
13 and

14 (3) identify technologies in existence or in de-
15 velopment that, with or without adaptation, are ex-
16 pected to be suitable to meet the technical informa-
17 tion technology needs of the Administration.

18 (e) REPORT.—Not later than 2 years after the date
19 of enactment of this Act, the Administrator shall submit
20 to the Committee on Transportation and Infrastructure
21 of the House of Representatives and the Committee on
22 Commerce, Science, and Transportation of the Senate a
23 report detailing the results of the review required under
24 subsection (a).

25 (f) INSPECTOR GENERAL REVIEW.—

1 (1) IN GENERAL.—After the Administrator
2 completes the review under subsection (a), the in-
3 spector general of the Department of Transportation
4 shall conduct an audit of the integrity of the infor-
5 mation technology systems of the Administration
6 and assess the efforts of the Administration to ad-
7 dress the Administration’s aging information tech-
8 nology systems.

9 (2) REPORT.—The inspector general shall sub-
10 mit to the Committee on Transportation and Infra-
11 structure of the House of Representatives and the
12 Committee on Commerce, Science, and Transpor-
13 tation of the Senate a report on the results of the
14 audit carried out under this subsection.

15 **SEC. 821. BRIEFING ON RADIO COMMUNICATIONS COV-**
16 **ERAGE AROUND MOUNTAINOUS TERRAIN.**

17 (a) BRIEFING REQUIREMENT.—Not later than 180
18 days after the date of enactment of this Act, the Adminis-
19 trator of the Federal Aviation Administration shall provide
20 to the Committee on Transportation and Infrastructure
21 of the House of Representatives and the Committee on
22 Commerce, Science, and Transportation of the Senate a
23 briefing on the radio communications coverage within the
24 airspace surrounding the Mena Intermountain Municipal
25 Airport in Mena, Arkansas.

1 (b) BRIEFING CONTENTS.—The briefing required
2 under subsection (a) shall include the following:

3 (1) The radio communications coverage within
4 the airspace surrounding the Mena Intermountain
5 Municipal Airport with the applicable Air Route
6 Traffic Control Center.

7 (2) The altitudes at which radio communica-
8 tions capabilities are lost within such airspace.

9 (3) Recommendations on changes that may in-
10 crease radio communications coverage below 4,000
11 feet above ground level within such airspace.

12 **SEC. 822. STUDY ON CONGESTED AIRSPACE.**

13 (a) STUDY.—Not later than 180 days after the date
14 of enactment of this Act, the Comptroller General of the
15 United States shall initiate a study on the efficiency and
16 efficacy of scheduled commercial air service transiting con-
17 gested airspace.

18 (b) CONTENTS.—In carrying out the study required
19 under subsection (a), the Comptroller General shall exam-
20 ine—

21 (1) various regions of congested airspace and
22 the differing factors of such regions;

23 (2) commercial air service;

24 (3) military flight activity;

25 (4) emergency response activity;

1 (5) commercial space launch and reentry activi-
2 ties;

3 (6) weather; and

4 (7) air traffic controller staffing.

5 (c) REPORT.—Not later than 18 months after the
6 date of enactment of this Act, the Comptroller General
7 shall submit to the Committee on Transportation and In-
8 frastructure of the House of Representatives and the Com-
9 mittee on Commerce, Science, and Transportation of the
10 Senate a report on the results of the study and rec-
11 ommendations to reduce the impacts to scheduled air serv-
12 ice transiting congested airspace.

13 **SEC. 823. ADMINISTRATIVE SERVICES FRANCHISE FUND.**

14 Title I of the Department of Transportation and Re-
15 lated Agencies Appropriations Act, 1997 (49 U.S.C.
16 40113 note) is amended under the heading “Administra-
17 tive Services Franchise Fund” by striking “shall be paid
18 in advance” and inserting “may be reimbursed after per-
19 formance or paid in advance”.

2 causes a transportation sexual assault or harassment

15 consider—

16 (1) a safe, standardized process for acceptance,
17 handling, management, and transportation of an
18 organ in the cabin of such aircraft; and

19 (2) protocols to ensure the safe and timely
20 transport of an organ in the cabin of such aircraft,
21 including through connecting flights.

22 (d) RECOMMENDATIONS.—Not later than 1 year
23 after the convening of the working group, such working
24 group shall submit to the Secretary a report containing

1 recommendations for the best practices described in sub-
2 section (a).

3 (e) DEFINITION OF ORGAN.—In this section, the
4 term “organ”—

5 (1) has the meaning given such term in section
6 121.2 of title 42, Code of Federal Regulations; and

7 (2) includes organ-related tissue.

8 **SEC. 835. REPORT ON APPLICATION APPROVAL TIMING.**

9 Not later than 120 days after the date of enactment
10 of this Act, the Administrator of the Federal Aviation Ad-

3 for physical expansion.

4 (2) Key historical statistics for passenger, cargo
5 volumes, including freight, express, and mail cargo,
6 and operations, including statistics distinguishing
7 between passenger and freight operations.

8 (3) A description of air cargo facilities, includ-
9 ing the age and condition of such facilities and the
10 square footage and configuration of the landside and
11 airside infrastructure of such facilities, and cargo
12 buildings.

13 (4) The projected square footage deficit of the
14 cargo facilities and infrastructure described in para-
15 graph (3).

16 (5) The projected requirements and square
17 footage deficit for air cargo support facilities.

18 (6) The general physical and operating issues
19 and constraints associated with air cargo operations.

20 (7) A description of delays in truck bays associ-
21 ated with the infrastructure and critical landside
22 issues, including truck maneuvering and queuing
23 and parking for employees and customers.

24 (8) The estimated cost of developing new cargo
25 facilities and infrastructure, including the identifica-

1 tion of percentages for development with a return on
2 investment and without a return on investment.

3 (9) The projected leasing costs to tenants per
4 square foot with and without Federal funding of the
5 non-return on investment allocation.

6 (10) A description of customs and general staff-
7 ing issues associated with air cargo operations and
8 the impacts of such issues on service.

9 (11) An assessment of the impact, cost, and es-
10 timated cost savings of using modern comprehensive
11 communications and technology systems in air cargo
12 operations.

13 (12) A description of the impact of Federal reg-
14 ulations and local enforcement of interdiction and
15 facilitation policies on throughput.

16 (c) REPORT.—The Comptroller General shall submit
17 to the Committee on Transportation and Infrastructure
18 of the House of Representatives and the Committee on
19 Commerce, Science, and Transportation of the Senate the
20 results of the study carried out under this section.

21 **SEC. 837. NEXT GENERATION RADIO ALTIMETERS.**

22 (a) IN GENERAL.—Not later than 60 days after the
23 date of enactment of this Act, the Administrator of the
24 Federal Aviation Administration, in coordination with in-
25 dustry and other relevant government stakeholders, shall

1 carry out an accelerated program to assist with the devel-
2 opment, testing, and certification of the standards and
3 technology necessary to ensure industry and the Adminis-
4 tration can certify, produce and meet the installation re-
5 quirements for next generation radio altimeters across all
6 necessary aircraft by January 1, 2028.

7 (b) GRANT PROGRAM.—The Administrator may
8 award grants for the purposes of research and develop-
9 ment, testing, and other activities necessary to ensure that
10 next generation radio altimeter technology is developed,
11 tested, certified, and installed on necessary aircraft by
12 2028, including through public-private partnership grants
13 (which shall include protections for necessary intellectual
14 property with respect to any private sector entity testing,
15 certifying, or producing next generation radio altimeters
16 under the program carried out under this section) with
17 industry to ensure the accelerated production and installa-
18 tion by January 1, 2028.

19 (c) REVIEW AND REPORT.—Not later than 180 days
20 after the enactment of this Act, the Administrator shall
21 submit to the Committee on Transportation and Infra-
22 structure of the House of Representatives and the Com-
23 mittee on Commerce, Science, and Transportation of the
24 Senate a report on the steps the Administrator has taken
25 as of the date on which such report is submitted and any

1 actions the Administrator plans to take, including as part
2 of the program carried out under this section, to ensure
3 that next generation radio altimeter technology is devel-
4 oped, tested, certified, and installed by 2028.

5 **SEC. 838. SENSE OF CONGRESS REGARDING SAFETY AND**
6 **SECURITY OF AVIATION INFRASTRUCTURE.**

7 It is the sense of Congress that aviation provides es-
8 sential services critical to the United States economy and
9 that it is important to ensure the safety and security of
10 aviation infrastructure and protect such infrastructure
11 from unlawful breaches with appropriate legal safeguards.

14 Notwithstanding any other provision of law, the Ad-
15 ministrator of the Federal Aviation Administration shall
16 have sole jurisdiction over the maintenance and operations
17 of aircraft owned by civilian operators and type-certifi-

20 **SEC. 840. REPORT ON TELEWORK.**

21 Not later than 120 days after the date of the enact-
22 ment of this Act, the Secretary of Transportation shall
23 submit to the Committee on Transportation and Infra-
24 structure of the House of Representatives, the Committee
25 on Commerce, Science, and Transportation of the Senate,

1 and the Committees on Appropriations of the Senate and
2 the House of Representatives a detailed report on any di-
3 rect and indirect costs and inefficiencies associated with
4 COVID-era telework policies at the Federal Aviation Ad-
5 ministration.

6 **SEC. 841. CREWMEMBER PUMPING GUIDANCE.**

7 (a) IN GENERAL.—Not later than 180 days after the
8 date of enactment of this Act, the Administrator of the
9 Federal Aviation Administration shall issue guidance to
10 part 121 air carriers relating to the expression of milk
11 by crewmembers on an aircraft during noncritical phases
12 of flight, consistent with the performance of the crew-
13 member’s duties aboard the aircraft. The guidance shall
14 be equally applicable to any lactating crewmember. In de-
15 veloping the guidance, the Administrator shall—

16 (1) consider multiple methods of expressing
17 breast milk that could be used by crewmembers, in-
18 cluding the use of wearable lactation technology; and

19 (2) ensure the guidance will not require an air
20 carrier or foreign air carrier to incur significant ex-
21 pense, such as through—

22 (A) the addition of an extra crewmember
23 in response to providing a break;

24 (B) removal or retrofitting of seats on the
25 aircraft; or

1 (C) modification or retrofitting of an air-
2 craft.

3 (b) DEFINITIONS.—In this section:

4 (1) CREWMEMBER.—The term “crewmember”
5 has the meaning given such term in section 1.1 of
6 title 14, Code of Federal Regulations.

7 (2) CRITICAL PHASES OF FLIGHT.—The term
8 “critical phases of flight” has the meaning given
9 such term in section 121.542 of title 14, Code of
10 Federal Regulations.

11 (3) PART 121.—The term “part 121” means
12 part 121 of title 14, Code of Federal Regulations.

13 (c) AVIATION SAFETY.—Nothing in this section shall
14 limit the authority of the Administrator relating to avia-
15 tion safety under subtitle VII of title 49, United States
16 Code.

17 **SEC. 842. AIRCRAFT INTERCHANGE AGREEMENT LIMITA-**
18 **TIONS.**

19 (a) STUDY.—Not later than 90 days after the date
20 of enactment of this Act, the Administrator of Federal
21 Aviation Administration shall conduct a study of foreign
22 interchange agreements.

23 (b) CONTENTS.—In carrying out the study required
24 under subsection (a), the Administrator shall address the
25 following:

1 (1) Methods for updating regulations under
2 part 121.569 of title 14, Code of Federal Regula-
3 tions, for foreign interchange agreements.

4 (2) Time limits for foreign aircraft interchange
5 agreements.

6 (3) Minimum breaks between foreign aircraft
7 interchange agreements.

8 (4) Limits for no more than 1 foreign aircraft
9 interchange agreement between 2 airlines.

10 (5) Limits for no more than 2 foreign aircraft
11 on the interchange agreement.

12 **SEC. 843. FEDERAL AVIATION ADMINISTRATION ACADEMY**
13 **AND FACILITY EXPANSION PLAN.**

14 (a) PLAN.—

15 (1) IN GENERAL.—No later than 90 days after
16 the date of enactment of this section, the Adminis-
17 trator of the Federal Aviation Administration shall
18 initiate the development of a plan to—

19 (A) expand overall Federal Aviation Ad-
20 ministration capacity relating to facilities, in-
21 struction, equipment, and training resources to
22 grow the number of developmental air traffic
23 controllers enrolled per fiscal year and support
24 increases in FAA air controller staffing to ad-

1 vance the safety of the national airspace sys-
2 tem; and

3 (B) establish a second FAA Academy.

4 (2) CONSIDERATIONS.—In developing the plan
5 under paragraph (1), the Administrator shall con-
6 sider—

7 (A) the resources needed to support an in-
8 crease in the total number of developmental air
9 traffic controllers enrolled at the FAA Acad-
10 emies;

11 (B) the resources needed to lessen FAA
12 Academy attrition per fiscal year;

13 (C) how to modernize the education and
14 training of developmental air traffic controllers,
15 including through the use of new techniques
16 and technologies to support instruction, and
17 whether field training can be administered more
18 flexibly, such as at other Federal Aviation Ad-
19 ministration locations across the country;

20 (D) the equipment needed to support ex-
21 panded instruction, including air traffic control
22 simulation systems, virtual reality, and other
23 virtual training platforms;

24 (E) projected staffing needs associated
25 with FAA Academy expansion and the oper-

1 ation of virtual education platforms, including
2 the number of on-the-job instructors needed to
3 educate and train additional developmental air
4 traffic controllers;

5 (F) the use of existing Federal Aviation
6 Administration-owned facilities and classroom
7 space and identifying potential opportunities for
8 new construction;

9 (G) the costs of—

10 (i) expanding Federal Aviation Ad-
11 ministration capacity (as described in
12 paragraph (1)(A)); and

13 (ii) establishing a second FAA Acad-
14 emy (as described in paragraph (1)(B));

15 (H) soliciting input from, and coordinating
16 with, relevant stakeholders as appropriate, in-
17 cluding the exclusive bargaining representative
18 of air traffic control specialists of the Federal
19 Aviation Administration certified under section
20 7111 of title 5, United States Code; and

21 (I) other logistical and financial consider-
22 ations as determined by appropriate the Admin-
23 istrator.

24 (b) REPORT.—Not later than 1 year after the date
25 of enactment of this Act, the Administrator shall submit

1 to the Committee on Transportation and Infrastructure
2 of the House of Representatives and the Committee on
3 Commerce, Science, and Transportation of the Senate the
4 plan developed under subsection (a).

5 (c) BRIEFING.—Not later than 180 days after the
6 submission of the plan under subsection (b), the Adminis-
7 trator shall brief the Committee on Transportation and
8 Infrastructure of the House of Representatives and the
9 Committee on Commerce, Science, and Transportation of
10 the Senate on the plan, including the implementation of
11 the plan.

21 for fiscal year 2024, \$145,000,000 for fiscal year 2025,
22 \$150,000,000 for fiscal year 2026, \$155,000,000 for fis-

1 cal year 2027, and \$161,000,000 for fiscal year 2028.
2 Such sums shall remain available until expended.”.

3 **SEC. 903. CLARIFICATION OF TREATMENT OF TERRI-**
4 **TORIES.**

5 Section 1101 of title 49, United States Code, is
6 amended to read as follows:

7 **“§ 1101. Definitions**

8 “(a) IN GENERAL.—In this chapter:

9 “(1) ACCIDENT.—The term ‘accident’ includes
10 damage to or destruction of vehicles in surface or air
11 transportation or pipelines, regardless of whether the
12 initiating event is accidental or otherwise.

13 “(2) STATE.—The term ‘State’ means a State
14 of the United States, the District of Columbia, Puer-
15 to Rico, the Virgin Islands, American Samoa, the
16 Northern Mariana Islands, and Guam.

17 “(b) APPLICABILITY OF OTHER DEFINITIONS.—Sec-
18 tion 2101(23) of title 46 and section 40102(a) shall apply
19 to this chapter.”.

20 **SEC. 904. ADDITIONAL WORKFORCE TRAINING.**

21 (a) TRAINING ON EMERGING TRANSPORTATION
22 TECHNOLOGIES.—Section 1113(b)(1) of title 49, United
23 States Code, is amended—

24 (1) in subparagraph (I) by striking “; and” and
25 inserting a semicolon;

1 (2) in subparagraph (J) by striking the period
2 and inserting “; and”; and

3 (3) by adding at the end the following:

4 “(K) notwithstanding section 3301 of title 41,
5 acquire training on emerging transportation tech-
6 nologies.”.

7 (b) **ADDITIONAL TRAINING NEEDS.**—Section
8 1115(d) of title 49, United States Code, is amended by
9 inserting “and in those subjects furthering the personnel
10 and workforce development needs set forth in the strategic
11 workforce plan of the Board as required under section
12 1113(h)” after “of accident investigation”.

13 **SEC. 905. ACQUIRING MISSION-ESSENTIAL KNOWLEDGE**
14 **AND SKILLS.**

15 Section 1113(b) of title 49, United States Code, is
16 amended by adding at the end the following:

17 “(3) **DIRECT HIRE AUTHORITY.**—

18 “(A) **IN GENERAL.**—Notwithstanding section
19 3304 and sections 3309 through 3318 of title 5, the
20 Chairman may, on a determination that there is a
21 severe shortage of candidates or a critical hiring
22 need for particular positions, recruit and directly ap-
23 point into the competitive service highly qualified
24 personnel with specialized knowledge important to
25 the function of the Board.

1 “(B) LIMITATION.—The authority granted
2 under subparagraph (A) shall terminate on the date
3 that is 5 years after the date of the enactment of
4 this paragraph.

7 in the excepted service or the Senior Executive Service.

9 “(D) REQUIREMENTS.—In exercising the authority granted under subparagraph (A), the Board

12 “(i) is consistent with the merit principles
13 of section 2301 of title 5; and

14 “(ii) complies with the public notice requirements of section 3327 of title 5.”
15

16 **SEC. 906. OVERTIME ANNUAL REPORT TERMINATION.**

17 Section 1113(g)(5) of title 49, United States Code,
18 is repealed.

19 **SEC. 907. STRATEGIC WORKFORCE PLAN.**

20 Section 1113 of title 49, United States Code, is
21 amended by adding at the end the following:

22 “(h) STRATEGIC WORKFORCE PLAN.—

23 “(1) IN GENERAL.—The Board shall develop a
24 strategic workforce plan that addresses the immediate and long-term workforce needs of the Board
25

1 with respect to carrying out the authorities and du-
2 ties of the Board under this chapter.

3 “(2) ALIGNING THE WORKFORCE TO STRATEGIC
4 GOALS.—In developing the strategic workforce plan
5 under paragraph (1), the Board shall take into con-
6 sideration—

7 “(A) the current state and capabilities of
8 the Board, including a high-level review of mis-
9 sion requirements, structure, workforce, and
10 performance of the Board;

11 “(B) the significant workforce trends,
12 needs, issues, and challenges with respect to the
13 Board and the transportation industry;

14 “(C) the workforce policies, strategies, per-
15 formance measures, and interventions to miti-
16 gate succession risks that guide the workforce
17 investment decisions of the Board;

18 “(D) a workforce planning strategy that
19 identifies workforce needs, including the knowl-
20 edge, skills, and abilities needed to recruit and
21 retain skilled employees at the Board;

22 “(E) a workforce management strategy
23 that is aligned with the mission, goals, and or-
24 ganizational objectives of the Board;

1 “(F) an implementation system for work-
2 force goals focused on addressing continuity of
3 leadership and knowledge sharing across the
4 Board;

5 “(G) an implementation system that ad-
6 dresses workforce competency gaps, particularly
7 in mission-critical occupations; and

8 “(H) a system for analyzing and evalu-
9 ating the performance of the Board’s workforce
10 management policies, programs, and activities.

11 “(3) PLANNING PERIOD.—The strategic work-
12 force plan developed under paragraph (1) shall ad-
13 dress a 5-year forecast period, but may include plan-
14 ning for longer periods based on information about
15 trends in the transportation sector.

16 “(4) PLAN UPDATES.—The Board shall update
17 the strategic workforce plan developed under para-
18 graph (1) not less than once every 5 years.

19 “(5) RELATIONSHIP TO STRATEGIC PLAN.—The
20 strategic workforce plan developed under paragraph
21 (1) may be developed separately from, or incor-
22 porated into, the strategic plan required under sec-
23 tion 306 of title 5.

1 “(6) AVAILABILITY.—The strategic workforce
2 plan under paragraph (1) and the strategic plan re-
3 quired under section 306 of title 5 shall be—

4 “(A) submitted to the Committee on
5 Transportation and Infrastructure of the House
6 of Representatives and the Committee on Com-
7 merce, Science, and Transportation of the Sen-
8 ate; and

9 “(B) made available to the public on a
10 website of the Board.”.

1 overrun for any Board member not later than 30
2 days of such overrun becoming known to the
3 Board.”.

4 (b) CONFORMING AMENDMENT.—Section 9 of the
5 National Transportation Safety Board Amendments Act
6 of 2000 (49 U.S.C. 1113 note) is repealed.

7 **SEC. 909. RETENTION OF RECORDS.**

8 Section 1113 of title 49, United States Code, is fur-
9 ther amended by adding at the end the following:

10 “(j) RETENTION OF RECORDS.—Notwithstanding
11 chapters 21, 29, 31, and 33 of title 44, the Board may
12 retain investigative records for such periods as determined
13 by the Board.”.

14 **SEC. 910. NONDISCLOSURE OF INTERVIEW RECORDINGS.**

15 (a) IN GENERAL.—Section 1114 of title 49, United
16 States Code, is amended—

17 (1) in subsection (b)—

18 (A) in the subsection heading by striking
19 “TRADE SECRETS” and inserting “CERTAIN
20 CONFIDENTIAL INFORMATION”; and

21 (B) in paragraph (1)—

22 (i) by striking “The Board” and in-
23 serting “IN GENERAL.—The Board”; and

24 (ii) by striking “information related to
25 a trade secret referred to in section 1905

1 of title 18” and inserting “confidential in-
2 formation described in section 1905 of title
3 18, including trade secrets,”; and

4 (2) by adding at the end the following:

5 “(h) INTERVIEW RECORDINGS.—

6 “(1) IN GENERAL.—The Board may not pub-
7 licly disclose any part of any audio or video record-
8 ing of an interview of participants in, or witnesses
9 to, an accident or incident investigated by the
10 Board.

11 “(2) SAVINGS PROVISION.—Paragraph (1) shall
12 not be construed to apply to transcripts or sum-
13 maries of such interviews.”.

14 (b) AVIATION ENFORCEMENT.—Section 1151 of title
15 49, United States Code, is amended by adding at the end
16 the following:

17 “(d) NOTIFICATION TO CONGRESS.—If the Board or
18 Attorney General carry out such civil actions described in
19 subsection (a) or (b) of this section against an airman em-
20 ployed at the time of the accident or incident by an air
21 carrier operating under part 121 of title 14, Code of Fed-
22 eral Regulations, the Board shall immediately notify the
23 Committee on Transportation and Infrastructure of the
24 House of Representatives and the Committee on Com-

1 merce, Science, and Transportation of the Senate of such
2 civil actions, including—

3 “(1) the labor union representing the airman
4 involved, if applicable;

5 “(2) the air carrier at which the airman is em-
6 ployed;

7 “(3) the docket information of the incident or
8 accident in which the airman was involved;

9 “(4) the date of such civil actions taken by the
10 Board or Attorney General; and

11 “(5) a description of why such civil actions were
12 taken by the Board or Attorney General.

13 “(e) **SUBSEQUENT NOTIFICATION TO CONGRESS.**—
14 Not later than 15 days after the notification described in
15 subsection (d), the Board shall submit a report to or brief
16 the Committee on Transportation and Infrastructure of
17 the House of Representatives and the Committee on Com-
18 merce, Science, and Transportation of the Senate describ-
19 ing the status of compliance with the civil actions taken.”.

20 **SEC. 911. CLOSED UNACCEPTABLE RECOMMENDATIONS.**

15 “(a) ESTABLISHMENT.—Not later than 1 year after
16 the date of enactment of this section, the Board shall es-
17 tablish in the National Transportation Safety Board an
18 Office of Oversight, Accountability, and Quality Assurance
19 to provide oversight of the duties and responsibilities of
20 the Board.

21 “(b) DIRECTOR.—

22 “(1) APPOINTMENT.—The head of the Office of
23 Oversight, Accountability, and Quality Assurance
24 shall be the Director, who shall be appointed by the

1 Chairman of the Board and shall be approved by the
2 Board.

3 “(2) QUALIFICATIONS.—The Director shall
4 have demonstrated ability in investigations.

5 “(3) TERM.—The Director shall be appointed
6 for a term of 5 years.

7 “(4) VACANCIES.—Any individual approved to
8 fill a vacancy in the position of the Director occur-
9 ring before the expiration of the term for which the
10 predecessor of the individual was approved shall be
11 approved for the remainder of the term or for a new
12 term.

13 “(c) DUTIES.—The Director shall—

14 “(1) establish and ensure policies that promote
15 integrity, efficiency, and effectiveness;

16 “(2) prevent and detect waste, fraud, and abuse
17 in programs and operations;

18 “(3) provide policy direction related to the con-
19 duct, supervision, and coordination of audits and in-
20 vestigations relating to the activities of the Board;

21 “(4) identify trends and systemic issues within
22 the agency and create strategies and recommenda-
23 tions to address such issues;

1 “(5) conduct impartial information gathering
2 about complaints or concerns, and ensure the Board
3 is meeting any quality and timeliness standards; and

4 “(6) not conduct any of the duties under this
5 subsection in a manner that interferes with an ongo-
6 ing safety investigation of the Board.

7 “(d) REPORTING CRIMINAL VIOLATIONS TO DEPART-
8 MENT OF JUSTICE.—If the Director has reasonable
9 grounds to believe that there has been a violation of Fed-
10 eral criminal law, the Director shall refer the matter to
11 the Department of Justice.

12 “(e) SAVINGS CLAUSE.—Nothing in this section shall
13 be construed to interfere or give the Office jurisdiction
14 over any active investigation by the Board or the content
15 of products approved by a vote of the Board.

16 “(f) ANNUAL REPORT.—

18 to the Board, the Committee on Transportation and
19 Infrastructure of the House of Representatives and
20 the Committee on Commerce, Science, and Trans-
21 portation of the Senate an annual report on the ac-

11 “(3) require a manufacturer or the vendors,
12 suppliers, or affiliates of such manufacturer, to pro-
13 vide to the Board, without delay, data and other in-
14 tellectual property the Board determines necessary
15 to enable the Board to perform independent physics-
16 based simulations and analyses of the accident situa-
17 tion.”.

5 **passengers involved in aircraft acci-**
6 **dents**” and inserting “**to passengers involved**
7 **in aircraft accidents and families of such**
8 **passengers**”;

9 (2) in subsection (a)—

10 (A) by inserting “within United States air-
11 space or airspace delegated to the United
12 States” after “aircraft accident”;

13 (B) by striking “National Transportation
14 Safety Board shall” and inserting “Board
15 shall”; and

16 (C) in paragraph (2)—

17 (i) by striking “emotional care and
18 support” and inserting “emotional, psycho-
19 logical, and spiritual care and support
20 services”; and

23 public docket of an accident or incident investigation con-
24 ducted by the Board (or the public docket of a study, re-

1 port, or other product issued by the Board) electronically
2 available in a publicly accessible database on a website of
3 the Board, regardless of the date on which such public
4 docket or record was created.

5 (b) DATABASE.—In carrying out subsection (a), the
6 Board may utilize the multimodal accident database man-
7 agement system established pursuant to section 1108 of
8 the FAA Reauthorization Act of 2018 (49 U.S.C. 1119
9 note) or such other publicly available database as the
10 Board determines appropriate.

11 (c) BRIEFINGS.—The Board shall provide the Com-
12 mittee on Transportation and Infrastructure of the House
13 of Representatives and the Committee on Commerce,
14 Science, and Transportation of the Senate an annual
15 briefing on the implementation of this section until re-
16 quirements of subsection (a) are fulfilled. Such briefings
17 shall include—

18 (1) the number of public dockets that have been
19 made electronically available pursuant to this sec-
20 tion; and

21 (2) the number of public dockets that were un-
22 able to be made electronically available, including all
23 reasons for such inability.

15 mine barriers to accessibility to facilities.

21 accessibility guidelines established under part

24 (B) the Americans with Disabilities Act of
25 1990 (42 U.S.C. 12101 et seq.); and

1 (2) the best accessibility practices that exceed
2 the requirements and recommendations of the Acts
3 and guidelines described in paragraph (1).

4 **SEC. 923. MOST WANTED LIST.**

5 (a) TERMINATION OF PUBLICATION.—Not later than
6 90 days after the date of enactment of this Act, the Chair-
7 man of the National Transportation Safety Board shall
8 terminate publication of the Most Wanted List and any
9 activities associated with production of any future Most
10 Wanted List.

11 (b) RULES OF CONSTRUCTION.—Nothing in this sec-
12 tion shall be construed to prohibit the Board from—

13 (1) conducting advocacy activities unrelated to
14 the Most Wanted List that the Board had the au-
15 thority to conduct prior to the date of enactment of
16 this Act; and

17 (2) maintaining materials related to previously
18 issued Most Wanted Lists.

19 (c) MOST WANTED LIST DEFINED.—In this section,
20 the term “Most Wanted List” has the meaning given such
21 term in section 1102 of the FAA Reauthorization Act of
22 2018 (49 U.S.C. 1101 note).

23 **SEC. 924. TECHNICAL CORRECTIONS.**

15 **TITLE X—FREEDOM TO FLY ACT**
16 **OF 2023**

17 **SECTION 1001. SHORT TITLE.**

18 This title may be cited as the “Freedom to Fly Act
19 of 2023”.

20 **SEC. 1002. PROHIBITION ON IMPLEMENTATION OF VAC-**
21 **CINATION MANDATE.**

22 The Administrator may not implement or enforce any
23 requirement that employees of air carriers be vaccinated
24 against COVID–19.

1 **SEC. 1003. PROHIBITION ON VACCINATION REQUIREMENTS**
2 **FOR FAA CONTRACTORS.**

3 The Administrator may not require any contractor to
4 mandate that employees of such contractor obtain a
5 COVID–19 vaccine or enforce any condition regarding
6 COVID–19 vaccination status of employees of a con-
7 tractor.

8 **SEC. 1004. PROHIBITION ON VACCINE MANDATE FOR FAA**
9 **EMPLOYEES.**

10 The Administrator may not implement or enforce any
11 requirement that employees of the Administration be vac-
12 cinated against COVID–19.

13 **SEC. 1005. PROHIBITION ON VACCINE MANDATE FOR PAS-**
14 **SENGERS OF AIR CARRIERS.**

15 The Administrator may not implement or enforce any
16 requirement that passengers of air carriers be vaccinated
17 against COVID–19.

18 **SEC. 1006. PROHIBITION ON IMPLEMENTATION OF A MASK**
19 **MANDATE.**

20 The Administrator may not implement or enforce any
21 requirement that employee of air carriers wear a mask.

22 **SEC. 1007. PROHIBITION ON MASK MANDATES FOR FAA**
23 **CONTRACTORS.**

24 The Administrator may not require any contractor to
25 mandate that employees of such contractor wear a mask.

1 **SEC. 1008. PROHIBITION ON MASK MANDATE FOR FAA EM-**
2 **PLOYEES.**

3 The Administrator may not implement or enforce any
4 requirement that employees of the Administration wear a
5 mask.

6 **SEC. 1009. PROHIBITION ON MASK MANDATE FOR PAS-**
7 **SENGERS OF AIR CARRIERS.**

8 The Administrator may not implement or enforce any
9 requirement that passengers of air carriers wear a mask.

10 **SEC. 1010. DEFINITIONS.**

11 In this title:

12 (1) ADMINISTRATOR.—The term “Administra-
13 tion” means the Administrator of the Federal Avia-
14 tion Administration.

15 (2) AIR CARRIER.—The term “air carrier” has
16 the meaning given such term in section 40102 of
17 title 49, United States Code.

18 **TITLE XI—FAA RESEARCH AND**
19 **DEVELOPMENT**

20 **SEC. 1101. SHORT TITLE.**

21 This title may be cited as the “FAA Research and
22 Development Act of 2023”.

23 **SEC. 1102. DEFINITIONS.**

24 In this title:

1 (1) ADMINISTRATOR.—The term “Adminis-
2 trator” means the Administrator of the Federal
3 Aviation Administration.

4 (2) APPROPRIATE COMMITTEES OF CON-
5 GRESS.—The term “appropriate committees of Con-
6 gress” means the Committee on Science, Space, and
7 Technology of the House of Representatives and the
8 Committee on Commerce, Science, and Transpor-
9 tation of the Senate.

10 (3) FAA.—The term “FAA” means the Fed-
11 eral Aviation Administration.

12 (4) NASA.—The term “NASA” means the Na-
13 tional Aeronautics and Space Administration.

14 (5) SECRETARY.—The term “Secretary” means
15 the Secretary of Transportation.

16 **Subtitle A—Authorization of** 17 **Appropriations**

18 **SEC. 1111. AUTHORIZATION OF APPROPRIATIONS.**

19 Subsection (a) of section 48102 of title 49, United
20 States Code, is amended—

21 (1) in paragraph (14), by striking “and”;

22 (2) in paragraph (15) by striking the period at
23 the end and inserting a semicolon; and

24 (3) by adding at the end the following new
25 paragraphs:

1 “(16) \$255,130,000; for fiscal year 2024;
2 “(17) \$261,000,000 for fiscal year 2025;
3 “(18) \$267,000,000 for fiscal year 2026;
4 “(19) \$273,000,000 for fiscal year 2027; and
5 “(20) \$279,000,000 for fiscal year 2028.”.

6 **Subtitle B—FAA Research and** 7 **Development Organization**

8 **SEC. 1121. REPORT ON IMPLEMENTATION; FUNDING FOR** 9 **SAFETY RESEARCH AND DEVELOPMENT.**

10 Not later than one year after the date of the enact-
11 ment of this title, the Comptroller General of the United
12 States shall submit to the appropriate committees of Con-
13 gress a report on the allocation of funding pursuant to
14 section 48102 of title 49, United States Code, to the Sec-
15 retary of Transportation to conduct civil aviation research
16 and development and to assess the implementation of sec-
17 tion 48102(b)(2) of such title.

18 **Subtitle C—FAA Research and** 19 **Development Activities**

20 **SEC. 1131. AVIATION FUEL RESEARCH, DEVELOPMENT, AND** 21 **USAGE.**

22 (a) ROADMAP.—Not later than nine months after the
23 date of the enactment of this title, the Secretary of Trans-
24 portation shall coordinate with the Administrator of
25 NASA, the Secretary of Energy, and the Administrator

1 of the Environmental Protection Agency, and consult rel-
2 evant stakeholders, including those in industry and aca-
3 demia, to prepare and submit to the appropriate commit-
4 tees of Congress a coordinated research and development
5 roadmap to safely eliminate the use of leaded aviation fuel
6 in existing and future certified piston-engine aircraft.

7 Such roadmap shall—

8 (1) identify activities to accelerate the develop-
9 ment, testing, and certification of safe and lead-free
10 fuel for use in general aviation aircraft, including
11 requisite airport refueling infrastructure; and

12 (2) consider the feasibility of widespread use of
13 such safe and lead-free aviation fuel by not later
14 than 2028.

15 (b) PARTNERSHIP WITH PRIVATE INDUSTRY.—The
16 Administrator shall coordinate with industry and pilot op-
17 erators regarding research programs for mass production
18 and distribution of unleaded aviation gasoline for market
19 viability engine safety, and define criteria to explore incen-
20 tive programs to reduce lead emissions for communities
21 in need.

22 **SEC. 1132. CONTINUOUS LOWER ENERGY, EMISSION, AND**
23 **NOISE (CLEEN).**

24 The Administrator shall consider expanding the
25 CLEEN program under section 47511 of title 49, United

1 States Code, and broadening eligibility for the CLEEN
2 program to new entrants to the aviation system.

3 **SEC. 1133. STRATEGY ON HYDROGEN AVIATION RESEARCH**
4 **AND DEVELOPMENT.**

5 (a) IN GENERAL.—The Administrator, in consulta-
6 tion with the Administrator of NASA and the heads of
7 other relevant Federal agencies, shall lead the develop-
8 ment of a research and development strategy on the safe
9 use of hydrogen as part of a sustainable future for avia-
10 tion. Such strategy shall consider the following:

11 (1) The feasibility, opportunities, challenges,
12 and pathways toward the potential and safe uses of
13 hydrogen in aviation.

14 (2) The use of hydrogen in addition to research
15 and development efforts, including electrification,
16 operational efficiencies and other alternatives to tra-
17 ditional aviation fuel.

18 (b) TRANSMITTAL.—Not later than one year after the
19 date of the enactment of the Act, the Administrator shall
20 transmit to the appropriate committees of Congress the
21 research and development strategy required under sub-
22 section (a).

23 (c) RESEARCH AND DEVELOPMENT.—Based on the
24 results of the research and development strategy under
25 subsection (a), the Administrator, in coordination with the

1 Administrator of NASA, may conduct research and devel-
2 opment activities into the following:

3 (1) The qualification of hydrogen aviation fuel.

4 (2) The safe transition to such fuel for aircraft.

5 (3) The advancement of certification efforts for
6 such fuel.

7 (4) Risk mitigation measures for the use of
8 such fuel in aircraft systems, including propulsion
9 and storage systems.

10 **SEC. 1134. REPORT ON FUTURE ELECTRIC GRID RESIL-**
11 **IENCY.**

12 Not later than two years after the date of the enact-
13 ment of this title, the Administrator, in coordination with
14 the Secretary of Energy, shall submit to the appropriate
15 committees of Congress a report on the model use of the
16 electrical grid to support future electric advanced air mo-
17 bility, including cost, challenges, and opportunities for
18 clean generation of electricity relating to such support.

19 **SEC. 1135. AIR TRAFFIC SURVEILLANCE OVER OCEANS AND**
20 **OTHER REMOTE LOCATIONS.**

21 (a) AIR TRAFFIC SURVEILLANCE OVER OCEANS.—
22 Subject to the availability of appropriations for such pur-
23 pose, the Administrator, in consultation with the Adminis-
24 trator of NASA and the heads of other relevant Federal
25 agencies, shall carry out research, development, dem-

1 onstration, and testing on civilian air traffic surveillance
2 over oceans and other remote locations.

3 (b) REQUIREMENTS.—In carrying out the research,
4 development, demonstration, and testing under subsection
5 (a), the Administrator shall—

6 (1) consider the need for international inter-
7 operability of technologies, data, operations, and air
8 traffic control systems;

9 (2) examine the status of using air traffic sur-
10 veillance technologies, including space-based Auto-
11 matic Dependent Surveillance-Broadcast, to facili-
12 tate the implementation of minimal separation
13 standards over United States-controlled oceanic air-
14 space;

15 (3) identify mitigating approaches to reducing
16 any operational challenges, associated costs, or work-
17 load impacts; and

18 (4) use testing, data collection, evaluation, and
19 analysis on the use of air traffic surveillance tech-
20 nologies, including space-based Automatic Depend-
21 ent Surveillance-Broadcast, to support the activities
22 described in paragraphs (1) through (3).

23 (c) PILOT PROGRAM.—The Administrator may carry
24 out a pilot program to test and evaluate air traffic surveil-

1 lance equipment over United States-controlled oceanic air-
2 space and other remote locations.

3 (d) REPORT.—Not later than one year after the date
4 of the enactment of this title, the Administrator shall sub-
5 mit to the appropriate committees of Congress a report
6 on the activities carried out under this section.

7 **SEC. 1136. UTILIZATION OF SPACE-BASED ASSETS TO IM-**
8 **PROVE AIR TRAFFIC CONTROL AND AVIA-**
9 **TION SAFETY.**

10 (a) IN GENERAL.—Subject to the availability of ap-
11 propriations for such purpose, the Administrator, in co-
12 ordination with the Administrator of NASA, and in con-
13 sultation with industry stakeholders, shall carry out re-
14 search, development, and testing of the use of air traffic
15 Space-Based Automatic Dependent Surveillance-Broad-
16 cast (ADS-B) data.

17 (b) RESEARCH ACTIVITIES.—In carrying out the re-
18 search, development, and testing under subsection (a) the
19 Administrator shall focus on the following:

20 (1) Monitoring and automatically reporting air
21 turbulence events.

22 (2) Providing space-based multilateration sur-
23 veillance.

24 (3) Identifying global positioning system (GPS)
25 and global navigation satellite system (GNSS) dis-

1 ructions affecting air traffic services and assessing
2 the impact of such events on the safety of air traffic
3 and the National Airspace System.

4 (4) Evaluating the feasibility of implementing
5 and using aviation safety technologies and systems
6 using space-based Automatic Dependent Surveil-
7 lance-Broadcast data.

8 (c) REPORT.—Not later than 180 days after the date
9 of the enactment of this title, the Administrator shall pro-
10 vide to the appropriate committees of Congress a report
11 on the research and development under subsection (a) and
12 the activities researched pursuant to subsection (b).

13 **SEC. 1137. AVIATION WEATHER TECHNOLOGY REVIEW.**

14 (a) REVIEW.—The Administrator, in consultation
15 with the Administrator of the National Oceanic and At-
16 mospheric Administration, shall conduct a review of cur-
17 rent and planned research, modeling, and technology capa-
18 bilities that have the potential to more accurately detect
19 and predict weather impacts to aviation, including for un-
20 manned aircraft systems and advanced air mobility oper-
21 ations, inform how advanced predictive models can en-
22 hance aviation operations, and increase national airspace
23 system safety and efficiency.

24 (b) REPORT.—Not later than one year after the date
25 of the enactment of this title, the Administrator shall sub-

1 mit to the appropriate committees of Congress a report
2 containing the results of the review conducted under sub-
3 section (a).

4 **SEC. 1138. AIR TRAFFIC SURFACE OPERATIONS SAFETY.**

5 (a) RESEARCH.—Subject to the availability of appro-
6 priations for such purpose, the Administrator, in consulta-
7 tion with the Administrator of NASA and the heads of
8 other appropriate Federal agencies, shall continue to carry
9 out research on technologies and operations to enhance air
10 traffic surface operations safety.

11 (b) REQUIREMENTS.—The research program under
12 subsection (a) shall examine the following:

13 (1) The safety of current air traffic control op-
14 erations related to air traffic surface operations.

15 (2) Emerging in-cockpit technologies to enhance
16 ground situational awareness.

17 (3) Emerging technologies to enhance air traffic
18 control situational awareness.

19 (4) Air traffic surface operations safety for di-
20 verse advanced air mobility operations.

21 (5) Safety and operational data needed to in-
22 form current and future safety programs on ad-
23 vanced air mobility vehicles.

1 (6) Economic benefits of utilizing existing air-
2 port infrastructure for use in advanced air mobility
3 operations.

4 (c) REPORT.—Not later than 18 months after the
5 date of the enactment of this title, the Administrator shall
6 submit to the appropriate committees of Congress a report
7 on the research carried out under this section, including
8 regarding the transition into operational use of such re-
9 search.

10 **SEC. 1139. AIRPORT AND AIRFIELD PAVEMENT TECH-**
11 **NOLOGY RESEARCH PROGRAM.**

12 Section 744 of the FAA Reauthorization Act of 2018
13 (Public Law 115–254; 49 U.S.C. 44505 note) is amend-
14 ed—

15 (1) in paragraph (3), by striking “and”;

16 (2) in paragraph (4), by striking “durable air-
17 field pavements.” and inserting “resilient and sus-
18 tainable airfield and vertiport pavements; and”; and

19 (3) by adding at the end the following new
20 paragraph:

21 “(5) develop sustainability and resiliency guide-
22 lines to improve long-term pavement performance
23 and reduce carbon emissions.”.

1 **SEC. 1140. TECHNOLOGY REVIEW OF ARTIFICIAL INTEL-**
2 **LIGENCE AND MACHINE LEARNING TECH-**
3 **NOLOGIES.**

4 (a) REVIEW.—The Administrator shall conduct a re-
5 view of current and planned artificial intelligence and ma-
6 chine learning technologies to improve airport efficiency
7 and safety.

8 (b) SUMMARIES.—The review conducted under sub-
9 section (a) shall include examination of the application of
10 artificial intelligence and machine learning technologies to
11 the following:

12 (1) Jet bridges.

13 (2) Airport service vehicles on airport move-
14 ment areas.

15 (3) Aircraft taxi.

16 (4) Any other areas the Administrator deter-
17 mines necessary to help improve airport efficiency
18 and safety.

19 (c) REPORT.—Not later than one year after the date
20 of the enactment of this title, the Administrator shall sub-
21 mit to the appropriate committees of Congress a report
22 containing the results of the review conducted under sub-
23 section (a). The report shall also include an examination
24 of China's domestic application of artificial intelligence
25 and machine learning technologies identified under sub-
26 section (b).

1 **SEC. 1141. RESEARCH PLAN FOR COMMERCIAL SUPER-**
2 **SONIC RESEARCH.**

3 Not later than one year after the date of the enact-
4 ment of this title, the Administrator, in consultation with
5 the Administrator of NASA and industry, shall submit to
6 the appropriate committees of Congress a comprehensive
7 research plan to build on existing research and develop-
8 ment activities and identify any further research and de-
9 velopment needed to inform the development of Federal
10 and international policies, regulations, standards, and rec-
11 ommended practices relating to the certification and safe
12 and efficient operation of civil supersonic aircraft and su-
13 peronic overland flight.

14 **SEC. 1142. ELECTROMAGNETIC SPECTRUM RESEARCH AND**
15 **DEVELOPMENT.**

16 (a) IN GENERAL.—The Administrator shall conduct
17 research, engineering, and development related to the ef-
18 fective and efficient use and management of radio fre-
19 quency spectrum in the civil aviation domain, including for
20 aircraft, unmanned aircraft systems, and advanced air
21 mobility. Such research, engineering, and development
22 shall, at a minimum, address the following:

23 (1) How reallocation or repurposing of radio
24 frequency spectrum adjacent to spectrum allocated
25 for communication, navigation, and surveillance may
26 impact the safety of civil aviation.

1 (2) The effectiveness of measures to identify
2 risks, protect, and mitigate against spectrum inter-
3 ference in frequency bands used in civil and commer-
4 cial aviation operations to ensure public safety.

5 (b) REPORT.—Not later than one year after the date
6 of the enactment of this title, the Administrator shall sub-
7 mit to the appropriate committees of Congress a report
8 containing the results of the research, engineering, and de-
9 velopment conducted under subsection (a).

10 **SEC. 1143. AVIATION STRUCTURES, MATERIALS, AND AD-**
11 **VANCED MANUFACTURING RESEARCH AND**
12 **DEVELOPMENT.**

13 (a) IN GENERAL.—Using the amounts available
14 under section 48102(a) of title 49, United States Code,
15 the Administrator, in coordination with the Director of the
16 National Institute of Standards and Technology, shall
17 carry out a research and development program for advanc-
18 ing aviation structures, materials, and manufacturing for
19 the safe use in and on aircraft.

20 (b) INCLUSION.—The program under subsection (a)
21 shall, to the extent practicable, include research and devel-
22 opment relating to the following:

23 (1) Metallic and non-metallic based additive
24 materials and processes, composites, and other ad-
25 vanced materials.

1 (2) Process development for the development of
2 design and manufacturing standards for aviation
3 structures, materials, and additive manufacturing.

4 (3) Improving certification efficiency of aviation
5 structures, materials, and additively manufactured
6 aviation products and components.

7 (4) Evaluating long-term material and struc-
8 tural behavior and associated maintenance, including
9 support for fatigue life determination, structural
10 changes related to fatigue, thermal, corrosive envi-
11 ronments, and expected maintenance of such mate-
12 rials, including recommended repair techniques.

13 (5) Partnering with commercial entities to ma-
14 ture and certify, as appropriate, the following capa-
15 bilities for use in aircraft manufacturing:

16 (A) Additive manufacturing, including
17 large-scale additive manufacturing.

18 (B) Aviation structures.

19 (C) Advanced materials capabilities, in-
20 cluding the development and qualification of
21 new material chemistries.

22 (6) Inspection and quality assurance tech-
23 nologies for use with complex geometries enabled by
24 advanced manufacturing methods.

1 (c) REPORT.—Not later than 180 days after the date
2 of the enactment of this title, the Administrator shall pro-
3 vide to the appropriate committees of Congress a report
4 on the findings of the research under subsection (a).

5 **SEC. 1144. RESEARCH PLAN ON THE REMOTE TOWER PRO-**
6 **GRAM.**

7 (a) IN GENERAL.—Not later than 180 days after the
8 date of the enactment of this title, the Administrator shall
9 submit to the appropriate committees of Congress a com-
10 prehensive plan for research, development, testing, and
11 evaluation needed to mature remote tower technology and
12 provide a strategic roadmap to support standards develop-
13 ment, validation, and operational certification of such
14 technology.

15 (b) CONSIDERATIONS.—As part of the plan required
16 under subsection (a), the Administrator should consider
17 the use of remote tower technologies for advanced air mo-
18 bility operations.

19 **SEC. 1145. AIR TRAFFIC CONTROL TRAINING.**

20 (a) RESEARCH.—Subject to the availability of appro-
21 priations for such purpose, the Administrator shall carry
22 out a research program to evaluate opportunities to mod-
23 ernize, enhance, and streamline training time to become
24 a Certified Professional Controller.

1 (b) REQUIREMENTS.—The research under subsection

2 (a) shall—

3 (1) assess the use of advanced technologies,
4 such as artificial intelligence, machine learning,
5 adaptive computer-based simulation, virtual reality,
6 or augmented reality, to enhance controller knowl-
7 edge retention, improve performance, and improve
8 the effectiveness of training time;

9 (2) develop a timeline to deploy proven ad-
10 vanced technologies and associated processes for ac-
11 creditation in training programs and training facili-
12 ties within the national airspace system; and

13 (3) include collaboration with labor organiza-
14 tions and other stakeholders.

15 (c) REPORT.—Not later than one year after the date
16 of the enactment of this title, the Administrator shall sub-
17 mit to the appropriate committees of Congress a report
18 on the findings of the research under subsection (a).

19 **SEC. 1146. REPORT ON AVIATION CYBERSECURITY DIREC-**
20 **TIVES.**

21 Not later than 180 days after the date of enactment
22 of this title, the Administrator shall submit to the appro-
23 priate committees of Congress a report on the status of
24 the FAA's implementation of section 2111 of the FAA Ex-
25 tension, Safety, and Security Act of 2016 (Public Law

1 114–190; 49 U.S.C. 44903 note; relating to the develop-
2 ment of a comprehensive and strategic aviation cybersecu-
3 rity framework and establishment of a research and devel-
4 opment plan to mitigate cybersecurity risks in the Na-
5 tional Airspace System). The report, at minimum, shall
6 include the following:

7 (1) A description of the FAA’s progress in de-
8 veloping, implementing, and updating such frame-
9 work.

10 (2) A description of prioritized research and de-
11 velopment activities for the most needed improve-
12 ments, with target dates, to safeguard the National
13 Airspace System.

14 (3) An explanation for any delays or challenges
15 in so implementing such section.

16 **SEC. 1147. RULE OF CONSTRUCTION REGARDING COLLABO-**
17 **RATIONS.**

18 Nothing in this title may be construed as modifying
19 or limiting existing collaborations, or limiting potential en-
20 gagement on future collaborations, between the Adminis-
21 trator, stakeholders, and labor organizations, including
22 the exclusive bargaining representative of air traffic con-
23 trollers certified under section 7111 of title 5, United
24 States Code, pertaining to Federal Aviation Administra-

1 tion research, development, demonstration, and testing ac-
2 tivities.

3 **SEC. 1148. TURBULENCE RESEARCH AND DEVELOPMENT.**

4 (a) IN GENERAL.—Subject to the availability of ap-
5 propriations for such purpose, the Administrator, in col-
6 laboration with the Administrator of the National Oceanic
7 and Atmospheric Administration, and in consultation with
8 the Administrator of NASA, shall carry out applied re-
9 search and development to—

10 (1) enhance the monitoring and understanding
11 of severe turbulence, including clear-air turbulence;
12 and

13 (2) inform the development of measures to miti-
14 gate safety impacts on crew and the flying public
15 that may result from severe turbulence.

16 (b) RESEARCH AND DEVELOPMENT ACTIVITIES.—In
17 conducting the research and development on severe turbu-
18 lence in accordance with subsection (a), the Administrator
19 shall—

20 (1) establish processes and procedures for com-
21 prehensive and systematic data collection through
22 both instrumentation and pilot reporting, of severe
23 turbulence, including clear-air turbulence;

24 (2) establish measures for storing and man-
25 aging such data collection;

1 (3) support measures for monitoring and char-
2 acterizing incidents of severe turbulence;

3 (4) consider relevant existing research and de-
4 velopment from other entities, including Federal de-
5 partments and agencies, academia, and the private
6 sector; and

7 (5) carry out research and development—

8 (A) to understand the impacts of climate
9 change and other factors on the nature of tur-
10 bulence, including severe turbulence and clear-
11 air turbulence;

12 (B) to enhance turbulence forecasts for
13 flight planning and execution, seasonal pre-
14 dictions for schedule and route-planning, and
15 long-term projections of severe turbulence, in-
16 cluding clear-air turbulence; and

17 (C) on other subject matters areas related
18 to severe turbulence, as determined by the Ad-
19 ministrator; and

20 (6) support the effective transition of the re-
21 sults of research and development to operations,
22 where appropriate.

23 (c) NO DUPLICATION.—The Administrator shall en-
24 sure that research and development activities under this

1 section do not duplicate other Federal programs relating
2 to turbulence.

3 (d) TURBULENCE DATA.—

4 (1) COMMERCIAL PROVIDERS.—In conducting
5 research and development activities under subsection
6 (b), the Administrator may enter into agreements
7 with commercial providers for the following:

8 (A) The purchase of turbulence data.

9 (B) The placement on aircraft of instru-
10 ments relevant to understanding and moni-
11 toring turbulence.

12 (2) DATA ACCESS.—The Administrator shall
13 make the data collected pursuant to subsection (b)
14 widely available and accessible to the scientific re-
15 search, user, and stakeholder communities, including
16 the Administrator of the National Oceanic and At-
17 mospheric Administration, to the greatest extent
18 practicable and in accordance with Federal Aviation
19 Administration data management policies.

20 (e) REPORT ON TURBULENCE RESEARCH.—Not later
21 than 15 months after the date of the enactment of this
22 title, the Administrator, in collaboration with the Adminis-
23 trator of the National Oceanic and Atmospheric Adminis-
24 tration, shall submit to the appropriate committees of
25 Congress a report that—

1 (1) details the activities conducted under this
2 section, including how the research and development
3 activities under subsection (b) have contributed to
4 the goals specified in subsection (a);

5 (2) assesses the current state of scientific un-
6 derstanding of the causes, occurrence rates, and past
7 and projected future trends in occurrence rates of
8 severe turbulence, including clear-air turbulence;

9 (3) describes the processes and procedures for
10 collecting, storing, and managing, data in pursuant
11 to subsection (b);

12 (4) assesses—

13 (A) the use of commercial providers pursu-
14 ant to subsection (d)(1); and

15 (B) the need for any future Federal Gov-
16 ernment collection or procurement of data and
17 instruments related to turbulence, including an
18 assessment of costs;

19 (5) describes how such data will be made avail-
20 able to the scientific research, user, and stakeholder
21 communities; and

22 (6) identifies future research and development
23 needed to inform the development of measures to
24 predict and mitigate the safety impacts that may re-

1 sult from severe turbulence, including clear-air tur-
2 bulence.

3 **SEC. 1149. RESEARCH, DEVELOPMENT, AND DEMONSTRATION PROGRAMS.**
4

5 (a) IN GENERAL.—The Administrator shall carry out
6 research, development, testing, evaluation, and demonstra-
7 tion programs for low-carbon alternative aviation fuels,
8 which may include next-generation feedstocks, biofuels,
9 and bioderived chemicals.

10 (b) COLLABORATION.—The Administrator shall col-
11 laborate with Federal agencies, industry stakeholders, re-
12 search institutions, and other relevant stakeholders, to ac-
13 celerate the research, development, testing, evaluation,
14 and demonstrations programs described in subsection (a)
15 and facilitate United States sustainability and competi-
16 tiveness in aviation.

17 **SEC. 1150. LIMITATION.**

18 None of the funds authorized in this title may be used
19 to conduct research, develop, design, plan, promulgate, im-
20 plement, or execute a policy, program, order, or contract
21 of any kind with the Chinese Communist Party or any
22 Chinese-owned entity unless such activities are specifically
23 authorized by a law enacted after the date of enactment
24 of this title.

1 **TITLE XII—AVIATION REVENUE**

3 **SEC. 1201. AIRPORT AND AIRWAY TRUST FUND EXPENDI-**
4 **TURE AUTHORITY.**

5 (a) IN GENERAL.—Section 9502(d)(1) of the Inter-
6 nal Revenue Code of 1986 is amended—

7 (1) in the matter preceding subparagraph (A)
8 by striking “October 1, 2023” and inserting “Octo-
9 ber 1, 2028”; and

10 (2) in subparagraph (A) by striking the semi-
11 colon at the end and inserting “or the Securing
12 Growth and Robust Leadership in American Avia-
13 tion Act;”.

14 (b) CONFORMING AMENDMENT.—Section 9502(e)(2)
15 of such Code is amended by striking “October 1, 2023”
16 and inserting “October 1, 2028”.

17 **SEC. 1202. EXTENSION OF TAXES FUNDING AIRPORT AND**
18 **AIRWAY TRUST FUND.**

19 (a) FUEL TAXES.—Section 4081(d)(2)(B) of the In-
20 ternal Revenue Code of 1986 is amended by striking “Sep-
21 tember 30, 2023” and inserting “September 30, 2028”.

22 (b) TICKET TAXES.—

23 (1) PERSONS.—Section 4261(k)(1)(A)(ii) of
24 such Code is amended by striking “September 30,
25 2023” and inserting “September 30, 2028”.

1 (2) PROPERTY.—Section 4271(d)(1)(A)(ii) of
2 such Code is amended by striking “September 30,
3 2023” and inserting “September 30, 2028”.

4 (c) FRACTIONAL OWNERSHIP PROGRAMS.—

5 (1) FUEL TAX.—Section 4043(d) of such Code
6 is amended by striking “September 30, 2023” and
7 inserting “September 30, 2028”.

8 (2) TREATMENT AS NONCOMMERCIAL AVIA-
9 TION.—Section 4083(b) of such Code is amended by
10 striking “October 1, 2023” and inserting “October
11 1, 2028”.

12 (3) EXEMPTION FROM TICKET TAX.—Section
13 4261(j) of such Code is amended by striking “Sep-
14 tember 30, 2023” and inserting “September 30,
15 2028”.

16 **SEC. 1203. DESIGNATION OF CERTAIN AIRPORTS AS PORTS**
17 **OF ENTRY.**

18 (a) IN GENERAL.—The President shall—

19 (1) pursuant to the Act of August 1, 1914 (38
20 Stat. 623, chapter 223; 19 U.S.C. 2), designate each
21 airport described in subsection (b) as a port of
22 entry; and

23 (2) terminate the application of the user fee re-
24 quirement under section 236 of the Trade and Tar-

1 iff Act of 1984 (19 U.S.C. 58b) with respect to the
2 airport.

3 (b) AIRPORTS DESCRIBED.—An airport described in
4 this subsection is an airport that—

5 (1) is a primary airport (as defined in section
6 47102 of title 49, United States Code);

7 (2) is located not more than 30 miles from the
8 northern or southern international land border of
9 the United States;

10 (3) is associated, through a formal, legal instru-
11 ment, including a valid contract or governmental or-
12 dinance, with a land border crossing or a seaport not
13 more than 30 miles from the airport; and

14 (4) through such association, meets the numer-
15 ical criteria considered by U.S. Customs and Border
16 Protection for establishing a port of entry, as set
17 forth in—

18 (A) Treasury Decision 82–37 (47 Fed.
19 Reg. 10137; relating to revision of customs cri-
20 teria for establishing ports of entry and sta-
21 tions), as revised by Treasury Decisions 86–14
22 (51 Fed. Reg. 4559) and 87–65 (52 Fed. Reg.
23 16328); or

24 (B) any successor guidance or regulation.
